## **DELAY IN DESPATCH OF CIRCULAR MAJOR TRANSACTION IN RELATION TO THE CMH SUBSCRIPTION, THE CMH ACQUISITION AND THE CMH OFFER**

Reference is made to the announcement (the “**Joint Announcement**”) dated 16th June, 2023 (as supplemented by the clarification announcement dated 19th June, 2023) jointly issued by the Offeror, TACI, AGL and CMH in relation to, among other things, the CMH Offer. Unless otherwise defined, capitalised terms used herein shall have the same meanings as those defined in the Joint Announcement.

Pursuant to Rule 14.41(a) of the Listing Rules, a circular (the “**Circular**”) of TACI containing, among others, details of the CMH Subscription, the CMH Acquisition and the CMH Offer and information regarding CMH is required to be despatched to the TACI Shareholders within 15 business days after publication of the Joint Announcement, which shall be on or before 10th July, 2023.

As additional time is required for TACI to finalise certain information in the Circular, TACI has applied for, and the Stock Exchange has granted, a waiver (the “**Waiver**”) from strict compliance with Rule 14.41(a) of the Listing Rules for an extension of time for the despatch of the Circular. The date of despatch of the Circular is expected to be delayed to a date falling on or before 28th July, 2023. The Waiver applies to this case only and the Stock Exchange may withdraw or change the Waiver if the situation of TACI changes.
