VOLUNTARY ANNOUNCEMENT UNAUDITED OPERATIONAL UPDATE FOR JUNE OF MEDICAL TOURISM FLAGSHIP CENTERS IN HONG KONG

The board of directors (the “**Board**”) of Perfect Medical Health Management Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce the unaudited operational update in relation to medical tourism flagship centers (the “**Medical Tourism Flagship Centers**”) which located at Causeway Bay and Tsim Sha Tsui for one month ended 30 June 2023 (the “**Period**”).

Moving along the resumption of Mainland China travel, the potential customers from Mainland China have an intense demand for Hong Kong premium medical beauty services. The value of sale contracts of these Medical Tourism Flagship Centers for the Period achieved increases of 26.6% as compared with last month. Looking ahead, the Group will vigorously expand the medical tourism business in the Guangdong-Hong Kong-Macau Greater Bay Area.
