NOTICE IS HEREBY GIVEN that an annual general meeting (the "**Meeting**") of Chong Kin Group Holdings Limited (the "**Company**") will be held at Suite 6808, 68th Floor, Central Plaza, 18 Harbour Road, Wan Chai, Hong Kong on Friday, 4 August 2023 at 10:00 a.m. for considering and, if thought fit, passing, with or without amendments, the following resolutions as ordinary resolutions of the Company:

ORDINARY RESOLUTIONS

- 1. To receive and consider the audited consolidated financial statements of the Company and the reports of the directors (the "**Directors**") and the independent auditor of the Company and its subsidiaries for the year ended 31 March 2023.
- 2. (a) To re-elect Mr. Zhang Jinbing as an executive Director; and
 - (b) To re-elect Mr. Tam Ping Kuen, Daniel as an independent non-executive Director.
- 3. To authorise the board (the "**Board**") of Directors to fix the remuneration of the Directors.
