## Remarks:

As disclosed in the circular dated 27 April 2023, the Capital Reorganisation of the Company may lead to adjustments to the number of new shares to be issued pursuant to the Consulting Agreements. Upon the Share Consolidation becoming effective on 5 June 2023, the possible issuance of new shares on or around 14 July 2023 and 14 July 2024 in aggregate will be changed from 1,853,334 to 92,666 new shares, with the issue price remains at HK\$0.166 which is the issue price fixed at the date of the Consulting Agreements. Details are set out in the Company's announcements dated 14 July 2021, 26 July 2021, 29 March 2023, 1 June 2023 and the circular dated 27 April 2023.

Given the share price after the Share Consolidation will theoretically become 20 times higher than that before the Share Consolidation, the issue price is multiplied by 20 (i.e. HK\$3.32) to achieve a fair comparsion with the closing market price per share of the immediately preceding business day.

- *the securities are of the same nominal value with the same amount called up or paid up;*
- *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
- *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*
