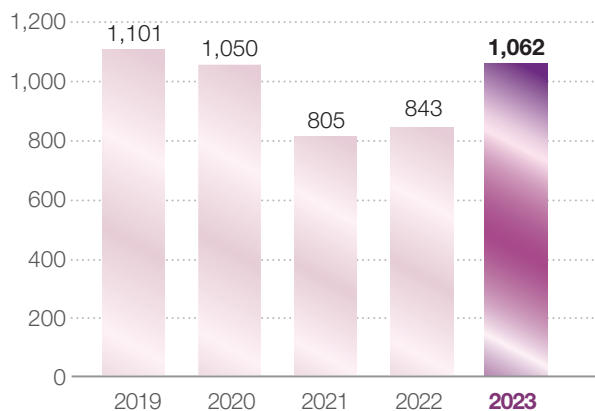

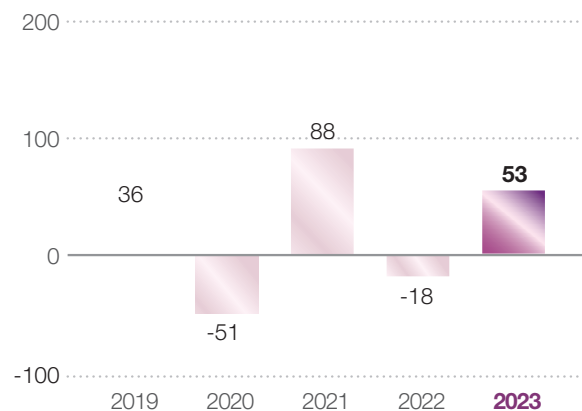

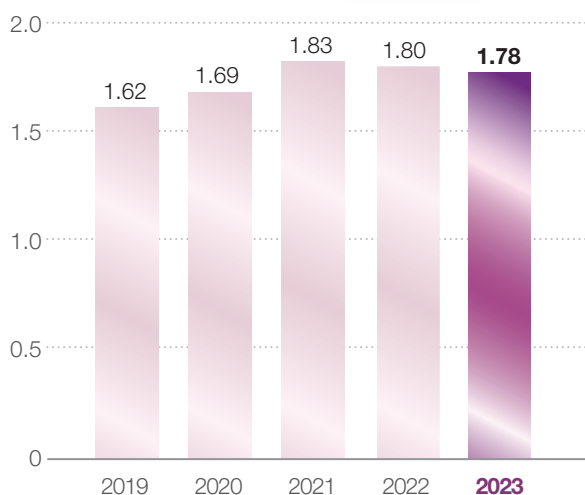

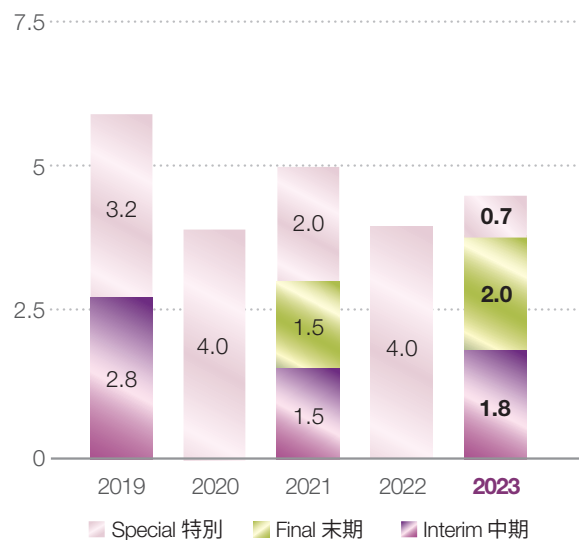

# Chairman's Statement 主席報告

## MACROECONOMIC DISCUSSION

The coming financial year continues to be a mix of growth impulses and interlocking challenges. On the positive side, the global economy has begun to stabilize and is showing signs of improvement, albeit to a relatively weak upturn. The reopening of China has provided impetus to global economic activity, but continuing trade tensions and geopolitical risks will remain a concern. Other downside risks include persistent global inflation despite an easing of energy prices from record levels in 2022, supply-side pressures in particular the tight labor markets, and the impact of high interest rates.

To gain better clarity in this uncertain environment, manufacturers need to take a proactive approach to risk management by identifying relevant industry trends and signs of potential threats, developing contingency plans to cope with short-term market volatility, and implementing long-term capacity and capability upgrading plans to secure sustainable growth.

## STRATEGIES AND OUTLOOK

Entering the financial year 2024, the order pipeline continues to lack visibility. It is expected that the footwear brands' inventory adjustment period will extend into the first half of this coming financial year, until client inventories recover to healthier levels.

In light of this, the Group will maintain prudence in capacity expansion plans and instead focus on upgrading our facilities to handle anticipated client procurement requirements of higher sophistication, short turnaround time, and small batch sizes. To maintain cost competitiveness, careful workforce planning is also essential. We have adjusted our manpower cautiously in line with the forthcoming order forecasts, while at the same time, helping workers upskill to better serve our strategy of product portfolio enhancement.

## 宏觀經濟討論

下一財政年度既有增長動力，亦會見到環環相扣的挑戰，兩者並行。從積極的一面來看，全球經濟漸次企穩並出現好轉跡象，但回彈幅度相對較弱。中國解封重開為全球經濟活動提供了動力，但持續的貿易緊張局勢和地緣政治風險仍令人憂慮。而儘管能源價格已自二零二二年的紀錄水平回調，全球通脹仍然揮之不去，加上供應方面的壓力，尤其是緊張的勞動力市場，以及高利率的影響，均構成下行風險。

因此，製造商需要採取積極主動的風險管理方針，通過識別相關行業趨勢和潛在威脅跡象，制定可應對短期市場波動的應變計劃，並實施長期的產能升級和擴充計劃以確保可持續增長，以期在不確定的環境中獲得更佳清晰度。

## 策略和前景

踏入二零二四財政年度，訂單管道仍然缺乏可視性。預計鞋履品牌的庫存調整期將伸延至下一財年的上半年，直至客戶庫存恢復到更健康的水平。

有鑑於此，本集團將在產能擴張計劃上保持審慎態度，轉而專注於為設施升級，以應對預期客戶對更複雜、更短週轉期和小批量的採購要求。為了保持成本競爭力，審慎的勞動力規劃亦很重要。我們根據未來的訂單預測，謹慎地調整了勞工人手，同時幫助工人提高技能，以配合提升產品組合的策略。



# Chairman's Statement

## 主席報告

Our future-ready initiatives can be summarized in these six strategic action areas:

### 1 Fortify business growth and enhance revenue profile

Adopting a set of growth strategies that aligns ongoing business development activities with our unique capabilities, the Group will continue to stay focused on the higher end of the active footwear arena.

To this end, we will take forward customized research and development (“R&D”) for brands that offer potential of value growth, and to meet client requirements, the R&D center in Zhuhai, mainland China, will be relocated to the available premises adjacent to the southern Vietnam production site. This plan is set to be implemented within the next few years and will bring R&D activities closer to the Group’s main production hub, offering a one-stop service to clients. By equipping the center with upgraded facilities, and moving it to a more strategic location, we can improve our overall production service offering.

Plans are also underway to move the outsole factory to the premises next to our main production site in southern Vietnam, to enable more efficient manufacturing arrangements. Upon ceasing of operation of the partnership outsole factory in Cambodia, vacated space there can be re-designated for manufacturing purposes.

### 2 Capacity and capability planning

We aim to grow our capacity and capability in tandem with our strategy to develop a higher-value product portfolio. Given the current uncertainty in the macroeconomic environment, we will take a prudent approach to capacity expansion. Instead, we will upgrade our facilities and replace old machinery. We also plan to increase automation moderately to raise our overall efficiency.

While continuing to maintain a cross-location platform in southern Vietnam and Cambodia, we are actively adjusting the manufacturing activities between these two sites to support brand clients’ procurement plans. We will continue to work with our clients to make inter-site manufacturing adjustments.

面向未來的舉措，可概括為以下六大策略行動領域：

### 1 促進業務增長並提升收入結構

本集團已採取一系列增長策略，配合我們的獨有優勢，繼續專注發展較高端的活力鞋履領域。

為此，我們著眼於具有價值增長潛力的品牌，為其進行定制研究與開發（「研發」）。而為配合客戶要求，位於中國內地珠海的研發中心將遷至越南，落戶毗鄰集團越南南部生產基地、可供使用的廠房。此計劃將在未來數年內實施，將使研發活動更靠近集團的主要生產中心，為客戶提供一站式服務。通過為研發中心配備升級設施，並將其遷移到更具策略意義的位置，將可改善整體生產服務。

我們同時計劃將大底工廠遷至越南南部的的主要生產基地旁，以實現更高效的製造流程。在柬埔寨的合作大底工廠停止營運後，騰出的空間可以重新撥作製造用途。

### 2 規劃產能和能力

我們按照價值產品策略，規劃產能和能力，支持開發更高產值的鞋履組合。鑑於當前宏觀經濟環境的不確定性，我們將採取審慎的產能擴張規劃，轉而為設施升級並更換舊機器。我們亦計劃適度增加自動化，以提高整體效率。

我們會繼續在越南南部和柬埔寨維持跨地生產平台，並積極調配兩地之間的製造活動，以支持品牌客戶的採購計劃。我們會繼續與客戶合作，調整兩地之間的製造活動。

### 3 Pursue operational excellence

As a production partner for leading footwear brands, innovation in product development is at the forefront of our operations. From the use of materials to the manufacturing process, we prioritize innovation in order to fulfill the ever-changing design needs of our clients. Additionally, we are committed to enhancing our work processes to cope with new requirements, including the need for quick production cycles and frequent line changes.

During the Year, we undertook a thorough and in-depth revamp of our manufacturing process with an aim of achieving further efficiency gains and improving the overall performance and output quality of our production centers. Our local management teams have also made some production line realignments in order to flexibly respond to ad hoc events that may disrupt our order fulfillment ability.

### 4 Mitigate cost inflation

Cost inflation remains a significant issue for manufacturers, and we are taking stringent measures to mitigate inflationary pressures. We are driving cost control initiatives across our operations and constantly advancing our lean manufacturing and enterprise resource planning systems.

While we are scaling back moderately on our workforce, we have primarily reduced unskilled labor and focused our resources on further training skilled workers. This approach will enable us to achieve savings and at the same time enhance the quality of our output. Additionally, we will increase the proportion of subcontracting to supplement our existing workforce, allowing us to keep fixed labor costs in check and flexibly meet urgent order requirements. By optimizing our workforce and leveraging subcontracting, we can efficiently meet the demands of our customers while maintaining cost control.

Strict cost control measures apply not only to our production operations but also to our sales, administrative and other corporate functions.

### 3 追求卓越營運

作為領先鞋履品牌的生產夥伴，產品開發創新是我們營運的重中之重。從材料的選用，乃至製造過程均優先考慮創新，以滿足客戶不斷變化的設計要求。此外，我們致力改進工作流程以應對新的要求，包括快速生產週期和頻繁更換生產線的需要。

本年度內，我們對製造流程進行了徹底而深入的改造，旨在進一步提高效率，並改善生產中心的整體績效和產出質量。本地管理團隊亦對生產線進行了調整，以靈活應對可能干擾訂單履行能力的突發情況。

### 4 紓緩成本通脹壓力

成本通脹仍然是製造商面對的一大課題，我們正採取嚴格措施以緩解通脹壓力。成本控制舉措貫穿整個營運架構，我們並不斷改進精益製造和企業資源規劃系統。

儘管我們適度縮減勞動力，但所減的主要為非熟練勞工，同時我們將資源投放於進一步培訓熟練工人上，既能實現節約，同時可提高產出的質量。此外，我們將增加分包比例以補充現有的勞動力，使我們能夠控制固定勞動力成本，並靈活滿足緊急訂單的需求。通過優化勞工團隊和運用分包，我們可以有效地滿足客戶的需求，同時保持成本控制。

嚴格的成本控制措施不僅適用於生產營運，亦適用於銷售、行政和其他公司職能。

### 5 Talent development

The Group values its staff team, which brings a wide array of specialist skills to various business units. Our team is committed to helping clients thrive as we build a world-class business that shares in our clients' success. To attract and retain top talent, we offer competitive compensation packages, including a share option scheme and a share award scheme as incentives and rewards for eligible participants who contribute to the Group's success.

Our capable management team has consistently met unprecedented challenges with dedication and resolve. With their strong leadership and crisis management capabilities, we have navigated difficult operating terrain over the past few years.

Localization is also a key focus for the long-term development of our manufacturing locations, and we have dedicated efforts to building up local leadership. The encouraging performance of our operations in Vietnam and Cambodia is a testament to the increasing maturity of our local teams.

The independent non-executive directors (“INEDs”) of our board (the “Board”) of directors play an important role in the corporate governance of the Company. They provide an external and independent view on our business and governance matters. As part of our ongoing effort to enhance corporate governance standards, we regularly review our Board's composition, specifically in terms of director independence and diversity. This includes appointing new INEDs and maintaining an appropriate make-up of the Board.

### 5 人才發展

本集團重視員工團隊，他們為不同業務單位帶來廣泛的專業技能。團隊致力建立一家世界級企業，幫助客戶蓬勃發展，並能助集團分享客戶成就。為招募和保留人才，我們提供具競爭力的薪酬待遇，亦設有購股權計劃及股份獎勵計劃，對本集團成功經營而作出貢獻之合資格員工提供鼓勵和獎賞。

我們的管理團隊能幹務實，積極投入，並憑著堅定決心，持續應對前所未見的挑戰。在團隊的領導和危機管理能力支持下，集團得以應對過去數年經營環境中的困難。

本地化對生產基地的長遠發展亦至為重要。我們一直致力在越南和柬埔寨建立本地管理團隊，他們的表現令人鼓舞，足證團隊日益成熟。

董事會內的獨立非執行董事（「獨董」）在本公司企業管治中發揮重要作用。他們就集團的業務和管治事宜提供外部和獨立的觀點。本公司一直致力提高企業管治標準，董事會定期審視其組成，特別聚焦董事的獨立性和多元化，包括任命新的獨董，及保持董事會的適當組成。

### 6 Resilience and sustainability

The past couple of years have seen major disruptive events, including the pandemic, trade conflicts, and geopolitical tensions. These events have called for new levels of preparedness to address surging threats that add to normal business risks. Our first line of defense is to support the continuity of our operations and provision of services for clients by constantly renewing our crisis mechanisms at different operating levels. Recognizing the potential for shocks from more profound market and technological changes, we are also focused on building resilience by enhancing our operations and updating our value proposition.

In addition to business resilience, we are committed to practicing sustainable manufacturing. This involves implementing standard procedures and new initiatives to reduce the carbon footprint of production while following strict guidelines to ensure employee, product, and community safety. These efforts are overseen by a sustainability working group comprising our executive directors, senior management, and heads of our production centers. Importantly, we make conscious efforts to build a culture throughout our organization that prioritizes sustainability considerations in our business decisions.

The United Nations' (UN) 2030 Agenda for Sustainable Development is a commitment made by all to work together towards the well-being of everyone on a healthy, thriving planet. Unfortunately, this joint effort has been somewhat sidetracked by the pandemic and other disruptive events over the past few years, as we approach the halfway point to 2030.

### 6 韌力和可持續性

過去數年間，具顛覆性的重大事件頻生，包括疫情、貿易衝突和地緣政治緊張局勢等，企業需要將備戰狀態提高至新水平，以應對常態業務風險以外的洶湧威脅。我們的第一道防線是鞏固持續營運、為客戶提供服務的實力，因此必須不斷在不同營運層面更新危機處理機制，以確保生產穩定。更深遠的市場和科技轉變，亦可帶來更大的潛在衝擊。為此，我們通過優化營運和更新價值主張，為業務建立韌性。

業務韌性之外，我們亦致力實踐可持續生產，當中牽涉減低生產碳足跡的標準程序和新規章，同時嚴格遵守指引，以確保僱員、產品和社區安全。這些舉措由執行董事、高級管理人員和生產中心領導所組成的可持續工作小組監管。重要的是，我們在業務決策中優先考慮可持續性因素，從而在整個組織中建立永續文化。

聯合國的二零三零年可持續發展議程，倡導所有人作出承諾，共同努力維繫健康、繁榮的地球，為每個人謀求福祉。遺憾的是，在接近二零三零年中點的同時，過去數年出現了疫情和其他顛覆性事件，一定程度影響了相關倡議的進程。

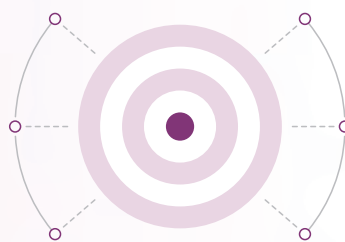

With a focus on enhancing our product and revenue portfolio under an overall margin-accretive strategy, we prioritize value over volume in business development. As such, we have been pursuing business with strategic value that best utilizes our capabilities in high-end products.

On a macroeconomic level, the outlook for the remainder of the financial year 2024 continues to be uncertain due to the banking sector stress, inflation and geopolitical tensions, despite some improvements at the onset of 2023. On a more positive note, as we witness some improvement on the retail end, with interest rates increasing at a slower pace and some signs of inflation easing, we are cautiously optimistic that our manufacturing performance will improve in the second half of the coming financial year as brand clients' inventories return to healthier levels.

Our Group will continue to maintain a healthy financial position, which will enable us to weather challenging market conditions and remain resilient, and also allows us to capitalize on new opportunities as they arise.

Our team, facilities and skill sets are all in place and ready to meet the demands of our customers. We believe that our solid foundation will enable us to adapt to emerging trends and economic cycles. We are confident in our ability to navigate the challenges ahead and emerge stronger on the other side.

## 結語

展望未來，我們將繼續致力為客戶、股東和員工創造價值，並持續投資於人才和技術能力，以保持競爭力和創新能力。

在整體利潤增長策略下，我們專注提升產品和營收組合，因而在業務發展上優先考慮價值而非數量。因此，我們一直追求具有策略價值的業務，全面發揮我們在高端產品方面的能力。

儘管宏觀經濟在二零二三年年初有見改善，但銀行業承壓、通脹和地緣政治緊張局勢，均令二零二四財年剩餘時間的前景持續不明朗。從較積極的角度來看，零售端出現改善勢頭，加息步伐放緩，通脹亦有緩和跡象，我們持審慎樂觀展望，相信隨著品牌客戶的庫存恢復到更健康的水平，製造業務業績可望在下一財年下半年得到改善。

本集團將繼續維持健康的財務狀況，以支持我們在充滿挑戰的市場環境中前行，保持經營韌力，同時能在新商機出現時及時掌握。

我們擁有強健的團隊、設施和技能，並已準備就緒，可以滿足客戶未來的需求。集團堅實的基礎，使我們能夠應對新湧現的趨勢和經濟週期。我們有信心能夠應對未來的挑戰，成為實力更強大的企業。

### FINANCIAL RESULTS

The Board is delighted to announce the annual results of the Company for the Year.

The Group recorded a strong start in the Year, with the first-half performance driven by a general recovery of the global footwear retail sector after the lifting of pandemic restrictions. However, as inflation and slowing US and European economies continued to take a toll on retail demand, the Group's order growth softened to some extent during the second half of the Year.

### 財務業績

董事會欣然公佈本公司於本年度之全年業績。

本年度上半年疫情解封後，本集團受全球鞋履零售業的普遍復甦帶動，業績開局良好。然而，由於通脹及歐美經濟放緩，繼續對零售需求造成影響，集團下半年的訂單增長有所放緩。

For footwear brands, the latter part of the Year was characterized by elevated inventory levels as a result of downstream congestion on the retail end. The inventory challenges across footwear retailing have impacted branded clients' procurement behaviour and momentum, resulting in more conservative order placements for the Group. To this end, the Group has worked closely with its clients to help them manage this challenging task by adjusting the shipment plans and schedules.

The Group concluded the Year with positive results, but will stay alert to the geopolitical tensions, interest rate increases and global inflation, which have added to the macroeconomic uncertainty. The Group remains committed to safeguarding its operations against the unprecedented challenges that lie ahead, particularly given the low visibility in the current operating environment.

### Revenue

During the Year, revenue increased by 26.0% year on year to approximately HK\$1,062 million (2022: approximately HK\$843 million) on a 7.9% increase in footwear business volume (pairs) and a 16.0% improvement in the average selling price (“ASP”). The ASP improvement was a result of the Group's ongoing business development strategy to prioritize value over volume growth.

對於鞋履品牌而言，由於零售下游擁堵，致使本年度較後期面對高庫存問題。鞋履零售業庫存普遍高企，影響了品牌客戶的採購行為和動能，導致下單更為保守。為此，集團與客戶密切合作，通過調整付運計劃和時間表幫助他們應對挑戰。

本集團於本年度取得正面業績，但注意到地緣政治局勢緊張、利率上升和全球通脹等問題，均會為宏觀經濟增添不確定性，故會保持警惕。面對前所未有的挑戰，尤其慮及當前經營環境的可見度低，集團會致力維護營運穩定，免受此等因素影響。

### 營業額

本年度內，營業額按年上升26.0%至約1,062,000,000港元（二零二二年：約843,000,000港元），期間鞋履業務量（雙數）上升7.9%，平均售價亦錄得16.0%升幅。本集團按照一貫業務發展策略，優先考慮價值而非數量，故平均售價得以提升。

### Gross Profit

The Group achieved year-on-year increase in gross profit to approximately HK\$90 million (2022: approximately HK\$25 million) for the Year. With continuous discipline to drive business-focused cost optimization, the Group has kept its labor, administrative and transportation costs in check. At the same time, the Group has actively managed its clientele portfolio with a focus on higher-margin products; the gross profit margin thus expanded to approximately 8.4% (2022: approximately 3.0%), mainly attributable to:

- (i) economies of scale achieved as a result of the revenue growth, which was mainly contributed by the improved order book for the Year;
- (ii) higher ASP and shipment volume recorded, resulting in a comparative improvement in the gross profit margin;
- (iii) cost-mitigating measures and stabilized manufacturing operations driving down cost-to-revenue ratios, including:
  - (a) direct wages, which shrank 1.1% to approximately HK\$185 million (2022: approximately HK\$187 million) on a slightly scaled back workforce in the southern Vietnam production center, with proportionate direct labor wages decreasing to 17.5% of revenue (2022: 22.2%);
  - (b) transportation costs; and
- (iv) non-recurrence of pandemic-induced expenses.

Meanwhile, there was an increase in material costs due to rising prices of raw materials including leather and outsoles, as well as the usage of more leather material for higher-value items and increased R&D in support of new business development.

### 毛利

本集團毛利按年增加至約90,000,000港元(二零二二年：約25,000,000港元)。集團持續推行以業務為主導的成本優化措施，勞工、行政和運輸成本均處於可控範圍。同時，集團積極管理客戶組合，專注開發較高利潤產品，毛利率因而擴大至約8.4% (二零二二年：約3.0%)，主要歸因於：

- (i) 本年度內因訂單增加而帶動營業額提升，從而取得規模經濟效益；
- (ii) 平均售價及付運量同錄增幅，帶動毛利率相對改善；
- (iii) 成本緩減措施加上製造業務運作穩定，令成本收入比下降，包括：
  - (a) 越南南部生產中心略微縮減勞工，直接工資省減1.1%至約185,000,000港元(二零二二年：約187,000,000港元)，直接勞工工資佔營業額比例下降至17.5% (二零二二年：22.2%)；
  - (b) 運輸成本；及
- (iv) 並無重現疫情引致的開支。

同時，由於包括皮革和大底在內的原材料價格上漲，加上耗用更多皮革材料以製造更高價值產品，以及配合新業務拓展的研發工作增加，導致材料成本上漲。

### Net Profit/Loss

The Group's return to net profit was mainly attributable to the improved performance of the manufacturing business in particular during the first half of the Year. For the full Year, the Group turned around to achieve a net profit attributable to equity holders of the Company of approximately HK\$53 million (2022: net loss of approximately HK\$18 million), taking into account:

- (i) the share of profit of associates of approximately HK\$32.5 million (2022: approximately HK\$32.8 million) contributed by the Group's associated company operating in central Vietnam;

which was partially offset by:

- (i) the fair value loss of approximately HK\$13.0 million for the Year (2022: loss of HK\$20.1 million) on revaluation of the Group's investment properties in Hong Kong and mainland China.

Basic earnings per share attributable to equity holders of the Company for the Year were approximately HK7.92 cents (2022: loss of approximately HK2.69 cents).

### Key Financial Ratios

The Group maintained healthy financial ratios during the Year:

- Debtors' turnover decreased to 60 days (2022: 88 days) for the Year;
- Creditors' turnover decreased to 86 days (2022: 100 days);
- Stock turnover was 109 days (2022: 141 days);
- A healthy liquidity position with net cash in hand of approximately HK\$393 million as at 31 March 2023 (2022: approximately HK\$290 million);

### 純利／淨虧損

本集團回復淨溢利，主要由於製造業務表現改善，於本年度上半年所錄得的業績增長尤為顯著。全年計，集團轉虧為盈，錄得本公司權益持有人應佔純利約53,000,000港元（二零二二年：淨虧損約18,000,000港元），其中計入：

- (i) 本集團於越南中部營運的聯營公司產生應佔聯營公司溢利約32,500,000港元（二零二二年：約32,800,000港元）；

及部分被以下抵銷：

- (i) 本集團於香港和內地的投資物業於本年度內經重估所產生的公平值虧損約13,000,000港元（二零二二年：虧損約20,100,000港元）。

本年度本公司權益持有人應佔每股盈利約7.92港仙（二零二二年：每股虧損約2.69港仙）。

### 主要財務比率

本集團於本年度內繼續維持健康的財務比率：

- 於本年度內，應收賬款週轉天數減少至60天（二零二二年：88天）；
- 應付賬款週轉天數減少至86天（二零二二年：100天）；
- 存貨週轉天數為109天（二零二二年：141天）；
- 於二零二三年三月三十一日，流動資金維持強健，手頭淨現金為約393,000,000港元（二零二二年：約290,000,000港元）；

- Zero gearing ratio (total bank borrowings to total equity) (2022: 1.2%); and
- Current and quick ratios were 2.8 and 2.2 respectively (2022: 2.5 and 1.8 respectively).
- 零負債比率(銀行借貸總額比權益總額)(二零二二年: 1.2%); 及
- 流動及速動比率分別為2.8及2.2(二零二二年: 分別為2.5及1.8)。

### Final and Special Final Dividends

With dedicated efforts to prudently manage working capital, the Company was able to maintain a stable financial position. In view of this and to share results with shareholders, the Board has resolved to declare a final dividend of HK2.0 cents (2022: Nil) per ordinary share and a special final dividend of HK0.2 cent (2022: HK2.0 cents) per ordinary share. Together with the interim dividend of HK1.8 cents per ordinary share and special interim dividend of HK0.5 cent per ordinary share, this brings the total dividends for the Year to HK4.5 cents (2022: HK4.0 cents) per ordinary share.

The Board reviews its dividend policy from time to time, with consideration given to the Group's capital expenditure plans, the operating environment, order book visibility and overall business prospects.

## OPERATIONAL REVIEW

### Macro Environment

For the footwear industry, major export markets saw a positive start last year as COVID-19 restrictions began to relax. The Group's shipment increase during the first six months of the Year reflected the broad-based demand growth in most consumer markets over this period.

Entering the second half of the Year, the industry saw supplies resuming progressively on the upstream side but weakened sales on the downstream side, resulting in higher inventory levels across major retail markets. Manufacturers were faced with consequential procurement adjustments as brand owners sought to navigate the inventory challenges.

### 末期及特別末期股息

本集團審慎管理營運資金，以維持穩定的財務狀況。有鑑於此並冀與股東分享業績成果，董事會已議決派發末期股息每股普通股2.0港仙(二零二二年: 無)，並派發特別末期股息每股普通股0.2港仙(二零二二年: 2.0港仙)。連同中期股息每股普通股1.8港仙，及特別中期股息每股普通股0.5港仙，本年度將共派發股息每股普通股4.5港仙(二零二二年: 4.0港仙)。

董事會會按本集團的資本性支出計劃、經營環境、訂單可視度和整體業務前景，不時檢視派息政策。

### 營運回顧

#### 宏觀環境

對於鞋履業而言，主要出口市場去年隨著COVID-19限制逐步放寬，實現良好開局。集團本年度首六個月所錄得的出貨量增長，反映了大部分消費市場在此期間的廣泛需求增長。

進入下半年，行業上游供應逐步恢復，但下游銷售則呈現疲軟態勢，導致主要零售市場庫存水位升高。品牌需要應對庫存挑戰，而製造商則面臨相應的採購調整。

In addition, the pandemic-induced disruptions to manufacturing have brought to light unforeseen vulnerabilities in operations and logistics, while magnifying some pre-existing supply-chain challenges, including shortage of skilled labor, rising production costs and shortened order lead time coupled with reduced batch sizes. On the macroeconomic level, the disruption and trade tensions have stimulated an advocacy for reshoring, which has also called for manufacturers to reassess their supply chain arrangements.

### Manufacturing Business

Maintaining geographic diversity, the Group operates two core manufacturing sites in southern Vietnam and Cambodia, both equipped with R&D facilities. A small-scale R&D center is in operation in Zhuhai, mainland China. In addition, the Group holds a 40% interest in a joint-venture factory in central Vietnam.

As at the Year-end date, the Group had a combined production scale of 26 processing lines, mostly under the concept-line setup. They contributed an annual capacity of around 8 million pairs of shoes, and were 73.5% utilized (2022: 78.0%).

In southern Vietnam, there were 12 concept lines and 4 traditional lines in operation. Coupled with the 10 concept lines the Group had in Cambodia, this robust and multi-location production platform enables the Group to provide capacity with flexibility to meet clients' sourcing plans in terms of country of manufacture.

The geographical distribution of markets continued to be demand-led, while at the same time, the Group supports clients' initiatives to develop markets with promising prospects. Revenue from the United States remained robust, generating 37.3% (2022: 44.4%) of the Group's revenue. Europe's proportionate contribution stood at 22.5% (2022: 24.3%), and shipments to other markets, including Asia and other areas, accounted for 40.2% (2022: 31.3%).

此外，疫情引致的製造鏈干擾，暴露了營運和物流過程中無法預料的弱點，同時加劇了一些先前存在的供應鏈挑戰，包括熟練勞動力短缺、生產成本上漲、訂單交貨期縮短，以及批次量縮減。在宏觀經濟層面，貿易干擾和緊張局勢激發了將製造回流本土的呼聲，促使製造商重新評估其供應鏈安排。

### 製造業務

本集團於越南南部及柬埔寨經營兩個核心生產基地，以保持多元地域生產，兩地均配備研發設施；另於中國珠海營運一所小規模研發中心。此外，本集團持有位於越南中部一間合營工廠的40%權益。

於本年度結束日，本集團的合併生產規模共26條生產線，大部分為小流水概念生產線，合共年產能約8百萬雙鞋履，使用率為73.5%（二零二二年：78.0%）。

本集團於越南南部營運12條小流水生產線及4條傳統生產線。此外，集團在柬埔寨設有10條小流水生產線。憑藉堅實的多地域生產平台，集團能靈活地提供產能，以迎合客戶採購計劃的產地要求。

市場地區分佈繼續由需求主導，同時集團亦支援客戶開拓前景優秀的市場。美國市場銷售維持強健，對本集團營業額貢獻達37.3%（二零二二年：44.4%）。而歐洲市場的貢獻佔22.5%（二零二二年：24.3%），輸往其他市場（包括亞洲及其他地區）則為40.2%（二零二二年：31.3%）。

The rugged-shoe category delivered an impressive performance during the Year, with shipment volume exceeding pre-pandemic levels, contributing 73.7% (2022: 71.3%) of total revenue. Despite the strong sales expansion of rugged shoes, the proportionate contribution of premium casual footwear increased to 15.4% (2022: 8.6%). Revenue generated by babies' and children's footwear decreased proportionately to 10.9% (2022: 20.1%).

In line with its strategy to pursue value growth, the Group has been more selective in terms of clientele portfolio management and new business development. Major customers for the Year included Cat, Chaco, Dr. Martens, Merrell and Wolverine; which in aggregate contributed 95.3% (2022: 89.6%) of total revenue. The Group has continued to actively develop business with brands, including some emerging niche labels that offer growth prospects.

Key developments in the Group's production centers are summarized below:

### **Southern Vietnam**

The southern Vietnam manufacturing site holds a portfolio of facilities in operation, premises ready for equipment installation, and land for future expansion, which will enable the Group to fulfill existing demand and ready it to capture future growth opportunities.

This location remained a core manufacturing site for the Group. It achieved a speedy recovery after the three-month COVID-19-induced halt in 2021, and production has remained uninterrupted throughout the Year. On the back of a robust order pipeline during the Year, this location returned to high utilization with its contribution to total volume output rebounding to 58.8% (2022: 55.0%).

### **Cambodia**

With the support of local government authorities, the Group has expanded its foothold in this major footwear manufacturing country for the world.

於本年度內，豪邁型鞋類銷售表現突出，付運量更超出疫情前水平，佔總營業額73.7%（二零二二年：71.3%）。儘管豪邁型鞋類銷售強勁，優質便服鞋的貢獻佔比仍有所上升，佔15.4%（二零二二年：8.6%）。嬰幼兒鞋履方面，其貢獻佔比則降至10.9%（二零二二年：20.1%）。

配合追求價值增長的策略，本集團在客戶組合管理和新業務開發上進行更嚴格的篩選。本年度之主要客戶包括Cat、Chaco、Dr. Martens、Merrell及Wolverine；彼等合共佔總營業額的95.3%（二零二二年：89.6%）。本集團繼續與其他具有增長前景的新興小眾品牌積極開發業務。

本集團生產中心的主要發展概述如下：

### **越南南部**

越南南部產地擁有營運中的廠房、可供裝置機器後使用的廠房物業，以及供未來擴展之用的土地。此設施組合有助集團滿足現有需求，並作好準備捕捉未來的增長機會。

此產地仍為本集團的主要生產中心。於二零二一年因COVID-19而暫停生產三個月後，已迅速恢復並於本年度內維持無間斷生產。本年度內，受惠於穩健的訂單管道，其設施使用率回復高水平，對總產量的貢獻反彈至58.8%（二零二二年：55.0%）。

### **柬埔寨**

在當地政府部門支持下，本集團逐漸於此世界主要鞋履生產國擴大據點。

During the Year, the Cambodia site contributed 41.2% (2022: 45.0%) of total output in pairs. Benefiting from this location's further maturity in capacity and efficiency, both volume and value growth were achieved. Supported by clients' order plans, production lines in Cambodia is well on schedule to develop into a more important contributor for the Group.

### Mainland China

A R&D center was maintained in Zhuhai, mainland China, staffed by a lean workforce to cater to the development requirements of some clients. The Group will continue to monitor this center's utilization and proactively consider adjustments to its R&D offerings as deemed appropriate.

With the exception of the R&D center, the Zhuhai plant was leased out and continued to generate a stable stream of recurrent rental income for the Group. The Board will keep a close watch on the local business environment, and will work with the tenant to respond to property market trends.

### Investments in associates

The Group holds a 40% interest in an associated company jointly owned with Evervan Group ("**Evervan**") in central Vietnam. Evervan is a leading athletic footwear manufacturer for international markets.

Investments made over the past few years have given this site a solid capacity to meet more sophisticated production requirements. As at the Year-end date, the associated company operated a total of 29 production lines, which were designated for world-leading footwear brands Crocs and Columbia.

The associated company recorded a revenue of approximately HK\$957 million (2022: approximately HK\$895 million) during the Year, a growth of 6.9% year on year. It contributed to the Group a share of profit of associates of approximately HK\$32.5 million (2022: approximately HK\$32.8 million).

於本年度內以鞋履雙數計，柬埔寨廠房貢獻產出 41.2% (二零二二年：45.0%)。此產地受惠於廠房產能和效率日益成熟，實現量價齊升。在客戶訂單計劃支持下，柬埔寨中心的生產線正按計劃發展成為集團更重要的貢獻成員。

### 中國內地

為配合部分客戶的發展所需，集團在珠海保留了一所研發中心，配以精簡人手繼續運作。本集團將繼續檢視其使用率，如合適會積極考慮調整其研發服務。

除研發中心外，珠海廠房已租出，為集團持續產生穩定的經常性租金收入。董事會將密切注視當地的營商環境，並與租戶一起應對物業市場趨勢。

### 於聯營公司的投資

本集團與榮誠集團（「榮誠」）於越南中部聯合擁有一聯營公司，持有其40%權益。榮誠為領先的國際運動鞋履製造商。

經過數年的投資，此基地已具備更強實力，能滿足更複雜的生產要求。聯營公司於本年度結束日共營運29條生產線，主要為全球領先鞋履品牌Crocs及Columbia從事生產。

聯營公司於本年度錄得營業額約957,000,000港元（二零二二年：約895,000,000港元），按年增長6.9%；向本集團貢獻應佔聯營公司溢利約32,500,000港元（二零二二年：約32,800,000港元）。

As uncertainty in the macroeconomic environment persists, the associated company will take a more cautious stance towards capacity management and business development in the coming financial year. Nevertheless, given the strong background and expertise of Evervan, the Board is confident of the long-term prospects of this joint-venture operation.

### Investment Properties

Depending on the Group's business needs and capacity planning, certain self-owned factories and office properties may not be fully utilized at times. The Board regularly considers these properties' sales or leasing options and potential in order to create returns on these assets. This will help the Group make good use of idle properties, realize the investment value of its assets, and generate additional stable income to enhance working capital.

During the Year, the portfolio of assets classified as investment properties was all leased out, yielding gross rental income of approximately HK\$28.2 million (2022: approximately HK\$24.8 million).

The Board considers that the portfolio is currently generating a steady stream of recurrent income. Considering the current property market conditions in mainland China, the Group has responded to local authorities' recommendations by offering more flexible rental payment arrangements for tenants during the challenging times of the pandemic. The Group understands that this is a temporary measure and will continue to monitor the market situation closely.

The Board is satisfied with the overall rental performance of its investment asset portfolio. It will regularly review this asset base and examine options available with a view to creating greater long-term value for shareholders.

由於環球經濟存在不確定性，聯營公司在下一財政年度將對產能管理和業務發展採取更謹慎的態度。儘管如此，有見於榮誠的堅實背景和專業技術，董事會對合營業務的長遠前景充滿信心。

### 投資物業

基於本集團業務需要和產能規劃，自置工廠和辦公室物業不時或未被充分利用。董事會定期評估物業的租售選項及潛力，務求善用資產以創造回報。這有助本集團活用閒置物業，將資產的投資價值變現，並產生額外穩定收入以鞏固營運資金。

於本年度，被歸類為投資物業的資產組合悉數租出，總租金收入約28,200,000港元（二零二二年：約24,800,000港元）。

董事會認為此投資組合目前正產生穩定的經常性收入。考慮到中國內地目前的房地產市場狀況，本集團響應當地政府的建議，在疫情期間為租戶提供更靈活的租金支付安排。本集團明白此為臨時措施，並將繼續密切監察市場情況。

董事會對投資資產組合的整體租金表現感到滿意，並會定期檢視資產基礎和審視可行選項，為股東創造更大的長期價值。

#### Liquidity and Financial Resources

The Group generally finances its operation by internally generated cashflow and banking facilities provided by its bankers.

Prudent financial management and selective investment criteria have enabled the Group to maintain a strong financial position. As at 31 March 2023, the Group's cash and cash equivalents were approximately HK\$393 million (2022: approximately HK\$304 million) and total bank borrowings of Nil (2022: HK\$15 million). The Group's gearing ratio (total bank borrowings to total equity) was Nil (2022: 1.2%). As at 31 March 2023, the Group had net cash and cash equivalents of approximately HK\$393 million (2022: approximately HK\$290 million).

As at 31 March 2023, the Group had available banking facilities amounted to approximately HK\$40 million (2022: approximately HK\$55 million) of which Nil (2022: HK\$15 million) was utilized.

For the year ended 31 March 2023, the current ratio was approximately 2.8 (2022: approximately 2.5) based on current assets of approximately HK\$771 million and current liabilities of approximately HK\$272 million and the quick ratio was approximately 2.2 (2022: approximately 1.8).

The Group will continue to maintain conservative cash flow management to sustain a strong cash position. Having considered the major expansion plans of the Group, including Vietnam and Cambodia in the next two to three years, the Directors are of the opinion that the Group has adequate liquidity to meet its current and future working capital requirements on its operations and expansion.

### 財務回顧

#### 流動資金及財務資源

本集團一般以內部產生之現金流量及其往來銀行提供之銀行信貸為其業務提供資金。

審慎的財務管理及選擇性投資標準，令本集團之財務狀況維持穩健。於二零二三年三月三十一日，本集團之現金及等同現金項目約為393,000,000港元（二零二二年：約304,000,000港元），而銀行借貸總額為零（二零二二年：15,000,000港元）。本集團的槓桿比率（銀行借貸總額比權益總額）為零（二零二二年：1.2%）。於二零二三年三月三十一日，本集團的現金及等同現金項目淨額約為393,000,000港元（二零二二年：約290,000,000港元）。

於二零二三年三月三十一日，本集團獲得銀行信貸約為40,000,000港元（二零二二年：約55,000,000港元），其中零（二零二二年：15,000,000港元）已動用。

截至二零二三年三月三十一日止年度，流動比率約為2.8（二零二二年：約2.5），此乃按流動資產約771,000,000港元及流動負債約272,000,000港元之基準計算，而速動比率約為2.2（二零二二年：約1.8）。

本集團將繼續維持保守之現金流量管理，以鞏固穩健的現金狀況。經考慮本集團於未來兩至三年包括在越南及柬埔寨進行之主要擴充計劃，董事認為本集團具備充足之流動資金以應付其目前及日後營運及拓展之營運資金需求。

### Foreign Exchange Risk Management

Most of the Group's assets and liabilities, revenue and expenditure are denominated in Hong Kong dollars, the Renminbi, the Vietnamese Dong and the US dollars. It is the Group's policy to adopt a conservative approach on foreign exchange exposure management.

However, the Group will continue to monitor its foreign exchange exposure and market conditions to determine if any hedging is required. The Group generally finances its operation with internal resources and bank facilities provided by banks in Hong Kong. Interest rates of borrowings are fixed by reference to the Hong Kong Inter-Bank Offered Rate or the Secured Overnight Financing Rate.

The Group's treasury policies are designed to mitigate the impact of fluctuations in foreign currency exchange rates arising from the Group's global operations and to minimise the Group's financial risks. As a measure of additional prudence, the Group cautiously uses derivatives financial instruments, principally forward currency contracts as appropriate for risk management purposes only, for hedging transactions and for managing the Group's receivables and payables.

The exposure to foreign currency of the Group mainly arose from the net cash flows and the net working capital translation of its PRC and Vietnam subsidiaries. The management of the Group will actively hedge the foreign currency exposures through natural hedges, forward contracts and options, if consider necessary. The management of currency risk is centralised in the headquarter of the Group in Hong Kong.

### Capital Structure

The Group is substantially debt free. Shareholders' equity decreased to approximately HK\$1,205 million as at 31 March 2023 (2022: approximately HK\$1,211 million).

### 外匯風險管理

本集團大部分之資產與負債及收益與開支以港元、人民幣、越南盾及美元計值。採用保守方法管理外匯風險乃本集團之政策。

然而，本集團將繼續監控其外匯風險及市場狀況，以確定是否需要採取對沖措施。本集團一般以內部資源及香港銀行所提供之銀行融資作為營運所需資金。借貸利率按香港銀行同業拆息率或擔保隔夜融資利率釐定。

本集團之財務政策旨在減輕本集團環球業務所帶來之外幣匯率波動之影響，以及將本集團之財務風險降至最低。本集團採用一項更為審慎之措施，審慎運用衍生金融工具（主要為遠期貨幣合約（如適用）僅作風險管理之用）以作對沖交易及管理本集團應收賬項及應付賬項之用。

本集團面臨之外匯風險主要來自其中國及越南附屬公司之現金流量淨額及營運資金淨額之換算。本集團管理層將積極透過自然對沖、遠期合約及期權方式（倘必要）對沖外匯風險。貨幣風險集中由本集團之香港總部管理。

### 股本架構

本集團基本上並無債項。股東權益下跌至二零二三年三月三十一日約1,205,000,000港元（二零二二年：約1,211,000,000港元）。

### Purchase, Redemption or Sale of Listed Securities

During the Year, the Company repurchased 1,446,000 of its ordinary shares of HK\$0.10 each on the Stock Exchange at an aggregate consideration of approximately HK\$1,554,000 excluding transaction cost and cancelled the repurchased shares subsequent to the year end date. The repurchase of the Company's shares during the Year was effected by the Board, pursuant to the repurchase mandate granted by the shareholders, with a view to benefit shareholders as a whole by enhancing the net asset value per share and earnings per share of the Company.

### EMPLOYMENT AND REMUNERATION POLICIES

The Group, including its subsidiaries in Hong Kong, Taiwan, the PRC, Vietnam and Cambodia, employed approximately 6,700 employees as at 31 March 2023. The Group's remuneration policies are primarily based on prevailing market salary levels and the performance of the respective companies and individuals concerned. Share options and awarded shares may also be granted in accordance to the terms of the Group's approved share option scheme and share award scheme, respectively.

During the Year, the trustee of the Company's share award scheme adopted on 26 June 2019 (the "**Share Award Scheme**") did not purchase any shares on the market. 5,890,000 shares have been awarded under the Share Award Scheme during the Year.

During the Year, the Company granted 3,000,000 share options to certain Directors and employees of the Group in accordance with the Company's share option scheme adopted on 26 August 2022 (the "**Share Option Scheme**").

Details of the Share Award Scheme and the Share Option Scheme will be included in the annual report of the Company for the year ended 31 March 2023.

### ABOUT THE ESG REPORT

Kingmaker Footwear Holdings Limited (the “**Company**”) together with its subsidiaries (the “**Group**”) is delighted to present its Environmental, Social and Governance (“**ESG**”) Report (the “**ESG Report**”). This ESG Report herein focuses on providing an overview of the environmental and social aspects of the Group for the financial year from 1 April 2022 to 31 March 2023 (the “**Reporting Period**”), and outlines how we seek to continually improve our operational strategy in regard to our environment and society in order to cope with the global standards of sustainability.

In the course of preparing the ESG Report, the Group conducted a thorough review and assessment towards its existing environmental and social policies with aims to achieve better performance in aspects of the environment, social, corporate governance and operation in the future and make more contributions to the communities where it operates.

### ESG Report Scope and Boundary

The Group is a large-scale shoe-manufacturing company, designated as an original shoe manufacturer for internationally renowned brands as our core business. The scope of the ESG Report covers the environmental and social performance of manufacturing factories located in Vietnam and Cambodia. There is no change in the reporting scope or boundary covered in this ESG report from the previous year.

The ESG Report is prepared in accordance with the ESG Reporting Guide (the “**Guide**”) as set out in Appendix 27 to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (“**HKEX**”) (the “**Listing Rules**”) and complies with all provisions of “comply or explain” and “mandatory disclosure”. In response to the latest revisions effective for the financial year commencing on or after 1 July 2020, our reporting framework was enhanced to address all newly introduced reporting requirements.

The Group recognises that a robust ESG governance structure is the crux of fostering a sustainable business operation. The Board has oversight of ESG strategies, management approaches and evaluates all ESG issues in the annual risk assessment. They are also responsible for formulating long-term sustainability direction along our business chain, as well as reviewing the progress and achievement against ESG objectives and targets, and thus providing strategic guidance on ESG-related issues. The responsibility of detailed considerations and implementation of ESG strategies has been delegated to the ESG Working Group (the “**ESG Working Group**”). The annual ESG report submitted by the ESG Working Group would be approved by the Board to evaluate the effectiveness of ESG management in building up our resilience in respect of ESG-related risks.

The ESG Working Group comprises Executive Directors and senior management staffs who have sound knowledge of current and emerging ESG matters, as well as the Group’s operations. The responsibility of the ESG Working Group is to assist in 1) identifying, reviewing and analysing the significant ESG risks and opportunities in operational strategy and risk management with associated impacts on the Group, 2) establishing ESG goals and objectives with actions plans in line with the determined ESG strategies, 3) monitoring the current market trends and development, industry practices, and norms in respect of ESG related issues, and 4) performing stakeholder engagement and materiality assessment. The ESG Working Group carries out performance reviews and reports the progress and achievements of the Group’s ESG objectives to the Board on a regular basis.

The responsible units are responsible for implementing the ESG-related action plans determined by the ESG Working Group in daily operations, supporting stakeholder engagement activities and coordinating the data collection for the preparation of the ESG Report and monitoring performance progress and achievements against the determined objectives and initiatives.

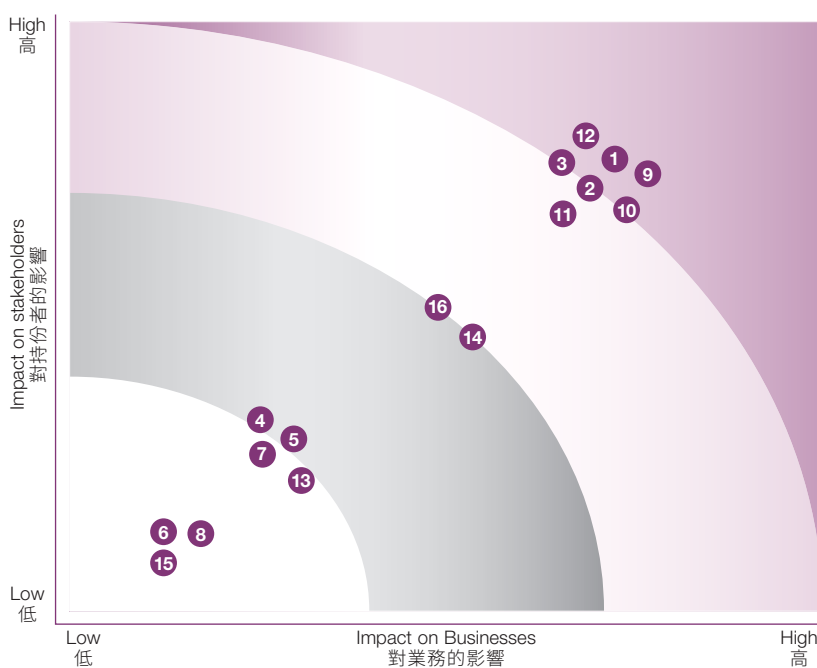

### Employment

The Group strictly complies with the requirements of the Labor Law Code in Vietnam and Cambodia, as well as other relevant laws and regulations related to employment protection and benefits, including but not limited to the Social Insurance Law in Vietnam, the Medical Insurance Law in Vietnam, the Syndical Law in Vietnam, the Law on Social Security Schemes in Cambodia, the Trade Union Law in Cambodia, and the Law on the Protection and Promotion of the Rights of Persons with Disabilities in Cambodia.

The Group has established personnel policies and procedures that set out its standard internal procedures relating to recruitment and promotion, working hours, holidays, equal opportunities, compensation and dismissal, employee diversity, anti-discrimination and other human resources treatments and benefits, etc., to provide standardized and comprehensive guidelines on work practices for employees. For anti-discrimination, the Group has established a procedural policy prohibiting discrimination, harassment and retaliation, along with a complaint and resolution process. Moreover, the Group has set specific policies and practices that protect female rights, and reinforce feminist social and political rights through training courses.

In Vietnam and Cambodia factories, approximately 6,300 employees (2022: approximately 7,000 employees) were employed during the Reporting Period. The Group welcomes industrial experts to join our team, add value to our pool of professional expertise in the industry, and bring in innovative ideas. In terms of gender diversity, the majority of the Group's employees in Vietnam and Cambodia are female. The Group highly appreciates the women workforce to support our daily operation and strives to empower women in the local communities in which we operate.

### 僱傭

本集團嚴格遵守越南及柬埔寨勞動法的規定，以及其他與就業保護及福利相關的法律及法規，包括但不限於越南社會保險法、越南醫療保險法、越南工團法、柬埔寨社會保障計劃法、柬埔寨工會法、柬埔寨維護及提高殘障人士權利法。

本集團已制定人事政策及程序，當中載列其有關招聘及晉升、工作時間、假期、平等機會、補償及解僱、僱員多元化、反歧視及其他人力資源待遇及福利的標準內部程序等，為員工的工作實踐提供標準化及全面的指引。就反歧視而言，本集團已制定禁止歧視、騷擾及報復的程序政策，並設有投訴及解決程序。此外，本集團已設置專項政策及慣例保護女性權利，並通過培訓課程，加強女性社會及政治權利。

於報告期間，在越南及柬埔寨的工廠，我們有約6,300名（二零二二年：約7,000名）僱員。本集團歡迎行業專才加入我們的團隊，為我們行業的專業知識庫增值，激發創新理念。於性別多元化方面，本集團在越南及柬埔寨的大部分僱員為女性。本集團十分感謝女性員工對我們的日常營運的支持，並努力在我們當地營運社區賦權女性。

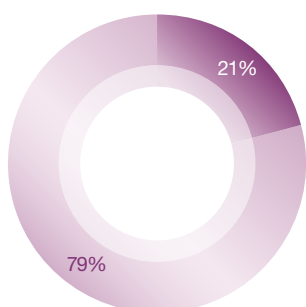

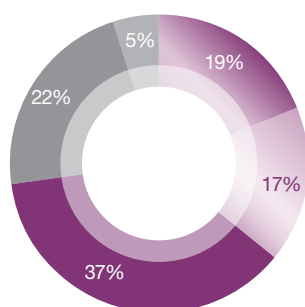

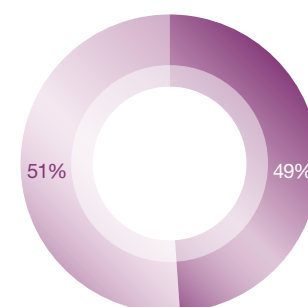

### Attract and retain talents

The remuneration policies of the Group are in line with prevailing market practices and are determined on the basis of competency, qualifications and experience of the individual employees. Management of the Group constantly reviews its employees' remuneration packages and promotion opportunities. Adjustments are made, usually annually, to conform to the market standard in order to retain talents and ensure the offer is competitive as compared to the rivals in the industry. A standard remuneration package includes basic salary and variable incentive-based remunerations which are distributed according to individual employee performance. Share options and awarded shares may also be granted in accordance with the terms of the Group's approved share option scheme and share award scheme.

### 吸引及挽留人才

Moreover, a labor union has been established to protect the interests of our employees. To better understand the concerns of workers, meetings between management and the labor union are held on a quarterly basis. It acts as a channel of regular and constructive communication between the Group and its employees to have an open discussion about employee welfare and employment conditions.

### Anti-discrimination and equal opportunities

The Group is committed to building a diverse and inclusive working environment. The Group ensures that no interviewee or employee will be discriminated against or deprived of opportunities due to gender, ethnic background, religious belief, color, sexual orientation, age, marital status or family status in respect of recruitment and promotion. Any kind of discrimination or harassment based on the employees' gender, age, marital status, race, sexual orientation and religion at our workplace is strictly prohibited.

The Group always listens and responds to the requests from our employees. It is the goal of the Group to create a friendly and peaceful working environment. We encourage our employees to provide feedback in relation to any employment-related matters, especially when they encounter any unpleasant or undesired treatment from colleagues or senior management. Employees may lodge their complaints in writing and place them in the suggestion box at the office building. The Human Resources Department is responsible for handling all cases and conducting investigations. If any unfair treatment and harassment are found and confirmed, the Group will issue a warning in writing to the employee who has done the wrongdoing and may dismiss him or her depending on the seriousness of the incident.

此外，我們已建立工會保障僱員的利益。為更好地了解員工的擔憂，管理層與工會將每個季度舉行會議。其作為本集團與其僱員之間定期及建設性溝通的渠道，就僱員福利及僱傭條件進行公開討論。

### 反歧視及平等機會

本集團致力營造多元化及具包容性的工作環境。本集團確保在招聘及晉升時不會有應聘者或僱員因性別、種族背景、宗教信仰、膚色、性取向、年齡、婚姻狀況或家庭情況而受歧視或被剝奪機會。工作場所嚴禁任何基於僱員性別、年齡、婚姻狀況、種族、性取向及宗教的歧視或騷擾。

本集團致力傾聽並回應僱員的要求。本集團的目標是營造友善和平的工作環境。我們鼓勵僱員就任何與僱傭相關的事宜提供反饋，特別是當他們遇到來自同事或高級管理層的任何不愉快或非期望的對待時。僱員可以書面形式提出投訴，並將其投入辦公樓的意見箱中。人力資源部負責處理所有事件並進行調查。倘發現並確認任何不公平的對待及騷擾，本集團將以書面形式向作出錯誤行為的僱員發出警告，並可視事件的嚴重性而將其解僱。

### Welfare and benefits

To increase the employees' sense of belonging, the Group offers various welfare and benefits to our employees. For instance, employees are entitled to an extra number of days of paid leave according to their job level, in addition to all public holidays and the minimum number of days of paid leave in accordance with the Labor Laws in Vietnam and Cambodia.

Moreover, the Group conducts a series of team-building activities every year to promote our Group's corporate culture among employees. However, due to the Coronavirus disease 2019 ("COVID-19"), large-scale company activities were not organized.

As most of our employees are female, the Group does its best to ensure its female staff are feeling comfortable and happy while working with us. The Group offers a wide range of activities including training related to reproductive health care, health care of women, health and welfare of pregnant women and many more health-related topics to its employees. However, due to COVID-19, large-scale training activities were not organized.

In addition, 6 months of paid maternity leave are offered to all pregnant employees of our Vietnam factory to ensure that their job positions are available when they return from their maternity leave. As stipulated in our staff handbook, the Group offers full support and care to its pregnant staff. At the Vietnam office and factory, labels are provided to pregnant workers in order to remind other staff to provide special assistance when needed. Last but not least, employees who have children aged between 1 and 6 years old are entitled to subsidies if they are living in Binh Duong Province in Vietnam.

### 福利及利益

為增加僱員的歸屬感，本集團為僱員提供各種福利及利益。例如，除所有公眾假期及根據越南及柬埔寨勞動法規定的帶薪假期的最少天數外，僱員有權根據其工作水平獲得額外的帶薪假期天數。

此外，本集團每年亦會舉辦一系列團建活動，向僱員推廣本集團的企業文化。然而，由於2019冠狀病毒病（「COVID-19」），未能組織大型公司活動。

由於我們大部分員工均為女性，本集團盡最大努力確保女性員工在與我們共事時感到舒適及快樂。本集團為其僱員提供廣泛的活動，包括有關生育保健、婦女保健、孕婦健康及福利相關的培訓以及更多與健康相關的課題。然而，由於COVID-19，未能組織大型培訓活動。

此外，我們為在越南工廠的所有懷孕的僱員提供6個月的帶薪產假，並確保彼等從產假回來時可以回歸工作崗位。正如我們的員工手冊所規定，本集團向其懷孕的僱員提供全力支持及關愛。在越南辦公室及工廠，我們會為懷孕工人提供標籤，以提醒其他員工在需要時提供特別幫助。最後同樣重要的是，擁有1至6歲子女的僱員如在越南平陽省生活，則有權獲得補貼。

### Health and Safety

Employee's health and safety is of utmost importance to the Group. During the Reporting Period, the Group has complied with all relevant laws and regulations in relation to safety, as well as hygiene and health. The laws and regulations include but are not limited to the Labor Safety and Health Law in Vietnam, the Medical Insurance Law in Vietnam. The Group aims to provide a safe and healthy working environment to our employees, and encourage them to achieve a balance between work and a healthy lifestyle. To prevent our employees working in manufacturing factories from occupational hazards, the Group has established "Occupational Safety and Health Policy", "Chemical Safety Policy", "Personal Protective Equipment Policy", "Accident Investigation Procedure", "Emergency Response Policy and Procedure", and "Risk Assessment Policy" that cover labor safety and health. The policies clearly detail all the appropriate practices and requirements related to employee health and safety so that the safety of our employees is protected. For instance, workers are required to wear earplugs during trimming and wear gloves during gluing. When using dusting machines, workers are required to wear masks.

The Group has also established a "Health and Safety Control Procedure" in line with ISO14001 and OHSAS 18001 international standards, with an aim to provide a safe and hazard-free working environment, prevent and mitigate the safety risks exposure of our employees. The Procedure clearly lists out the corresponding responsibilities of environmental and safety management representatives, department heads, management level etc., to allocate the tasks of promoting, monitoring and implementing relevant safety policy. In addition to establishing a robust environmental management structure, the Group also conducts a series of health and safety training for our employees in orientation or on a regular basis, so that it can be ensured all employees are aware of potential occupational accidents and risks in the manufacturing factories. The training topics include hazardous chemicals, first-aid and other Occupational Safety and Health-related topics. However, due to COVID-19, large-scale training activities were not organized.

### 健康與安全

僱員健康與安全對本集團而言至關重要。於報告期間，本集團已遵守有關安全、衛生及健康的所有相關法律法規。該等法律法規包括但不限於越南勞動安全衛生法及越南醫療保險法。本集團旨在為僱員提供安全及健康的工作環境，並鼓勵員工在工作與健康生活方式之間取得平衡。為防止在製造工廠工作的僱員遭受職業危害，本集團已設立涵蓋勞工安全及健康的「職業安全與健康政策」、「化學品安全政策」、「個人防護裝備政策」、「事故調查程序」、「應急響應政策和程序」及「風險評估政策」。該等政策明確詳述與僱員健康及安全相關的所有適當的慣例及要求，以保護僱員的安全。例如，工人須在修剪時佩戴耳塞以及在粘合時戴上手套。在使用除塵器時，工人需要佩戴口罩。

本集團亦已建立符合ISO14001及OHSAS 18001國際標準的「健康及安全控制程序」，旨在提供安全無危險的工作環境，預防及減輕僱員面臨的安全風險。程序明確列載環境安全管理代表、部門主管、管理層等的相應職責，以分配相關安全政策的推廣、監督及實施工作。除建立健全的環境管理架構外，本集團亦定向或定期對僱員進行一系列健康與安全培訓，以確保所有僱員了解於製造工廠的潛在職業事故及風險。培訓主題包括危險化學品、急救及其他職業安全與健康相關主題。然而，由於COVID-19，未能組織大型培訓活動。

Moreover, a safety audit is conducted for annual inspections to make sure that all our machines and fire alarms are functioning well. Any machinery defects and malfunctions would be immediately reported to the Maintenance Department for repair and maintenance. The safety audit is followed by working environment monitoring and safety risk assessment, in which existing dangerous sources of toxic gases, noise, high falling, explosives, etc. are identified. The goal is to evaluate the risk level of the working environment and implement appropriate measures to eliminate the identified risks correspondingly.

The Group's health and safety policies and procedures are summarized as follows:

The Group has carried out the following actions in order to create and maintain a good, comfortable, safe and healthy working environment for its employees:

- Establish a Health, Safety, Environment (“HSE”) team to conduct random checks on workers to ensure that they are wearing proper work gear;
- Keep all emergency exits in the workplace unobstructed;
- Provide sufficient light in the workplace;
- Ensure that all devices, machines and equipment are safe;
- Carry out regular repair and maintenance work on all devices and machines used in the workplace;
- Maintain a high standard of hygiene in the workspace;
- Prohibit smoking in the workplace; and
- Conduct regular safety inspections and fire drills.

During the Reporting Period and the past three reporting periods, the Group did not have any work-related fatalities. The statistics of work-related injuries and lost day results during the past three reporting periods, including this Reporting Period, are shown as follows:

During the Reporting Period, there were 51 work-related injuries, which the employees concerned have been compensated for and covered by the Group’s medical insurance. The number of working days lost due to work-related injury was 182 days. The Group continues to reflect on its existing safety policies and is committed to continuously adapting and improving its occupational safety measures as would be necessary.

本集團已採取以下行動，以為其僱員創造並維持良好、舒適、安全及健康的工作環境：

- 建立健康、安全及環境（「HSE」）團隊對工人進行隨機檢查，確保彼等穿戴合適的工作裝備；
- 保持工作場所內所有緊急出口暢通無阻；

- 確保所有設備、機器及裝置安全；
- 對工作場地的所有設備及機器進行定期維修及保養；
- 在工作場地維持高標準的衛生；
- 禁止於工作場所內吸煙；及
- 定期進行安全檢查及火警演習。

於報告期間及過去三個報告期間，本集團並無發生因工死亡事故。於包括本報告期間的過去三個報告期間的工傷及損失天數統計結果如下：

於報告期間，發生51宗工傷事故，而有關僱員已獲本集團醫療保險的補償及保障。因工傷損失工作日數182日。本集團繼續反思其現有的安全政策，並致力於在必要時不斷調整及改進其職業安全措施。

The Group has implemented various measures to ensure employees' health and safety. For each work-related injury, an incident investigation report was prepared and evaluated, a corrective action plan was also prepared with a target date to complete the rectification at the first opportunity. In response to the incidents, the Group held a special meeting and training workshop to enhance employees' awareness on personal protection and work safety. Moreover, the HSE team would undergo more frequent inspections on-site to alert the employees of occupational safety and underlying risks in the workplace.

In response to the COVID-19 pandemic, the Group has developed guidelines on the prevention of COVID-19 and work arrangements for offices and factories. The guidelines help to reduce the risk of mass infection in the workplace. The Group's preventative measures and hygienic guidelines in response to COVID-19 are shown as follows:

- Encouraging employees feeling unwell to take sick leave and caring for their wellbeing;
- Cleaning shared vehicles regularly;
- Maintaining a high standard of hygiene in the workspace; and
- Advising employees who have respiratory symptoms to leave and seek medical advice promptly.

The Group will continue to assess the impact of the COVID-19 pandemic on its financial performance, closely monitor the development of the COVID-19 pandemic and the exposure to the risks and uncertainties in this connection. The Group will take appropriate measures as necessary.

本集團已採取多項措施確保員工的健康及安全。針對每起工傷事故，已編製並評估事故調查報告，亦已編製糾正行動計劃，其中規定了在第一時間完成整改的目標日期。針對該等事件，本集團已舉辦專題會議及培訓班以提高僱員的個人防護及工作安全意識。此外，HSE團隊將更頻繁地進行現場檢查，以提醒僱員職業安全及於工作場所的潛在風險。

為應對COVID-19疫情，本集團已制定預防COVID-19的指引，並作出辦公室及工廠的工作安排。該等指引有助於降低工作場所大規模感染的風險。本集團針對COVID-19的預防措施及衛生指南如下所示：

- 鼓勵感覺不適的僱員請病假並關心彼等的健康；
- 每天清潔共用車輛；
- 在工作場地維持高標準的衛生；及
- 呈現呼吸道症狀的僱員會被勸離並立即就醫。

本集團將繼續評估COVID-19疫情對其財務業績的影響，並密切監測COVID-19疫情的發展以及與此相關的風險及不確定性。必要時本集團將採取適當的措施。

### Development and Training

The Group believes that the skills and experience of employees are critical to the long-term development of the Group. The Group offers opportunities that foster our employees' leadership skills and professional development, and in turn, promote job satisfaction, work motivation and staff loyalty. An annual training schedule is in place to ensure our employees are offered training during the Reporting Period in order to keep them updated with information, knowledge and skills required at work. All new joiners received induction training on their first day of employment.

The Group's professional training programs cover a wide range of specialties. The training categories include human rights safety and skills applicable to work, etc. Employees are also encouraged to attend external training courses and seminars that can help them gain practical knowledge in the fast-changing business world. Any fees incurred for the courses or seminars are sponsored by the Group. During the Reporting Period, the Group has conducted training for its employees in relation to occupational safety and health, disease prevention, legal compliance and first-aid.

Due to the COVID-19 pandemic, no training was conducted in Vietnam during the Reporting Period to comply with the government rules and protect the health and safety of our employees. The Group will schedule more training hours in late 2023 for our employees to ensure they gain adequate knowledge and skills required at work.

### 發展及培訓

本集團認為僱員的技能及經驗對本集團的長遠發展至關重要。本集團向僱員提供機遇，培養彼等的領導技能及專業發展，從而提高工作滿意度、工作動力及員工的忠誠度。我們制定了年度培訓計劃，以確保我們的僱員於報告期間獲得培訓，以更新工作所需的信息、知識及技能。所有新入職員工於受僱首日即接受入職培訓。

本集團的專業培訓計劃涵蓋多種專業。培訓類別包括人權安全和適用於工作的技能等。我們亦鼓勵僱員參加外部培訓課程及研討會，以幫助彼等在急速轉變的商業世界獲得實踐知識。課程或研討會所產生的任何費用均由本集團資助。於報告期間，本集團已為其僱員開展有關職業安全與健康、疾病預防、法律合規及急救的培訓。

由於COVID-19疫情，於報告期間並未在越南進行任何培訓以遵守政府規定並保護我們僱員的健康與安全。本集團於二零二三年年底為僱員安排更多的培訓時間，以確保彼等得到工作所需的足夠知識及技能。

### Labor Standards

The Group is committed to complying with the labor laws and regulations in Vietnam and Cambodia, as well as the relevant international human rights conventions relating to employees' protection and prevention of child or forced labor. Every employment of the Group is subject to a stringent internal review process that involves a well-established monitoring procedure for verifying a candidate's personal information, in order to avoid misrepresentation and any form of child labor. For instance, the staff member responsible for recruitment collects the identity proof from the candidates to ensure that the age of the candidates fulfils the requirements as stipulated by the law.

The employment of forced and child labor is strictly prohibited. In Cambodia and Vietnam, the Labor Law allows the younger generation aged 15 or above to work. As such, the Group has established a policy for young employees (15 to 18 years old) to provide additional guidance on the arrangement of welfare and work allocations. The Group strictly follows the relevant laws and regulations, and provides adequate protection for our employees. Employees' rest time is well respected by the Group, and any arrangement of overtime work must be agreed by the employees voluntarily in advance, in order to prevent forced overtime work.

If any employment of child or forced labor is discovered, the Group will immediately terminate the employment concerned. During the Reporting Period, all employees were legally and properly employed in accordance with the requirements of all applicable laws and regulations. No incident of illegal child labor or forced labor was recorded.

### 勞工準則

本集團致力於遵守越南及柬埔寨的勞動法律法規及有關僱員保護以及防止童工或強迫勞工的國際人權公約。本集團每次僱傭均須遵守嚴格的內部覆核過程，當中涉及目的為核實有關應聘者個人資料的明確監察程序，以避免失實陳述及任何形式的童工。例如，負責招聘的工作人員負責收集申請人身份證明以確保申請者年齡符合法律規定。

嚴格禁止強迫勞工及童工行為。在柬埔寨及越南，勞動法允許15歲或以上的更年輕一代參加工作。因此，本集團已制定一項針對15至18歲的年輕僱員的政策，以就福利及工作分派安排提供額外指導。本集團嚴格遵循相關法律法規，並為我們的僱員提供充分保障。本集團充分尊重僱員的休息時間。為防止強制加班，任何加班安排須事先經僱員自願同意。

倘發現僱傭童工或強迫勞工，本集團將立刻終止相關僱傭。於報告期間，所有僱員均合法及根據所有適用法律及法規的規定妥為僱用。並無記錄非法童工或強迫勞工事件。

### OPERATING PRACTICES

#### Supply Chain Management

The Group understands that supply chain management has an inseparable relationship with its sustainable development, and is therefore committed to establishing a long-term and harmonious cooperation relationship with its suppliers. The Group expects its suppliers to uphold the principles of integrity and pragmatism, and provide products and services in strict compliance with the requirements of applicable laws and regulations concerning both environmental and social aspects.

Although most of the suppliers are designated by our customers, the Group has an internal mechanism to assess and evaluate our suppliers in order to control the quality of our materials. The Group evaluates all potential suppliers' backgrounds, qualifications, expertise, experience, financial status, and professionalism, etc. Moreover, social and environmental aspects are also important criteria for supplier selection. To promote environmentally preferable products in the industry, the Group will not select suppliers with poor environmental performance or reputation. All approved suppliers are reviewed regularly to ensure the quality of the services and products purchased is up to standard.

During the Reporting Period, the Group had a total of 399 main suppliers. The number of suppliers by geographical region during the Reporting Period is shown as follows:

#### 供應鏈管理

### Product Responsibility

Providing safe, quality and reliable products to our customers is one of the core values of the Group, and it has a strong commitment to attain high quality standards in our manufacturing process. During the Reporting Period, the Group has strictly complied with the laws and regulations in regard to product responsibility in the PRC, Vietnam, Cambodia, Korea, Taiwan and Hong Kong that have a significant impact on our businesses, including but not limited to, Law of the PRC on the Protection of Consumer Rights and Interests, the Civil Code of the PRC, the Trade Description Ordinance in Hong Kong, the Sale of Goods Ordinance in Hong Kong, and Law on Protection of Consumer Rights in Vietnam. During the Reporting Period, the Group did not recall any sold or delivered products for safety or health reasons.

The Group's primary focus is to provide high quality services and products to our customers. In order to build customer trust and loyalty, the Group has established relevant policies which cover product and service quality. The Group has a product quality inspection team that monitors product quality. The Group's production processes, including manufacturing, packaging, labelling, etc., are subject to the product quality inspection team's monitoring and auditing. Products and materials must go through sampling tests to ensure the quality of products meets our customers' expectations. The Group also welcomes customer's own quality control teams to visit our factories to conduct quality inspections.

During the Reporting Period, the Group did not make any advertisements relating to products and services provided. If the Group makes any advertisements, we will adhere to all relevant laws and regulations to ensure that we do not convey false or misleading messages in relation to our products.

### 產品責任

為我們的客戶提供安全、優質、可靠產品是本集團核心價值之一，本集團堅定承諾於生產過程中達致高質量標準。於報告期間，本集團嚴格遵守中國、越南、柬埔寨、韓國、台灣及香港關於產品責任，且對我們的業務有重大影響的有關法律及法規，包括但不限於中華人民共和國消費者權益保護法、中華人民共和國民法典、香港商品說明條例、香港貨品售賣條例，以及越南消費者權益保護法。於報告期間，本集團並未因安全或健康原因召回任何已售或已交付的產品。

本集團主要注重向我們的客戶提供高質素的服務及產品。為建立客戶信任及忠誠度，本集團已制定涵蓋產品及服務質素的相關政策。本集團設立產品質檢團隊監控產品質量。本集團的生產過程（包括製造、包裝、貼標等）受產品質檢團隊的監控及審核。產品及材料須經抽樣檢測以確保產品質素符合我們客戶的預期。本集團亦歡迎客戶自身的質檢團隊造訪我們的工廠，以進行質檢。

### Complaints and Feedback Mechanism

The Group has established a “Customer Feedback and Complaint Policy and Procedure” to ensure that customers’ feedback and complaints are addressed efficiently. Customers may lodge a formal complaint to the Group through email, phone call or letter. When a complaint is received, the manager from the responsible department relevant to the complaint shall conduct an internal investigation, propose suitable solutions to the customers and finally initiate internal corrective actions that must be completed within a proposed timeframe. All customer complaints must be responded to within a reasonable time. For each complaint received, a Customer Complaint Form shall be filled in with the customer complaint details, the date of receiving the complaint, the solution and corrective action. The Group’s management office will monitor the status of the complaint handling process to ensure that all complaints are handled within a reasonable time, and internal corrective actions are carried out within the timeframe proposed by the responsible department. The case of the complaint will be deemed as closed only after the Head of the Factory reviews the Customer Complaint Form and confirms that all corrective actions are performed properly. During the Reporting Period, the Group did not receive any product or service related complaints.

### 投訴及反饋機制

本集團已制定「客戶反饋與投訴政策及程序」以確保高效處理客戶反饋及投訴。客戶可透過電郵、電話或信件向本集團提出正式投訴。收到投訴後，投訴所涉責任部門經理應開展內部調查，向客戶提出合適的解決方案，並最終啟動內部整改措施，且須在提出的時限內完成。所有客戶投訴必須在合理的時間內作出答覆。對於所收到的每項投訴，應在客戶投訴表中填寫客戶投訴詳情、收到投訴的日期、解決方案及整改措施。本集團管理層辦公室會監控投訴處理過程的狀態，以確保所有投訴均在合理的時間內得到處理，且相關責任部門在提出的時限內完成內部整改。只有在廠長審閱過客戶投訴表並確認所有整改措施均妥為執行後，投訴案例才會被視為完結。於報告期間，本集團並未收到任何產品或服務相關投訴。

### Intellectual Property Rights

In respect of privacy, data and intellectual property rights protection, the Group has complied with all the relevant laws and regulations, including but not limited to, the Intellectual Property Law of Vietnam, the Cyber Information Security Law of Vietnam, the Trademark Law of Cambodia, the Law on Copyright and Related Rights of Cambodia and the Patent Law of Cambodia. The Group has established internal policies that cover intellectual property and privacy protection. Its employees are obligated to retain in confidence all information obtained during the course of their employment, including, but not limited to, trade secrets, know-how, customer's information and personal data, supplier information and other confidential information. The information is clearly stated in the staff handbook. The Group also maintains information technology systems with the high level of security to prevent unauthorized access to confidential information. Fingerprint identification facilities are installed at the showroom to allow only a few authorized employees to enter.

### Anti-corruption

The Group strictly prohibits corruption and bribery committed by its employees. In the case of conflict of interests, employees must declare the concerns to management. In the case of suspected corrupt practices, employees should report to the management. Employees are strictly prohibited from utilizing business opportunities, power and/or occupational position for obtaining personal interests or benefits. During the Reporting Period, no reported case of corruption, bribery, fraud or extortion was noted by the Group.

The Group values and welcomes our employees to report any suspected malpractices confidentially to the management. The Group handles reported cases of malpractice cautiously in line with the whistle-blowing mechanism established. A full investigation will be conducted confidentially, disciplinary action will be imposed on the employee involved upon confirmation of the occurrence, and further legal action may be taken depending on the nature and particular circumstances of each case.

### 知識產權

在隱私、數據及知識產權保護方面，本集團已遵守所有相關法律法規，包括但不限於越南知識產權法、越南網絡信息安全法、柬埔寨商標法、柬埔寨版權及相關權利法及柬埔寨專利法。本集團已制定涵蓋知識產權及私隱保護的內部政策。其僱員有義務保密供職期間獲取之一切資料，包括但不限於商業秘密、專有技術、客戶資料及個人數據、供應商資料以及其他機密資料。該等資料於員工手冊內有清楚訂明。本集團亦已建立較高安全級別的信息技術系統，以防止未經授權獲取機密資料。展廳內已安裝指紋識別設備，僅少數獲授權僱員獲准進入。

### 反貪污

本集團嚴格禁止僱員貪污及賄賂。一旦出現利益衝突，僱員必須向管理層申報衝突事宜。一旦涉嫌貪污行為，僱員應向管理層舉報。嚴禁僱員使用商機、權力及／或職位牟取私利。於報告期間，本集團並無得悉有關貪污、賄賂、欺詐或勒索的舉報案件。

本集團重視並歡迎僱員向管理層匿名舉報任何涉嫌瀆職行為。本集團將按照已建立的舉報機制審慎處理舉報的瀆職案件。本集團將秘密進行全面調查，在確認瀆職行為屬實後，將對涉案僱員進行紀律處分，並可能視乎各案件的性質及具體情況採取進一步的法律行動。

The Group closely monitors regulatory development and will arrange relevant training for employees and directors when necessary. In order to prevent any corruption or bribery behavior within the Group, the Group will brief newly joined employees on our anti-corruption practices during their orientation, and emphasize that we do not tolerate any form of corruption. All directors received training on corporate governance prior to the Group's listing or at the time of joining the Group, it is ensured that they are aware of their duties and responsibilities in relation to integrity.

### Community Investment

The Group earnestly fulfils its social responsibilities, actively carries out public welfare activities, and regards public welfare as an important aspect of its corporate culture. Therefore, the Group encourages our employees to take part in community services so as to contribute to a more sustainable and harmonious society. In particular, the Group is devoted to helping orphans through making donations to charitable bodies, building primary schools and participating in school visits. During the Reporting Period, the Group made a donation of approximately HK\$162,000 (2022: approximately HK\$185,000). The Group has donated to World Vision Hong Kong for Child Sponsorship in helping 50 needy children to bring life-transforming changes by improving their growth environment. Also, we donated to the Cambodia Government to assist in flood relief and purchase of COVID-19 vaccines for society.

The Group will continue to contribute to the local community to develop a better environment for society and children.

The Group strives to work towards a 'green' and sustainable working environment by improving energy efficiency, addressing waste management, supporting environmental education and promoting the idea of recycling and reusing. The Group has established a set of management policies, mechanisms and measures on environmental protection and natural resources conservation to help ensure the operations of the Group are in line with world-class environmental protection practices. Moreover, the Group has recruited third party professionals to conduct energy audit test in order to assess and evaluate our existing energy saving policies and to determine whether the adopted measures are adequate in terms of saving cost and energy, as well as increasing productivity, while meeting stakeholders' expectations.

本集團通過提高能源效率、解決廢棄物管理、支持環境教育以及推廣回收及再利用的理念，朝著「綠色」及可持續工作環境努力。本集團制定了一套有關環境保護及自然資源保護的管理政策、機制及措施，有助於確保本集團的業務營運符合世界級的環保實踐。此外，本集團已聘請第三方專業人士進行能源審核測試，以評估及評價我們的現有節能策略，並確定所採取的措施在節省成本及能源以及提高生產力的同時，亦能滿足持份者的期望。

Since our manufacturing factories are located in Vietnam and Cambodia, this ESG Report will mainly focus on the environmental issues and relevant measures that are applicable to these two operating units. To achieve the environmental goals, the Group has implemented the following measures:

- Comply with all applicable environmental laws and regulations;
- Identify, assess and mitigate all potential environmental impacts associated with the Group's activities;
- Maintain high leadership commitment and develop a strong culture of environmental stewardship within the entire workforce; and
- Make resources and systems available, with the provision of the necessary training to empower our employees to fulfill our environmental responsibilities.

### Emissions

The Group's greenhouse gas ("GHG") emissions mainly resulted from direct vehicle emissions and the Liquefied Petroleum Gas ("LPG") used for cooking; while other indirect emissions mainly arise from the use of business facilities. The Group has implemented various measures to ensure that the emissions are kept at the minimum, and to reduce the impact of our business activities caused to the environment. During the Reporting Period, the Group has complied with relevant environmental laws and regulations, including but not limited to, the Environmental Protection Law in Vietnam, the Water Resources Law in Vietnam, and the Law on Environmental Protection and Natural Resources Management of Cambodia.

由於我們的製造工廠位於越南及柬埔寨，本ESG報告將著重關注適用於該兩個營運單位的環境問題及有關措施。為達致環境目標，本集團已實施下列措施：

- 遵守一切適用的環保法律法規；
- 識別、評估及減輕與本集團活動有關之一切潛在環境影響；
- 在全體員工中保持高度領導力並發展強大的環境管理文化；及
- 開放資源及系統，以及提供必要的培訓，以便我們的員工能夠履行我們的環境責任。

### 排放

本集團的溫室氣體（「溫室氣體」）排放主要來自車輛直接排放以及烹飪使用的液化石油氣（「液化石油氣」）；而其他間接排放主要來自使用之商業設施。本集團已採取多項措施以確保排放保持在最低水平，從而減少我們的業務活動對環境造成的影響。於報告期間，本集團遵守了相關環保法律法規，包括但不限於越南環境保護法、越南水資源法以及柬埔寨環境保護及自然資源管理法。

### Air Emissions

During the Reporting Period, 8 motor vehicles were used to serve our management team members, guests and clients, while 3 forklifts were used for lifting and transporting heavy loads in Vietnam and Cambodia factories. In our business operations, employees are seldom required to travel to different locations for work. Due to the epidemic situation being relieved, the business of the Group has gradually resumed and more business operations are incurred during the Reporting Period. Hence, higher usage of fuel for vehicles leads to the air emissions increased. To uphold the principles of sustainable development, the Group is committed to reducing or maintaining each type of air emissions between 95% to 120% for the next reporting period, against the level of the baseline year ended 31 March 2023.

All usage of fuel and mileage of the vehicles are recorded by drivers on a daily basis in order to monitor the usage of vehicles. Furthermore, all vehicles are under regular maintenance checks to facilitate fuel consumption efficiency, ensure road safety and keep air emissions and carbon dioxide emissions at its minimum.

### 廢氣排放

於報告期間，越南及柬埔寨工廠使用8輛汽車接送我們的管理團隊成員、賓客及客戶，及使用3輛叉車起重及運輸重物。在我們的業務營運中，僱員很少需要前往不同地點工作。於報告期間，由於疫情有所緩解，本集團業務已逐步復甦且實現更多業務營運。因此，車輛燃料的使用量增加導致廢氣排放增加。為秉持可持續發展的原則，本集團致力於下一個報告期間將各類廢氣排放降低或保持在截至二零二三年三月三十一日止的基準年度水平的95%至120%之間。

司機每天會記錄車輛的所有燃料使用及里程情況，以監測車輛的使用情況。此外，所有車輛均會進行定期維護檢查，以便提高燃料消耗的效率和確保道路安全以及將廢氣排放和二氧化碳排放量保持在最低水平。

### GHG Emissions

GHG generated from human activities is one of the significant drivers of global warming which affect the lives of the present and future generation. Therefore, the Group is highly concerned about the importance of monitoring and mitigating the GHG emissions in our operations.


Due to the epidemic situation being relieved, the business of the Group has gradually resumed and more business operations are incurred during the Reporting Period. Hence, higher usage of fuel for vehicles and more consumption of purchased electricity, which leads to the total GHG emissions increased. In order to reduce the use of fuel and the emissions of GHG, all machines and equipment would be turned off while they are not in use. For mitigating measures to reduce indirect emissions from purchased electricity and paper, please refer to the below section sub-headed “electricity and energy usage” and “generation of waste” respectively. During the Reporting Period, the GHG emissions intensity increased by 3%, which achieved the target set in the previous reporting period. To uphold the principles of sustainable development, the Group is committed to reducing or maintaining the total GHG emissions intensity between 95% to 120% for the next reporting period, against the level of the baseline year ended 31 March 2023.

### 溫室氣體排放

人類活動產生的溫室氣體是導致全球變暖的重要因素之一，影響現代及後代生活。因此，本集團高度關注運營中監測及減少溫室氣體排放的重要性。

於報告期間內，由於疫情有所緩解，本集團業務已逐步復甦，出現更多的業務營運機會。因此，車輛燃料使用量及購買的電力消耗量增加，導致溫室氣體排放總量增加。為降低燃料的使用及溫室氣體的排放，所有不使用的機器及設備會關閉。有關減少外購電力及紙張間接排放的緩解措施，請分別參閱下文「電力及能源使用」以及「產生廢棄物」各節。於報告期間，溫室氣體排放密度上升3%，達致上一報告期間所設定的目標。為秉持可持續發展的原則，本集團致力於下一個報告期間將溫室氣體總排放密度降低或保持在截至二零二三年三月三十一日止的基準年度水平的95%至120%之間。

### Air-Conditioning

In Vietnam and Cambodia factories, the indoor temperature is maintained at 25 degree Celsius or above to reduce unnecessary energy wastage. Air-conditioners are switched off when they are not in use. The Group has also put notices at prominent locations to raise employees' awareness of energy conservation.

### Use of Resources

The Group always endeavors to promote sustainability and aims to cease resource wastage that provokes detrimental harm to the environment. Various measures have been implemented to attain the goal of using resources efficiently. These measures have been effectively communicated to all levels of staff, ensuring that all employees understand clearly the importance of conserving energy and making full use of available resources during work.

“Use of Resources Policy” has been implemented by the Group, and certain resource efficiency goals and plans have been made to save energy. The Group has also assigned a department responsible for energy management, whose duty includes carrying out regular inspections and monitoring the usage of energy. The Group is aware of the importance of energy saving for our business and society, and has made several investments in saving the use of energy and resources. The measures taken are as detailed in the below section headed “water usage” and “electricity and energy usage”.

### Water Usage

Water usage arises from the production process of footwear and the daily use of water by employees at the offices during working hours. Monthly water consumption depends highly on the production volume of the month and has slight fluctuation throughout the year.

### 空調

越南及柬埔寨工廠的室內溫度維持在25攝氏度或以上，以減少不必要的能源浪費。空調在不使用時會關閉。本集團亦於顯眼的位置張貼告示，以提高僱員的節能意識。

### 資源使用

本集團一向致力於提升可持續發展能力以及旨在杜絕資源浪費，以免對環境造成損害。為達致高效使用資源的目標，我們實施了多項措施。該等措施已有效傳達至各級員工，確保全體僱員清楚明白節約能源的重要性並在工作中充分使用可用資源。

本集團已實施「資源使用政策」，並已為節能制定若干資源效益目標及計劃。本集團亦指派部門負責能源管理，其職責包括開展定期檢查及監測能源的使用情況。本集團意識到節能對於企業及社會的重要性，並已在節約能源及資源的使用方面作出數項投資。所採取的措施詳見下文「用水」及「電力及能源使用」各節。

### 用水

用水需求來自鞋履的生產過程以及辦公室僱員於辦公時間內的日常用水。每月的用水量很大程度上取決於當月的產量，且全年只有小幅波動。

At the factory in Vietnam, meters are installed to monitor the water consumption which makes analyzing the consumption index of each production stage easier. As for the Cambodia factory, it is convenient for the site to source natural water from wells in the nearby area and meters were installed during the Reporting Period to monitor the water consumption.

In order to enhance water efficiency, the Group has installed automatic water saving taps in toilets and has placed written notices in conspicuous areas to remind staff to save resources. Moreover, we have also consulted third party professionals to evaluate the existing energy saving policies and suggest ways to improve our measures.

During the Reporting Period, we complied with all relevant laws and regulations in relation to the discharge of sewage in Vietnam and Cambodia, and paid sewage fees to Vietnam Singapore Industrial Park in Vietnam and Manhattan Industrial Zone in Cambodia, to handle the waste water on our behalf. No confirmed non-compliance incidents or grievances were noted by the Group.

越南工廠已安裝計量表以監測用水量，從而更易於分析每個生產階段的消耗指數。至於柬埔寨工廠，從附近地區的井中獲取天然水更加方便，且於報告期間已安裝計量表以監測用水量。

為提高用水效率，本集團在廁所安裝了自動節水水龍頭，並在顯眼的位置設置了書面告示，提醒員工節約資源。此外，我們亦諮詢第三方專業人士對現有節能政策進行評估，並建議改進措施的方法。

於報告期間，我們已遵守越南及柬埔寨有關污水排放的所有相關法律及法規，並向位於越南的越南新加坡工業園及柬埔寨曼哈頓工業區支付相關的排污費，以代表我們處理廢水。本集團並無得悉經確認的不合規事件或投訴。

Due to the epidemic situation being relieved, the business of the Group has gradually resumed and more business operations during the Reporting Period. Hence, the total water consumption increased. During the Reporting Period, the water consumption intensity and sewage intensity increased by 2% and 4% respectively, which achieved the target set in the previous reporting period. The Group will continue to put more effort into reducing unnecessary water consumption. Therefore, the Group strives to uphold our leadership in sustainability and aims to reduce or maintain the water consumption intensity and sewage intensity between 90% and 120% for the next reporting period, against the level of the baseline year ended 31 March 2023.

### Electricity and Energy Usage

In consideration of the potential environmental threats to the communities, the Group has made steady progress in reducing its carbon footprints across its business operations. The electricity consumption of the Group has mainly arisen from daily consumption at the offices and factories in Vietnam and Cambodia. Moreover, the Group has engaged a third party consulting company to perform energy audit tests at the Vietnam factory and provide suggestions and comments on the existing policies for improvements in electricity and energy usage.

Due to the epidemic situation being relieved, the business of the Group has gradually resumed and more business operations during the Reporting Period. Hence, the total energy consumption increased. Although the total energy consumption level increased, it increased by a proportion less than the increase in the production volume. Thus, the energy consumption intensity decreased by 2% during the Reporting Period and achieved the target set in the previous reporting period. The Group pledges to reduce or maintain the energy consumption intensity between 90% to 120% for the next reporting period, against the level of the baseline year ended 31 March 2023.

於報告期間，由於疫情有所緩解，本集團業務已逐步復甦且實現更多業務營運。因此，用水總量增加，用水量密度及污水量密度分別上升2%至4%，達致上一報告期間所設定的目標。因此，本集團致力維持我們在可持續發展方面的領先地位，並力求於下一個報告期間將用水量密度及污水量密度降低或維持在截至二零二三年三月三十一日止的基準年度水平的90%至120%之間。

### 電力及能源使用

考慮到社區可能面臨的環境威脅，本集團在減少整個業務運營的碳足跡方面已取得穩步進展。本集團耗電量主要產生自越南及柬埔寨的辦公室及工廠日常消耗。此外，本集團已聘請第三方諮詢公司在越南工廠進行能源審核測試，並就現有電力及能源使用政策的改進提出建議及意見。

於報告期間，由於疫情有所緩解，本集團業務已逐步復甦且實現更多業務營運。因此，耗電總量增加。能源消耗總量水平雖有所上升，其增幅低於產量增幅。因此，能源消耗密度於報告期間下降2%，達致上一報告期間所設定的目標。本集團承諾於下一個報告期間將能源消耗密度降低或維持在截至二零二三年三月三十一日的基準年度水平的90%至120%之間。

The following are the measures that the Group has implemented to preserve energy and electricity:

- Lighting, appliances, machines and equipment are turned off when they are not in use to reduce energy consumption;
- Air conditioners and lights are turned off during non-office hours, including lunch hours, and in idle rooms;
- Employees are required to put computers and other devices into sleep mode or turn them off when they are not in use (such as during customer visits and lunch time) during business hours;
- Regular maintenance of office equipment such as air conditioners, computers, lights, refrigerators, etc. to ensure they are operating efficiently;
- Printing machine in the office is set to energy-saving mode by default, and the sleep mode is automatically turned on if not in use for a certain interval in time so as to reduce unnecessary energy consumption;

The Group's products mainly use packaging materials such as paper, paper boxes, and partition cardboard. In response to environmental protection, the Group has strived to minimize the wastage of packaging materials to the greatest extent by reducing the use of new cartons by reusing and recycling old carton boxes. The following table sets forth the total usage of shoe boxes and carton boxes during the Reporting Period.

### Generation of Waste

The solid waste generated by the Group mainly arises from day-to-day operations, including, but not limited to, office-use paper, office waste and excessive materials generated during the production process. Total paper waste disposed at landfills was approximately 8,000 kilograms (2022: approximately 8,700 kilograms). The Group has made a great effort in reducing paper waste, which leads to a drop in total paper waste level. In order to alleviate the pressure on landfills and promote environmental friendliness, we have implemented various measures to encourage recycling of office supplies and other materials, and eliminate the over-consumption of unnecessary products; prioritizing reuse and recycling over disposal. For example, the Group promotes the use of double-sided printing and encourages its employees to use electronic administrative platforms and online communication channels.

### 包裝材料

本集團的產品主要使用紙張、紙箱及分隔紙板等包裝材料。為應對環境保護，本集團已盡量減少包裝材料的浪費，最大限度地通過重複使用及回收舊紙盒減少新紙箱的使用。下表載列於報告期間鞋盒及硬紙盒總使用量。

### 產生廢棄物

本集團產生的固體廢物主要由日常營運產生，包括但不限於辦公用紙、辦公室廢棄物及生產過程中所產生的剩餘材料。在堆填區處置的廢紙總量約為8,000千克（二零二二年：約8,700千克）。本集團竭力減少紙張浪費，致使廢紙總量下降。為減輕對堆填區的壓力及促進環保意識，我們已實行多項措施，鼓勵回收辦公用品及其他物料，以杜絕過度消耗不必要用品；就處理而言優先重複使用及回收。例如，本集團推廣使用雙面印刷，並鼓勵其僱員使用電子行政平台及在線溝通渠道。

Both hazardous and non-hazardous wastes are generated during the manufacturing processes. In order to reduce the production of solid waste, statistics of waste are recorded monthly in order to keep track of the volume of disposal of hazardous and non-hazardous wastes. Employees are always reminded to use resources carefully and avoid using excessive materials during the process of shoe-making. The head of the factory closely monitors the monthly waste disposal record. If there is a large increase in the amount of monthly waste disposal, the head of the factory will conduct a thorough investigation and perform follow-up action promptly. For example, the head of the factory will put reminder labels in the factory or hold a briefing session with the factory workers to re-emphasize the importance of waste reduction.

As our customers introduce new types of products, the production process and material were changed accordingly. Also, due to the epidemic situation being relieved, the business of the Group has gradually resumed and more business operations are incurred during the Reporting Period. Hence, the hazardous waste intensity increased by 11%, which achieved the target set in the previous reporting period. For the non-hazardous waste, the Group has made a great effort in reducing the waste, which leads to a drop in total non-hazardous waste level and its intensity, which also achieved the target set in the previous reporting period. The Group will strive to reduce or maintain the hazardous waste and non-hazardous waste intensity between 90% and 120% for the next reporting period, against the level of the baseline year ended 31 March 2023.

製造過程中會產生有害及無害廢棄物。為減少產生固體廢棄物，我們每月記錄廢棄物統計數據，以便跟蹤有害及無害廢棄物的處置量。我們始終提醒僱員小心使用資源，避免在製鞋過程中使用過量的材料。廠長密切監控每月的廢棄物處置記錄。倘月度廢棄物處置量大幅增加，廠長會進行徹底調查，並及時採取後續行動。例如，廠長會在工廠張貼警醒告示或與工人召開簡報會，重申減廢的重要性。

隨著客戶不斷推出新型產品，我們的生產流程及材料也隨之發生變化。亦因疫情狀況有所緩解，本集團業務已逐步恢復且於報告期間開展更多業務。因此，有害廢棄物密度上升11%，達致上一報告期間所設定的目標。就無害廢棄物而言，本集團竭力減少廢棄物產生，致使無害廢棄物總量及其密度均有所下降，達致上一報告期間所設定的目標。本集團將於下一個報告期間盡力將有害廢棄物及無害廢棄物密度降低或維持在截至二零二三年三月三十一日止的基準年度水平的90%至120%之間。

During the Reporting Period, the Group complied with all relevant environmental laws and regulations that have a significant impact on us, including but not limited to, Law on Environmental Protection and Natural Resources Management in Cambodia and Law on Environmental Protection in Vietnam. No confirmed non-compliance incidents or grievances were noted by the Group in relation to environmental issues.

The Board is committed to ensuring the self-regulatory practices exist to protect the interests of the shareholders of the Company. These include a Board with high caliber members, Board Committees and effective internal audit and good systems of internal controls. The Board and the management of the Company are committed to the maintenance of good corporate governance practices and procedures. The Company believes that good corporate governance provides a framework that is essential for effective management, a healthy corporate culture, sustainable business growth and enhancing shareholders' value. The Company regularly reviews the corporate governance procedures and developments of the Company. The corporate governance duties have been delegated by the Board to the audit committee of the Company. The primary duties of the audit committee in relation to corporate governance include developing and reviewing the Company's policies and practices on corporate governance and making recommendations to the Board, so as to enhance and to ensure the corporate governance practices of the Company are in line with the relevant requirements. The Company applied the principles and complied with all the code provisions as set out in the Corporate Governance Code (the "CG Code") contained in Appendix 14 to the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") throughout the year under review.

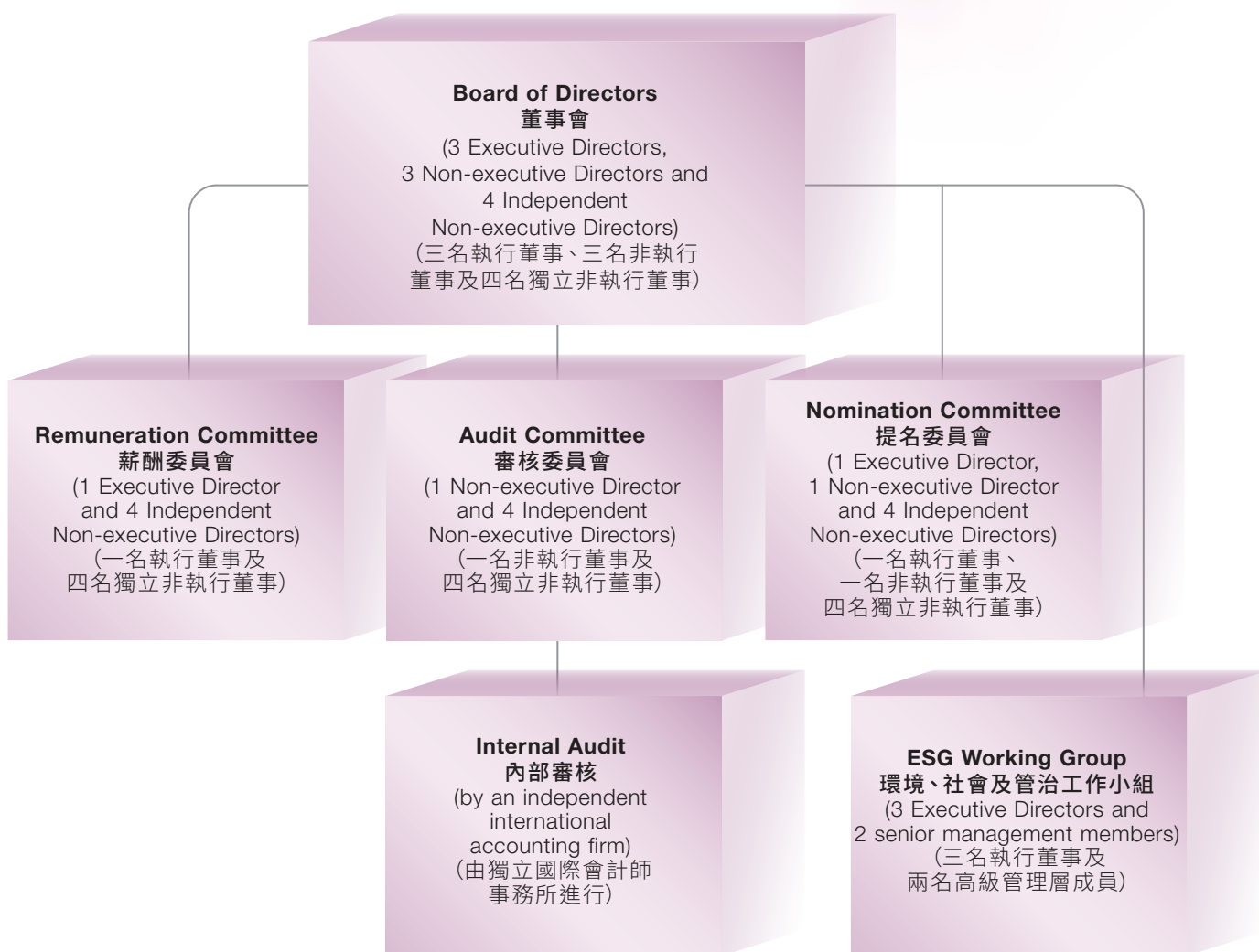

Apart from the above regular Board meetings of the year, the Board will meet on other occasions when a Board level decision on a particular matter is required. The Directors receive details of agenda items for decision and minutes of committee meetings in advance of each Board meeting. The Board has reserved for its decision or consideration matters covering corporate strategy, annual and interim results, Directors' appointment, succession planning, risk management, major acquisitions, disposals and capital transactions, and other significant operational and financial matters. Major corporate matters that are specifically delegated by the Board to the management include the preparation of annual and interim financial statements for Board approval before public reporting, execution of business strategies and initiatives adopted by the Board, implementation of adequate systems of internal controls and risk management procedures, and compliance with relevant statutory requirements, rules and regulations.

The Board is responsible for determining the corporate strategic development and ensuring the business operations are properly monitored. The Board reserves the right to decide all policy matters and material transactions of the Group.

The Board delegates the day-to-day operations to general managers and department heads who are responsible for different business functional units of the operations of the Group.

Besides, to assist the Board in discharge of its duty, the Board established the audit committee, remuneration committee and nomination committee and their scope of duties and terms of reference were discussed and approved in the Board meetings.

### Non-executive Directors

All the non-executive Directors were appointed for a specific term of three years that are subject to retirement by rotation and re-election at the Company's annual general meeting in accordance with the bye-laws of the Company.

### Independent non-executive Directors

The Board has received from each of the independent non-executive Directors a written annual confirmation of their independence and satisfied that their independence up to the date of this report is in accordance with the Listing Rules.

The Company has subscribed an insurance policy since 2000 with an aim to indemnify its Directors and senior executives from any losses, claims, damages, liabilities and expenses arising from, including but not limited to, any proceedings brought against them during the performance of their duties pursuant to their respective service agreements entered into with the Company.

### PROCEEDINGS OF BOARD MEETINGS AND BOARD COMMITTEE MEETINGS

The Board considers that all meetings should be properly convened. With the assistance of the Company Secretary, the Chairman of the Board takes the lead to ensure that Board meetings and Board committee meetings are convened in accordance with the requirements set out in the bye-laws of the Company, the terms of reference of the respective Board committees and the Listing Rules.

In convening Board meetings, the Chairman is responsible for drawing up and approving the agenda for each meeting after consultation with all the Directors and the Company Secretary. Prior notice of each regular Board meeting is given to all the Directors at least 14 days in advance.

Board meetings are held at least four times a year. In addition, special Board meetings are held when necessary. Such Board meetings involve the active participation, either in person or through other electronic means of communication, of all the Directors.

Dates of regular Board meetings are scheduled in advance to provide sufficient notice to give all the Directors an opportunity to attend. For special Board meetings, reasonable notice is given.

The Directors have access to the advice and services of the Company Secretary to ensure that Board procedures and all applicable rules and regulations are followed.

The minutes of Board meetings record in sufficient detail the matters considered by the Board, including all concerns raised by the Directors and dissenting views expressed. The minutes of all Board meetings and Board committee meetings are kept by the Company Secretary and are available for inspection by any Director, auditors or any relevant eligible parties who can have access to such minutes.

Our diversity philosophy including the gender diversity was generally followed in the workforce level throughout the Group for the 12 months ended 31 March 2023. We will continue with our endeavours to maintain female representation in our workforce.

The Nomination Committee may also put forward candidates who are not nominated by Board members.

The Nomination Committee should evaluate such candidate based on the selection criteria mentioned above to determine whether such candidate is qualified for directorship. If he or she is considered appropriate, the Nomination Committee shall make recommendations for the Board's consideration and approval for filling a casual vacancy. For proposing candidates to stand for election at a general meeting, the Nomination Committee shall make nominations to the Board for its consideration and recommendation. A candidate is allowed to withdraw his/her candidature at any time before the general meeting by serving a notice in writing to the company secretary of the Company. The Group's audited consolidated financial statements for the year ended 31 March 2023 have been reviewed by the Audit Committee, which was of the opinion that the preparation of the consolidated financial statements complied with the applicable accounting standards, the Listing Rules and legal requirements, and that adequate disclosures have been made.

The Audit Committee considered that the existing proposed terms in relation to the appointment of the Group's external auditor are fair and reasonable.

### AUDITOR'S REMUNERATION

The Audit Committee is responsible for considering the appointment of the external auditor and reviewing any non-audit functions performed by the external auditor, including whether such non-audit functions could lead to any potential material adverse effect on the Group. During the year under review, the fees payable to the Company's external auditor for audit services and non-audit services were HK\$1,816,000 and HK\$593,000 respectively. The non-audit services relate primarily to tax compliance and consultancy services.

The Directors have prepared the financial statements for the year ended 31 March 2023 on a going concern basis. The Directors are responsible for keeping proper accounting records which reflect the financial position of the Group with reasonable accuracy at any time.

### RISK MANAGEMENT AND INTERNAL CONTROLS

The Board recognizes its responsibility for maintaining an adequate and sound enterprise risk management and internal control system and through the Audit Committee and, if necessary, an external independent professionals to provide internal control services, conducts reviews on the effectiveness of these systems at least annually, covering material controls, including financial, operational, compliance and strategic risk control functions. The Board understands that such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

During the year under review, the Board, through the Audit Committee, conducted an annual review of both design and implementation effectiveness of the risk management and internal control systems of the Group, covering all material controls, including financial, operational and compliance controls, with a view to ensuring that resources, staff qualifications and experience, training programmes and budget of the Group's accounting, internal audit and financial reporting functions are adequate. In this respect, the Audit Committee communicates any material issues identified to the Board.

During the year under review, the Company appointed BT Corporate Governance Limited (an operating entity of Baker Tilly Hong Kong) ("BTCGL"), an external independent professionals to:

- assist in identifying and assessing the risks of the Group through a series of workshops and interviews; and
- independently perform internal control review and assess effectiveness of the Group's risk management and internal control systems.

The results of the independent review and assessment were reported to the Audit Committee and the Board. Moreover, improvements in internal control and risk management measures as recommended by BTCGL to enhance the risk management and internal control systems of the Group and mitigate risks of the Group were adopted by the Board. Based on the findings and recommendations of BTCGL as well as the comments of the Audit Committee, the Board considered the internal control and risk management systems effective and adequate.

The Board has adopted a whistleblowing policy and an anti-corruption policy during the financial year ended 31 March 2023. Such Policies are reviewed annually by the Audit Committee to ensure their effectiveness.

### Our Enterprise Risk Management Framework

The Group established its enterprise risk management framework during the year. While the Board has the overall responsibility to ensure that sound and effective internal controls are maintained, management is responsible for designing and implementing an internal control system to manage all kinds of risks faced by the Group.

Through the risk identification and assessment processes, risks are identified, assessed, prioritized and allocated treatments. Our risk management framework follows the COSO Enterprise Risk Management – Integrated Framework, which allows the Board and management to manage the risks of the Group effectively. The Board receives regular reports through the Audit Committee that oversight risk management and internal audit functions.

### Risk Control Mechanism

The Group adopts a “three lines of defence” corporate governance structure with operational management and controls performed by operations management, coupled with risk management monitoring carried out by the finance and compliance team and independent internal audit outsourced to and conducted by BTCGL. The Group adopts risk management policy and procedure (the “Risk Management Policy”) and maintains a risk register to keep track of all identified major risks of the Group. The risk register provides the Board, the Audit Committee, and management with a profile of its major risks and records management’s action taken to mitigate the relevant risks. Each risk is evaluated at least annually based on its likelihood of occurrence and potential impact upon the Group. The risk register is updated by management as the risk owners with addition of new risks and/or removal of existing risks, if applicable, at least annually, after the annual risk evaluation has been performed. This review process can ensure that the Group proactively manages the risks faced by it in the sense that all risk owners have access to the risk register and are aware of and alert to those risks in their area of responsibility so that they can take follow-up action in an efficient manner.

Our risk management activities are performed by management on an ongoing process. The effectiveness of our risk management framework will be evaluated at least annually, and periodic management meeting is held to update the progress of risk monitoring efforts. Management is committed to ensuring that risk management forms part of the daily business operation processes in order to align risk management with corporate goals in an effective manner.

### 風險監控機制

本集團採用「三線防守」企業管治結構，由營運管理層執行經營管理及監控，加上財務及合規團隊開展的風險管理監督，以及由哲慧企管專才外包及執行的獨立內部審核。本集團採納風險管理政策及程序（「風險管理政策」）並維繫風險記錄，以監察本集團所有已識別的主要風險之動向。風險記錄為董事會、審核委員會及管理層提供其主要風險的概要情況，並記錄管理層為緩解相關風險所採取的行動。本集團至少每年根據各風險發生的可能性和對本集團的潛在影響進行評估。在執行年度風險評估之後，管理層（作為風險承擔者）將至少每年更新風險記錄，增加新風險及／或刪除現有風險（如適用）。審核流程可確保本集團主動管理其面臨的風險，即所有風險承擔者都可以取得風險記錄，並且了解並警惕其責任領域的風險，以便彼等有效率地採取後續行動。

我們的風險管理活動由管理層持續進行。我們的風險管理框架的有效性將至少每年進行一次評估，並定期舉行管理層會議以更新風險監測工作的進展。管理層致力於確保風險管理構成日常業務運營流程的一部分，以便有效地統一風險管理與公司目標。

The Company will continue to engage external independent professionals to review the Group's system of internal controls and risk management annually and further enhance the Group's internal control and risk management systems as appropriate.

There is currently no internal audit function within the Group. The directors have reviewed the need for an internal audit function and are of the view that in light of the size, nature and complexity of the business of the Group, it would be more cost effective to appoint external independent professionals to perform internal audit function for the Group in order to meet its needs. Nevertheless, the directors will continue to review at least annually the need for an internal audit function.

### Disclosure of Inside Information

The Group has established internal control procedures for the handling and dissemination of inside information in order to comply with Chapter 13 of the Listing Rules as well as Part XIVA of the Securities and Futures Ordinance ("SFO"). The internal control mechanism includes information flow and reporting processes, confidentiality arrangements, disclosure procedures, and staff training arrangements, etc.

### DIVIDEND POLICY

It is the policy of the Board, in recommending dividends, to allow shareholders to participate in the Company's profits and for the Company to retain adequate reserves for future growth. The Company expects to maintain a general dividend policy of declaring and paying approximately 30% to 60% of the Company's consolidated net profit attributable to shareholders of the Company in each financial year subject to the financial performance, business development, working capital requirements and capital expenditure plan of the Group. The Company may in addition from time to time consider to declare special dividends subject to the macroeconomic environment, funding needs on business development, overall cash position and any future capital commitments of the Group.

本集團已就處理及發佈內幕消息制訂內部監控程序，以遵守上市規則第13章以及證券及期貨條例（「證券及期貨條例」）第XIVA部。內部監控機制包括消息流向與申報流程、保密安排、披露程序及員工培訓安排等。

### 股息政策

董事會在建議派發股息時遵循讓股東分享本公司溢利，同時為本公司日後發展保留充足儲備的政策。本公司預期維持一般股息政策，以宣派及派付於各財政年度內本公司股東應佔本公司綜合純利約30%至60%，惟須視乎本集團的財務表現、業務發展、營運資金需求及資本開支計劃而定。此外，本公司可不時考慮根據宏觀經濟環境、業務發展的資金需求、本集團整體現金狀況及任何未來資本承擔宣派特別股息。

Declaration and payment of dividends shall remain to be determined at the sole discretion of the Board, taking into consideration of, among others, the following factors:

- (i) operations and earnings;
- (ii) business development;
- (iii) liquidity position;
- (iv) capital requirements and surplus;
- (v) general financial conditions;
- (vi) contractual restrictions (if any); and
- (vii) any other factors that the Board considers appropriate.

Subject to the Companies Act of Bermuda and the bye-laws of the Company (the “Bye-laws”), the Company may from time to time declare dividends in any currency to be paid to the members of the Company but no dividend shall be declared in excess of the amount recommended by the Board.

The Board may also from time to time pay to the members of the Company such interim dividends as appear to the Board to be justified by the profits of the Company. Any declaration and payment as well as the amount of the dividend will be subject to the Bye-laws and the Companies Act of Bermuda.

### INVESTOR RELATIONS

The Company continues to promote and enhance investor relations and communications with its investors. An intensive communications channel has been maintained with the media, analysts and fund managers through one-on-one meeting, road shows and conferences. Designated senior management maintains regular dialogue with institutional investors and analysts to keep them abreast of the Company’s development.

### COMMUNICATION WITH SHAREHOLDERS

The Company sets high priority in communicating with shareholders and investors and has adopted the Shareholders Communication Policy. Regular meetings with institutional shareholders and general presentation of financial results are made when financial results are announced. The Company also provides extensive information in its annual report, interim report and announcements which are available on the Stock Exchange's website at [www.hkexnews.hk](http://www.hkexnews.hk) and the Company's website at [www.kingmaker-footwear.com](http://www.kingmaker-footwear.com).

The Board endeavours to maintain an ongoing dialogue with shareholders. All directors are encouraged to attend the general meetings to have personal communication with shareholders. In annual general meeting, the chairman of the Board and the chairman of each committee are required to attend and answer questions from shareholders in respect of the matters that they are responsible and accountable for. In addition, a representative of the Company's external auditors is requested to attend the annual general meeting to answer questions about the conduct of the audit, the preparation and content of the auditors' report, accounting policies and auditor independence.

The Company's annual general meeting ("AGM") and special general meeting ("SGM") provide good opportunities for shareholders to express their views and ask Directors and management questions regarding the Company. All shareholders of the Company receive the annual report, circulars and notices of AGM and SGM and other corporate communications. Separate resolutions are required at general meetings on each distinct issue. Each shareholder is permitted to appoint a proxy to attend and vote in his stead.

The Hong Kong branch share registrar of the Company serves the shareholders in respect of share registration, dividend payment and related matters.

The Company has reviewed the implementation and effectiveness of the Shareholder Communication Policy during the year and concluded that it continues to be effective in engaging with the Company's shareholders.

### PROCEDURES FOR SHAREHOLDERS TO NOMINATE A DIRECTOR, MAKE PROPOSALS AND CONVENE GENERAL MEETINGS

Pursuant to the Bye-laws of the Company, if a shareholder, who is duly qualified to attend and vote at the general meeting convened to deal with appointment/election of director(s), wishes to propose a person (other than the shareholder himself/herself) for election as a director of the Company, the shareholder must deposit a written notice to the principal place of business of the Company in Hong Kong for the attention of the company secretary of the Company. Details for nominating candidates to stand for election as a director are set out in the Corporate Governance section of the Company website.

(i) Any one or more shareholders holding not less than one-twentieth of the total voting rights of all shareholders having the right to vote at the general meeting; or (ii) not less than 100 shareholders may submit a written request to make proposals or move a resolution at a general meeting; or a statement of not more than 1,000 words with respect to the matter referred to in any proposed resolution or the business to be dealt with at a particular general meeting. Such request must be deposited at the principal place of business of the Company in Hong Kong, for the attention of the company secretary of the Company, not less than six weeks before the meeting in the case of a requisition requiring notice of a resolution and not less than one week before the meeting in the case of any other requisition. Details of the requirements and procedures for making proposals or moving a resolution at a general meeting are set out in the Corporate Governance section of the Company website.

Any one or more shareholders holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition sent to the Company's registered office and at its principal place of business in Hong Kong, for the attention of the Board or the company secretary of the Company, to require a special general meeting to be called by the Board for the transaction of any business specified in such requisition. Details of the requirements and procedures for convening general meetings are set out in the Corporate Governance section of the Company website.

As at 31 March 2023, the Group had net inventories of HK\$171.6 million, which represented 22% and 11% of the Group's total current assets and total assets, respectively. The estimation of the inventory provision requires significant management judgement, which includes judgement about the recoverability of the cost of inventories, the nature and condition of inventories, the marketability of finished goods and the future usage of raw materials.

Related disclosures are included in notes 3, 7 and 17 to the financial statements.

#### How our audit addressed the key audit matter

We tested the ageing analysis of the Group's inventories. We recalculated the inventory provision based on management's estimation and assessed the basis, rationale and consistency of the assumptions applied in the inventory provision. We assessed obsolescence provisions by considering the inventory level against historical inventory turnover days and checked subsequent sales and usage information on a sample basis. We also discussed with management about the potential obsolete inventories.

The valuation of investment properties was highly dependent on estimates and assumptions, such as those relating to the rental value, rental growth rate, market yield, market knowledge and historical transactions.

#### How our audit addressed the key audit matter

We considered the competence, capabilities and objectivity of the external valuer engaged by management. We involved our internal valuation specialists to assist us in assessing the valuation methodology and assumptions and our procedures included comparing the rent and term periods against the existing lease agreements and performing market research on key valuation parameters such as the rental growth rate, capitalisation rate and market rent of similar properties.

Management is required to make judgement and estimates when determining the tax provision as the Group operates in a number of tax jurisdictions. Due to the complexity of local and international tax legislation, judgements have to be made by management on the tax treatment on transactions in advance of the ultimate tax determination being certain. Where the amount of tax payable or recoverable is uncertain, the Group estimates provision based on management's judgement of the probable amount of the liability, or expected amounts recoverable.

Related disclosures are included in notes 3, 10 and 24 to the financial statements.

#### How our audit addressed the key audit matter

We involved our tax specialists to review the tax provision of the Group. We assessed management's judgements in respect of estimates of tax exposures by considering the associated fact pattern and the Group's correspondence with the relevant tax authorities and recent developments in the tax jurisdictions which may have an impact on existing tax exposures.

### 1. CORPORATE AND GROUP INFORMATION

Kingmaker Footwear Holdings Limited is a limited liability company incorporated in Bermuda. The registered office of the Company is located at Clarendon House, 2 Church Street, Hamilton HM11, Bermuda.

During the year, the Group was involved in the manufacture and trading of footwear and property investment. Particulars of the Company's principal subsidiaries are detailed in note 34 to the financial statements.

#### 2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for investment properties which have been measured at fair value. These financial statements are presented in Hong Kong dollars ("HK\$") and all values are rounded to the nearest thousand except when otherwise indicated.

### 1. 公司及集團資料

信星鞋業集團有限公司為於百慕達註冊成立之有限公司。本公司之註冊辦事處位於Clarendon House, 2 Church Street, Hamilton HM11, Bermuda。

年內，本集團從事製造及買賣鞋類以及物業投資。本公司主要附屬公司之詳情載於財務報表附註34。

#### 2.1 編製基準

此等財務報表已根據香港會計師公會（「香港會計師公會」）頒佈之香港財務報告準則（「香港財務報告準則」，其包括所有香港財務報告準則、香港會計準則（「香港會計準則」）及詮釋）、香港公認之會計原則以及香港公司條例之披露規定編製。此等財務報表乃根據歷史成本法而編製，惟按公平值計量之投資物業除外。此等財務報表以港元（「港元」）呈列，除另有註明者外，所有款項已捨入至最接近之千位數。

#### Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the “Group”) for the year ended 31 March 2023. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

Generally, there is a presumption that a majority of voting rights results in control. When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group’s voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

#### 綜合賬目基準

綜合財務報表包括本公司及其附屬公司（統稱「本集團」）截至二零二三年三月三十一日止年度之財務報表。附屬公司乃本公司直接或間接控制之實體（包括結構性實體）。當本集團對參與投資對象業務之浮動回報承擔風險或享有權利以及能透過對投資對象之權力（即本集團獲賦予現有能力以主導投資對象相關活動之既存權利）影響該等回報時，即取得控制權。

一般情況下均存在多數投票權形成控制權之推定。倘本公司直接或間接對投資對象沒有大多數投票權或類似之權利，本集團於評估其是否擁有對投資對象之權力時會考慮一切相關事實及情況，包括：

- (a) 與投資對象其他投票持有人之合約安排；
- (b) 其他合約安排所產生之權利；及
- (c) 本集團之投票權及潛在投票權。

附屬公司與本公司之財務報表之報告期間相同，並採用一致之會計政策編製。附屬公司之業績由本集團獲得控制權當日起綜合入賬，並繼續入賬直至有關控制權終止當日為止。

#### Basis of consolidation (continued)

Profit or loss and each component of other comprehensive income are attributed to the equity holders of the Company and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

倘事實及情況反映上文所述三項控制權因素之其中一項或多項有變，則本集團會重估是否仍然控制投資對象。附屬公司擁有權權益之變動（並無失去控制權），於入賬時列作權益交易。

倘本集團失去對附屬公司之控制權，則終止確認(i)該附屬公司之資產（包括商譽）及負債，(ii)任何非控股權益之賬面值及(iii)於權益內記錄之累計換算差額；及確認(i)已收代價之公平值，(ii)所保留任何投資之公平值及(iii)任何因此於損益內產生之盈餘或虧絀。先前於其他全面收益內確認之本集團應佔部分按猶如本集團已直接出售相關資產或負債所規定之相同基準重新分類至損益或保留溢利（如適當）。

The nature and the impact of the revised HKFRSs are described below:

- (a) Amendments to HKFRS 3 replace a reference to the previous *Framework for the Preparation and Presentation of Financial Statements* with a reference to the *Conceptual Framework for Financial Reporting* (the “Conceptual Framework”) issued in June 2018 without significantly changing its requirements. The amendments also add to HKFRS 3 an exception to its recognition principle for an entity to refer to the Conceptual Framework to determine what constitutes an asset or a liability. The exception specifies that, for liabilities and contingent liabilities that would be within the scope of HKAS 37 or HK(IFRIC)-Int 21 if they were incurred separately rather than assumed in a business combination, an entity applying HKFRS 3 should refer to HKAS 37 or HK(IFRIC)-Int 21 respectively instead of the Conceptual Framework. Furthermore, the amendments clarify that contingent assets do not qualify for recognition at the acquisition date. The Group has applied the amendments prospectively to business combinations that occurred on or after 1 April 2022. As there were no contingent assets, liabilities and contingent liabilities within the scope of the amendments arising in the business combination that occurred during the year, the amendments did not have any impact on the financial position and performance of the Group.

- (b) Amendments to HKAS 16 prohibit an entity from deducting from the cost of an item of property, plant and equipment any proceeds from selling items produced while bringing that asset to the location and condition necessary for it to be capable of operating in the manner intended by management. Instead, an entity recognises the proceeds from selling any such items, and the cost of those items as determined by HKAS 2 *Inventories*, in profit or loss. The Group has applied the amendments retrospectively to items of property, plant and equipment made available for use on or after 1 April 2021. Since there was no sale of items produced prior to the property, plant and equipment being available for use, the amendments did not have any impact on the financial position or performance of the Group.
- (c) Amendments to HKAS 37 clarify that for the purpose of assessing whether a contract is onerous under HKAS 37, the cost of fulfilling the contract comprises the costs that relate directly to the contract. Costs that relate directly to a contract include both the incremental costs of fulfilling that contract (e.g., direct labour and materials) and an allocation of other costs that relate directly to fulfilling that contract (e.g., an allocation of the depreciation charge for an item of property, plant and equipment used in fulfilling the contract as well as contract management and supervision costs). General and administrative costs do not relate directly to a contract and are excluded unless they are explicitly chargeable to the counterparty under the contract. The Group has applied the amendments prospectively to contracts for which it has not yet fulfilled all its obligations at 1 April 2022 and no onerous contracts were identified. Therefore, the amendments did not have any impact on the financial position or performance of the Group.

#### Investments in associates

An associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it is in a position to exercise significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

The Group's investments in associates are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses. Adjustments are made to bring into line any dissimilar accounting policies that may exist. The Group's share of the post-acquisition results and other comprehensive income of associates is included in the consolidated statement of profit or loss and consolidated other comprehensive income, respectively. In addition, when there has been a change recognised directly in the equity of the associate, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its associates are eliminated to the extent of the Group's investments in the associates, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of associates is included as part of the Group's investments in associates.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate upon loss of significant influence and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

### 2.4 重大會計政策概要

#### 聯營公司投資

聯營公司為本集團於其一般不少於20%股本投票權中擁有長期權益的實體，且可對其發揮重大影響力。重大影響力指的是參與投資對象的財務和經營決策的權力，但不是控制或共同控制這些決策的權力。

本集團於聯營公司的投資乃按本集團根據權益會計法應佔資產淨值減任何減值虧損於綜合財務狀況表列賬。倘出現任何不相符的會計政策，即會作出調整加以修正。本集團應佔聯營公司收購後業績及其他全面收益分別計入綜合損益表及綜合其他全面收益表。此外，倘於聯營公司的權益直接確認變動，則本集團會於綜合權益變動表確認其應佔任何變動（倘適用）。本集團與其聯營公司間交易的未變現收益及虧損將以本集團於聯營公司的投資為限對銷，惟倘未變現虧損證明所轉讓資產減值則除外。收購聯營公司所產生的商譽已計入作本集團於聯營公司投資的一部分。

倘於聯營公司之投資變成於合營企業之投資或出現相反情況，則不會重新計量保留權益。反之，該投資繼續根據權益法入賬。在所有其他情況下，失去對聯營公司之重大影響力後，本集團按其公平值計量及確認任何保留投資。聯營公司於失去重大影響力時的賬面值與保留投資及出售所得款項的公平值之間的任何差額乃於損益內確認。

### Fair value measurement

The Group measures its investment properties at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

### 公平值計量

本集團於各報告期末按公平值計量其投資物業。公平值乃市場參與者於計量日期在有序交易中出售資產所收取之價格或轉讓負債所支付之價格。公平值計量乃根據假設出售資產或轉讓負債之交易於資產或負債主要市場或（在無主要市場情況下）於資產或負債最具優勢市場進行而作出。主要或最具優勢市場須為本集團可進入之市場。資產或負債之公平值乃按假設市場參與者於資產或負債定價時會假設以彼等最佳經濟利益行事而計量。

非財務資產之公平值計量須計及市場參與者能通過最大限度使用該資產達致最佳用途，或將該資產出售予將最大限度使用該資產達致最佳用途之其他市場參與者所產生之經濟效益。

本集團採納適用於不同情況且具備充分數據以供計量公平值之估值方法，盡量使用相關可觀察輸入數據及盡量減少使用不可觀察輸入數據。

### Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, financial assets and investment properties), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs. In testing a cash-generating unit for impairment, a portion of the carrying amount of a corporate asset (e.g., a headquarters building) is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cash-generating units.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the statement of profit or loss in the period in which it arises.

### 非財務資產減值

倘若出現減值跡象，或當有需要為資產（不包括存貨、財務資產及投資物業）進行每年減值測試時，則會估計資產的可收回金額。除非某類資產產生之現金流入不能很大程度上獨立於其他資產或多項資產所產生之現金流入（在此情況下，可收回金額按資產所屬之現金產生單位釐定），否則資產的可收回金額按資產或現金產生單位的使用價值與其公平值減出售成本兩者中的較高者計算，並按個別資產釐定。測試現金產生單位的減值時，倘公司資產（如總部大樓）賬面值的一部分可按合理一致的基準進行分配，則分配至個別現金產生單位，否則分配至最小的現金產生單位組別。

僅於資產的賬面值超過可收回金額時，減值虧損方予確認。評估使用價值時，估計未來現金流量是以除稅前貼現率貼現至現值，而該貼現率反映當時市場對貨幣之時間價值之評估及該項資產的特有風險。減值虧損在其於符合減值資產功能的開支類別中所產生期間於損益表扣除。

於各報告期末，將評定是否有跡象顯示先前確認之減值虧損不再存在或減少。倘出現該等跡象，則會估計可收回金額。先前確認之資產（商譽除外）減值虧損，只會在用以釐定該項資產之可收回金額之估計有所改變時撥回，惟撥回之金額不得超過該項資產倘於過往年度未獲確認減值虧損而釐定的賬面值（經扣除任何折舊）。所撥回之減值虧損，乃於其發生期間計入損益表。

#### Property, plant and equipment and depreciation

Property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

物業、廠房及設備(在建工程除外)乃按成本減累計折舊及任何減值虧損列賬。物業、廠房及設備項目之成本,包括其購買價及使該項資產達至其營運狀態及地點以用於其擬定用途之任何直接應佔成本。物業、廠房及設備項目於運作後所產生之支出,包括維修及保養費乃通常於產生時於該期間之損益表內扣除。如符合確認條件,則有關主要查驗之支出乃於資產之賬面值中資本化為重置。倘物業、廠房及設備之重要部分須不時重置,則本集團將確認該等部分為擁有特定使用年期之獨立資產,並將該等資產進行相應折舊。

折舊乃採用直線法於每項物業、廠房及設備項目估計可使用年限內將其成本撇銷至其剩餘價值予以計算。為此目的所使用的主要年率如下:

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in the statement of profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Construction in progress represents a building under construction, which is stated at cost less any impairment losses, and is not depreciated. Cost comprises the direct costs of construction during the period of construction. Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

### Investments in club memberships

The useful lives of club memberships are assessed to be either finite or indefinite. Club memberships with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the club memberships may be impaired. The amortisation period and the amortisation method for club memberships with a finite useful life are reviewed at least at each financial year end.

當一項物業、廠房及設備項目的各部分有不同的可使用年期，該項目的成本按合理基礎在各部分分配，而每部分將作個別折舊。剩餘價值、可使用年期和折舊方法至少於各財政年度末進行檢討和調整(如適合)。

一項物業、廠房及設備項目(包括初步獲確認的任何重要部分)於出售時或預計經其使用或出售而不再產生日後經濟效益時，將被取消確認。於年內被取消確認的資產因其出售或報廢並在損益表被確認的任何收益或虧損乃有關資產的出售所得款項淨額與賬面值的差額。

在建工程指建設中的樓宇，乃按成本減任何減值虧損列賬，且不會予以折舊。成本包括建築期間之直接建築成本。在建工程於完工並投入使用後重新列入物業、廠房及設備之適當類別。

### 會所會籍投資

會所會籍之可使用年期評估為有限或無限。年期有限之會所會籍其後於可使用經濟年期內攤銷，並評估是否有跡象顯示會所會籍可能出現減值。可使用年期有限之會所會籍之攤銷年期及攤銷方法至少於各財政年度末檢討一次。

Club memberships with indefinite useful lives are tested for impairment annually either individually or at the cash-generating unit level. Such club memberships are not amortised. The useful life of a club membership with an indefinite life is reviewed annually to determine whether the indefinite life assessment continues to be supportable. If not, the change in the useful life assessment from indefinite to finite is accounted for on a prospective basis.

#### Investment properties

Investment properties are interests in land and buildings (including the leasehold property held as a right-of-use asset which would otherwise meet the definition of an investment property) held to earn rental income and/or for capital appreciation, rather than for use in the production or supply of goods or services or for administrative purposes; or for sale in the ordinary course of business. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at fair value, which reflects market conditions at the end of the reporting period.

Gains or losses arising from changes in the fair values of investment properties are included in the statement of profit or loss in the year in which they arise.

Any gains or losses on the retirement or disposal of an investment property are recognised in the statement of profit or loss in the year of the retirement or disposal.

無限可使用年期之會所會籍於每年按個別或現金產生單位等級作減值測試。該等會所會籍不予攤銷。具無限年期之會所會籍之可使用年期於每年作評估，以釐定無限可使用年期之評估是否持續可靠。如不可靠，則可使用年期之評估自此由按無限年期更改為有限年期按前瞻基準列賬。

#### 投資物業

投資物業是指在持有以賺取租金收入及／或資本增值而非用作生產、提供貨品或服務、行政用途或在日常業務過程中持作銷售之土地和樓宇（包括持作使用權資產並在其他方面符合投資物業定義之租賃物業）之權益。該等物業初始時按成本（包括交易成本）計量。於初步確認後，該等投資物業於報告期末以反映市況之公平值列賬。

投資物業公平值的變動產生之收益或虧損於其產生當年之損益表中列賬。

投資物業因報廢或出售而產生之任何收益或虧損於報廢或出售當年之損益表中確認。

### Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

### Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

#### (a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

Leasehold land	19 to 38 years
Buildings	3 to 4 years

If ownership of the leased asset transfers to the Group by the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

本集團於合約開始時評估合約是否為租賃或包含租賃。倘合約轉讓於一段時間內控制已確認資產使用的權利以換取代價，則該合約為租賃或包含租賃。

### 本集團作為承租人

本集團對所有租賃採用單一確認及計量方法，惟短期租賃及低價值資產租賃除外。本集團確認作出租賃款項的租賃負債及代表相關資產使用權的使用權資產。

#### (a) 使用權資產

使用權資產於租賃開始日期（即相關資產可供使用的日期）確認。使用權資產按成本減任何累計折舊及任何減值虧損計量，並就租賃負債之任何重新計量作出調整。使用權資產之成本包括已確認租賃負債金額、已產生初始直接成本及於開始日期或之前作出之租賃款項減已收取之任何租賃優惠。使用權資產於資產的租期及估計可使用年期（以較短者為準）內以直線法折舊如下：

##### (b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

##### (b) 租賃負債

租賃負債於租賃開始日期按於租期內作出之租賃款項現值確認。租賃款項包括固定付款 (包括實質固定付款) 減任何應收租賃優惠、取決於某一指數或比率之可變租賃款項及預期根據剩餘價值擔保將支付之金額。租賃款項亦包括本集團合理確定行使購買選擇權之行使價，且倘租期反映了本集團行使選擇權終止租賃，則須就終止租賃支付罰款。並非取決於某一指數或比率之可變租賃款項於觸發付款之事件或狀況出現期間確認為開支。

於計算租賃款項現值時，由於租賃中所隱含之利率不易釐定，本集團於租賃開始日期使用其增量借貸利率。於開始日期後，租賃負債金額會增加，以反映利息增加並因作出的租賃款項而減少。此外，倘出現修訂、租期變動、租賃款項變動 (如因指數或比率變動導致未來租賃款項變動) 或購買相關資產的選擇權評估變動，租賃負債的賬面值將重新計量。

#### (c) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to its short-term leases of buildings (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets to leases of equipment that is considered to be of low value. Lease payments on short-term leases and leases of low-value assets are recognised as an expense on a straight-line basis over the lease term.

#### Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in revenue in the statement of profit or loss due to its operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

Leases that transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee are accounted for as finance leases.

#### (c) 短期租賃及低價值資產的租賃

本集團對其樓宇的短期租賃(即自開始日期起該等租賃租期為12個月或以內且並無包含購買選擇權)應用短期租賃確認豁免。其亦對被視作低價值的設備之租賃應用低價值資產租賃的確認豁免。短期租賃的租賃款項及低價值資產租賃在租期內按直線法確認為開支。

#### 本集團作為出租人

倘本集團作為出租人，其於租賃開始時(或於租賃修訂時)將每一項租賃分類為經營租賃或融資租賃。

倘本集團於租賃中並無轉移一項資產所有權附帶的絕大部分風險及回報，則租賃分類為經營租賃。倘合約包含租賃及非租賃部分，本集團根據相對獨立的售價基準將合約代價分配至各部分。租金收入於租期內按直線法入賬並因其屬經營性質而計入損益表內之收益。協商及安排經營租賃時產生的初始直接成本加至租賃資產的賬面值，並按與租金收入相同的基準在租期內確認。或然租金於其賺取之期間確認為收益。

將一項相關資產所有權附帶的絕大部分風險及回報轉移予承租人的租賃入賬為融資租賃。

#### Investments and other financial assets

##### Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income, and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of accounts receivable that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Accounts receivable that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 in accordance with the policies set out for "Revenue recognition" below.

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

##### 初步確認及計量

財務資產於初步確認時分類為其後按攤銷成本、按公平值計入其他全面收益及按公平值計入損益計量。

於初步確認時，財務資產分類取決於財務資產的合約現金流量特點及本集團管理該等財務資產的業務模式。除並無重大融資成分或本集團已應用不調整重大融資成分影響的可行權宜方法的應收賬項外，本集團初步按其公平值加(倘並非按公平值計入損益的財務資產)交易成本計量財務資產。根據下文「收益確認」所載政策，並無重大融資成分或本集團已應用可行權宜方法的應收賬項按香港財務報告準則第15號釐定的交易價格計量。

為使財務資產按攤銷成本或按公平值計入其他全面收益進行分類及計量，需產生純粹為支付未償還本金及本金利息(「純粹為支付本金及利息」)的現金流量。現金流量並非為純粹為支付本金及利息的財務資產以按公平值計入損益分類及計量，而不論業務模式。

#### Initial recognition and measurement (continued)

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

#### Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

#### Financial assets at amortised cost (debt instruments)

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in the statement of profit or loss when the asset is derecognised, modified or impaired.

#### 初步確認及計量 (續)

本集團管理財務資產的業務模式指其如何管理其財務資產以產生現金流量。業務模式確定現金流量是否來自收取合約現金流量、出售財務資產，或兩者兼有。按攤銷成本分類及計量之財務資產為在業務模式內以持有財務資產以收取合約現金流量為目的的財務資產，而按公平值計入其他全面收益分類及計量的財務資產為持有以收取合約現金流量及銷售為目的在業務模式內持有的財務資產。未於上述業務模式內持有之財務資產按公平值計入損益分類及計量。

#### Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

### Derecognition of financial assets (continued)

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

### Impairment of financial assets

The Group recognises an allowance for expected credit losses (“ECLs”) for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

### General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

### 財務資產減值

本集團就並非按公平值計入損益賬持有的所有債務工具確認預期信貸虧損（「預期信貸虧損」）撥備。預期信貸虧損乃基於根據合約到期的合約現金流量與本集團預期收取並按原始實際利率的相若利率貼現的所有現金流量之間的差額釐定。預期現金流量將包括出售所持抵押品或合約條款所包含的其他信貸升級措施所得的現金流量。

### 一般方法

預期信貸虧損分兩個階段確認。就初步確認以來信貸風險並無大幅增加的信貸敞口而言，會為未來12個月可能發生的違約事件所產生的信貸虧損（12個月預期信貸虧損）計提預期信貸虧損。就初步確認以來信貸風險大幅增加的信貸敞口而言，須就預期於敞口的餘下年期產生的信貸虧損計提虧損撥備，不論違約的時間（全期預期信貸虧損）。

##### General approach (continued)

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information. The Group considers that there has been a significant increase in credit risk when contractual payments are more than 30 days past due.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

於各報告日期，本集團評估金融工具的信貸風險是否自初步確認以來大幅提高。於作出該評估時，本集團比較報告日期金融工具產生的違約風險及於初步確認日期金融工具產生的違約風險，並考慮在毋須付出繁重成本或努力而可獲得合理及支持資料，包括過往及前瞻性資料。倘合約款項逾期超過30日，則本集團認為信貸風險大幅上升。

本集團認為，財務資產於合約付款逾期90日時視作違約。然而，於若干情況下，在並無計及本集團持有的任何信貸升級措施前，本集團亦可於內部或外部資料顯示本集團不大可能悉數收取尚未償還合約金額時將財務資產視作違約。於無法合理預期收回合約現金流量時，則撇銷財務資產。

##### Simplified approach

For accounts receivable that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For accounts receivable that contain a significant financing component, the Group chooses as its accounting policy to adopt the simplified approach in calculating ECLs with policies as described above.

#### Financial liabilities

##### Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as loans and borrowings, other payables as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and other payables, net of directly attributable transaction costs.

The Group's financial liabilities include accounts payable, accrued liabilities, other payables and contract liabilities, bank borrowing, lease liabilities and loans from non-controlling shareholders.

##### 簡化方法

就不包含重大融資組成部分的應收賬項或當本集團使用不調整重大融資組成部分影響的可行權宜方法時，本集團計算預期信貸虧損時應用簡化法。根據簡化法，本集團並無追蹤信貸風險的變化，但於各報告日期根據全期預期信貸虧損確認虧損撥備。本集團已根據過往信貸虧損經驗，建立撥備矩陣，並就債務人及經濟環境的特定前瞻性因素作出調整。

對於包含重大融資組成部分的應收賬項，本集團選擇上文所述政策作為其會計政策，於計算預期信貸虧損時採納簡化方法。

#### 財務負債

##### 初步確認及計量

財務負債於初步確認時可分類為貸款及借貸或其他應付賬項（倘適用）。

所有財務負債初步按公平值確認及倘為貸款及借貸以及其他應付賬項，則扣除直接應佔交易成本。

本集團之財務負債包括應付賬項、應計負債、其他應付賬項及合約負債、銀行借貸、租賃負債及非控股股東貸款。

#### Subsequent measurement

The subsequent measurement of financial liabilities depends on their classification as follows:

#### Financial liabilities at amortised cost (loans and borrowings)

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in the statement of profit or loss.

#### Financial guarantee contracts

Financial guarantee contracts issued by the Group are those contracts that require a payment to be made to reimburse the holder for a loss it incurs because the specified debtor fails to make a payment when due in accordance with the terms of a debt instrument. A financial guarantee contract is recognised initially as a liability at its fair value, adjusted for transaction costs that are directly attributable to the issuance of the guarantee. Subsequent to initial recognition, the Group measures the financial guarantee contracts at the higher of: (i) the ECL allowance determined in accordance with the policy as set out in "Impairment of financial assets"; and (ii) the amount initially recognised less, when appropriate, the cumulative amount of income recognised.

財務負債之其後計量取決於其以下分類：

#### 按攤銷成本計量之財務負債 (貸款及借貸)

於初步確認後，附息貸款及借貸隨後以實際利率法按攤銷成本計量，倘折現之影響並不重大，於該情況下則按成本列賬。當取消確認負債時，收益及虧損以實際利率按攤銷過程於損益表內確認。

計算攤銷成本時會計及收購所產生之任何折現或溢價，以及作為實際利率一部分之費用或成本。實際利率攤銷已計入損益表。

#### 財務擔保合約

本集團所發行的財務擔保合約指因特定債務人未能根據債務工具的條款於到期時付款而須就持有人所招致的損失向其付款以補償持有人的合約。一份財務擔保合約按其公平值並就發出該財務擔保合約直接相關的交易成本進行調整後，初步確認為負債。初步確認後，本集團按以下兩者中的較高者計量財務擔保合約：(i)根據「財務資產減值」所載的政策釐定的預期信貸虧損撥備；及(ii)初步確認的金額減(倘適用)已確認收入的累計金額。

#### Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

#### Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

#### Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the first-in, first-out basis and, in the case of work in progress and finished goods, comprises direct materials, direct labour and an appropriate proportion of overheads. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

#### 取消確認財務負債

當負債責任獲解除或註銷或屆滿時，即取消確認財務負債。

倘現有財務負債被來自同一借方但不同條款之另一筆財務負債替代，或現有負債之條款被大幅修訂，此變動或修訂被視作取消確認原負債並確認新負債，而各賬面值之間之差額則於損益表中確認。

#### 抵銷金融工具

當具現時可強制執行之法定權利抵銷已確認金額及計劃以淨額結算，或同時變賣資產以清償負債，財務資產與財務負債可互相抵銷，並在財務狀況表內以淨額列示。

#### 存貨

存貨按成本與可變現淨值兩者中之較低者列賬。成本乃根據先入先出法計算，就在製品及製成品而言，成本包括直接材料、直接人工及適當比例之經常性費用。可變現淨值以估計售價扣除完成及出售時預期所產生之任何估計成本計算。

### Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in the statement of profit or loss.

### Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

### 撥備

倘因過往事件而產生之現時責任(法律或推定)，且將來極可能需有資源流出以應付有關責任時，則確認撥備，惟責任所涉及之數額必須能可靠地估計。

倘貼現之影響屬重大時，所確認撥備之數額乃為預期須履行有關責任之未來開支於報告期末之現值。因時間流逝而導致所貼現之現值增加之數額，乃計入損益表中。

### 所得稅

所得稅包括即期及遞延稅項。有關損益表外確認項目的所得稅於損益外確認，即於其他全面收益或直接於權益內確認。

即期稅項資產及負債乃根據於報告期末已頒佈或實際上已頒佈的稅率(及稅法)，並考慮本集團經營所在國家的現有詮釋及慣例，按預期可獲稅務當局退回或支付予稅務當局之金額計量。

遞延稅項為就財務申報而言，於報告期末就資產與負債之稅基與彼等賬面值之所有暫時差額，利用負債法作出撥備。

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of taxable temporary differences associated with investments in subsidiaries and associates, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of deductible temporary differences associated with investments in subsidiaries and associates, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

### Shares held under share award scheme

Own equity instruments which are reacquired and held by the Company or the Group (treasury shares) are recognised directly in equity at cost. No gain or loss is recognised in the statement of profit or loss on the purchase, sale, issue or cancellation of the Group's own equity instruments.

遞延稅項資產之賬面值乃於各報告期末進行審閱，並予以相應扣減，直至不可能有足夠應課稅溢利以動用全部或部分遞延稅項資產為止。未確認之遞延稅項資產乃於各報告期末重新評估，並於應課稅溢利足以可收回全部或部分遞延稅項資產時確認。

遞延稅項資產及負債乃根據於報告期末已頒佈或實際上已頒佈的稅率（及稅法），按變現資產或清償負債之期間預期適用之稅率予以計量。

僅當本集團有可合法執行權利可將即期稅項資產與即期稅項負債抵銷，且遞延稅項資產與遞延稅項負債與同一稅務機關對同一應稅實體或於各未來期間預期有大額遞延稅項負債或資產需要結算或收回時，擬按淨額基準結算即期稅項負債及資產或同時變現資產及結算負債之不同稅務實體徵收之所得稅相關，則遞延稅項資產與遞延稅項負債可予抵銷。

### 股份獎勵計劃所持股份

購回及持有本公司或本集團本身股本工具（庫存股份）乃按成本直接於權益中確認。概無於損益表中確認因購買、出售、發行或註銷本集團本身股本工具之收益或虧損。

#### Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the financial statements.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

#### Foreign currencies

These financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

末期股息於股東大會上獲股東批准後確認為負債。建議末期股息披露於財務報表附註。

因本公司組織章程大綱及章程細則授權董事宣派中期股息，故同時建議並宣派中期股息。因此，中期股息在建議並宣派時即時確認為負債。

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related assets, expenses or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipt in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currencies of certain overseas subsidiaries and associates are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into Hong Kong dollars at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into Hong Kong dollars at the exchange rates that approximate to those prevailing at the dates of the transactions. The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in the statement of profit or loss.

For the purpose of the consolidated statement of cash flows, the cash flows of overseas subsidiaries are translated into Hong Kong dollars at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of overseas subsidiaries which arise throughout the year are translated into Hong Kong dollars at the weighted average exchange rates for the year.

#### Revenue recognition

##### Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

#### Sale of footwear products

Revenue from the sale of footwear products is recognised at the point in time when control of the assets is transferred to the customer, generally on delivery of the footwear products.

##### Other income

Rental income is recognised on a time proportion basis over the lease terms.

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Dividend income is recognised when the shareholders' right to receive payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

##### Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

The cost of equity-settled transactions is recognised in employee benefit expense, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to the statement of profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

### Other employee benefits

#### Retirement benefit schemes

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the “MPF Scheme”) under the Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees’ basic salaries and are charged to the statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group’s employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group’s subsidiaries which operate in Vietnam, Cambodia and Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute a certain percentage of their payroll costs to the central pension scheme. The contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension scheme.

#### Termination benefits

Termination benefits are recognised at the earlier of when the Group can no longer withdraw the offer of those benefits and the Group recognises restructuring costs involving the payment of termination benefits.

#### 退休福利計劃

本集團已遵照強制性公積金計劃條例為合資格參與定額供款強制性公積金退休福利計劃(「強積金計劃」)之僱員執行強積金計劃。供款乃按僱員基本薪金某個百分比作出，並於根據強積金計劃之規則應付時自損益表扣除。強積金計劃之資產與本集團之資產分開，由獨立管理之基金持有。本集團之僱主一旦就強積金計劃作出供款，有關供款將悉數歸予該僱員所有。

本集團於越南、柬埔寨及中國內地經營的附屬公司之僱員需要參加地方市政府運作之中央退休金計劃。該等附屬公司須按工資若干百分比向中央退休金計劃作出供款。供款於根據中央退休金計劃規則應付時自損益表扣除。

#### Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, which are not restricted as to use.

### 3. SIGNIFICANT ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

#### Judgements

In the process of applying the Group's accounting policies, management has made the following judgements, apart from those involving estimations, which have the most significant effect on the amounts recognised in the financial statements:

#### 現金及等同現金項目

##### Property lease classification – Group as lessor

The Group has entered into commercial property leases on its investment property portfolio. The Group has determined, based on an evaluation of the terms and conditions of the arrangements, such as the lease terms and constituting a major part of the economic life of the commercial property and the present value of the minimum lease payments not amounting to substantially all the fair value of the commercial property, that it retains substantially all the significant risks and rewards incidental to ownership of these properties which are leased out and accounts for the contracts as operating leases.

##### Classification between investment properties and owner-occupied properties

The Group determines whether a property qualifies as an investment property, and has developed criteria in making that judgement. Investment property is a property held to earn rentals or for capital appreciation or both. Therefore, the Group considers whether a property generates cash flows largely independently of the other assets held by the Group. Some properties comprise a portion that is held to earn rentals or for capital appreciation and another portion that is held for use in the production or supply of goods or services or for administrative purposes. If these portions could be sold separately or leased out separately under a finance lease, the Group accounts for the portions separately. If the portions could not be sold separately, the property is an investment property only if an insignificant portion is held for use in the production or supply of goods or services or for administrative purposes. Judgement is made on an individual property basis to determine whether ancillary services are so significant that a property does not qualify as an investment property.

##### 物業租賃分類—本集團為出租人

本集團已就其投資物業組合訂立商業物業租賃。根據對有關安排條款及條件之評估，如租賃期及構成商業物業之經濟壽命的主要部分且最低租賃付款現值不等於商業物業之絕大部分公平值，本集團已釐定其保留已出租並作為經營租賃入賬為合約的該等物業所有權附帶的絕大部分風險及回報。

##### 投資物業及自置物業兩者間之分類

本集團決定其物業是否屬投資物業，並制定有關判斷標準。投資物業為持作賺取租金收入或資本增值（或上述兩者）之物業。因此，本集團會考慮物業產生的現金流量是否大致上獨立於本集團持有之其他資產。若干物業包含部分持作賺取租金收入或資本升值及部分持作生產，或提供商品或服務，或作行政用途。如該等部分可獨立出售（或獨立以融資租賃形式出租），本集團會將該等部分單獨入賬。倘該等部分不可獨立出售，該物業（僅在物業之極少部分持作生產，或提供商品或服務，或作行政用途之情況下）則列作投資物業。輔助服務是否因重要而使物業不被列為投資物業乃按個別物業基準作出判斷。

#### Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

#### Provision for inventories

The estimation of the inventory provision requires significant management judgement, which includes judgement about the recoverability of the cost of inventories, the nature and condition of inventories, the marketability of finished goods and the future usage of raw materials.

#### Provision for expected credit losses on accounts receivable

The Group uses a provision matrix to calculate ECLs for accounts receivable. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns (i.e., by customer type). The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. At each reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates, forecast economic conditions and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forecast economic conditions. The Group's historical credit loss experience and forecast of economic conditions may also not be representative of a customer's actual default in the future. The information about the ECLs on the Group's accounts receivable is disclosed in note 18 to the financial statements.

本集團使用撥備矩陣計算應收賬項的預期信貸虧損。撥備率乃基於具有類似虧損模式（即按客戶類型劃分）的不同客戶分部組合逾期日數釐定。撥備矩陣初步基於本集團過往觀察所得違約率而釐定。本集團將調整矩陣，藉以按前瞻性資料調整過往信貸虧損經驗。於各報告日期，過往觀察所得違約率已予更新，並分析前瞻性估計變動。

對過往觀察所得違約率、預測經濟狀況及預期信貸虧損之間的關連性進行的評估屬重大估計。預期信貸虧損金額對環境及預測經濟狀況的變化相當敏感。本集團過往信貸虧損經驗及預測經濟狀況亦未必能代表客戶日後的實際違約情況。有關本集團應收賬項預期信貸虧損的資料已於財務報表附註18披露。

##### Estimation of fair value of investment properties

The best evidence of fair value is current prices in an active market for properties in the same location and condition and subject to similar lease and other contracts. In the absence of such information, the Group considers information from a variety of sources. The valuation of the investment properties at fair value was highly dependent on estimates and assumptions, such as those relating to the rental value, rental growth rate, market yield, market knowledge and historical transactions.

Further details, including the key assumptions used for fair value measurement, a sensitivity analysis and the carrying amount of investment properties, are given in note 15 to the financial statements.

##### Impairment of non-financial assets

The Group assesses whether there are any indicators of impairment for all non-financial assets (including the right-of-use assets) at the end of each reporting period. Indefinite life intangible assets are tested for impairment annually and at other times when such an indicator exists. Other non-financial assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment exists when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value in use. The calculation of the fair value less costs of disposal is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposing of the asset. When value in use calculations are undertaken, management must estimate the expected future cash flows from the asset or cash-generating unit and choose a suitable discount rate in order to calculate the present value of those cash flows. Further details, including the key assumptions used for the impairment assessment, are given in note 13 to the financial statements.

##### Tax

The Group is subject to income taxes in several tax jurisdictions. Due to the complexity of local and international tax legislation, judgements have to be made by management on the tax treatment on transactions in advance of the ultimate tax determination being certain. Where the amount of tax payable or recoverable is uncertain, the Group estimates provision based on management's judgement of the probable amount of the liability, or expected amounts recoverable, which may be materially different from the estimated provision. Further details are included in note 10 to the financial statements.

### 4. OPERATING SEGMENT INFORMATION

For management purposes, the Group is organised into business units based on their business activities and has two reportable operating segments as follows:

- (a) manufacturing and sale of footwear products; and
- (b) property investment.

Pursuant to the Corporate Income Tax Law of the People's Republic of China ("PRC"), a 10% withholding tax is levied on dividends declared to foreign investors from the foreign investment enterprises established in Mainland China. The requirement is effective from 1 January 2008 and applies to earnings after 31 December 2007. A lower withholding tax rate may be applied if there is a tax treaty between Mainland China and the jurisdiction of the foreign investors. For the Group, the applicable rates are 5% and 10%. The Group is therefore liable for withholding taxes on dividends distributed by those subsidiaries established in Mainland China in respect of earnings generated.

In addition, pursuant to Cambodian withholding tax regulations, a 14% withholding tax is levied on dividends declared to non-resident shareholders. Therefore, the Group is liable for withholding taxes on dividends distributed by those subsidiaries established in Cambodia in respect of earnings generated.

At 31 March 2023, no deferred tax has been recognised for withholding taxes that would be payable on the unremitted earnings that are subject to withholding taxes of the Group's subsidiaries established in Mainland China and Cambodia. In the opinion of the directors, it is not probable that these subsidiaries will distribute such earnings in the foreseeable future. The aggregate amount of temporary differences associated with undistributed profit of Mainland China and Cambodia subsidiaries for which deferred tax liabilities have not been recognised totalled approximately HK\$49,570,000 (2022: HK\$32,239,000) at 31 March 2023.

The Group has estimated tax losses of approximately HK\$72,372,000 (2022: HK\$81,718,000) arising in Hong Kong that are available indefinitely for offsetting against future taxable profits of the companies in which the losses arose. Deferred tax assets have not been recognised in respect of these losses as they have arisen in subsidiaries that have been loss-making for some time and it is considered not probable that the Group can utilise these losses in the foreseeable future.

#### Credit risk

The Group trades only with recognised and creditworthy customers. It is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. In addition, receivable balances are monitored on an ongoing basis and on an individual basis. Each of the customers has been attached with a trading limit and any excess to the limit must be approved by the general manager of the operation unit. Under the tight control of the credit term and detailed assessment of the creditworthiness of individual customers, the Group's exposure to bad debts is maintained as minimal.

The credit risk of the Group's other financial assets, which comprise cash and cash equivalents, deposits, other receivables and an amount due from an associate, arises from default of the counterparty, with a maximum exposure equal to the carrying amounts of these instruments.

At the end of the reporting period, the Group had certain concentrations of credit risk as 50% (2022: 50%) and 96% (2022: 66%) of the Group's accounts receivable were due from the Group's largest customer and five largest customers, respectively.
