The Board is pleased to announce that at the meeting of the Board held on 18th July, 2023, having considered the financial and cash flow position of the Group as well as various possible investment opportunities available, the Board has resolved to declare a special dividend (the “**Special Dividend**”) of HK\$0.96 per ordinary share of the Company. The Special Dividend is expected to be paid on or about Thursday, 31st August, 2023 in cash to the Shareholders whose names appear on the register of members of the Company as at Thursday, 17th August, 2023.

To determine entitlements to the Special Dividend, the register of members of the Company will be closed from Tuesday, 15th August, 2023 to Thursday, 17th August, 2023 (both days inclusive), during which period no transfer of shares of the Company will be registered. The record date for the Special Dividend is Thursday, 17th August, 2023. In order to qualify for the Special Dividend, all properly completed transfer forms accompanied by the relevant share certificates must be lodged with the Company’s branch registrar and transfer office in Hong Kong, Computershare Hong Kong Investor Services Limited at Shops 1712-16, 17th Floor, Hopewell Centre, 183 Queen’s Road East, Wan Chai, Hong Kong for registration no later than 4:30 p.m., Hong Kong time, on Monday, 14th August, 2023.
