Capital reorganisation</p> <p>(i) Share Consolidation : Consolidation of every forty (40) issued and unissued Existing Shares of par value of HK\$0.01 each into one (1) Consolidated Share of par value of HK\$0.40 each in the share capital of the Company.</p> <p>(ii) Capital Reduction : Immediately upon the Share Consolidation becoming effective, reduction of the par value of each issued Consolidated Share from HK\$0.40 to HK\$0.01 by (a) eliminating any fraction of a Consolidated Share in the issued share capital of the Company arising from the Share Consolidation in order to round down the total number of the Consolidated Shares to a whole number; and (b) cancelling HK\$0.39 of the paid-up capital of the Company on each issued Consolidated Share so that each issued New Share treated as one (1) fully paid-up share of par value of HK\$0.01 each in the share capital of the Company immediately following the Capital Reduction and the credit arising from the Capital Reduction transferred to the contributed surplus account of the Company.</p> <p>(iii) Share Subdivision : Immediately following the Share Consolidation and the Capital Reduction becoming effective, subdivision of each authorised but unissued Consolidated Share (including those authorised unissued Consolidated Shares arising from the Capital Reduction) into forty (40) authorised but unissued New Shares of par value of HK\$0.01 each.</p> <p>The Capital Reorganisation was approved pursuant to passing of a special resolution at the special general meeting of the Company held on 17 July 2023 and became effective on 19 July 2023.</p> <p>Date of changes 19 July 2023</p> | -2,072,776,560 | 97.5 % | | | % |

Notes to Section I:

- *“issue price per share” should be construed as “redemption price per share”.*

8. *The closing balance date is the date of the last relevant event being disclosed.*

9. *Items (i) to (viii) are suggested forms of confirmation which may be amended to meet individual cases.*

10. *“Identical” means in this context:*

- *the securities are of the same nominal value with the same amount called up or paid up;*
- *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
- *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*

11. *SEHK refers to Stock Exchange of Hong Kong.*
