PROFIT ALERT FOR THE FIRST HALF OF 2023

The Board hereby informs the shareholders of the Company and potential investors that, based on the preliminary assessment by the Board of the internal unaudited consolidated management accounts of the Group and information on market conditions currently available, as compared to a net profit of approximately RMB460 million for the six months ended 30 June 2022 as disclosed in the interim results announcement for the year 2022, the Group is expected to record a net profit of approximately RMB930 million to approximately RMB1,030 million for the six months ended 30 June 2023, which is mainly attributable to a year-on year increase in volume processed by the system due to the recovery of domestic and international passenger traffic.

The Board hereby reminds investors that the Company is still in the process of finalizing the Company's interim financial results for the year 2023. If there is any change, the Company will perform information disclosure obligations according to relevant requirements under the Listing Rules in due course (if necessary). The information contained in this announcement is only preliminary assessment results based on the internal management records of the Company and with reference to the information currently available, which has not been reviewed or audited by the auditors of the Company and the audit and risk management committee (supervisory committee) of the Company and may be subject to finalization and necessary adjustments. The monthly operating data and relevant financial data disclosed by the Company only serve as preliminary and periodical data for investors' reference, which may differ from the figures to be disclosed in the unaudited consolidated financial statements to be published by the Company on a semiannual basis. The actual financial results of the Company for the six months ended 30 June 2023, which may differ from those disclosed in this announcement due to changes in the market conditions during such period, will be disclosed in the interim results announcement of the Company for the six months ended 30 June 2023 which is expected to be published by the end of August 2023.
