The board (the "Board") of directors (the "Directors") of the Company wishes to inform the shareholders of the Company (the "Shareholders") and potential investors that, based on a preliminary review on the unaudited consolidated management accounts of the Group for the six months ended 30 June 2023 ("1H2023") and other relative information currently available to the Board, the Group is expected to record an increase in the net profit attributable to owners of the Company for 1H2023 in the range of approximately 65% to 78% as compared to that for the corresponding period in 2022.

The Board considers that such increase in profit for 1H2023 is mainly due to the combined effects of:

- (i) increase in revenue generated from the sale of automotive moulds;
- (ii) increase in gross profit due to the decrease in the amount of inventory provision as a result of the decrease in the amount of long aged work-in-process; and
- (iii) increase in general and administrative expenses and income tax expenses.

The Company is still in the process of finalizing the interim results of the Group for 1H2023. The information contained in this announcement is only based on a preliminary review of the consolidated management accounts of the Company and has not been reviewed or audited by the auditors of the Company. The actual results of the Group for 1H2023 may differ from those disclosed in this announcement.
