Instruction in relation to future Corporate Communications

If we do not receive the reply, we will send the printed Chinese version of future Corporate Communications to all Hong Kong Shareholders who are natural persons with a Chinese name using a Hong Kong address, and the printed English version to all overseas Shareholders and all Hong Kong Shareholders (other than natural persons with a Chinese name) using a Hong Kong address. Whether a Shareholder is a Hong Kong or an overseas Shareholder will be determined by the address of that Shareholder appearing in the register of members of the Company maintained by the Company’s Branch Share Registrar.

If you choose electronic means, we will send you an e-mail notification of the release of the relevant Corporate Communications on the Company’s website on the day such corporate communication(s) is/are sent to Shareholders. Alternatively, if the electronic means is chosen, but you have not provided your e-mail address, printed Corporate Communications will be sent out in accordance with the arrangements described in the previous paragraph.

After your election, you may choose to change your choice of language and/or means of receipt at any time, free of charge, by completing and returning the Change Request Form to the Company’s Branch Share Registrar by post or by email to “buildking240-ecom@hk.tricorglobal.com”. A copy of the Change Request Form will be sent to you together with future Corporate Communications.

Both the English and Chinese versions of future Corporate Communications will be available from the Company’s Branch Share Registrar (Tricor Progressive Limited of 17/F., Far East Finance Centre, 16 Harcourt Road, Hong Kong) upon request, and the same will also be available on the Company’s website (<http://www.buildking.hk>) after they have been despatched.
