**ANNOUNCEMENT ON UNAUDITED OPERATING DATA  
FOR THE SECOND QUARTER OF  
THE THREE MONTHS ENDED 30 JUNE 2023 AND  
THE HALF YEAR ENDED 30 JUNE 2023**

This announcement is voluntarily made by Dynagreen Environmental Protection Group Co., Ltd.\* (the “**Company**”, together with its subsidiaries, the “**Group**”).

The board of directors (the “**Board**”) of the Company is pleased to announce that the unaudited waste input volume, electricity generation volume, on-grid electricity volume and steam supply volume of the Group amounted to 3,304,600 tons, 1,156,980,600 kWh, 954,956,700 kWh and 94,100 tons respectively in the second quarter of the three months ended 30 June 2023. For the half year ended 30 June 2023, the unaudited accumulated waste input volume of the Group amounted to 6,297,800 tons, representing a year-on-year increase of 14.60%; the accumulated electricity generation volume was 2,214,258,200 kWh, representing a year-on-year increase of 7.88%; the accumulated on-grid electricity volume was 1,835,203,800 kWh, representing a year-on-year increase of 8.73%; and the accumulated volume of steam supply amounted to 195,100 tons, representing a year-on-year increase of 39.65%.
