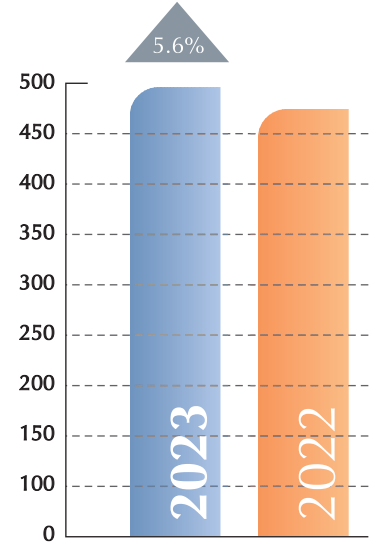

Chairman's Statement 主席報告書

Dear Shareholders,

On the behalf of the board of the directors of the Company, I am pleased to present to shareholders of the Company the review of our annual results for the year ended 31 March 2023 and our prospect.

It has been exceedingly difficult to avoid discussing the ever-changing global political and financial landscape, which can certainly impact our business in Hong Kong in our board meetings. One of the main factors that contributed to the decline of Hong Kong's economic performance last year was China's strict policy to eliminate COVID-19, which disrupted trade and travel. Another factor was the Russian-Ukraine conflict that has affected the global economy through several channels, including financial sanctions, commodities prices, and supply-chain disruptions.

It has contributed to a drop in projected global economic growth. The conflict has also caused energy and food prices to soar, which has led to inflationary pressure that, in turn, made leading jurisdictions tighten their fiscal and monetary policies with rate hikes to curb inflation. These external factors impact global production, trade, investment, and employment growth. There is no sign of any improvement in these parameters any time soon.

Hong Kong's economy suffered a 3.5% contraction last year. China's economy expanded by just 3% in 2022, slightly below the government's forecasts of 3.2% because of the "Dynamic Zero COVID-19" policy.

Hong Kong's economy showed signs of recovery in the first quarter of 2023, thanks to the strong rebound of inbound tourism and domestic consumption. According to the Trade Development Council's June 2023 report, the real Gross Domestic Product grew by 2.7% in real terms from a year earlier, ending four quarters of contraction in 2022. The Government forecasts economic growth of 3.5% to 5.5% in real terms for 2023. Meanwhile, China's economy also registered a robust growth of 4.5% in the first quarter of 2023 year on year at a constant price, marking highest growth since the first quarter of last year. Hong Kong and China have benefited from the end of COVID restrictions and the resumption of regular travel and business activities.

各位股東：

本人欣然代表本公司董事會向本公司股東提呈截至二零二三年三月三十一日止年度之全年業績回顧及未來展望。

在我們的董事會會議上，我們很難不去討論瞬息萬變的全球政治及金融格局，其變化無疑會對我們的香港業務造成影響。中國消除COVID-19的嚴格政策阻斷了貿易與差旅，乃導致去年香港經濟表現衰退的一大主要因素。另一因素為俄烏衝突，其通過金融制裁、大宗商品價格及供應鏈中斷等途徑影響全球經濟。

俄烏衝突促成全球經濟預期增長下調，能源及食品價格飆升，繼而引發通脹壓力。故此，主要司法權區透過加息來收緊其財政及貨幣政策，以遏制通貨膨脹。此等外部因素對全球生產、貿易、投資及就業增長均造成影響，且於短期內並無任何好轉跡象。

香港經濟去年收縮3.5%。由於實行「COVID-19動態清零」政策，二零二二年中國經濟僅增長3%，略低於政府預測的3.2%。

由於入境旅遊和國內消費強勁反彈，香港經濟在二零二三第一季度顯示復甦跡象。根據貿易發展局二零二三年六月的報告，實際本地生產總值按年實質增長2.7%，結束了二零二二年全年的萎縮態勢。政府預測二零二三年實際經濟增長率為3.5%至5.5%。同時，中國經濟在二零二三年第一季度按固定價格同比強勁增長4.5%，創自去年第一季度以來的最高增長。COVID限制措施的結束、正常差旅及業務活動的恢復使香港及中國獲益頗多。



Chairman's Statement 主席報告書

It is too early to be optimistic, as both economies are still recovering from the pandemic and will have to deal with external economic challenges in the year ahead. China's economic problems include slowing growth in investment and exports, high debt, trade tensions, stabilising the real estate sector, inflation, international and regional geopolitical conflicts, and demographic changes. These factors create uncertainty for Hong Kong's annual economic growth as it relies on China's economic performance, anything that happens in China would directly impact Hong Kong's economy, and the continuing high-interest rates would dampen the investment and real estate market this year.

Regarding Hong Kong's challenge, the HKSAR government is committed to implementing the 2022 Policy Address unveiled by the Chief Executive on 21 June 2023, some of the highlights of the Policy Address include exhibiting effort in creating more land for property development, enhancing the competitiveness of Hong Kong as an international financial and innovation centre, dovetailing with national strategies to develop a strong impetus for growth, and earnestly addressing people's concerns and difficulties in daily life. The HKSAR government believes these policy initiatives will help chart a brighter tomorrow for Hong Kong under the "One Country, Two Systems" principle.

The "Northern Metropolis Development Strategy" is another government's crucial initiative to promote the synergy and collaboration between Hong Kong, Shenzhen, and other cities in the Guangdong-Hong Kong-Macao Greater Bay Area. By enhancing the connectivity and complementarity of these cities, the strategy will create more opportunities for innovation, trade, and social development.

To expand the innovative industry in Hong Kong, the HKSAR government has launched Top Talent Pass Scheme (TTPS) that introduced in October 2022 aims to entice talents from various fields to pursue their careers in Hong Kong. The TTPS offers a two-year visa to eligible applicants who can explore employment opportunities or start their businesses in Hong Kong. Some of the TTPS's benefits include developing green and sustainable finance, attracting mainland China and overseas information technology enterprises to the Hong Kong-Shenzhen Innovation and Technology Park, etc.

In addition, the HKSAR government introduced a sector-specific Labour Importation Scheme for the constructions and transport sectors and a Supplementary Labour Scheme to address acute manpower shortages across various sectors.

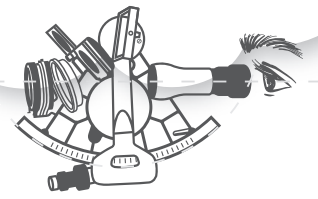
鑒於中港兩地經濟仍在從疫情中復甦，加之要應對來年外部經濟挑戰，現在持樂觀態度為時過早。中國經濟存在投資出口增長緩慢、高負債、貿易緊張、穩定房地產業、通脹、國際及地區地緣政治衝突以及人口結構變化等問題。該等因素為香港的年度經濟增長帶來不確定性，此乃由於香港依賴中國的經濟表現，中國的任何發展均會直接影響香港經濟，而持續的高利率環境將打壓今年的投資及房地產市場。

就香港所面臨的挑戰，香港特區政府致力落實行政長官於二零二三年六月二十一日發佈的二零二二年施政報告，施政報告的部分亮點包括努力創造更多的土地以供物業發展、提升香港作為國際金融及創新中心的競爭力、配合國家戰略發展強勁增長動力點及切實解決民生關切及困難。香港特區政府相信，此等政策舉措將在「一國兩制」方針下為香港創造更美好的明天。

《北部都會區發展策略》是政府推動香港、深圳與粵港澳大灣區其他城市間協同合作的又一重大舉措，通過加強該等城市的互聯互補性，為創新、貿易及社會發展創造更多機遇。

為拓展香港的創新產業，香港特區政府於二零二二年十月推出高端人才通行證計劃(TTPS)，旨在吸引各領域的人才來港發展。TTPS向可於香港尋求就業機會或開展業務的合資格申請人提供兩年期簽證。TTPS可帶來若干益處，包括發展綠色及可持續金融、吸引中國內地及海外資訊科技企業入駐港深創新及科技園等。

此外，香港特區政府推出針對建築業及運輸業的特定行業勞工輸入計劃及補充勞工計劃，以解決各行業嚴重的人力短缺問題。



A high-interest rate environment will threaten the operation of small businesses due to higher borrowing costs, weaken the consumer confidence index, reducing investment and retail. Since Hong Kong faces the abovementioned factors, this year will be challenging for Hong Kong businesses.

The right issue in the year benefited our Group, enabling us to strengthen our financial position in a high-interest rate environment. This resulted in lower finance costs for the Group. Despite the challenging market environment in 2022, our revenue for the financial year ended on 31 March 2023 was marginally more decreased by 8.1% compared with last financial year.

The Hong Kong housing market is still in a state of recovery from the pre-pandemic level; it is expected that with the opening of the China-Hong Kong border and the arrival of top talents from China and overseas, it would generate more demand for residential units. However, the current high-interest rate environment is expected to dampen home buyers' sentiment and slow down the market.

As there are still some uncertainties and risks for the above reasons, Hong Kong's real estate market outlook for 2023 and ours are cautiously optimistic.

The ever-changing adverse market environment posed many challenges we could not control, but we had successfully adapted to them. Our flexibility has enabled us to operate optimally in dynamic business conditions. Therefore, we will monitor market trends, leverage our strengths, and revise our strategies accordingly. The Group will remain alert to the changes in the business environment and strive to enhance its operational efficiency to ensure sustainability.

Lastly, on behalf of the Board, I would like to express my sincere gratitude to all our staff members for their contribution and devotion. I would also like convey my heartfelt appreciation to our consumers and all business associates for the continued trust and support.

由於借貸成本高企，高利率環境將威脅小型企業的營運，削弱消費者信心指數，從而減少投資及零售。由於香港面臨上述因素，今年對香港企業而言將是充滿挑戰的一年。

本集團因本年進行的供股而受益，在高利率的環境下得以強化我們的財務狀況，從而降低本集團的融資成本。儘管二零二二年的市場環境充滿挑戰，但我們於截至二零二三年三月三十一日止財政年度之收益較上一財政年度小幅下降8.1%。

香港住房市場仍處於疫情前水平的恢復階段，預期隨著中港邊境的開放以及中國及海外高端人才的到來，將產生更多住房需求。然而，當前的高利率環境預計將抑制購房者的情緒，拖慢市場發展步伐。

由於上述原因，香港房地產市場仍存在若干不確定性及風險，我們對其二零二三年的前景及我們自身的前景均持審慎樂觀態度。

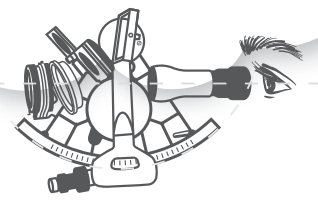

Management Discussion and Analysis 管理層討論與分析

BUSINESS REVIEW

The principal activity of the Company is investment holding. Its subsidiaries are principally engaged in importing, wholesale, retailing and installing architectural builders' hardware, bathroom, kitchen collections and furniture and providing interior design services, project and contract management in Hong Kong and the People's Republic of China (the "PRC").

A business review of the Group and an analysis of the Group's performance using financial key performance indicators during the year are provided in the Management Discussion and Analysis. In addition, discussions on the Group's environmental policies and implementation and an account of the Group's key relationships with its employees, customers, suppliers and others that have a significant impact on the Group and on which the Group's success depends are provided in the Environmental, Social and Governance Report of the Annual Report 2022/23.

Details of the Company's compliance with the code provisions in Appendix 14 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") are provided in the Corporate Governance Report of the Annual Report 2022/23. Except the code provision D.2.5 of Appendix 14 of the Listing Rules, during the year ended 31 March 2023, the Company has complied with the requirements under the Listing Rules, the Hong Kong Companies Ordinance (Cap. 622), the Securities and Futures Ordinance and the Cayman Islands Companies Act.

For many years in Hong Kong, businessmen have always been able to focus on commercial priorities and not worry too much about political developments. However, much more than before, it is challenging to avoid geopolitical issues in our board meetings when formulating any future business plans.

The Russian-Ukraine conflict has seriously affected the global economies, especially commodities and agriculture sectors, causing high food and energy prices and combining the United States (the US), the United Kingdom (UK) and Europe (EU) sanctions against Russia, creating inflationary pressure. It, in turn, affects the US monetary policy by increasing rates steadily over a year to curb inflation. The Federal Reserve (the US Fed), the European Central Bank and central banks in other developed countries have continued to raise interest rates in 2023, but at a slower pace than last year, which saw the most aggressive monetary tightening in a decade and the high-interest rate is expected to remain at the similar level this year. Global liquidity has contracted, and capital has flowed out of the emerging markets. As a result, Hong Kong's financial market has been affected.

業務回顧

本公司的主要業務為投資控股。其附屬公司主要於香港及中華人民共和國（「中國」）從事進口、批發、零售及安裝建築五金、衛浴、廚房設備及傢俬，以及提供室內設計服務、項目及合約管理。

本集團的業務回顧及使用財務關鍵表現指標對本集團於本年度表現的分析，已載於管理層討論與分析。此外，本集團環境政策及實施情況的討論、有關本集團與其僱員、客戶、供應商及對本集團有重大影響且關係本集團成功的其他人士的重要關係的說明，則載於二零二二／二三年年報環境、社會及管治報告內。

本公司遵守香港聯合交易所有限公司證券上市規則（「上市規則」）附錄十四載列之守則條文之詳情載於二零二二／二三年年報企業管治報告內。除上市規則附錄十四之守則條文D.2.5外，截至二零二三年三月三十一日止年度，本公司遵守上市規則、香港公司條例（第622章）、證券及期貨條例以及開曼群島公司法之規定。

香港多年以來，商界人士總是能夠專注於商業優先事項，而不太過多擔憂政治發展。然而，在我們的董事會會議上制定任何未來的商業計劃時，要避免地緣政治問題與以往相比更具挑戰性。

俄烏衝突嚴重影響了全球經濟，尤其是大宗商品和農業部門，引致食品和能源價格高企，加上美國、英國和歐盟對俄羅斯的制裁，造成通脹壓力。故此，美國貨幣政策亦受到影響從而而在一年內穩步提高利率以壓抑通貨膨脹。美聯儲、歐洲央行及其他發達國家的央行在二零二三年持續加息，但加息步伐低於去年，去年乃近十年來最激進的貨幣緊縮，預計今年的高利率將保持在相似水平。全球流動性收縮，資本從新興市場流出。因此，香港金融市場亦受到影響。

BUSINESS REVIEW (CONT'D)

According to the World Economic Situation and Prospects issued by the United Nations (UN) Department of Economic and Social Affairs Economic Analysis on 16 May 2023, it suggested that “as of mid-2023, Global trade remains under pressure due to geopolitical tensions, weakening global demand and tighter monetary and fiscal policies. Global trade volume in goods and services is forecast to grow by 2.3 per cent in 2023, well below the pre-pandemic trend.” The relatively weak Global trade performance suggested that a global slowdown continued to pose challenges to the Global economic growth outlook.

Hong Kong’s correlation with Russia in terms of direct trade is relatively low. On 13 March 2022, Hong Kong Financial Secretary Paul Chan assessed that the overall risks of the conflict between Ukraine and Russia in Hong Kong are manageable. Still, Hong Kong remains “highly vigilant” for any possible impact on financial markets. “Ukraine accounted for 0.05% of Hong Kong’s goods exports last year, while Russia made up 0.78%.” Therefore, the impact of the Russian-Ukraine conflict on Hong Kong’s energy and agricultural product supply is limited.

Last year, the global economy softened due to the continued impact of tightening monetary policy and the Russian-Ukraine conflict. Hong Kong has to raise its rates simultaneously, which means higher borrowing costs for the Government, corporations and households. Therefore, Hong Kong has also faced risks from high inflation and the aggressive monetary tightening in advanced economies with higher borrowing costs and a pessimistic economic outlook hitting asset prices.

As a result of PRC’s “Dynamic Zero COVID-19” policy aimed to keep cases as close to Zero as possible, the Chinese economy shrank 4.2 per cent year on year in the fourth quarter of 2022, marking a fourth consecutive quarter of contraction. The full-year figure for 2022 was worse than government forecasts of a 3.2 per cent decline. PRC’s economy expanded 4.5 per cent in the first quarter of the 2023 year on year at a constant price, marking the highest growth since the first quarter of last year mainly because of the ending of COVID restrictions end of last year, indicating that PRC’s economic recovery is appropriately on track.

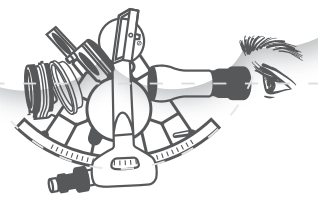
業務回顧(續)

根據聯合國經濟和社會事務部經濟分析部二零二三年五月十六日發佈的《世界經濟形勢與展望》，「截至二零二三年年中，由於地緣政治緊張、全球需求疲軟以及貨幣及財政政策收縮，全球貿易仍然面臨壓力。預計二零二三年全球商品和服務貿易量將增長2.3%，遠低於疫情前的趨勢。」環球貿易表現相對疲軟預示全球經濟放緩繼續對全球經濟增長前景構成挑戰。

在直接貿易方面，香港與俄羅斯的關聯性較低。於二零二二年三月十三日，香港財政司司長陳茂波評估，俄烏衝突對香港造成的整體風險屬可控。儘管如此，香港仍對金融市場可能受到的任何影響保持「高度警惕」。「烏克蘭去年佔香港貨物出口的0.05%，而俄羅斯則佔0.78%。」因此，俄烏衝突對香港能源及農產品供應的影響有限。

去年，由於緊縮貨幣政策及俄烏衝突的持續影響，全球經濟走軟。香港不得不跟隨外圍加息，這意味著政府、企業和家庭的借貸成本提高。因此，香港亦面臨高通脹和發達經濟體積極收緊貨幣政策、借貸成本上升和悲觀的經濟前景打擊資產價格的風險。

由於中國旨在使病例盡可能接近於零的「COVID-19 動態清零」政策，中國經濟在二零二二年第四季度同比收縮4.2%，此為連續第四個季度收縮。二零二二年的全年數字比政府預測的下降3.2%更差。中國經濟在二零二三年第一季度按固定價格同比增長4.5%，創自去年第一季度以來的最高增長，這乃主要由於去年底COVID限制措施的結束，其表明中國經濟正在復甦。



BUSINESS REVIEW (CONT'D)

However, the Chinese economy, which has been the primary engine of regional and global growth for decades, is expected to slow considerably in the face of new challenges such as corporate debt climbing to pre-pandemic, continuing tax cuts, high unfavourable demographics, slowing down of productivity, the trade disputes between PRC and other jurisdictions will likely dampen credit and investment growth in the future.

More importantly, the impact of the US restricting the export of sensitive technology to PRC in the last quarter of last year, specifically regarding advanced computing, supercomputing, semiconductor capabilities, and artificial intelligence, on its economic performance has yet to be assessed.

Hong Kong's economic growth has been very dependent on the Mainland, so the slowdown of PRC's economy due to the pandemic was a primary contributing factor to the poor financial performance last year, much less the interest hike in response to the US Fed's monetary policy; US-China trade dispute and the contraction of trade volume due to the Russian-Ukraine conflict, Hong Kong's economy suffered a 3.5 per cent contraction last year.

According to the Trade Development Council's June 2023 report, Hong Kong's Gross Domestic Product increased by 2.7% in real terms from a year earlier. It is mainly due to the strong recovery of inbound tourism and domestic demand as the value of retail sales, in nominal terms, was provisionally estimated to have increased by 19.9% for the first four months of 2023 over the same period in 2022. The Government forecasts economic growth of 3.5% to 5.5% in real terms for 2023.

Economic growth turnaround indicated an end to a recession after four consecutive quarters of contraction last year. However, Hong Kong is also facing new challenges: the uncertainty of the economic performance of PRC due to geopolitical conflict, high-interest rates, shortage of workers across the trades, the relatively poor performance of export trade due to lower demands of goods from the leading economies as a result of high-interest rates and inflation pressure.

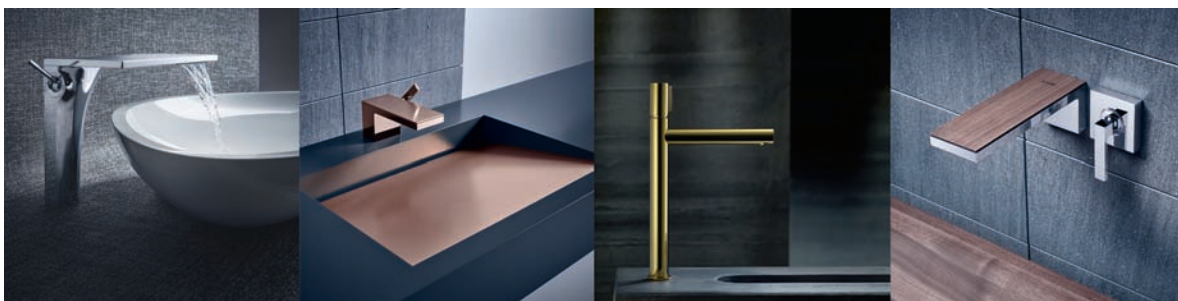
然而，幾十年來一直是地區和全球增長主要引擎的中國經濟，將在面臨各種新挑戰時大幅放緩，例如企業債務攀升至疫情前水平、持續減稅、高度不利的人口統計數據、生產力放緩，中國對外的貿易爭端將可能會抑制未來的信貸和投資增長。

更重要的是，美國去年最後一個季度限制向中國出口敏感技術，特別是有關先進計算、超級計算、半導體產能和人工智能方面，對其經濟表現的影響尚待評估。

香港經濟增長一直非常依賴內地，故中國經濟因疫情放緩為去年財務表現不佳的主要因素，加上應對美聯儲貨幣政策的加息；中美貿易爭端和俄烏衝突導致貿易額萎縮，香港經濟去年收縮3.5%。

根據貿易發展局二零二三年六月的報告，香港本地生產總值按年實質增長2.7%。主要是由於入境旅遊和內需強勁復甦，初步估計二零二三年首四個月的名義零售額較二零二二年同期上升19.9%。政府預測二零二三年實際經濟增長率為3.5%至5.5%。

經濟增長好轉表明經濟衰退在去年連續四個季度收縮後結束。然而，香港亦面臨新的挑戰：地緣政治衝突導致中國經濟表現的不確定性、高利率、各行各業工人短缺，高利率及通脹壓力導致主要經濟體對貨物的需求減少，導致出口貿易表現相對較弱。

Hong Kong's residential price dropped by about 15% due to high-interest rates last year, but it rebounded by 5% in the first quarter of this year; with the reopening of the city's border and the end of the "Dynamic Zero COVID-19" policy, and a relatively stable interest rate, it was still 10% lower than those a year ago. The new home buyers from Hong Kong and PRC are expected to create more demand for residential housing, and the price will remain at this level for this year.

There is slightly decline in our revenue for the financial year ended on 31 March 2023, when compared with year 2021/22, which impacted by the general economic and market conditions in Hong Kong and mainland China. However, despite these challenges, our group would continue to capitalise our experience, work hard to maintain and strength our working relationship in Hong Kong & PRC and co-operation with reputable property developers.

Revenue by business segment

For the year ended 31 March 2023, the Group's total turnover was HK\$454.8 million, representing a decrease of 8.1% as compared with the previous year.

香港住宅價格去年受高利率影響下跌約15%，今年首季反彈了5%；隨著城市邊界的重新開放和「COVID-19動態清零」政策的結束，以及相對穩定的利率，其乃較一年前低10%。預計來自香港和中國的新購房者對住宅創造更多需求，今年的住宅價格將維持在該水平。

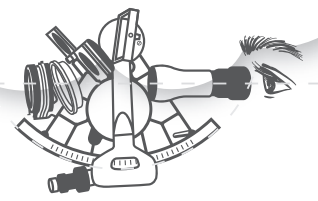

Revenue from the architectural builders' hardware, bathroom collections and others segment decreased by 13.2% to HK\$314.6 million (2022: HK\$362.3 million) as compared to the previous year. During the year, we supplied for projects such as KT Marina 1, High Park, Skycity, Cullinan Sky.

Revenue from the kitchen collection and furniture segment increased by 5.9% to HK\$140.2 million (2022: HK\$132.3 million) as compared to the previous year. During the year, we supplied for projects such as The Southland.

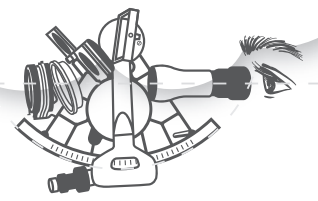
The overall gross profit of the Group amounted to HK\$180.6 million (2022: HK\$183.5 million), representing an decrease of 1.6% from the previous year. The overall gross profit margin slightly increased to 39.7% from 37.1%.

本集團之整體毛利為180.6百萬港元(二零二二年:183.5百萬港元),較去年減少1.6%。整體毛利率由37.1%輕微增長至39.7%。

The Group's operating profit was HK\$18.3 million (2022: HK\$19.2 million), representing an decrease of 4.6% from the prior year. The amount of administrative expenses and distribution costs decreased by 0.5% to HK\$164.1 million (2022: HK\$164.9 million) which reflected our efforts in controlling selling expenses despite resumption in selling activities and employment subsidies from the Government and cost control in staffing and distribution. Government subsidies received by the Group during the year totalled HK\$2.9 million (2022: the Group did not receive any government subsidies).

Liquidity and Financial Resources

The Group continues to expand its business in Hong Kong and the PRC while adopting a prudent financial management policy. The current ratio and quick ratio are 1.9 (2022: 2.0) and 1.2 (2022: 1.4), respectively. Cash and cash equivalents and time deposits with maturity over three months approximated HK\$146.7 million as at 31 March 2023 (2022: HK\$104.2 million).

Inventories increased to HK\$144.9 million (2022: HK\$115.4 million). The trade, retention and other receivables decreased to HK\$99.0 million (2022: HK\$154.7 million), while the trade and other payables increased to HK\$43.3 million (2022: HK\$34.4 million).

As at 31 March 2023, the gearing ratio (net debt divided by total equity) of the Group is not applicable, the Group has a net cash position (2022: same). The interest-bearing borrowings of the Group increased to HK\$64.0 million (2022: HK\$42.1 million) as at 31 March 2023.

Treasury Policy

Borrowings, cash and cash equivalents are primarily denominated in Hong Kong Dollars (“HK\$”) and Euro (“Euro”). During the year, the Group entered into certain forward contracts to buy Euro for settlement of purchases. The management will continue to monitor the foreign exchange risk exposure of the Group.

Contingent Liabilities

We seek to manage our cash flow and capital commitments effectively to ensure that we have sufficient funds to meet our existing and future cash requirements. We have not experienced any difficulties in meeting our obligations as they become due. Assets under charge include mortgaged property acquired. As at 31 March 2023, performance bonds of approximately HK\$23.3 million (2022: HK\$32.5 million) have been issued by the Group to customers as security of contracts. Save for the performance bonds for projects, the Group has no other material financial commitments and contingent liabilities as at 31 March 2023.

流動資金及財務資源

本集團繼續採取審慎財務管理政策拓展在香港及中國之業務。流動比率及速動比率分別為1.9(二零二二年：2.0)及1.2(二零二二年：1.4)。於二零二三年三月三十一日，現金及現金等價物及到期日超過三個月的定期存款約為146.7百萬港元(二零二二年：104.2百萬港元)。

存貨增加至144.9百萬港元(二零二二年：115.4百萬港元)。應收賬款、應收保留款及其他應收款減少至99.0百萬港元(二零二二年：154.7百萬港元)，而應付賬款及其他應付款增加至43.3百萬港元(二零二二年：34.4百萬港元)。

於二零二三年三月三十一日，因本集團呈淨現金狀況，故本集團之資產負債比率(債項淨額除以總權益)並不適用(二零二二年：相同)。本集團於二零二三年三月三十一日之有息借款增加至64.0百萬港元(二零二二年：42.1百萬港元)。

財務政策

借款、現金及現金等價物主要以港元(「港元」)及歐羅(「歐羅」)計值。於本年度，本集團訂立若干遠期合約，買入歐羅以結付採購。管理層將繼續監察本集團面臨之外匯風險。

我們致力有效管理現金流量及資本承擔，確保具備充足資金滿足現行及未來的現金需求。我們在依期履行付款責任方面未曾遭遇任何困難。所抵押資產包括已按揭之收購物業。於二零二三年三月三十一日，本集團向客戶發出履約保證約23.3百萬港元(二零二二年：32.5百萬港元)作為合約擔保。於二零二三年三月三十一日，除項目之履約保證外，本集團並無其他重大財務承擔及或然負債。

USE OF PROCEEDS FROM RIGHTS ISSUE

On 9 January 2023, the Company completed a rights issue and issued 118,238,942 rights shares, on the basis of one (1) rights share for every four (4) then existing shares, at a price of HK\$0.192 per rights share (the “2023 Rights Issue”). Upon completion of the 2023 Rights Issue, the Company received net cash proceeds of approximately HK\$21.4 million (the “Net Proceeds”). The Company intended to apply the Net Proceeds as to: (i) approximately HK\$11.7 million for financing the estimated renovation costs and related expenses for setting up a new showroom and warehouse in connection with the Group’s kitchen collection and furniture business; (ii) approximately HK\$7.7 million for repayment of bank loans; and (iii) approximately HK\$2.0 million as general working capital of the Group.

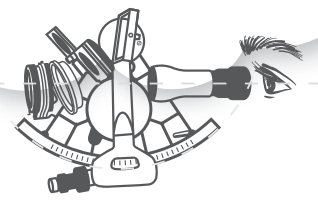

FUTURE PROSPECTS

As discussed in our business review, the contraction of the economic performance of Hong Kong in 2022 was mainly due to the uncertainty arising from PRC's "Dynamic Zero COVID-19" policy on the one hand and, on the other hand, the Russian-Ukraine conflict that had seriously affected the global economies, especially commodities and agriculture sectors, causing high food and energy prices and combining the US, UK and EU sanctions against Russia, creating inflationary pressure. It, in turn, affects the US monetary policy by increasing rates steadily over a year to curb inflation. Global trade remains under pressure due to geopolitical tensions, weakening global demand and tighter monetary and fiscal policies.

正如我們於業務回顧中所討論，二零二二年香港經濟表現的收縮主要由於：中國「COVID-19動態清零」政策帶來不確定性；另一方面，俄烏衝突嚴重影響了全球經濟，尤其是大宗商品和農作物，引致食品和能源價格高企，加上美國、英國和歐盟對俄羅斯的制裁，造成通脹壓力。故此，美國貨幣政策亦受到影響從而在一年內穩步提高利率以壓抑通貨膨脹。由於地緣政治緊張、全球需求疲軟以及貨幣及財政政策收縮，全球貿易仍然面臨壓力。

Still, the Hong Kong economy improved in the first quarter of 2023. Its economy grew by 2.7% year-on-year in the first quarter of 2023, recovering from a downward contraction in the previous year led by the strong recovery of inbound tourism ((7.3 million visitors (5.7 million from Mainland) over the period, representing around 30% of pre-pandemic levels)) and domestic demand. The Government forecasts economic growth of 3.5%. Likewise, PRC's economy grew by 4.5% in the first quarter of 2023 after it had ended the "Dynamic Zero COVID-19" policy end in 2022, and it is expected that the Gross Domestic Product (GDP) will achieve 6% growth at the end of this year.

PRC's economy relies heavily on fixed asset investment, exports and domestic consumption, while its property market accounts for a large share of GDP. Despite the reopening, PRC's real estate sector has not fully recovered from the credit crunch on property developers and several property firms, most notably Evergrande (its offshore bond default in mid-2021), have since struggled to maintain liquidity. New home construction still declines as developers struggle to finish existing projects, pressuring future income. The local governments will also feel the heat due to weaker economic growth and fiscal revenue from plummeting land sales.

The Chinese government has recently unveiled sweeping measures to rescue the struggling real property sector. The banking regulator and central bank issued a 16-point set of internal directives to promote the "stable and healthy development" of the industry. The measures include credit support for debt-laden housing developers, financial support to ensure the completion and handover of projects to homeowners, and assistance for deferred-payment loans for homebuyers. The directive signals the end of the golden age of real estate development with an adverse effect towards local governments and financial institutions.

Thus, China still faces long-term persistent challenges to maintain its growth momentum. As Hong Kong depends on China for its economic growth, its economic performance would affect Hong Kong.

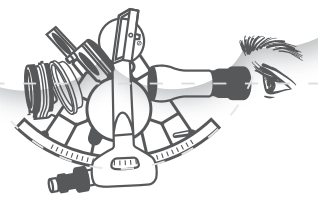

儘管如此，香港經濟於二零二三年第一季度仍有所改善。在入境旅遊(期間有7.3百萬遊客(5.7百萬遊客來自內地)，約佔疫情前水平的30%)及境內需求強勁復甦的帶動下，其經濟已由去年的下行收縮中恢復過來，於二零二三年第一季度同比增長2.7%。政府預測經濟增長為3.5%。同樣，於二零二二年底結束「COVID-19動態清零」政策後，中國經濟於二零二三年第一季度增長4.5%，預計今年年底國內生產總值將實現6%的增長。

中國經濟以固定資產投資、出口及國內消費為主，而其物業市場在國內生產總值中佔很大比重。儘管在疫情封禁措施重開後，中國的房地產業尚未完全從對物業發展商的信貸收緊中恢復過來，一些物業公司(最引人注目的是恒大(其離岸債券於二零二一年中期違約))此後一直努力維持流動性。由於發展商努力完成現有項目，新住宅建設仍在下降，對未來收入構成壓力，而土地銷售下跌帶來的經濟增長放緩及財政收入下降亦使本地政府備受壓力。

中國政府最近公佈了全面措施，以拯救陷入困境的物業行業。銀行業監管機構和央行發佈16條金融措施，以推動該行業的「平穩健康發展」。該等措施包括為負債的住房發展商提供信貸支持，為確保項目完工並交付給房主提供財政支持，及為購房者延期支付貸款提供援助。該等措施標誌著房地產發展黃金時代的結束，對當地政府及金融機構產生不利影響。

因此，中國為保持其增長勢頭仍面臨長期持續的挑戰。由於香港的經濟增長依賴中國，其經濟表現將影響香港。



FUTURE PROSPECTS (CONT'D)

Looking forward, there may be plenty of reasons to be confident about the continued improvement in the Chinese Mainland and Hong Kong economies. It is too early to be optimistic given that both economies are still recovering from the pandemic, weakening in consumer sentiment and business confidence Index, and will face external economic challenges such as global economic pressures, Russian-Ukraine conflict, high inflation, high-interest rate, geopolitical tensions and technological competition with the US in the year ahead. For these reasons, we expect to see a slow recovery of the Hong Kong economy.

According to the Housing Bureau of Hong Kong, the estimated total public housing production by the Housing Authority and the Hong Kong Housing Society in the five years from 2023/24 to 2027/28 is about 128,800 flats, comprising about 82,900 public rental housing/Green Form Subsidised Home Ownership Scheme apartments and about 45,900 other subsidised sale flats). The actual completion of flats would inevitably be affected by factors such as site constraints, inclement weather, contractors' progress, labour shortage, materials supply of the construction industry, etc. The yearly housing production is, therefore, subject to adjustments accordingly.

According to the Hong Kong Rating and Valuation Department, the forecast completions for private and domestic in 2023 and 2024 are 19,950 and 26,970 units, respectively.

Although the private domestic price index rebounded in the first quarter by nearly 5 per cent, the strength of the rebound would be impacted by factors such as high-interest rates, consumer sentiment, weakening demand, the uncertainty of external fiscal environments and an oversupply of newly built private and domestic flats.

The Hong Kong government's new round of the Consumption Voucher Scheme 2023, with a total value of HK\$5,000 in instalments for each eligible Hong Kong resident, was expected to increase HK GDP by 0.6% in 2023. The vouchers will be disbursed in two instalments: HK\$3,000 in April 2023 and the remaining HK\$2,000 in mid-2023. Non-Hong Kong residents who are in the city to study or through different admission programmes will receive vouchers worth HK\$2,500. Still, the prospect of higher interest rates is expected to continue to depress Hong Kong's secondary housing market until next year.

展望未來，雖有很多理由對中國內地及香港經濟的持續改善保持信心。但兩個經濟體仍在從疫情中復甦，消費者情緒及商業信心指數疲軟，且未來一年將面臨全球經濟壓力、俄烏衝突、高通脹、高利率、地緣政治局勢緊張及與美國的技術競爭等外部經濟挑戰，現在樂觀為時過早。因此，我們預計香港經濟將緩慢復甦。

根據香港房屋局的資料，房屋委員會及香港房屋協會預計於二零二三／二四年至二零二七／二八年五年內公共房屋總建屋量約為128,800個單位，包括82,900個公共租住房屋／綠表置居計劃單位及約45,900個其他資助出售單位。房屋的實際落成不可避免地受到場地限制、惡劣天氣、承建商進度、勞工短缺、建築業材料供應等因素的影響。因此，每年的建屋量亦會作出相應調整。

根據香港差餉物業估價署的預測，二零二三年及二零二四年私人及住宅單位的竣工量分別為19,950個單位及26,970個單位。

儘管私人住宅售價指數於第一季度反彈近5%，但反彈的力度會受到高利率、消費者情緒、需求疲軟、外部財政環境的不確定性及新建私人及住宅單位供過於求等因素的影響。

香港政府新一輪的二零二三年消費券計劃向每名合資格香港居民分期發放總價值5,000港元的消費券，預計二零二三年將帶動香港本地生產總值增加0.6%。消費券將分兩期發放：於二零二三年四月發放3,000港元及餘下2,000港元於二零二三年年中發放。在港就讀或透過不同入境計劃入境的非香港居民將收取價值2,500港元的消費券。儘管如此，高息前景預計將於今明兩年繼續壓抑香港二手房地產市場。

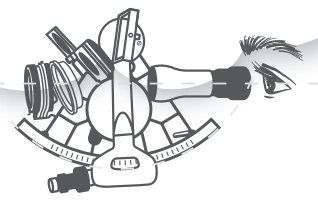

Our revenue last year was marginally lower at HK\$455 million as compared to the previous year. The weakening demand for housing units in Hong Kong will likely remain for 2023 due to those mentioned external and local market environments. Considering market trends impacted by external factors, this year will be a difficult challenge for our business; as usual, we will continue minimising our operation costs, lowering the debt-to-equity/leverage ratio, capitalising on our strengths in product ranges, and our relationships with well-established developers to adjust our strategies accordingly.

未來展望(續)

我們去年的收益較前一年略有下降，為455百萬港元。受上述外部及當地市場環境的影響，香港房屋單位需求疲軟的情況或會持續至二零二三年。經考慮受外部因素影響的市場趨勢，今年我們的業務將面臨艱巨的挑戰；像往常一樣，我們將繼續最大程度地降低我們的運營成本，降低債務與權益／槓桿比率，善用在產品範疇之優勢及與具規模的發展商之關係，相應調整我們的策略。





Directors' Report 董事報告

The Board of Directors is pleased to submit their report together with the audited consolidated financial statements for the year ended 31 March 2023.

PRINCIPAL ACTIVITIES AND ANALYSIS OF OPERATIONS

The principal activity of the Company is investment holding. Particulars of the Company's principal subsidiaries are set out on pages 179 to 181.

The Company believes that accountability and reporting system with high transparency for the Company’s operation has been in place. Disclosures could also be made timely and accurately. At the same time, the rights of shareholders can be treated and protected equitably.

The Company is led by an effective and responsible board of directors (the “Board”), which is comprised of individuals with high qualifications and relevant experience. This can ensure that the Company and its subsidiaries (together the “Group”) maintain good corporate governance practices and have comprehensive internal control and risk management systems, so as to cope with the Group’s development strategies and increase the shareholders’ value.

- (a) code provisions, with which issuers are expected to comply, but from which they may choose to deviate, provided that they give considered reasons; and
- (b) recommended best practices, with which issuers are encouraged to comply, but which are provided for guidance only.

Amendments to the CG Code (the “New CG Code”) came into effect on 1 January 2022 and the requirements under the New CG Code will apply to corporate governance reports for financial periods beginning on or after 1 January 2022. Corporate Governance Report of the Company in the following financial year and onward will be based on the New CG Code.

In the opinion of the directors of the Company (the “Directors”), the Company has complied with all code provisions in the CG Code throughout the year ended 31 March 2023, except for the following:

Under the code provision D.2.5, the Company should have an internal audit function. Given the current scale of operations, the Company does not have an internal audit department. However, the Board has put in place adequate measures to perform the internal audit function. The Board reviews the Group’s complex risk management and internal control systems from time to time so as to assurance its adequacy and effectiveness. The Board will continue to review, at least annually, this arrangement going forward in light of the evolving needs of the Group.

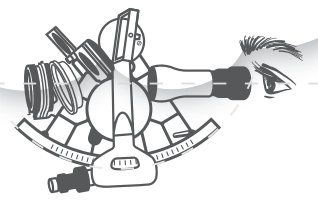

Except as disclosed in the Directors' Report, there is no special relationship, including financial, business, family or other material/relevant relationship among the members of the Board.

The Board and Management

The Board assumes responsibility for leadership and control of the Company and is collectively responsible for promoting the success of the Company by directing and supervising its affairs. Directors take decisions objectively in the best interests of the Company.

The Board is responsible for establishing the strategic direction of the Company, setting the objectives of management, monitoring the performance of management, overseeing the management of the Company's relationship with shareholders, ensuring that a framework of prudent and effective controls is in place to enable risks to be assessed and managed, setting the Company's values and standards, reviewing and monitoring the training and continuous professional development of directors and senior management.

When the Board delegates management and administration functions to management, it has given clear directions on the powers of management with respect to the circumstances where management is to report back and obtain prior approval from the Board before making decisions or entering into any commitments on behalf of the Company. The Company has formalised functions reserved to the Board and the management respectively; and the Board reviews those arrangements periodically to ensure that they remain appropriate to the Company's needs.

The management and staff of the Company ensure the successful implementation of the strategies, business directions and policies as determined by the Board. In doing so, they must apply business principles and ethics, which are consistent with those expected by the Board and Shareholders and other stakeholders.

Independent Non-executive Directors

The Independent Non-executive Directors help to ensure that the Board can make independent judgement efficiently and effectively. They also take the lead where potential conflicts of interests arise. They scrutinise the Company's performance in achieving agreed corporate goals and objectives, and monitor performance reporting. They make a positive contribution to and independent judgement on the development of the Company's strategies, policies, performance, accountability, resources, key appointments and standards of conduct through board meetings by bringing in independent, constructive and informed comments. They form a strong independent element on the Board.

The Independent Non-executive Directors possess appropriate professional qualification. Among them, some possess expertise in accounting or financial management. They give the Board and Board committees on which they serve the benefit of their skills, expertise and varied backgrounds and qualifications through regular attendance and active participation. Independent Non-executive Directors attend general meetings to gain and develop a balanced understanding of the view of the shareholders of the Company.

Each Independent Non-executive Director has also submitted an annual written confirmation to the Company confirming his independence as regards each of the factors referred to in Rule 3.13(1) to (8) of the Listing Rules. All Independent Non-executive Directors are engaged by contract every year and are subject to retirement by rotation in accordance with the Company's Articles of Association and the Listing Rules. The Company considered that all Independent Non-executive Directors meet the independence guidelines set out in Rule 3.13 of the Listing Rules.

Mechanisms to Ensure Independent Views

The Board has adopted effective mechanisms to ensure independent views and input are available to the Board. Subject to approval of the Chairman of the Board, Directors may seek, at the Company's expense, independent legal, financial or other professional advices from advisors independent to those advising the Company as and when necessary in appropriate circumstances to enable them to discharge their responsibilities effectively. The Board will review the implementation and effectiveness of such mechanisms on an annual basis.

The Board considers that the above mechanisms are effective in ensuring that independent views and input are provided to the Board.

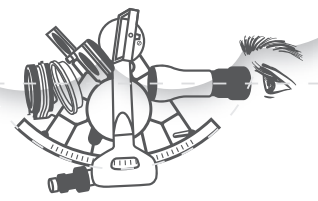

Directors' responsibilities

All Directors devote sufficient time and attention to the Group's affairs and have actively participated in the Board meetings to discuss the overall strategies, business directions and policies of the Group. Throughout the year, the Company held seven regular Board meetings, and one general meeting. To ensure that Directors could obtain all related information to make an informed decision and to perform their duties and responsibilities, documents for the Board meeting were supplied to Directors for their consideration before the meeting according to the regulations set out in the Listing Rules and code provisions of the CG Code.

The attendance of board meetings and general meeting(s) during the year is set out on page 65.

All Directors acknowledge their responsibility for preparing the financial statements. As at 31 March 2023, none of the Directors were aware of any material uncertainty relating to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern. As such, the Directors have prepared the Company's financial statements on a going concern basis. Reporting responsibilities of external auditors on the financial statements are set out in "Independent Auditor's Report" (pages 104 to 113).

Board proceedings

The Board makes arrangement to provide opportunities for all Directors to include matters in the agenda of regular Board meetings. At least 14 days' notices are given in respect of regular Board meetings. For regular Board meetings, an agenda and accompanying board papers are sent, in full, to all Directors in a timely manner and at least 3 days before the intended date of board meeting. For all other Board meetings, Directors are given as much notice as reasonable and practicable in the circumstances.

董事會議事程序

Management provides the Board and Board committees with adequate and timely information which is accurate, clear, complete and reliable to enable Directors to make informed decisions on matters placed before them, and perform their duties and responsibilities as directors. Management provides adequate explanations and information to the Board to enable Directors to make an informed assessment of the financial and other information put before them for approval. In addition, the Board and each Director have separate and independent access to the Company's senior management. All Directors have free access to board papers and related materials. Board papers and related materials are in a form and quality sufficient to enable the Board to make informed decisions on matters placed before it. Queries raised by Directors are provided with a prompt and full response. Minutes of each Board meeting and Board committee meeting are kept by the company secretary (the "Company Secretary") and are available for inspection by any Director.

Minutes record in sufficient detail the matters considered by the Board and Board committees and the decisions reached. Draft and final versions of minutes are sent to all Directors for their comment and records respectively within a reasonable time after the Board meeting is held.

All Directors have access to the advice and services of the Company Secretary with a view to ensuring that good information flow within the Board, Board policies, Board procedures, applicable laws, rules and regulations are followed. Moreover, upon request from any Director, the Company provides separate independent professional advice to Directors to assist them to perform their duties at the Company's expense.

If a substantial shareholder or Director has a conflict of interest in a matter to be considered by the Board which the Board has determined to be material, the matter will be dealt with by a physical board meeting set up for that purpose and voted on by Directors who, and whose close associates, have no material interest in the transaction. Independent Non-executive Directors who, and whose close associates, have no material interests in the transaction should be present at that board meeting. Directors' concerned must abstain from voting on any Board resolution and will not be counted in the quorum.

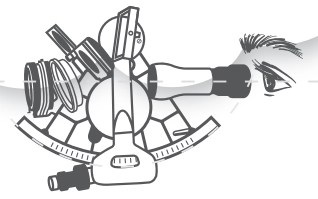

全體董事均可向公司秘書諮詢意見及要求提供服務，以確保董事會成員之間資訊交流良好，董事會政策、董事會程序、適用法例、規則及條例獲得遵守。此外，應任何董事之要求，本公司向董事提供獨立專業意見，以協助彼等履行職務，費用由本公司支付。

Board effectiveness

A formal, considered and transparent procedure is in place for the appointment of new directors. Newly appointed directors are provided with briefing materials to ensure that they have a proper understanding of the Company's operations and business, and are fully aware of their responsibilities under statute and common law, the Listing Rules, legal and other regulatory requirements and the Company's business and governance policies. In addition, an orderly succession for appointments is maintained to ensure high standard of corporate governance of the Company. Every Director is subject to re-election by rotation at an annual general meeting at least once every three years.

To ensure Directors' contribution remains informed and relevant, the Company is responsible for arranging and funding suitable training to Directors. In addition, the Company encourages Directors and the senior management to participate in continuous professional development to develop and refresh their knowledge, skills and understanding of the business and markets in which the Group operates. Directors are timely updated on the latest developments regarding the Listing Rules and other applicable regulatory requirements, as well as information related to the Group's business and operations, to ensure compliance, enhance their awareness of good corporate governance practices and enable them to discharge duties properly. This has involved various forms of activities including attending seminars, reading materials relevant to the Company's business, director's duties and responsibilities.

The records of training of Directors received during the year is set out on page 65.

Directors' and Officers' insurance

The Company has arranged an insurance cover in respect of legal action against its Directors and officers (as defined in the Listing Rules) arising from corporate activities.

The division of responsibilities between the Chairman of the Board and the Managing Director has been clearly defined and the written terms of reference have been set.

Responsibilities of the Chairman of the Board are as follows:

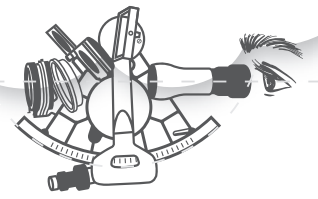
- (a) Providing leadership for the Board;

- (f) Ensuring that appropriate steps are taken to provide effective communication with Shareholders and that views of Shareholders are communicated to the Board as a whole;
- (g) Ensuring good corporate governance practices are in place and procedures are established;
- (h) Encouraging all Directors to make a full and active contribution to the Board’s affairs, giving each Director an opportunity to express his views at Board meetings, taking the lead to ensure that the Board acts in the best interests of the Company, encouraging Directors with different views to voice their concerns, allowing sufficient time for discussion of issues and ensuring that Board decisions fairly reflect Board consensus;

- (c) Overseeing the implementation by the Company of the objectives set by the Board;
- (d) Providing all such information to the Board as is necessary to enable the Board to monitor the performance of management;
- (e) Leading the management of the Company's relationships with its stakeholders;
- (f) Putting in place programmes for management development and succession;
- (g) Working with the Head of Finance, establishing and maintaining proper internal controls and systems as well as disclosure controls and procedures; and
- (h) Discharging such duties and authorities as may be delegated in writing to him by the Board.

The Terms of Reference of the Audit Committee is clearly defined and posted on the Company's website. The roles and function of the Audit Committee are as follows:

- (a) To be primarily responsible for making recommendations to the Board on the appointment, reappointment and removal of the external auditor, and to approve the remuneration and terms of engagement of the external auditor, and any questions of its resignation or dismissal;
- (b) To review and monitor the external auditor's independence and objectivity and the effectiveness of the audit process in accordance with applicable standards. The audit committee should discuss with the auditor the nature and scope of the audit and reporting obligations before the audit commences;
- (c) To develop and implement policy on engaging an external auditor to supply non-audit services. For this purpose, "external auditor" includes any entity that is under common control, ownership or management with the audit firm or any entity that a reasonable and informed third party knowing all relevant information would reasonably conclude to be part of the audit firm nationally or internationally. The audit committee should report to the Board, identifying and making recommendations on any matters where action or improvement is needed;

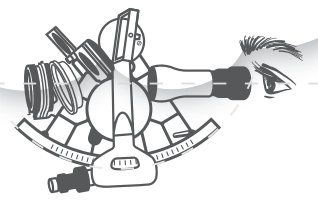

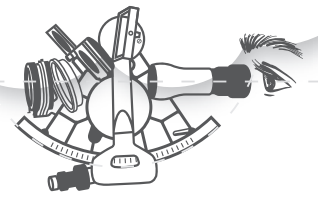

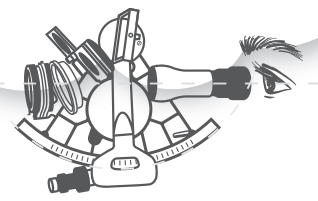

Board Diversity Policy

The Board has an appropriate mix of skills, experience and diversity of perspectives. The members of Board possess diverse competences, spanning business management, advisory and monitoring, accounting and financial management, legal, brand building, sales and marketing and I.T. development. The profile of Directors is set out in Biographical Details of Directors and Senior Management on pages 26 to 28.

The Board has adopted its own board diversity policy ("Board Diversity Policy"). The Board Diversity Policy aims to achieve diversity of the Board through consideration of a number of factors, including but not limited to gender, age, cultural and educational background, or professional experience. Board appointments will be based on objective criteria having due regard for the benefits of diversity on the Board. The Nomination Committee of the Company shall review the Board Diversity Policy as appropriate and make recommendations on any proposed revisions to the Board.

To comply with the Board Diversity Policy and improve gender diversity on the Board, the Board has aggressively sought out candidates who are competent and suitable to serve as board members. The current Board comprises eight male members and no female member. Since the Board was comprised with the single gender Directors as at the date of this report, the Board aims to nominate and appoint at least one female candidate to be our Board member no later than 31 December 2024. In order to increase gender diversity in the Board in the upcoming years, the Company will also proactively provide training to our senior management and will take into account the factor of gender diversity when recruiting suitable candidates for our senior management in the future.

As at the date of this report, the Company has 141 employees in total comprising of 65 females and 76 males (a female-to-male ratio of 0.86), reflecting a gender equality principle generally adhered by the Company. The Company is mindful of the objectives as set out in the diversity policy when assessing the candidacy of the employees, and will ensure that the Company shall continue to follow the policy.

At present, there are 3 Independent Non-executive Directors in the Board, accounting for over 1/3 of the total numbers of the Board. They bring them with diverse academic and professional qualifications and experience to the Board.

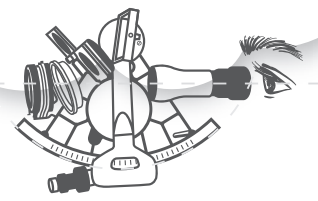

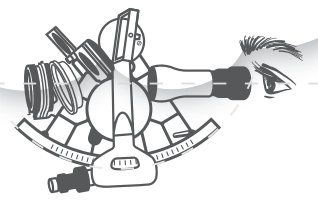

Our goal is to enhance the brand value of the Group by managing customers' expectation of getting products that commensurate with their lifestyles. Founded over four decades ago, the Group has established reputation and gained trust from major contractors, property developers and dealers. The Group also runs retail outlets and showrooms.

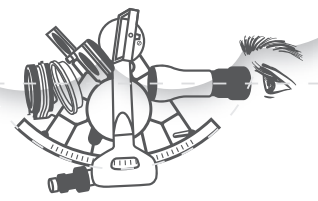

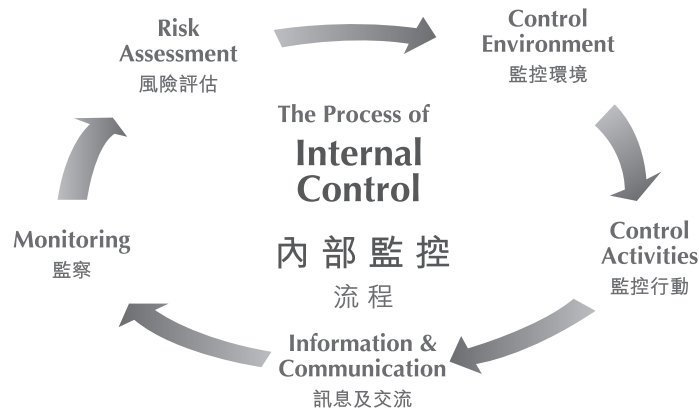
Anti-corruption policy

The Company has adopted an anti-corruption policy to govern acceptance of advantages by employees and a whistleblowing mechanism to provide guidance to employees and external stakeholders to report concerns about any suspected or actual improprieties relating to the Group.

The Board is responsible for evaluating and determining the nature and extent of the risks it is willing to take in achieving the Company's strategic objectives, and ensuring that the Company establishes and maintains appropriate and effective risk management and internal control systems to safeguard the shareholders' investment and the Group's assets. The Board is also responsible for the risk management and internal control system and reviewing their adequacy and effectiveness.

The systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

Process of risk management and internal control systems



Internal controls encompass a set of rules, policies, and procedures that the Group implements to provide reasonable assurance that:

- (a) The Group financial reports are reliable;
- (b) The Group operations are effective and efficient; and
- (c) The Group activities comply with applicable laws and regulations. The Board, management, and other personnel are responsible for the internal control system.

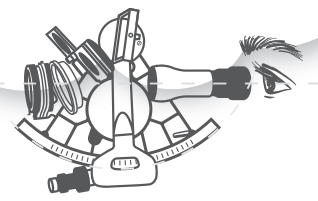

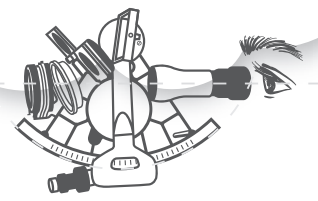

Risk assessment identifies and analyses the relevant risks associated with the Group's objectives. It forms the basis for determining what risks need to be controlled and the controls required to manage them. Our head of risk management has periodic meetings with directors and the management team to oversee and discuss the proper operating style with each other.

Directors and the management team will then make decision and delegate to each department for execution. Through daily communication and information gathered, Directors and management team will be able to monitor the daily operation and risks that might occur, thus be able to prevent or minimise them. It also makes sure operations are in compliance with laws, rules, and regulations. At the same time, each department's missions and goals are achieved.

Handling and Dissemination of Inside Information

The Company recognises its disclosure obligation under the SFO and the Listing Rules. The Company conducts its affairs with close regard to the "Guidelines on Disclosure of Inside Information" issued by the Securities and Futures Commission. The Company has included in its staff handbook a strict prohibition on the unauthorised use of confidential information including Inside Information (as defined under the SFO) in order to make sure appropriate handling and dissemination of Inside Information is in place.

The Group has set out the procedures and internal controls for handling and dissemination of inside information in order to comply with code provision D.2.4(e) of the CG Code. There are guidelines to the directors, officers and all relevant employees of the Group to ensure that proper safeguards exist to prevent the Company from breaching the statutory disclosure requirements. The handling and dissemination of inside information of the Group is strictly controlled and remains confidential including but not limited by the following ways:

- define the requirements of periodic financial and operational reporting to the Board and Company Secretary to enable them to assess inside information and make timely disclosures, if necessary;
- restrict access control to inside information by employees on a need-to-know basis, and safeguarding the confidentiality of the inside information before it is properly disclosed to public;
- reminder to employees who are in possession of inside information to ensure that they are fully conversant with their obligations to preserve confidentiality; and
- The Board and the senior management review the safety measures regularly to ensure inside information is properly handled and disseminated.

本公司深明其於證券及期貨條例及上市規則項下的披露責任。本公司密切根據證券及期貨事務監察委員會發佈的「內幕消息披露指引」處理其事務。本公司已在其員工手冊內訂明嚴格禁止在未經授權的情況下使用機密資料(包括內幕消息)(定義見證券及期貨條例)，以確保適當處理及發佈內幕消息。

本集團已訂明處理及發佈內幕消息的程序及內部監控，以符合企業管治守則第D.2.4(e)條的規定。本集團的董事、高級人員及所有相關僱員均獲得指引，以確保有適當的保障防止本公司違反法定披露規定。本集團內幕消息的處理及發佈受到嚴格控制並保密，包括但不限於以下方式：

- 明確向董事會及公司秘書作定期財務及營運報告的要求，使彼等能夠評估內幕消息並在必要時及時披露；
- 按需知基準限制僱員對內幕消息的訪問控制，並保障於內幕消息適當向公眾披露前的保密性；
- 提醒掌握內幕消息的僱員，確保彼等充分了解自身的保密責任；及
- 董事會及高級管理層定期檢討安全措施，以確保妥善處理及發佈內幕消息。

Review of risk management and internal control systems for the year ended 31 March 2023

The Group carried out control activities comprising a diverse range of policies and procedures, including: conducting reviews of actual performance, reviewing of performance reports, checking information processing in transactions, performing physical controls, analysing performance indicators and dividing and segregating duties amongst different people. These can help the Group ensure proper internal control is in place across departments/divisions.

The Board, through the Audit Committee, oversees management in the design, implementation and monitoring of the risk management and internal control systems of the Company, including financial controls, operational controls and compliance controls. During the year, the Audit Committee conducted an annual review to consider and discuss the risk management and internal control systems (including but not limited to, the adequacy of resources, staff qualifications and experience, training programmes and budget of the Group's accounting and financial reporting function) and reported the same to the Board. The Board conducted an annual review to consider environmental, social and governance performance and reporting.

During the year, the Company did not have an internal audit department; details of which are set out on page 39. The Board reviewed the scope and quality of management's on-going monitoring of systems of risks and the internal controls, examined the extent and frequency of communication of monitoring results to the Board and Board committees. Based on the review, save as disclosed under the section "Principal Risks and Uncertainties" on the Directors' Report, the Board considers that there is no significant change in the nature and extent of risks and the Company's ability to respond to changes in its business and the external environment since the last annual review. The Board considered that the systems of risk management and internal control of the Group for the year ended 31 March 2023 were effective and adequate.

Based on the internal financial controls, half-yearly financial reporting and timely updates on Listing Rules requirements, the Group's processes for financial reporting and Listing Rules compliance are considered by the Board as effective.

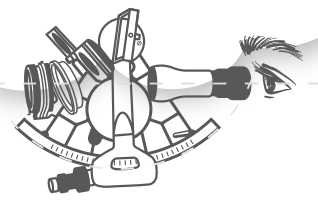

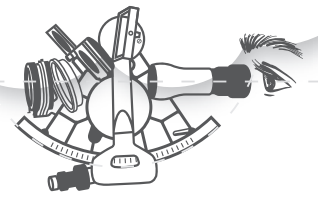

General Meetings

All registered shareholders shall receive either notice of the annual general meeting and extraordinary general meeting (together the "Meeting") or equivalent notification letter by post or by electronic means. The notice of the Meeting contains an agenda, resolutions proposed and a proxy form. All shareholders, whose shares are registered in the register of members, are entitled to attend the Meeting. Shareholders who cannot attend the Meeting can appoint their proxies or the chairman of the meeting as their proxies by completing the proxy form enclosed with the notice of the meeting and returning it to the Company's share registrar. Pursuant to the Company's Articles of Association and the Listing Rules, all votes of shareholders at the Meeting will be taken by poll.

Procedures for demanding a vote by poll, together with the notice of the Meeting, have been enclosed with a circular despatched to the shareholders. The procedures are read out at the Meeting by the chairman of the meeting so as to make sure shareholders are familiar with the detailed procedures for conducting a poll. The Company arranges to address questions from shareholders in the Meeting. In addition, separate resolutions for each substantially separated issues will be proposed to the Meeting for the approval of shareholders.

General meeting is the principal opportunity and ideal venue for shareholders to meet and exchange views on the Company's business with the Directors and the management. An annual general meeting is an annual significant event for shareholders and the Board to exchange constructive opinions. All Directors (including the Chairman of the Board) shall attend the annual general meeting. Apart from attending the annual general meeting, the Chairman of the Board shall arrange the chairmen of each Board Committee to attend and answer questions at the annual general meeting. The Company's auditor shall also attend the annual general meeting to answer questions about the conduct of the audit, the preparation and content of the auditor's report, the accounting policies and auditor independence.

股東大會

所有已登記之股東會以郵遞方式或電子方式收取股東週年大會及股東特別大會(統稱「股東大會」)通告或相關通知書。股東大會通告載有會議議程、提呈之決議案及代表委任表格。所有股份登記於股東名冊內之股東均有權出席股東大會。未能出席股東大會之股東可填妥大會通告隨附之代表委任表格並交回本公司股份過戶登記處，以委任彼等之受委代表或大會主席擔任彼等之代表。根據本公司組織章程細則及上市規則，股東大會上所有議決事項均須以投票方式表決。

The Board adopted a dividend policy (the “Dividend Policy”) which sets out when considering any payment of a dividend, the Board shall take into account of (i) the profitability of the Group for the financial year; (ii) the Group’s general financial condition supporting its normal operations; (iii) the Group’s actual and expected business performance; (iv) the Group’s overall results of operation, financial performance and liquidity position; (v) the Group’s expected capital commitments, future cash requirements and future business development plans and prospects such as market conditions; (vi) retained earnings and distributable reserves of the Company and each of the members of the Group; (vii) the general economic conditions, business cycles of the Group’s business and other internal or external factors that may have an impact on the business or financial performance and position of the Group; and (viii) any other factors that the Board considers relevant and appropriate. The Board will continually review the Dividend Policy from time to time.

SHAREHOLDERS’ RIGHTS

1. The Company has only one class of shares and the Articles of Association of the Company set out the rights of our shareholders.
2. Shareholders have right to receive corporate communications issued by the Company.
3. Shareholders whose shares held in Tricor Abacus Limited (“Tricor”) may notify the Company from time to time through Tricor if they wish to receive our corporate communications.
4. Shareholders are furnished with comprehensive background information in a timely manner concerning the matters to be decided at general meetings and they are well informed of the rules including the voting procedures that govern general meetings.
5. Subject to the Articles of Association and the rules prescribed by the Stock Exchange from time to time, shareholders have right to participate and vote in general meetings. Any shareholder not attending a general meeting can give proxy to vote on his/her behalf. Forms of Proxy are sent to shareholders of the Company together with the notice of meeting.
6. Shareholders have right to raise questions at general meetings.

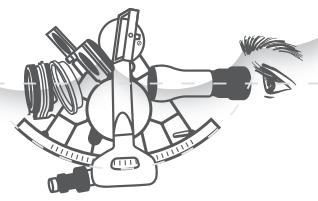

Proposing a person for election as a Director

If a shareholder wishes to propose a person other than a retiring Director for election as a Director at any general meeting, the shareholder should lodge a notice, signed by the shareholder (other than the person to be proposed), and a notice signed by the person to be proposed of his willingness to be elected (together the "Notices") at the Head Office or at the Registration Office provided that the minimum length of the period, during which such Notices are given, shall be at least seven days and that (if the Notices are submitted after the despatch of the notice of the general meeting appointed for such election) the period for lodgement of such Notices shall commence on the day after the despatch of the notice of the general meeting appointed for such election and end no later than seven days prior to the date of such general meeting.

Putting forward proposals at shareholders' meetings

There are no provisions in the Company's Articles of Association or the Companies Act of the Cayman Islands for shareholders to put forward new resolutions at general meetings. Shareholders who wish to put forward a new resolution may request the Company to convene a general meeting.

CONSTITUTIONAL DOCUMENTS

The Company's memorandum of association (the "Memorandum of Association") and articles of association (the "Articles of Association"), in both English and Chinese, are available on the Company's website at www.ebon.com.hk and the HKEXnews website at www.hkexnews.hk. There was no significant change to the Memorandum of Association and Articles of Association of the Company during the year ended 31 March 2023. In order to (i) bring the Articles of Association in line with the relevant requirements of the applicable laws of the Cayman Islands, the Listing Rules and the Companies Ordinance; and (ii) make other consequential and housekeeping amendments, the Company adopted the second amended and restated Articles of Association (the "New Articles of Association") in substitution for, and to the exclusion of, the existing Articles of Association at the annual general meeting held on 7 September 2022 with effect from 7 September 2022. Save for mentioned above, there were no other changes in the constitutional documents of the Company. The New Articles of Association of the Company has been published on the websites of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") and the Company on 7 September 2022.

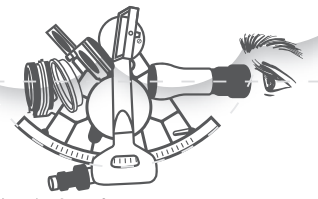


The Board has the overall responsibility for the Group's sustainability performance and ESG reporting. The Board sets out the sustainability vision of the Group and has delegated its execution and monitoring to an ESG workgroup which comprises of a director of the Company. The Board reviews and provides final approval for the sustainability approach, strategy and performance at least once a year.

The ESG Workgroup is pivotal to the success of ESG management: it lays down sustainability strategies based on the Board's vision, determines material aspects with reference to stakeholders' responses, gathers information from departments and functional heads and conducts analyses, directly reports back to the Board on the Group's performance and its recommendations.

The management is the decision-making body of environmental and social performance. Department and functional heads are responsible for managing sustainability risks during their day-to-day operations. They identify key performance indicators (KPIs) associated with their operations, monitor and report to the management. In addition, as risk owners, they identify and assess sustainability risks and report to the management for review.

Stakeholder Engagement

The expectation of stakeholders is evolving and so as our sustainability strategy. The Group regularly engages with stakeholders in order to keep our sustainability strategy relevant to stakeholders and our business.

The Group determines its sustainability strategy through a systematic process including:

- Plan — Identify stakeholders and their interests
- Engage — Interact with stakeholders
- Make decisions — Use stakeholder input to determine report content
- Evaluate — Determine the effectiveness of stakeholder engagement processes

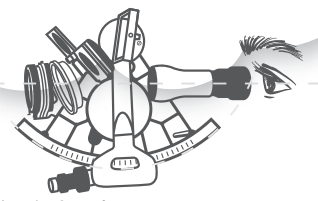

In addition, we regularly carry out materiality assessment to determine important issues to both internal and external stakeholders of the Group. It is an on-going process as material issues may change over time. Based on the results obtained in the last engagement cycle and the management's insights, the ESG Workgroup identified 13 material topics which would have a direct or indirect impact on the Group's ability to create, preserve or erode economic, environmental and social value of itself, its stakeholders and society at large. The Workgroup asked stakeholders to indicate topics that they considered the Group should give priority. This process enables us to categorise various groups of stakeholders into an engagement matrix: (1) engage, (2) communicate and (3) inform stakeholders. In this engagement cycle, concerns on occupational safety and health, product responsibility, operating compliance and financial performance are highlighted.

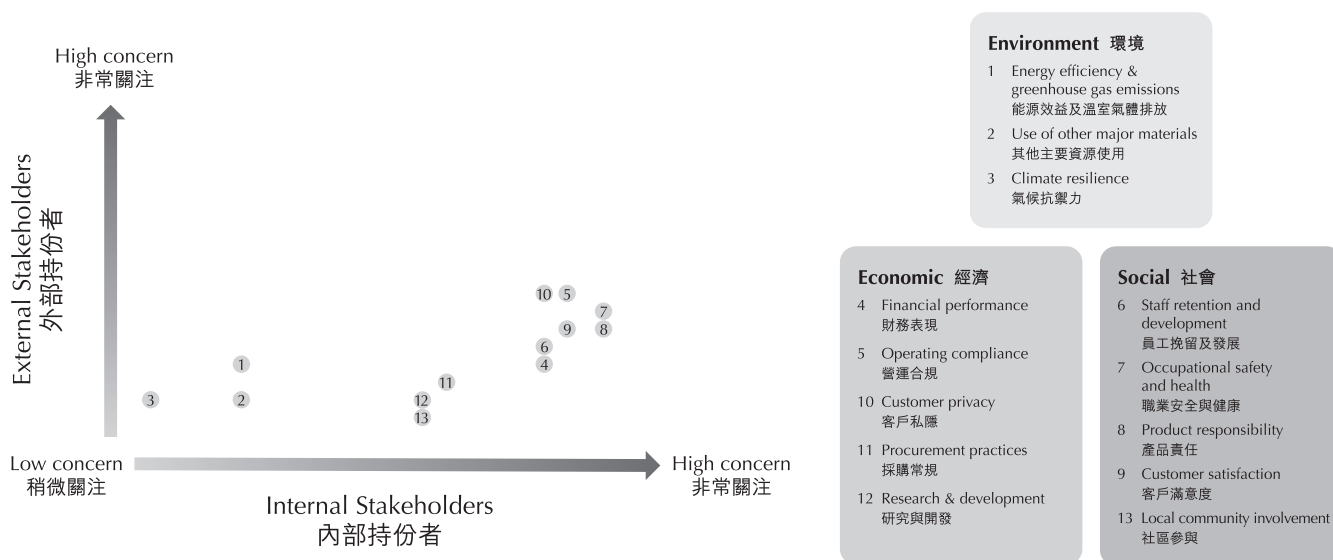

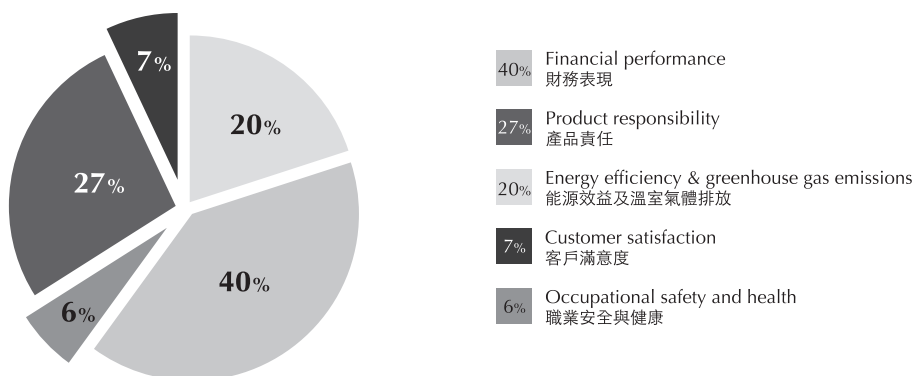

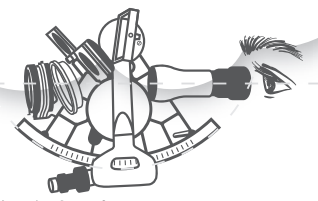

SUSTAINABILITY MEASUREMENT AND MONITORING

The Group adopted Appendix 27 of the Listing Rules as the sustainability measurement framework. It involves measuring sustainability performance and setting targets in quantitative manner. The ESG Workgroup regularly measure, record and analyse key performance indicators (KPIs) for the Board's discussion and establishment of improvement plans.

The Group has set a reduction target of 5% in total greenhouse gas (GHG) emission, non-hazardous waste disposal, total energy use and water consumption from the performance recorded for the year ended 31 March 2021 (the "Baseline") by the year ending 31 March 2024.

本集團已經制定目標，即於截至二零二四年三月三十一日止年度前，將其溫室氣體排放總量、無害廢棄物處置量、能源使用總量及耗水量從截至二零二一年三月三十一日止年度所記錄的表現(「基準線」)減少5%。

ENVIRONMENT

The Group endeavours to minimise pollution and protect the environment by conserving natural resources, reducing the use of energy and waste. We first implement business activities for which we bear responsibility and address the environmental issues by integrating environment considerations in our business. We create environmental awareness amongst our staff members and whenever possible and practical to do so. We aim to contribute to the sustainable future and be in harmony with the global environment.

A1 Emissions

Our electricity consumption accounts for a major part of its GHG emissions, with local transport contributing less than 5% of the total GHG emission. Measures aimed at improving energy efficiency are outlined on page 82.

Deliveries to the same district are gathered in bundles to minimise travel routes, hence reduce the use of petrol and emissions to air. In addition, we encourage our staff to use public transport; for those that are not accessible by public transport means, to carpool when travelling on business. Discharges to water are made through public sewages system. There was no discharge to water and/or land. There was no prosecution to the Group in relation to air emissions during the year. The Group has set to reduce total GHG emissions per employee by 5% by 2024 from the Baseline.

The Group pays attention to hazardous waste such as e-waste. We have implemented plans to reduce the quantity of e-waste as outlined on page 84. Disposal of hazardous waste is conducted safely in accordance to relevant regulations. There was no prosecution to the Group in relation to hazardous waste handling during the year.

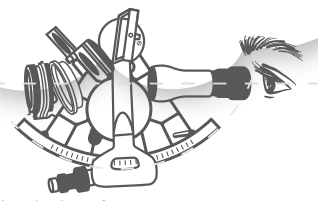

交付至相同區域的貨物集中付運，以盡量縮短運送路線，從而減少汽油的使用及空氣污染物的排放。此外，我們鼓勵員工使用公共交通工具，至於無法搭乘公共交通設施之情況，出差時則安排多人同乘一部汽車。向水排污乃透過公共污水收集系統進行。本集團概無向水源及／或土地的排污。於本年度，本集團並無受到有關廢氣排放的檢控。本集團已計劃到二零二四年將每名僱員的溫室氣體排放總量從基準線減少5%。

Electricity

We have been phasing out old air-conditioners by energy-saving ones. Indoor temperature remains at 23°C–25°C.

Besides, old halogen lamps in shops have also been gradually replaced by LED spotlights. It consumes less energy, helps lower the indoor temperature (which requires less air-conditioning) but maintains approximate brightness. We are planning to phase out fluorescent lightings from T8 to T5 which consumes less energy. The Group has set to reduce total energy use per employee by 5% by 2024 from the Baseline.

Our promotional light boxes go automatically off from midnight to morning to reduce energy consumption.

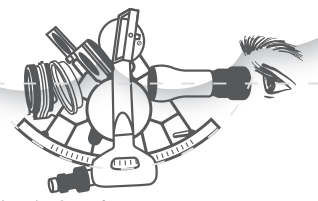

We plan to replace old taps with sensor-type and/or add flow regulators to control water flow when feasible. As a supplier of home fittings, we provide a range of products with green features (eco-sensor, flow regulator, smart green design) to the market. The Group has set to reduce total water consumption per employee by 5% by 2024 from the Baseline.

Electricity: Reduction

Details of electricity reduction is set out on page 82.

Paper: Reduction

All office paper and almost all paper for printing the Group's publications are Forest Stewardship Council (FSC)-certified or recycled paper, except old publication (such as catalogues) which is yet to disseminate. Not only adopting FSC certified paper, the Group encourages the use of paperless communication. If printing is necessary, we encourage environmentally friendly printing manner (such as to print on both sides, reduce font size and margin). For internal reference document, we upload to intranet or circulate hardcopies instead of printing one copy for each staff member. In addition, paper collection tray is placed next to printer to gather single-side-printed paper for re-use.

Our box packaging fits the size of goods so as to minimise the use of paper and provide the best protection to the goods contained. The materials of our carton boxes fulfil relevant safety standards. Besides, we encourage the use of carton boxes for multiple times.

** FSC is an independent, non-governmental, not-for-profit organisation established to promote environmentally appropriate, socially beneficial, and economically viable management of the world's forests.

Electronic devices: Re-use

Technology advancement leads to shorter lifespan of electronic devices. Certain equipment becomes obsolete or incompatible to our operations after software upgrades. We are aware of potential environmental and health hazards related to disposal of e-waste. Hence, we have adopted the following initiative:

- Obsolete: Donate to non-governmental organisations such as Hong Kong Caritas Computer Recycle Project

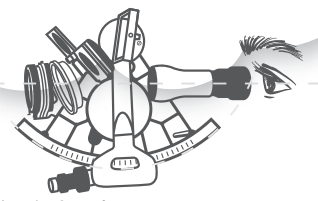

A4 Climate Change

Climate Change is undoubtedly one of the greatest challenges facing humanity. The World Economic Forum's Global Risks Report 2022 ranks climate action failure as the top long-term threat, giving rise potentially to the most severe impacts over the next decade. Therefore, we aim to build resilience to climate change by identifying and managing climate change risks and opportunities and by developing strategies to adapt to and to mitigate the impact the climate change on our operations.

The table below sets out our findings of significant climate-related risks and opportunities:

Our near term targets are to adapt to impacts of climate change. With extreme weather occurring more frequently, we place sandbags in low-lying areas and install floodgates when heavy rainfall is approaching. Our premises are well-maintained with resilient elements so as to lower potential damages resulting from extreme weather and attain better insurance packages. We make use of e-communications to keep close contact with staff members, customers and suppliers to ensure business continuity in place. We provide a range of products with green features to the market.

In long term, we endeavour to reduce carbon footprint in our operations to help mitigate climate change. The Group has set a reduction target of 5% in total energy use and total GHG emission from the Baseline by the year 31 March 2024. We regularly monitor our progress for review and continuous improvement, in addition to reporting the performance on an annual basis.

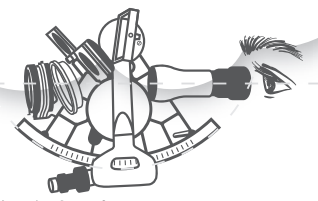

As at 31 March 2023, our workforce in operations in Hong Kong was recorded at 130 employees.

Competitive packages are offered to attract, retain and motivate competent individuals. We are dedicated to promoting equal opportunities for all of our employees in different areas, including recruitment, compensation and benefits, training, staff promotion and transfer. All staff members are assessed based on their ability, performance and contribution, irrespective of their gender, age, disability, family status, race, religious beliefs or sexual orientation. There was no prosecution to the Group in relation to employment issues during the year.

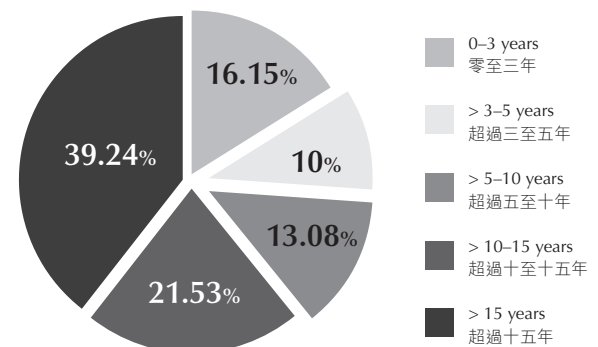

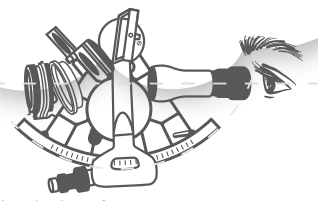

B2 Health and Safety

Our workplace is kept clean and tidy, with adequate work space for staff members to work. Apart from that, a number of initiatives have been carried out to increase the staff awareness in health and safety at work:

- Occupational safety briefing
 - Guide new staff members especially those work in warehouse or go to construction sites
 - Staff members are able to stop work if they feel unsafe or is not properly trained
- Staff handbook (detailing health and safety guidelines)

During the reporting year, there were no reported cases of non-compliance with the relevant laws and regulations in our Group regarding the environment, labour standards, occupational health and safety, anti-corruption or data privacy. Warehouse and shop frontline staff members are under supervision to ensure they work safely. All staff members, before going to construction sites, have attended safety training. When entering construction sites, they are equipped with safety helmet and briefed by relevant safety officers.

In light of the outbreak of Coronavirus during the year, we have implemented the following measures to safeguard the safety of our staff members, such as:

- Raise the frequency of cleaning in workplace
- Place air purifiers in workplace
- Provide surgical masks, disinfection products and rapid test kits to all staff members
- Take body temperature of staff members

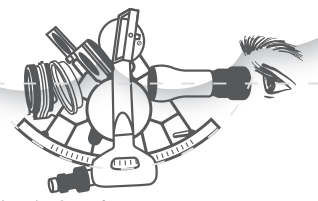

We comply with local employment regulations in all locations of our operations, and do not engage in any forced or child labour. To ensure we are legally compliant, we check applicants' identity including their age and eligibility for employment. Regular reviews on our employment practices (including recruitment procedures) are conducted to ensure we operate in a fair manner. Any case of illegal, forced and child labour will be investigated and escalated to the management where necessary.

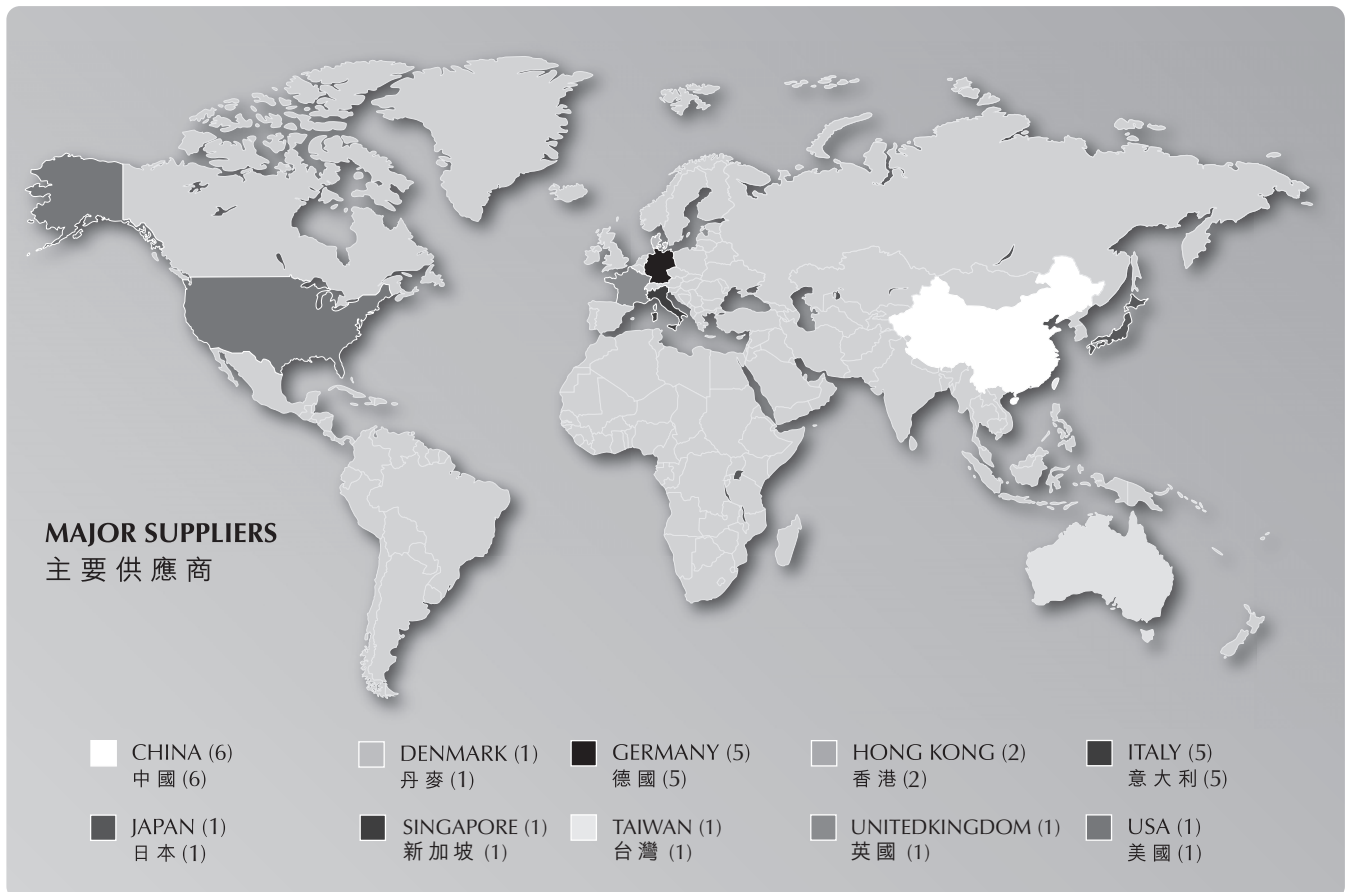

B5 Supply Chain Management (cont'd)

As our operations connect us to a wide range of stakeholders along the supply chain, we strive to make sure that sustainability considerations have been embedded in our procurement practices. Our Environmental and Social Policy is in place to facilitate communication and align our sustainability expectations, including legal compliance, anti-corruption policy, environmental protection, workplace health and safety, employment practices, with our suppliers and sub-contractors.

In selecting installation sub-contractors, we consider a range of factors such as price, past performance, scale of the project, technical competence, environmental records, workplace health and safety standards.

We conduct appraisals to evaluate performance of suppliers and sub-contractors. Factors assessed include production capacity, technical capability, quality control systems, personnel quality and sustainability performance. The results determine which suppliers and sub-contractors deemed high risk and require further consideration in future purchases. Appraisals are made at least annually to ensure our supply chain stays aligned with our vision. During the year, the Group was not aware that any key suppliers had significant actual or potential negative impact on business ethics, environmental protection, human rights or labour practices.

In view of the growing environmental awareness in Hong Kong, we advocate the adoption of green features in product selection, such as water flow control and FSC-certified materials. We give preference to those who have made strong environmental commitments and those produce in close proximity to reduce carbon emissions from transportation. We will continue our efforts in bringing environmentally friendly products to customers.

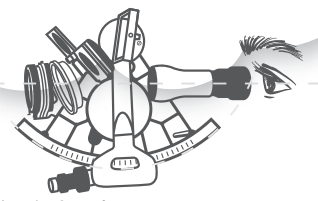
由於本集團業務過程讓我們與供應鏈上的眾多持份者建立聯繫，我們致力確保採購慣例已考慮可持續發展元素。我們已制定環境及社會政策，促進與供應商及分包商溝通，並符合我們對彼等的可持續發展期望，包括法律合規、防貪政策、環境保護、工作場所健康及安全、僱傭常規。

於挑選安裝分包商時，我們考慮多項因素，例如價格、過往表現、項目規模、技術能力、環保記錄、工作場所健康與安全標準。

我們對供應商及分包商的表現進行評估，其中評估因素包括生產能力、技術能力、質量控制系統、人員質素及可持續發展表現。評估結果釐定被視為高風險供應商及分包商者，並須在未來的採購中進一步考慮。評估每年至少進行一次，以確保我們的供應鏈與我們的願景保持一致。本年度，本集團沒有發現任何主要供應商或分包商對商業道德、環境保護、人權或勞工常規有重大的實際或潛在的負面影響。

鑒於香港的環保意識不斷增強，我們倡導選擇綠色產品，如用水流量控制及經森林管理委員會認證的材料。我們優先考慮對環保作出有力承諾以及在鄰近地區的生產商，以減少運輸過程中的碳排放。我們將繼續努力為客戶帶來環保產品。

B6 Product Responsibility

Our customers include contractors, property developers and dealers. We recognise the uniqueness of requirements of each customer, and offer a full range of products to satisfy customers' needs.

The Group's objective is to become one of the leading quality suppliers of architectural builder's hardware, bathroom, kitchen collections and furniture. Our goal is to enhance the brand value of the Group by managing customers' expectation of getting products that commensurate with their lifestyles. We strive to provide quality products and services to fulfil customers' needs; and to establish the brand and reputation of our Group for customers' recognition of our ability to serve them with two fundamental qualities, "sincerity" and "quality", which would enable us to build customer loyalty, allowing us to establish strong customer relationships for future businesses.

Product safety is our primary concern. The majority of our products, in terms of purchase value, originate from Europe where rigorous product testing regulations and requirements are in place. Nevertheless, we carry out a number of measures to ensure product safety, such as warranties and certificates from manufacturers, tests according to customers' requirements.

During the year, there was no product recall for safety and health issues in relation to products sold by us; there was no substantiated complaints received. And we did not receive any complaints lodged with the Consumer Council.

Apart from safety, we also value performance ratings and feedback from customers, of which feedback identifies areas of improvement. We have established various communication channels including corporate website and social media platforms to facilitate and strengthen communication with our customers. Feedback from customers is discussed and improvement will be made where appropriate. Our labelling and advertising materials are reviewed to ascertain their compliance with relevant marketing communication practices.

B6 產品責任

我們客戶包括承建商、物業發展商及經銷商。我們深明客戶各有不同的需要，並提供一系列產品以滿足客戶的需求。

本集團致力成為提供建築五金、衛浴、廚房設備及傢俬的領先優質供應商。我們因應客戶之生活方式供應產品，切合客戶所需，務求提升本集團之品牌價值。我們著重提供優質產品及服務滿足客戶需要，讓客戶領略我們貫徹「誠懇」及「質素」之宗旨；透過為本集團建立品牌價值及信譽取信於客戶，令本集團與客戶建立堅固關係，為日後發展作好準備。

產品安全是我們的首要考慮因素。就購買金額而言，本集團的產品主要產自歐洲，當地對產品測試規定及要求十分嚴格。儘管如此，我們採取不少措施確保產品安全，例如取得生產商的保證及證書、根據客戶的要求進行測試。

We protect our proprietary position by registering trademarks in markets of presence and in development. We respect others' intellectual property rights and conduct trademark searches to avoid infringement.

We comply with the latest Personal Data (Privacy) Ordinance, ensuring that the customer information we receive is only used for its intended purposes. We regularly brief our staff, especially front-line staff, to take great care in dealing with privacy matters. We did not receive any substantiated complaints regarding breaches of customer privacy or loss of customer data during the year.

B7 Anti-corruption

The Group is committed to maintaining the highest standard of integrity when doing business. We adopt the code of conduct (the "Code of Conduct") that complies with HKEX expectations on corporate governance and the Independent Commission Against Corruption's anti-corruption policies. Our staff handbook has outlined such code of conduct to all staff members including prevention of bribery.

Sub-contract works are made in accordance with the standard procedure of the Group. Once having received the quotations from potential contractors, we evaluate each based on a range of factors such as: price, past performance, scale of the project, technical competence, environmental records, workplace health and safety standards. Decisions on sub-contract appointments are reviewed and endorsed by the management of the Group.

The Group has a whistle-blowing mechanism for staff members and business partners to report any potential bribery or other misconduct behaviours. All cases are treated with strict confidence. The Managing Director is responsible to implement such mechanism while the Audit Committee is responsible to review.

The Code of Conduct and anti-bribery training is included in the induction programme of all staff members. Our conditions of employment require compliance with the Code of Conduct. Additionally, anti-corruption training materials were circulated to the Board of Directors during the year.

There was no legal case of corruption brought against our Group or its staff members during the year.

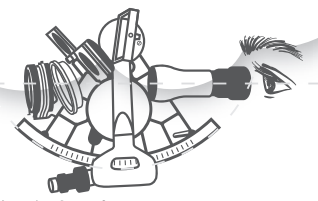

The Group is committed to be an active participant in the local community wherever it operates. Charitable and other donations made by the Group during the year amounted to HK\$80,000. We believe that support to communities does not limit to donations but also voluntary works.

Our approach is to primarily focus on the elderly, children and the underprivileged, and to give support to environmental protection. Our volunteering programmes continued to be limited due to the outbreak of coronavirus recurs in Hong Kong during the year 2022, yet we managed to donate the film production for “Collaborative Efforts to Intervene and Prevent Elder Abuse” and fund a scholarship during the year.

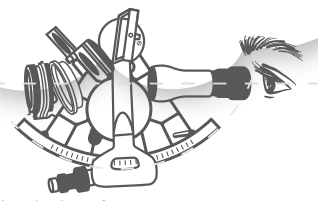

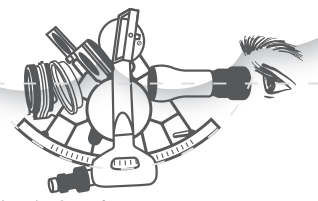

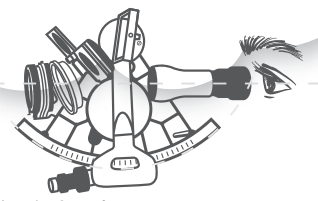

Scope and Objective of Verification

The process applied in this verification was based on the International Standard on Assurance Engagements 3000 (Revised), Assurance Engagements Other Than Audits or Reviews of Historical Financial Information issued by the International Auditing and Assurance Standards Board. Our evidence gathering process was designed to obtain a reasonable level of assurance as set out in the standard for the purpose of devising the verification conclusion. 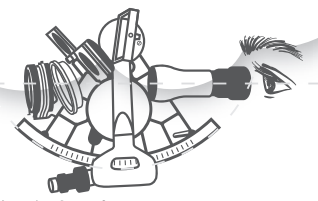

Provision for inventory obsolescence

Refer to notes 2.10, 4.1 and 19 to the consolidated financial statements for the disclosures of the related accounting policies, judgements and estimates

As at 31 March 2023, the Group held net inventories of approximately HK\$144,909,000 after provision of obsolescence.

Management assessed the provision at each period ended for obsolete or slow-moving inventories. In determining the amount of allowance required for obsolete and slow-moving inventories, management evaluates the ageing of inventories, their historical and estimated future sales pattern and other factors and compares the carrying value of inventories to their estimated net realisable value.

The identification of inventory obsolescence and determination of estimated net realisable value require the use of significant judgement and estimates, including their nature, ageing, latest selling price, and expectation of future sales orders. The estimates are subject to uncertainty of market trends, customer demands and fashion trends.

We focused on this area because of the significance of the gross inventory balance to the consolidated financial statements and the estimation and judgement involved in determining the provision for inventory obsolescence.

過時存貨撥備

於二零二三年三月三十一日，貴集團於扣除過時撥備後持有存貨淨額約144,909,000港元。

管理層評估各個期間末之過時或滯銷存貨撥備。於釐定過時及滯銷存貨所需撥備金額時，管理層會評估存貨賬齡、歷史及估計未來銷售模式及其他因素，並比較存貨之賬面值與其估計可變現淨值。

識別過時存貨及釐定估計可變現淨值需要作出重大判斷及估計，包括其性質、賬齡、最近期售價及對未來銷售訂單的預期。有關估計受市場趨勢、客戶需求及流行趨勢等不確定因素所影響。

我們專注於此領域乃由於總存貨結餘對綜合財務報表的重要性以及釐定過時存貨撥備所涉及的估計及判斷。

How our audit addressed the Key Audit Matter

Our audit procedures in relation to the provision for inventory obsolescence included:

- We understood and evaluated the key controls by which management reviews on inventory provision including procedures on periodic and annual review of obsolete and aged inventory, provision for inventory and assessed the inherent risk of material misstatement by considering the degree of estimation uncertainty and level of other inherent risk factors. We validated the key controls that the Group has implemented to estimate the provision for inventory obsolescence;
- We understood and assessed the appropriateness and reasonableness of the assumptions adopted in the provision policy and basis of identification of the obsolete and slow-moving inventories by referencing to their ageing, historical and subsequent sales patterns and estimated future sales;
- We tested, on a sample basis, of the accuracy of the ageing report of inventory against goods receipt notes;
- We tested, on a sample basis, the sales records of inventories against sales invoices of the past 2 years and the inventories utilisation rate to ensure the accuracy and completeness of provision for inventory obsolescence;
- We tested, on a sample basis, of estimated future sales against secured sales orders received from customers;
- We also assessed the estimated net realisable value by comparing the estimated selling price and sales quantity of inventories with the corresponding post year-end sales data; and
- We tested the mathematical accuracy of the calculation of inventory provision.

Based on the procedures performed, we considered the judgments and assumptions made by management in relation to their assessment for provision of inventory obsolescence were supportable by the available evidence.

Provision for impairment of trade and retention receivables and contract assets

Refer to notes 2.7 and 4.2 to the consolidated financial statements for the disclosures of the related accounting policies, judgements and estimates.

As at 31 March 2023, the Group had trade and retention receivables of approximately HK\$71,658,000 and contract assets of approximately HK\$3,259,000.

Management assesses the provision for impairment of trade and retention receivables and contract assets based on the lifetime expected credit losses. These receivables are grouped by shared credit risk characteristics and collectively assessed for likelihood of recovery, whenever appropriate. The expected credit loss rates are determined based on historical credit losses experience and credit profile of the customers and are adjusted to reflect the effects of current conditions as well as forward-looking information such as macroeconomic factors affecting the ability of the customers to settle the receivables. Receivables relating to customers with known financial difficulties or significant doubt on collection are assessed individually for provision for impairment.

We focused on this area due to the significance of the trade and retention receivables and contract assets to the consolidated financial statements and the estimation and judgement involved in determining the expected credit losses allowance of these receivables.

- We understood, evaluated the key control procedures performed by which management assessed the expected credit losses, including its procedures on periodic review of aged receivables and assessment on expected credit losses allowance of these receivables and assessed the inherent risk of material misstatement by considering the degree of estimation uncertainty and level of other inherent risk factors. We validated the key controls that the Group has implemented to estimate the loss allowance for impairment of trade and retention receivables and contract assets periodically;
- We evaluated the significant judgements and assumptions involved in the expected credit losses measurement model, including management's assessment of credit risks of the debtors, considering their credit profiles, historical repayment patterns, publicly available information of these debtors, and forward-looking factors such as market conditions and economic growth, and assessed the reasonableness of the judgements and assumptions adopted;
- We tested, on a sample basis, the accuracy of the ageing report of trade and retention receivables by tracing to invoices; and
- We performed recalculation of the ECL model to assess the mathematical accuracy.

Based on the procedures performed, we considered the estimation and judgement made by management in determining the expected credit losses allowance of trade and retention receivables and contract assets were supportable by the available evidence.

1 GENERAL INFORMATION

E. Bon Holdings Limited (the “Company”) is a limited liability company incorporated in the Cayman Islands. The address of its registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands and its principal place of business is 16th–18th Floors, First Commercial Building, 33 Leighton Road, Causeway Bay, Hong Kong. Its shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”).

The principal activity of the Company is investment holding. Its subsidiaries are principally engaged in the importing, wholesale, retail and installation of architectural builders’ hardware, bathroom, kitchen collections and furniture and provision of interior design services, project and contract management in Hong Kong and the People’s Republic of China (the “PRC”).

These consolidated financial statements are presented in Hong Kong dollars (HK\$), unless otherwise stated.

2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

2.1 Basis of preparation

The consolidated financial statements of the Company have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards (“HKFRSs”) and disclosure requirements of the Hong Kong Companies Ordinance (Cap. 622). The consolidated financial statements have been prepared under the historical cost convention, as modified by the revaluation of leasehold land and buildings held for own use and derivative financial instruments, which are carried at fair values.

除另有說明外，該等綜合財務報表以港元呈列。

2.1 編製基準

本公司之綜合財務報表乃根據所有適用香港財務報告準則(「香港財務報告準則」)及香港公司條例(第622章)的披露規定編製。本綜合財務報表依據歷史成本常規法編製，並已就持作自用租賃土地及樓宇及衍生金融工具之重估作出調整，按其公允值列賬。

2.2 Subsidiaries

2.2.1 Consolidation

Subsidiaries are all entity (including structured entities) over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

Intra-group transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the group.

2.2 附屬公司

2.2.1 綜合賬目

附屬公司為本集團對其擁有控制權之所有實體(包括結構實體)。當本集團透過參與實體之業務而承擔或有權享有可變回報；及有能力透過對實體運用權力而影響該等回報，本集團即可控制實體。附屬公司自控制權轉移至本集團當日全數綜合入賬，並自終止控制當日不再綜合入賬。

集團內公司間之交易、結餘及集團內公司間交易之未變現收益予以對銷。未變現虧損亦予以對銷。如有需要，會對附屬公司之會計政策作出調整，以確保與本集團採納之政策一致。

2.2.2 Separate financial statements

Investments in subsidiaries are accounted for at cost less impairment. Cost also includes direct attributable costs of investment. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

Impairment testing of the investments in subsidiaries is required upon receiving dividends from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

2.3 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the executive directors that make strategic decisions.

2.4 Foreign currency translation

(a) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates ("the functional currency"). The consolidated financial statements are presented in HK\$, which is the Company's functional and the Group's presentation currency.

2.2.2 獨立財務報表

附屬公司投資按成本扣除減值列賬。成本亦包括投資之直接應佔成本。附屬公司之業績由本公司按已收及應收股息入賬。

如股息超過宣派股息期內附屬公司之全面收益總額，或如在獨立財務報表之投資賬面值超過綜合財務報表中投資對象資產淨值(包括商譽)之賬面值，則必須於收取來自該等投資之股息時對附屬公司投資作減值測試。

2.3 分部報告

經營分部按照向首席經營決策者提供內部報告貫徹一致之方式報告。首席經營決策者被認為作出策略性決定之執行董事，負責分配資源及評估經營分部之表現。

2.4 外幣換算

(a) 功能及呈列貨幣

本集團每個實體之財務報表所列項目均以該實體經營所在主要經濟環境之貨幣計量(「功能貨幣」)。綜合財務報表以港元呈列，港元為本公司功能貨幣及本集團呈列貨幣。

(b) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions or valuation where items are re-measured. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at year end exchange rates are generally recognised in the profit or loss.

All foreign exchange gains and losses are presented within "Other gains/(losses), net" in the consolidated statement of comprehensive income.

(c) Group companies

The results and financial position of all the group entities (none of which has the currency of a hyper-inflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- (i) assets and liabilities for each statement of financial position presented are translated at the closing rate at the date of that statement of financial position;
- (ii) income and expenses for each statement of comprehensive income are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the rate on the dates of the transactions); and
- (iii) all resulting exchange differences are recognised in other comprehensive income.

外幣交易採用交易或項目重新計量之估值日期之匯率換算為功能貨幣。結算此等交易產生之匯兌收益及虧損以及將以外幣計值之貨幣資產及負債以年終匯率換算產生之匯兌收益及虧損一般在損益內確認。

Leasehold land and buildings are stated at revalued amount. Property, plant and equipment, other than leasehold land and buildings, are stated at cost less accumulated depreciation and accumulated impairment losses.

Leasehold land and buildings are stated in the consolidated statement of financial position at their revalued amount, being the revaluation value at the date of revaluation less any subsequent accumulated depreciation and amortisation and accumulated impairment losses. Revaluations are performed with sufficient regularity such that the carrying amount does not differ significantly from that which would be determined using revaluation values at the reporting date.

Any revaluation increase arising on the revaluation of leasehold land and buildings is credited to the revaluation reserve, except to the extent that it reverses a revaluation decrease of the same assets previously recognised as an expense, in which case the increase is credited to the profit or loss to the extent of the decrease previously charged. A decrease in net carrying amount arising on revaluation of an asset is dealt with as an expense to the extent that it exceeds the balance, if any, on the revaluation reserve relating to a previous revaluation of that asset.

Historical cost includes expenditure that is directly attributable to the acquisition of the items. Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repairs and maintenance are charged to profit or loss during the financial period in which they are incurred.

租賃土地與樓宇以重估價值列賬。除租賃土地與樓宇外，物業、廠房及設備按成本扣除累計折舊及累計減值虧損入賬。

租賃土地與樓宇於綜合財務狀況表以重估價值(即重估當日之重估價值減該重估後之任何累計折舊、攤銷及累計減值虧損)列賬。租賃土地與樓宇會進行定期重估，以確保其於報告日期的賬面值與重估價值之間無重大差異。

重估租賃土地與樓宇產生之任何重估增加將撥入重估儲備，惟倘撥回同一資產於早前確認為開支之重估減值，則該增加將撥入損益內，惟以早前扣除之減值為限。重估資產產生之賬面淨值減值，倘超過重估儲備內就該資產先前重估之結餘(如有)，則當作開支扣減。

歷史成本包括購買該等項目直接應佔之開支。後續成本僅於可能為本集團帶來與該項目有關之未來經濟利益，而該項目之成本能可靠計量時，方計入資產之賬面值或確認為一項單獨資產(如適用)。已更換零件之賬面值已在賬上移除。所有其他維修費用在產生之財政期間於損益支銷。

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (Note 2.6).

Gains and losses on disposals are determined by comparing the proceeds with the carrying amounts and are recognised in the profit or loss. On disposal of a revalued asset, the relevant portion of the asset revaluation reserve realised in respect of previous valuations is transferred to retained earnings as a movement in reserve.

2.6 Impairment of non-financial assets

Assets that have an indefinite useful life are not subject to amortisation and are tested annually for impairment. Other assets that are subject to amortisation are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows which are largely independent of the cash inflows from other assets or group of assets (cash-generating units). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at the end of each reporting period.

2.7 Financial assets

2.7.1 Classification

The Group classifies its financial assets in the following measurement categories:

- those to be measured at amortised cost; and
- those to be measured subsequently at fair value (either through other comprehensive income, or through profit or loss).

The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

For assets measured at fair value, gains and losses will either be recorded in profit or loss or other comprehensive income. For investments in equity instruments that are not held for trading, this will depend on whether the group has made an irrevocable election at the time of initial recognition to account for the equity investment at fair value through other comprehensive income ("FVOCI").

The Group reclassifies debt investments when and only when its business model for managing those assets changes.

2.7.1 分類

本集團將其金融資產按以下計量類別分類：

分類乃取決於實體管理金融資產之業務模式及現金流量之合約條款。

就按公允值計量之資產而言，收益及虧損將於損益或其他全面收益入賬。就並非持作買賣之權益工具投資而言，則取決於本集團是否於初次確認時行使不可撤銷選擇權，將權益投資按公允值計入其他全面收益(「按公允值計入其他全面收益」)。

當及僅當本集團管理債務投資之業務模式變動時，本集團即將該等資產重新分類。

2.7.2 Recognition and derecognition

Regular way purchases and sales of financial assets are recognised on trade-date, the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership.

2.7.3 Measurement

At initial recognition, the Group measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss ("FVPL"), transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at FVPL are expensed in profit or loss.

Financial assets with embedded derivatives are considered in their entirety when determining whether their cash flows are solely payment of principal and interest.

Debt instruments

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. There are three measurement categories into which the Group classifies its debt instruments:

2.7.2 確認及終止確認

以一般方式買賣的金融資產均於交易日(即本集團承諾收購或出售資產當日)確認。當本集團從該等金融資產收取現金流量的權利已到期或已被轉讓,且本集團已大致上將擁有權的所有風險和回報轉移,則終止確認該等金融資產。

2.7.3 計量

於初始確認時,本集團按公允值計量金融資產,倘金融資產並非按公允值計入損益(「按公允值計入損益」),則加上收購該金融資產直接應佔的交易成本。按公允值計入損益的金融資產交易成本於損益中支銷。

在釐定具有嵌入衍生工具金融資產的現金流量是否純粹為支付本金及利息時,須從金融資產的整體作考慮。

債務工具

債務工具的後續計量取決於本集團管理資產的業務模式及該項資產的現金流量特點。本集團對債務工具進行分類的三種計量方式如下:

— Amortised cost

Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. Interest income from these financial assets is included in finance income using the effective interest rate method. Any gain or loss arising on derecognition is recognised directly in profit or loss. Impairment losses are presented as separate line item in the consolidated statement of comprehensive income. The Group's financial assets carried at amortised cost comprise "trade and retention receivables", "deposits and other receivables" and "cash and cash equivalents" in the consolidated statement of financial position.

— FVOCI

Assets that are held for collection of contractual cash flows and for selling the financial assets, where the assets' cash flows represent solely payments of principal and interest, are measured at FVOCI. Movements in the carrying amount are taken through other comprehensive income, except for the recognition of impairment gains or losses, interest revenue and foreign exchange gains and losses which are recognised in profit or loss. When the financial asset is derecognised, the cumulative gain or loss previously recognised in other comprehensive income is reclassified from equity to profit or loss. Interest income from these financial assets is included in finance income using the effective interest rate method. Impairment expenses are presented as separate line item in the consolidated statement of comprehensive income.

債務工具(續)

— 攤銷成本

為收取合約現金流量(而該等現金流量純粹為支付本金及利息)而持有之資產乃按攤銷成本計量。此等金融資產之利息收入使用實際利率法計入財務收入。終止確認產生之任何收益或虧損乃直接於損益確認。減值虧損於綜合全面收益表獨立呈列為一個項目。本集團按攤銷成本列賬的金融資產包括綜合財務狀況表內「應收賬款及應收保留款」、「按金及其他應收款」及「現金及現金等價物」。

— 按公允值計入其他全面收益
為收取合約現金流量及出售金融資產(而該等資產之現金流量純粹為支付本金及利息)而持有之資產乃按公允值計入其他全面收益計量。賬面值變動於其他全面收益入賬,惟確認減值收益或虧損、利息收益以及外匯收益及虧損於損益確認。終止確認金融資產時,先前於其他全面收益確認之累計收益或虧損由權益重新分類至損益。此等金融資產之利息收入使用實際利率法計入財務收入。減值開支於綜合全面收益表獨立呈列為一個項目。

Debt instruments (cont'd)

— FVPL

Assets that do not meet the criteria for amortised cost or FVOCI are measured at FVPL. A gain or loss on a debt investment that is subsequently measured at FVPL is recognised in profit or loss and presented net within "Other gains/(losses), net" in the period in which it arises.

Equity instruments

The Group subsequently measures all equity investments at fair value. Where the Group's management has elected to present fair value gains and losses on equity investments in other comprehensive income, there is no subsequent reclassification of fair value gains and losses to profit or loss following the derecognition of the investment. Dividends from such investments continue to be recognised in profit or loss as other income when the Group's right to receive payments is established.

Changes in the fair value of financial assets at FVPL are recognised in "Other gains/(losses), net" in the consolidated statement of comprehensive income as applicable. Impairment losses (and reversal of impairment losses) on equity investments measured at FVOCI are not reported separately from other changes in fair value.

2.7.4 Impairment

The Group assesses on a forward-looking basis the expected credit losses associated with its debt instruments carried at amortised cost. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

For trade and retention receivables and contract assets, the Group applies the simplified approach permitted by HKFRS 9, which requires expected lifetime losses to be recognised from initial recognition of the receivables. Details on how the Group determines the expected credit losses are set out in Note 3.1(c).

債務工具(續)

— 按公允值計入損益

並不符合攤銷成本或按公允值計入其他全面收益條件之資產按公允值計入損益。其後按公允值計入損益之債務投資之收益或虧損於產生期間於損益確認及於「其他收益/(虧損), 淨額」呈列。

權益工具

本集團隨後就所有股本投資按公允值計量。倘本集團管理層已選擇於其他全面收益呈列股本投資的公允值收益及虧損, 公允值收益及虧損於終止確認投資後不會重新分類至損益。有關投資的股息於本集團收取款項的權利確立時繼續於損益確認為其他收入。

按公允值計入損益的金融資產公允值變動於綜合全面收益表中確認為「其他收益/(虧損), 淨額」(倘適用)。按公允值計入其他全面收益計量的股本投資的減值虧損(及減值虧損撥回)不會因公允值其他變動而分開列報。

2.7.4 減值

本集團按前瞻基準評估其按攤銷成本列賬之債務工具相關之預期信貸虧損。所應用之減值方法取決於信貸風險有否大幅增加。

就應收賬款及應收保留款及合約資產而言, 本集團應用香港財務報告準則第9號允許之簡化方法, 其規定自初步確認應收款起確認預期全期虧損。有關本集團如何釐定預期信貸虧損的詳情載於附註3.1(c)。

2.8 Offsetting financial instruments

Financial assets and liabilities are offset and the net amount reported in the consolidated statement of financial position when there is a legally enforceable right to offset the recognised amounts and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously.

The legally enforceable right must not be contingent on future events and must be enforceable in the normal course of business and in the event of default, insolvency or bankruptcy of the company or the counterparty.

2.9 Derivative financial instruments

Derivatives are initially recognised at fair value on the date a derivative contract is entered into and are subsequently re-measured at their fair value. The gain or loss relating to the fair value re-measurement is recognised immediately in the profit or loss within "Other gains/(losses), net".

2.10 Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the first-in, first-out (FIFO) method. Net realisable value is the estimated selling price in the ordinary course of business, less applicable variable selling expenses.

2.11 Trade, retention and other receivables

Trade and retention receivables are amounts due from customers for merchandise sold or services performed in the ordinary course of business. If collection of trade, retention and other receivables is expected in one year or less (or in the normal operating cycle of the business if longer), they are classified as current assets. If not, they are presented as non-current assets.

Trade, retention and other receivables are recognised initially at the amount of consideration that is unconditional unless they contain significant financing components, when they are recognised at fair value. The Group holds the trade receivables with the objective to collect the contractual cash flows and therefore measures them subsequently at amortised cost using the effective interest method.

2.8 抵銷金融工具

當有法定可執行權利可抵銷已確認金額，並有意按淨額基準結算或同時變現資產及結算負債時，金融資產與負債可互相抵銷，並在綜合財務狀況表報告其淨額。

法定可執行權利不得依賴未來事件而定，而在一般業務過程中以及倘本公司或對手方一旦出現違約、無償債能力或破產時，這也必須具有約束力。

2.9 衍生金融工具

衍生工具於訂立衍生工具合約日期按公允價值初步確認，其後按其公允價值重新計量。重新計量公允價值的相關收益或虧損即時於損益「其他收益／(虧損)」淨額」確認。

2.10 存貨

存貨按成本與可變現淨值兩者中之較低者入賬。成本採用先進先出法計算。可變現淨值為在日常業務過程中之估計銷售價，減適用的變動銷售開支。

2.11 應收賬款、應收保留款及其他應收款

應收賬款及應收保留款為在日常業務過程中就銷售商品或履行服務而應收客戶之款項。如應收賬款、應收保留款及其他應收款預期在一年或以內(或倘時間更長，則於業務之一般營運週期內)收回，其獲分類為流動資產；否則呈列為非流動資產。

應收賬款、應收保留款及其他應收款初步按已成為無條件的代價金額確認，除非含有重大融資成份，在有關情況下，則按公允價值確認。本集團持有目的為收取合約現金流量的應收賬款，因此其後使用實際利率法按攤銷成本對其進行計量。

2.12 Cash and cash equivalents

For the purpose of presentation in the consolidated statement of cash flows, cash and cash equivalents includes cash on hand, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

2.13 Share capital

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

2.14 Trade and other payables

Trade payables are obligations to pay for goods or services that have been acquired in the ordinary course of business from suppliers. Trade and other payable are classified as current liabilities if payment is due within one year or less (or in the normal operating cycle of the business if longer). If not, they are presented as non-current liabilities.

Trade and other payables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

2.15 Borrowings

Borrowings are initially recognised at fair value, net of transaction costs incurred. Borrowings are subsequently measured at amortised cost. Any difference between the proceeds (net of transaction costs) and the redemption amount is recognised in the profit or loss over the period of the borrowings using the effective interest method.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the end of the reporting period.

2.12 現金及現金等價物

就綜合現金流量表之呈列而言，現金及現金等價物包括手頭現金、其他原到期日為三個月或以下、可輕易轉換為已知金額現金及價值變動風險不大的高流動短期投資。

2.13 股本

普通股被列為權益。發行新股或購股權直接應佔增量成本於權益中列示為自所得款扣除(除稅後)。

2.14 應付賬款及其他應付款

應付賬款為在日常業務過程中向供應商購買商品或服務而應支付之義務。如應付賬款及其他應付款之支付日期為一年或以內(或倘時間更長，則於業務之一般營運週期內)，其獲分類為流動負債；否則呈列為非流動負債。

應付賬款及其他應付款初步以公允值確認，其後使用實際利息法按攤銷成本計量。

2.15 借款

借款初步按公允值並扣除產生之交易費用確認。借款其後按攤銷成本列賬；所得款(扣除交易成本)與贖回價值之任何差額使用實際利息法於借款期間於損益確認。

除非本集團有權無條件將負債之結算遞延至報告期末後最少12個月，否則借款分類為流動負債。

2.16 Borrowings costs

General and specific borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

All other borrowing costs are recognised in the profit or loss in the period in which they are incurred.

2.17 Current and deferred income tax

The income tax expense for the period is the tax payable on the current period's taxable income based on the applicable income tax rate for each jurisdiction adjusted by changes in deferred income tax assets and liabilities attributable to temporary differences and to unused tax losses.

(a) Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the end of the reporting period in the countries where the company and its subsidiaries and associates operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation and considers whether it is probable that a taxation authority will accept an uncertain tax treatment. The Group measures its tax balances either based on the most likely amount or the expected value, depending on which method provides a better prediction of the resolution of the uncertainty.

2.16 借款成本

直接歸屬於收購、興建或生產合資格資產(指必須經一段長時間處理以作其預定用途或銷售之資產)之一般及特定借款成本將加入該等資產之成本內，直至資產大致上備妥供其預定用途或銷售為止。

所有其他借款成本在產生期間於損益確認。

2.17 本期及遞延所得稅

期內所得稅開支為按照各司法權區的適用所得稅率就本期應課稅收入應付的稅項，並就暫時差額及未動用稅項虧損應佔遞延所得稅資產及負債的變動作出調整。

(a) 本期所得稅

本期所得稅支出根據本公司及其附屬公司及聯營公司經營及產生應課稅收入之國家於報告期末已頒佈或實質上已頒佈之稅務法例計算。管理層就適用稅務法例受詮釋所規限之情況定期評估報稅表之狀況，並考慮稅務機關是否有可能接受不確定的稅務處理。本集團根據最有可能出現的金額或預期價值(視乎哪個方法能較好地預測不確定因素的解決方案而定)計量其稅項結餘。

2.17 Current and deferred income tax (cont'd)

(b) *Deferred income tax*

Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, deferred income tax liabilities are not recognised if they arise from the initial recognition of goodwill. Deferred income tax is also not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the end of the reporting period and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

The deferred income tax liability in relation to investment property that is measured at fair value is determined assuming the property will be recovered entirely through sale.

Deferred income tax assets are recognised only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

Deferred income tax liabilities and assets are not recognised for temporary differences between the carrying amount and tax bases of investments in foreign operations where the company is able to control the timing of the reversal of the temporary differences and it is probable that the differences will not reverse in the foreseeable future.

2.17 本期及遞延所得稅(續)

(b) *遞延所得稅*

遞延所得稅利用負債法就資產及負債之稅基與資產及負債在綜合財務報表之賬面值之間產生之暫時性差異悉數計提。然而，若遞延所得稅負債來自對商譽之初步確認，則不予確認。若遞延所得稅來自在交易(不包括業務合併)中對資產或負債之初步確認，且在交易時不影響會計損益或應課稅損益，則不予入賬。遞延所得稅採用在報告期末前已頒佈或實質上已頒佈，並在相關遞延所得稅資產變現或遞延所得稅負債結算時預期將會適用之稅率(及法例)而釐定。

按公允值計量有關投資物業的遞延所得稅負債乃根據物業將可於出售時整體收回的假設而釐定。

遞延所得稅資產僅於可能有未來應課稅金額可抵銷暫時性差異及虧損時確認。

遞延所得稅負債及資產未有就賬面值及投資於境外業務的稅基的暫時性差額(其由本公司控制撥回的時間，而該等差額可能不會在可見未來撥回)作出確認。

(b) *Deferred income tax (cont'd)*

Deferred income tax assets and liabilities are offset where there is a legally enforceable right to offset current tax assets and liabilities and where the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

Current and deferred tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

2.18 Employee benefits

(a) *Pension obligations*

A defined contribution plan is a pension plan under which the Group pays fixed contributions into a separate entity. The Group has no legal or constructive obligations to pay further contributions if the fund does not hold sufficient assets to pay all employees the benefits relating to employee service in the current and prior periods. A defined benefit plan is a pension plan that is not a defined contribution plan.

For defined contribution plans, the Group pays contributions to publicly or privately administered pension insurance plans on a mandatory, contractual or voluntary basis. The Group has no further payment obligations once the contributions have been paid. The contributions are recognised as employee benefit expense when they are due. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in the future payments is available.

2.17 本期及遞延所得稅(續)

(b) *遞延所得稅(續)*

倘存在可依法強制執行的權利將本期稅項資產與負債抵銷，及倘遞延稅項結餘與同一稅務機構相關，則可將遞延所得稅資產與負債抵銷。倘實體有可依法強制執行抵銷權利且有意按淨值基準清償或同時變現資產及清償負債時，則本期稅項資產與稅項負債抵銷。

本期及遞延稅項於損益中確認，惟有關於其他全面收益或直接於權益確認的項目除外。在此情況下，稅項亦分別於其他全面收益或直接於權益中確認。

2.18 員工福利

(a) *退休金責任*

界定供款計劃是本集團向一個單獨實體支付定額供款之退休計劃。若該基金並無持有足夠資產向所有員工就其在本期及以往期間之服務支付福利，本集團亦無法定或推定義務支付進一步供款。界定受益計劃為非界定供款計劃之退休計劃。

就界定供款計劃而言，本集團以強制性、合約性或自願性方式向公開或私人管理之退休保險計劃供款。本集團作出供款後，即無進一步付款義務。供款在應付時確認為員工福利支出。預付供款按照現金退款或可減少未來付款而確認為資產。

2.18 Employee benefits (cont'd)

(b) Long service payments

The Group's net obligation in respect of long service payments to its employees upon the termination of their employment or retirement when the employee fulfils certain circumstances under the Hong Kong Employment Ordinance is the amount of future benefit that employees have earned in return for their services in the current and prior periods.

2.19 Provisions

Provisions are recognised when: the Group has a present legal or constructive obligation as a result of past events; it is probable that an outflow of resources will be required to settle the obligation; and the amount has been reliably estimated.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of the expenditures expected to be required to settle the obligation using a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as finance cost.

2.18 員工福利(續)

(b) 長期服務金

根據香港僱傭條例，本集團終止聘用僱員或僱員在滿足若干情況下退休而須向其支付的長期服務金責任淨額，數額為僱員因本期及過往期間提供服務而賺取的未來福利金額。

2.19 撥備

當本集團因已發生之事件而產生現有法律或推定義務；很可能需要資源流出以結算該義務；及金額已獲可靠估計時，本集團將確認撥備。

倘有多項類似義務，則根據義務之類別全面考慮結算時會否需要有資源流出。即使在同一義務類別所包含任何一個項目相關之資源流出之可能性極低，仍須確認撥備。

撥備採用稅前利率按預期需結算有關義務之支出現值計量，該利率反映當時市場對金錢時間值及有關義務特定風險之評估。隨時間增加之撥備確認為財務費用。

2.20 Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable, and represents amounts receivable for goods supplied, stated net of discounts and returns. The Group recognises revenue when goods are transferred or services are rendered to the customer.

A contract asset is the Group's right to consideration in exchange for the services that the Group has transferred to a customer. In addition, incremental costs incurred to obtain a new contract, if recoverable, are capitalised as contract assets and subsequently amortised when the related revenue is recognised. A contract liability is the Group's obligation to render the services to a customer for which the Group has received consideration from the customer. A contract liability is recognised by the Group when the customer pays consideration in advance before the Group satisfy the performance obligation to the customer.

A contract asset is the Group's right to consideration in exchange for the services that the Group has transferred to a customer. In addition, incremental costs incurred to obtain a new contract, if recoverable, are capitalised as contract assets and subsequently amortised when the related revenue is recognised. A contract liability is the Group's obligation to render the services to a customer for which the Group has received consideration from the customer. A contract liability is recognised by the Group when the customer pays consideration in advance before the Group satisfy the performance obligation to the customer.

2.20 收益確認

收益按已收或應收代價的公允值計量，指就所供應的貨品而應收的金額，經扣除折扣及退貨後列賬。本集團於貨品轉讓或向客戶提供服務時確認收益。

合約資產指本集團就交換本集團已轉移予客戶的服務之代價的權利。此外，為獲取新合約所得之增量成本(倘可收回)乃資本化為合約資產，並於其後在相關收益確認時攤銷。合約負債指本集團向客戶提供服務的責任，本集團就此已向客戶收取代價。本集團於客戶在本集團履行向客戶的責任前預先支付代價時確認合約負債。

合約資產指本集團就交換本集團已轉移予客戶的服務之代價的權利。此外，為獲取新合約所得之增量成本(倘可收回)乃資本化為合約資產，並於其後在相關收益確認時攤銷。合約負債指本集團向客戶提供服務的責任，本集團就此已向客戶收取代價。本集團於客戶在本集團履行向客戶的責任前預先支付代價時確認合約負債。

2.20 Revenue recognition (cont'd)

(a) Sales of goods

The Group sells architectural builders' hardware, bathroom, kitchen collections and furniture in the wholesale and retail market. Revenue from sales of goods is recognised when control of the goods has transferred, being when the goods are delivered to the customer.

(b) Contract revenue

The Group engages in importing, selling and installation of kitchen collections, and other construction and decoration works to contractors and property developers. Revenue from the services rendered by the Group is recognised over time as the Group's performance creates or enhances an asset or work in progress that the customer controls as the asset is created or enhanced. The Group has applied the output method in recognising the revenue from construction contracts over time. The progress towards complete satisfaction of a performance obligation of construction contracts is measured with reference to either surveys of work performed or actual stage of completion of the contract work.

(c) Rental income

Rental income from investment property is recognised in the profit or loss on a straight-line basis over the term of the lease.

(d) Finance income

Finance income is recognised using the effective interest method to the gross carrying amount of a financial asset except for financial assets that subsequently become credit-impaired. For credit-impaired financial assets the effective interest rate is applied to the net carrying amount of the financial asset (after deduction of the loss allowance).

2.20 收益確認 (續)

(a) 銷售貨品

本集團銷售建築五金、衛浴、廚房設備及傢俬予批發及零售市場。銷售貨品所得收益乃於貨品控制權轉讓之時(即向客戶交付貨品時)予以確認。

(b) 合約收益

本集團從事進口、銷售及安裝廚房設備以及向承建商及物業發展商提供其他建築及裝修工程。本集團提供服務所得收益隨時間確認，因為本集團履約時會創建和提升由客戶控制的資產或在建工程。本集團已採用產出法隨時間確認建築合約的收益。完成建築合約的履約責任的進度乃參考已進行工程調查或完成合約工程的實際階段來計量。

(c) 租金收入

投資物業租金收入於租期內按直線基準在損益確認。

(d) 財務收益

財務收益採用實際利率法確認金融資產的賬面總值，惟後續變為信貸減值的金融資產除外。對於信貸減值的金融資產，實際利率適用於金融資產的賬面淨值(經扣除虧損撥備)。

2.21 Leases

Leases are recognised as a right-of-use asset and a corresponding liability at the date at which the leased asset is available for use by the Group.

Contracts may contain both lease and non-lease components. The Group allocates the consideration in the contract to the lease and non-lease components based on their relative stand-alone prices. However, for leases of real estate for which the Group is a lessee, it has elected not to separate lease and non-lease components and instead accounts for these as a single lease component.

Lease terms are negotiated on an individual basis and contain a wide range of different terms and conditions. The lease agreements do not impose any covenants other than the security interests in the leased assets that are held by the lessor. Leased assets may not be used as security for borrowing purposes.

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities include the net present value of the following lease payments:

- fixed payments (including in-substance fixed payments), less any lease incentives receivable
- variable lease payment that are based on an index or a rate, initially measured using the index or rate as at the commencement date
- amounts expected to be payable by the Group under residual value guarantees
- the exercise price of a purchase option if the Group is reasonably certain to exercise that option, and
- payments of penalties for terminating the lease, if the lease term reflects the Group exercising that option.

2.21 租賃

租賃於租賃資產可供本集團使用當日確認為使用權資產及相應負債。

合約可包含租賃及非租賃部分。本集團根據其相對獨立的價格將合約的代價分配至租賃及非租賃部分。然而，就本集團作為承租人的房地產租賃而言，本集團已選擇不分開租賃及非租賃部分而以單一租賃部分入賬。

租期按個別基準磋商，並包含各種不同之條款及條件。租賃協議概無施加任何契諾，惟於出租人持有之租賃資產中之抵押權益除外。租賃資產不得用作借款抵押。

租賃所產生的資產及負債初步按現值基準計量。租賃負債包括以下租賃付款的淨現值：

- 固定付款(包括實質固定付款)減任何應收租賃優惠
- 基於指數或利率並於開始日期按指數或利率初步計量的可變租賃付款
- 剩餘價值擔保下本集團預期應付款項
- 購買選擇權的行使價(倘本集團合理確定行使該選擇權)，及
- 支付終止租賃的罰款(倘租期反映本集團行使該選擇權)。

2.21 Leases (cont'd)

Lease payments to be made under reasonably certain extension options are also included in the measurement of the liability.

The lease payments are discounted using the interest rate implicit in the lease. If that rate cannot be readily determined, which is generally the case for leases in the Group, the lessee's incremental borrowing rate is used, being the rate that the individual lessee would have to pay to borrow the funds necessary to obtain an asset of similar value to the right-of-use asset in a similar economic environment with similar terms, security and conditions.

To determine the incremental borrowing rate, the Group:

- where possible, uses recent third-party financing received by the individual lessee as a starting point, adjusted to reflect changes in financing conditions since third party financing was received
- makes adjustments specific to the lease, e.g. term, country, currency and security.

Lease payments are allocated between principal and finance cost. The finance cost is charged to profit or loss over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period.

Right-of-use assets are measured at cost comprising the following:

- the amount of the initial measurement of lease liability
- any lease payments made at or before the commencement date less any lease incentives received
- any initial direct costs, and
- restoration costs.

根據合理確定延長選擇權作出的租賃付款亦計入負債計量。

租賃付款採用租賃所隱含的利率貼現。倘無法輕易釐定該利率(本集團的租賃一般屬此類情況)，則使用承租人增量借款利率(即個別承租人在類似經濟環境中按類似條款、抵押及條件借入獲得與使用權資產價值類似資產所需資金必須支付的利率)。

為釐定增量借款利率，本集團：

- 在可行情況下，使用個別承租人最近獲得的第三方融資為出發點(經調整以反映自獲得第三方融資以來融資條件的變動)
- 就租賃進行特定調整，例如期限、國家、貨幣及抵押。

租賃付款於本金及財務費用之間作出分配。財務費用在租期內自損益扣除，以得出各期間負債餘款的固定週期利率。

使用權資產按成本計量，包括以下各項：

- 初步計量租賃負債的金額
- 在開始日期或之前作出的任何租賃付款減任何已收租賃優惠
- 任何初始直接成本，及
- 復原成本。

2.21 Leases (cont'd)

Right-of-use assets are generally depreciated over the shorter of the asset's useful life and the lease term on a straight-line basis. If the Group is reasonably certain to exercise a purchase option, the right-of-use asset is depreciated over the underlying asset's useful life. While the Group revalues its land and buildings that are presented within property, plant and equipment, it has chosen not to do so for the right-of-use buildings held by the Group.

Payments associated with short-term leases are recognised on a straight-line basis as an expense in profit or loss. Short-term leases are leases with a lease term of 12 months.

Lease income from operating leases where the Group is a lessor is recognised in income on a straight-line basis over the lease term (Note 17). Initial direct costs incurred in obtaining an operating lease are added to the carrying amount of the underlying asset and recognised as expense over the lease term on the same basis as lease income. The respective leased assets are included in the consolidated statement of financial position based on their nature. The Group did not need to make any adjustments to the accounting for assets held as lessor as a result of adopting the new leasing standard.

The Group has adopted Amendment to HKFRS 16 — Covid-19-Related Rent Concessions beyond 30 June 2021. The amendment provides an optional practical expedient allowing lessees to elect not to assess whether a rent concession related to COVID-19 is a lease modification. Lessees adopting this election may account for qualifying rent concessions in the same way as they would if they were not lease modifications.

使用權資產一般按資產的使用年限及租期(以較短者為準)按直線法折舊。倘本集團合理確定行使購買選擇權,則使用權資產按相關資產的使用年限折舊。本集團會重估物業、廠房及設備內呈列的土地及樓宇,惟本集團持有的使用權樓宇不予重估。

短期租賃相關付款按直線法於損益中確認為開支。短期租賃為租期12個月的租賃。

倘本集團作為出租人,則自經營租賃所得租賃收入根據租期按直線法於收入內確認(附註17)。獲取經營租賃產生的初始直接成本會加入相關資產的賬面值,並根據租期按與租賃收入相同的基準確認為開支。相關租賃資產按其性質計入綜合財務狀況表。本集團無需因採納新租賃準則而對作為出租人持有的資產會計處理法作任何調整。

本集團已自二零二一年六月三十日起追溯性採納香港財務報告準則第16號修訂本—2019冠狀病毒病相關租金寬減。該修訂本提供了一項可選的可行權宜方法,允許承租人選擇不評核與2019冠狀病毒病相關的租金寬減是否屬租賃修改。採納該選擇的承租人可以同一方式將合資格租金寬減入賬(倘彼等並非租賃修改)。

2.21 Leases (cont'd)

The practical expedient only applies to rent concessions occurring as a direct consequence of the COVID-19 pandemic and only if all of the following conditions are met:

- (a) the change in lease payments results in revised consideration for the lease that is substantially the same as, or less than, the consideration for the lease immediately preceding the change;
- (b) any reduction in lease payments affects only payments due on or before 30 June 2021; and
- (c) there is no substantive change to other terms and conditions of the lease.

The Group has applied the practical expedient to all qualifying COVID-19-Related Rent Concessions.

2.22 Dividend distribution

Dividend distribution to the Company's shareholders is recognised as a liability in the Group's and the Company's financial statements in the period in which the dividends are approved by the Company's shareholders or directors, where appropriate.

2.23 Government grants

Grants from the government are recognised at their fair value where there is a reasonable assurance that the grant will be received and the group will comply with all attached conditions.

(a) *Basic earnings per share*

Basic earnings per share is calculated by dividing:

- the profit attributable to owners of the company, excluding any costs of servicing equity other than ordinary shares
- by the weighted average number of ordinary shares outstanding during the financial year, adjusted for bonus elements in ordinary shares issued during the year and excluding treasury shares.

(b) *Diluted earnings per share*

Diluted earnings per share adjusts the figures used in the determination of basic earnings per share to take into account:

- the profit attributable to owners of the company, excluding any costs of servicing equity other than ordinary shares
- by the weighted average number of ordinary shares outstanding during the financial year, adjusted for bonus elements in ordinary shares issued during the year and excluding treasury shares.

3.1 Financial risk factors

The Group's activities expose it to a variety of financial risks: market risk (including interest rate risk and foreign currency risk), credit risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(a) Interest rate risk

The Group's income and operating cash flows are substantially independent of changes in market interest rates. The Group's interest rate risk arises from borrowings and interest-bearing bank deposits. Interest-bearing financial assets/liabilities at variable rates expose the Group to cash flow interest rate risk. Interest-bearing financial assets/liabilities at fixed rates expose the Group to fair value interest rate risk.

As at 31 March 2023, if the interest rate had increased/decreased by 50 basis points with all other variables held constant, the Group's profit for the year and retained earnings would increase/decrease by approximately HK\$344,000 (2022: HK\$259,000). The 50 basis point increase/decrease represents management's assessment of a reasonably possible change in interest rates over the period until the next annual reporting date.

(b) Foreign currency risk

The Group mainly operates in Hong Kong with most of the sales transactions settled in Hong Kong dollars. However, foreign currencies are required to settle the Group's purchases from overseas suppliers. It is exposed to foreign exchange risk primarily with respect to United States dollar ("US\$"), EURO ("EUR") and Chinese Renminbi ("RMB") denominated transactions.

3 財務風險管理

3.1 財務風險因素

本集團面對不同財務風險：市場風險（包括利率風險及外匯風險）、信貸風險及流動資金風險。本集團整體風險管理集中在難以估計之金融市場，並致力減低對本集團財務表現之潛在不利影響。

(a) 利率風險

本集團絕大部分收入及經營現金流量不受市場利率變動之影響。本集團之利率風險來自借貸及有息銀行存款。按浮動利率計息之金融資產／負債導致本集團面對現金流量利率風險。按固定利率計息之金融資產／負債則導致本集團面對公允價值利率風險。

於二零二三年三月三十一日，假若利率上浮／下浮50基點，而所有其他變數維持不變，則本集團之年度溢利及保留溢利將增加／減少約344,000港元（二零二二年：259,000港元）。50基點之上浮／下浮區間代表管理層評估截至下一年度報告日止之合理可能利率變動。

(b) 外匯風險

本集團主要於香港營運，故大部分銷售交易均以港元結算，但向各海外供應商購貨付款時則使用外幣。本集團所面對的外匯風險主要來自以美元（「美元」）、歐羅（「歐羅」）及人民幣（「人民幣」）為單位的交易。

3.1 Financial risk factors (cont'd)

(b) Foreign currency risk (cont'd)

To manage their foreign exchange risk arising from certain future commercial transactions and recognised liabilities, entities in the Group use forward contracts, transacted with external financial institutions. Foreign exchange risk arises when future commercial transactions or recognised liabilities are denominated in a currency that is not the entity's functional currency.

As at 31 March 2023, some group entities with functional currency of HKD had considerable amount of trade payables and bank balances and cash denominated in US\$. Under the Linked Exchange Rate System in Hong Kong, HKD is pegged to US\$, management therefore considers that there is no significant foreign exchange risk with respect to US\$ (2022: same).

At 31 March 2023, if the EUR had strengthened/weakened by 5% (2022: 5%) against the HKD with all other variables held constant, there will be no significant impact on the post-tax profit of the Group (2022: same).

At 31 March 2023, if the RMB had strengthened/weakened by 5% (2022: 5%) against the HKD with all other variables held constant, profit for the year would have changed as follows. The changes are mainly as a result of the foreign exchange gains/losses on translation of RMB denominated trade payables.

(b) 外匯風險(續)

為管理若干未來商業交易及確認負債所產生的外匯風險，本集團旗下實體與外部財務機構交易時使用遠期合約。當未來商業交易或已確認負債以非實體功能貨幣的貨幣計值時會產生外匯風險。

於二零二三年三月三十一日，功能貨幣為港元的若干集團實體有大量以美元為單位的應付賬款以及銀行結餘及現金。根據香港聯繫匯率制度，港元與美元掛鈎，故管理層認為並無有關美元的重大外匯風險(二零二二年：相同)。

於二零二三年三月三十一日，假若歐羅兌港元升值/貶值5%(二零二二年：5%)，而所有其他變數維持不變，將不會對本集團之除稅後溢利產生重大影響(二零二二年：相同)。

於二零二三年三月三十一日，假若人民幣兌港元升值/貶值5%(二零二二年：5%)，而所有其他變數維持不變，則年度溢利將變動如下。變動主要由於換算以人民幣為單位之應付賬款產生匯兌收益/虧損所致。

(c) Credit risk

(i) Risk management

The Group's credit risk is primarily attributable to cash and cash equivalents, trade, retention and other receivables and contract assets.

To manage the risk arising from cash and cash equivalents, the Group only transacts with reputable banks which are all high-credit-quality financial institutions. There has no recent history of default in relation to these financial institutions. The expected credit loss is insignificant.

For other receivables, management makes periodic collective assessments as well as individual assessment on the recoverability of deposits and other receivables based on historical settlement records, past experience, current conditions and forward-looking information on macroeconomic factors. The management believes that the expected credit loss is insignificant.

For trade and retention receivables and contract assets, management makes periodic individual assessment on their recoverability.

The Group applies the HKFRS 9 simplified approach to measuring expected credit losses which uses a lifetime expected loss allowance for all trade and retention receivables and contract assets.

To measure expected credit losses, the Group categorises its trade and retention receivables and contract assets based on the nature of customer accounts and shared credit risk characteristics.

(c) 信貸風險

(i) 風險管理

本集團之信貸風險主要由現金及現金等價物、應收賬款、應收保留款及其他應收款以及合約資產組成。

為管理現金及現金等價物產生的風險，本集團僅與有信譽的銀行(均為高信用等級的財務機構)交易。並無近期違約記錄與該等財務機構有關。預期信貸虧損並不重大。

就其他應收款而言，管理層根據過往結算記錄、過往經驗、流動狀況及有關宏觀經濟因素的前瞻性資料對按金及其他應收款的可收回性定期作出整體評估以及個別評估。管理層認為預期信貸虧損並不重大。

就應收賬款及應收保留款以及合約資產而言，管理層定期個別評估其可收回性。

本集團應用香港財務報告準則第9號簡化法計量預期信貸虧損，就所有應收賬款及應收保留款以及合約資產應用全期預期虧損撥備。

為計量預期信貸虧損，本集團根據客戶賬目的性質及共享的信貸風險特徵分類其應收賬款及應收保留款以及合約資產。

(d) Liquidity risk

The Group's policy is to regularly monitor current and expected liquidity requirements to ensure that it maintains sufficient reserves of cash to meet its liquidity requirements in the shorter and longer term.

As at 31 March 2023, the Group held cash and cash equivalents of approximately HK\$123,296,000 (2022: approximately HK\$104,199,000) that could be readily realised to generate cash inflows for managing liquidity risk.

As at 31 March 2023 and 2022, the remaining contractual maturities of the Group's and the Company's financial liabilities, based on undiscounted cash flows and the earliest date our Group can be required to pay. Balance date within 12 months equal their carrying balance circulating both interest and principal as the impact of discounting is not significant.

本集團定期監察現有及預期之流動資金需求，以確保本集團維持足夠現金儲備以滿足短期及長期流動資金需求。

於二零二三年及二零二二年三月三十一日，本集團及本公司按照未貼現現金流量及本集團須支付的最早日期之金融負債之餘下合約到期日。由於貼現影響不大，12個月內的結餘相當於其流通利息及本金的賬面結餘。

Note: According to Hong Kong Interpretation 5, "Presentation of Financial Statements — Classification by the Borrower of a Term Loan that contains a Repayment on Demand Clause", if a term loan agreement includes an overriding repayment on demand clause ("callable feature"), which gives the lender a clear and unambiguous unconditional right to demand repayment at any time at its sole discretion, a borrower shall classify the term loan as a current liability in its statement of financial position, as the borrower does not have an unconditional right to defer settlement of the liability for at least twelve months after the reporting period. Accordingly the long-term portion of the Group's bank borrowings of approximately HK\$50,843,000 (2022: approximately HK\$37,250,000) were classified as current liabilities in the consolidated statement of financial position as at 31 March 2023.

3.2 Capital management

The Group's objectives on capital management are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, return capital to shareholders, issue new shares or sell assets to reduce debt.

Consistent with others in the industry, the Group monitors capital on the basis of gearing ratio. This ratio is calculated as net debt divided by total capital. Net cash is calculated as total borrowings plus lease liabilities less cash and cash equivalents. Total capital is calculated as "equity" as shown in the consolidated statement of financial position plus net debt.

附註：根據香港詮釋第5號「財務報表之呈列 — 借款人對載有應要求償還條款之有期貸款之分類」，有期貸款協議倘包含凌駕一切之應要求償還條款（「催繳權」），給予貸款人清晰明確之無條件權利可隨時全權酌情要求還款，則借款人應於財務狀況表將有期貸款分類為流動負債，原因為借款人並沒有無條件權利可將償還負債之期限遞延至報告期間後最少十二個月。因此，於二零二三年三月三十一日，本集團銀行借款長期部分約50,843,000港元（二零二二年：約37,250,000港元）已於綜合財務狀況表分類為流動負債。

3.2 資本管理

本集團管理資本之目標為保障本集團能夠持續經營，從而繼續為股東提供回報、惠及其他持份者以及維持理想之資本架構以減低資本成本。

為維持或調整資本架構，本集團或會調整支付予股東的股息金額、向股東退回資本、發行新股份或出售資產以減少債務。

本集團根據資產負債比率監控其資本，而此亦符合行業一般政策。此比率按債項淨額除以資本總額計算。現金淨額則以總借貸加租賃負債減現金及現金等物計算。資本總額按綜合財務狀況表所載之「權益」加上債項淨額計算。

4 CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are addressed below.

4.1 Provision for inventory obsolescence

In determining the amount of allowance required for obsolete and slow-moving inventories, the Group evaluates the ageing of inventories, their historical sales pattern, their subsequent utilisation and other factors and compare the carrying value of inventories to their estimated net realisable values. The identification of inventory obsolescence and estimated selling price in the ordinary course of business requires the use of judgement and estimates. Where the expectation is different from the original estimate, such difference will impact the carrying value of inventory and impairment provision in the year in which such estimate has been changed.

4.2 Provision for impairment of trade and retention receivables and contract assets

The Group makes provision for impairment of trade and retention receivables and contract assets based on assumptions about risk of default and expected loss rates. The Group uses judgement in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's historical default rates, existing market conditions as well as forward looking estimates at the end of each reporting period. The estimation of expected credit losses requires the use of judgement and estimates. Where the expectations are different from the original estimates, such differences will impact the carrying value of receivables and loss for the impairment of receivables recognised in the periods in which such estimates have been changed.

4 重大會計估計及判斷

本集團根據過往經驗及其他因素不斷評估估計及判斷，包括在相信屬合理之情況下對未來事件之期望。

本集團對未來作出估算及假設。所得的會計估算顧名思義極少與其實際結果相同。對資產及負債於下一個財政年度之賬面值造成重大調整風險之估計及假設如下。

4.1 過時存貨撥備

於決定過時及滯銷存貨所需撥備金額時，本集團會評估存貨賬齡、歷史銷售模式、後續運用情況及其他因素，並比較存貨之賬面值與其估計變現淨值。識別過時存貨及在日常業務過程中之預計售價需要作出判斷及估計。倘預期與原本估計有差異，此差異將影響估計數值出現變動年內之存貨之賬面值及減值撥備。

4.2 應收賬款及應收保留款及合約資產減值撥備

本集團基於違約風險及預期虧損率的假設就應收賬款及應收保留款及合約資產作出減值撥備。本集團根據本集團的歷史違約率、現有市場狀況及各報告期末的前瞻性估計，使用判斷作出該等假設及選擇減值計算的輸入數據。預期信貸虧損的估計需要使用判斷及估計。倘預期與原始估計不同，有關差額將影響應收款項的賬面值及估計變更期間確認的應收款項減值虧損。

4 CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS (CONT'D)

4.3 Recognition for contract revenue over time

The Group uses the output method in accounting for its construction contracts for sales and installation of kitchen collections, and other construction and decoration works. The progress towards complete satisfaction of the performance obligation is determined by reference to independent surveys of work performed or actual stage of completion of the contract work. The Group reviews and revises the estimates of contract revenue, contract costs, variation orders and contract claims prepared for each construction contract as the contract progresses. Budgeted construction income is determined in accordance with the terms set out in the relevant contracts. Budgeted construction costs which mainly comprise sub-contracting charges and costs of materials are prepared by the management on the basis of quotations from time to time provided by major contractors, suppliers or vendors involved and the experience of the management. In order to keep the budget accurate and up-to-date, the Group's management conducts periodic review on the management budgets by comparing the budgeted amounts to the actual amounts incurred.

A considerable amount of judgement is required in estimating the total contract revenue, contract costs, variation orders and contract claims which may have an impact in terms of progress towards complete satisfaction of the performance obligation.

4.4 Valuation of leasehold land and buildings

The best evidence of fair value is the current prices in an active market for similar properties. In making its estimates, the Group considers the information from the valuations of leasehold land and buildings performed by external professional valuers by using the open market value approach. If the Group used different valuation techniques, the fair value of the leasehold land and buildings may be different and thus may have an impact to the consolidated statement of comprehensive income.

4.3 合約收益隨時間確認

本集團於確認其銷售及安裝廚房設備以及其他建築及裝修工程之工程合約時採用產出法。履約責任完成進度乃依據已進行工程之獨立調查或佔合約工程的實際完工階段而釐定。本集團於合約進行期間檢討及修訂各工程合約之合約收益、合約成本、變更項目及合約索償估計。預算工程收入乃根據相關合約所載條款而定。預算工程成本主要包括分包費用及材料成本，由管理層按所涉及及主要承包商、供應商或賣方不時提供之報價以及管理層之經驗而釐定。為維持準確及最新之預算，本集團管理層透過比較預算金額與實際款項定期檢討管理預算。

由於估計總合約收益、合約成本、變更項目及合約索償時需作出相當程度之判斷，故可能影響履約責任完成進度。

4.4 租賃土地及樓宇估值

公允值之最佳證據為類似物業於活躍市場之當前價格。在作出估計時，本集團考慮由外聘專業估值師以公開市值法就租賃土地及樓宇進行估值之資料。倘本集團採用不同評估方式，則租賃土地及樓宇之公允值或會不一樣，而綜合全面收益表或會受影響。

4.5 Income tax

Deferred income tax assets are recognised for unused tax losses to the extent that it is probable that future taxable profit will be available against which the tax losses can be utilised. Significant management judgement is required to determine the amount of deferred income tax assets that can be recognised, based upon the likely timing and level of future taxable profits together with future tax planning strategies. Management's assessment is regularly reviewed and additional deferred income tax assets are recognised if it becomes probable that future taxable profits will allow the deferred income tax assets to be recovered.

The Group is subject to income taxes in Hong Kong and the PRC. Significant judgement is required in determining the provision for income tax. There are many transactions and calculations for which the ultimate determination is uncertain. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such difference will impact the income tax and deferred tax provisions in the period in which such determination is made.

4.5 所得稅

倘很可能有未來應課稅溢利以抵銷可動用稅項虧損，則遞延所得稅資產將按尚未動用稅項虧損確認。釐定可予確認之遞延所得稅資產數額需要管理層作出重要判斷，主要根據時間性、未來應課稅溢利及未來稅務安排策略釐定。本集團定期審閱管理層之評估，且倘很有可能未來應課稅溢利，致使可收回遞延所得稅資產，則將確認額外遞延所得稅資產。

本集團須在香港及中國繳納所得稅。於釐定所得稅撥備時須作出重大判斷。大量交易及計算均無法確定最終所得稅。倘該等事項之最終稅務結果有別於最初記錄之金額，則有關差額將影響作出有關決定之期間之所得稅及遞延所得稅撥備。

8 SEGMENT INFORMATION

The executive directors of the Company (the “Executive Directors”) are the Group’s chief operating decision-makers. Management has determined the operating segments based on the information reviewed by the Executive Directors for the purposes of allocating resources and assessing performance.

The Group’s reportable operating segments are as follows:

- Architectural builders’ hardware, bathroom collections and others segment — importing, wholesale and retail of architectural builders’ hardware and bathroom collections and others
- Kitchen collection and furniture segment — designing, importing, wholesale, retail and installation of kitchen collections and furniture

The measurement policies the Group used for reporting segment results under HKFRS 8 are the same as those used in its consolidated financial statements prepared under HKFRSs.

The Executive Directors assess the performance of the operating segments based on the measure of gross profit. Other operating income and expenses are not allocated to the operating segments as the information is not regularly reviewed by the Executive Directors.

Segment assets include all assets but exclude current income tax recoverable, deferred income tax assets, derivative financial assets, time deposits with maturity over three months, cash and cash equivalents, property, plant and equipment related to the office premises and warehouse of the Group and other corporate assets which are managed on central basis and are not directly attributable to the business activities of any operating segment.

Segment liabilities include all liabilities but exclude current and deferred income tax liabilities, borrowings, derivative financial liabilities and other corporate liabilities which are managed on central basis and are not directly attributable to the business activities of any operating segment.
