The Board was notified by Broad Landscape International Company Limited (the "**Broad Landscape International**") that it had on 31 July 2023, after trading hours, entered into (i) a sale and purchase agreement with Hopeful International Limited (the "**Hopeful**"), pursuant to which Broad Landscape International agreed to sell and Hopeful agreed to purchase 160,000,000 shares of the Company ("**Shares**"), representing approximately 4.79% of the issued Share capital of the Company as at the date of this announcement, for cash consideration of HK\$16,000,000 (being HK\$0.1 per Share); (ii) a sale and purchase agreement with Hong Kong HDB Investment Company Limited (the "**Hong Kong HDB**"), pursuant to which Broad Landscape International agreed to sell and Hong Kong HDB agreed to purchase 160,000,000 Shares, representing approximately 4.79% of the issued Share capital of the Company as at the date of this announcement, for cash consideration of HK\$16,000,000 (being HK\$0.1 per Share); and (iii) a sale and purchase agreement with China Li Ying Investment Company Limited (the "**China Li Ying**"), pursuant to which Broad Landscape International agreed to sell and China Li Ying agreed to purchase 165,000,000 Shares, representing approximately 4.79% of the issued Share capital of the Share); and (iii) a sale and purchase agreement with China Li Ying Investment Company Limited (the "**China Li Ying**"), pursuant to which Broad Landscape International agreed to sell and China Li Ying agreed to purchase 165,000,000 Shares, representing approximately 4.94% of the issued Share capital of the Company as at the date of this announcement, for cash consideration of HK\$16,500,000 (being HK\$0.1 per Share) (the "**Disposals**").

The Disposals were completed immediately after entering into the respective sale and purchase agreements. Broad Landscape International remains as a substantial shareholder of the Company upon the completion of the Disposals.

Hopeful is a company incorporated in Republic of Seychelles with limited liability. Hopeful is an investment holding company. The beneficial owners are Zhang Zhenhai, Xu Shiping and Hu Jie.

Hong Kong HDB is a company incorporated in Hong Kong with limited liability. Hong Kong HDB is principally engaged in provision of a modern logistics platform integrating cross-border e-commerce, international logistics and global warehousing services, and create a high-end professional cross-border e-commerce logistics provider. The beneficial owner is Ma Liangping.

China Li Ying is a company incorporated in Hong Kong with limited liability. China Li Ying is principally engaged in provision of investment consulting and corporate financing services. The beneficial owners are Wang Mei and Zhu Yun.
