The board of directors (the “**Board**”) of Sunkwan Properties Group Limited (the “**Company**”, together with its subsidiaries, collectively the “**Group**”) is pleased to announce that the cumulative contracted sales of the Group, together with the joint ventures and associates, for the seven months ended 31 July 2023, were approximately RMB1.73 billion, and the contracted sales area was approximately 158,027 square meters. The average contracted sales price for the seven months ended 31 July 2023 was approximately RMB10,920 per square meter.
