The Board hereby announces that on August 11, 2023: (i) the Company (as the buyer) entered into the Purchase Agreement with the Supplier and the Lessee, pursuant to which, the Company shall purchase the Leased Assets from the Supplier at the total consideration of RMB69,230,000; and (ii) the Company (as the lessor) entered into the Financial Lease Agreement with the Lessee, pursuant to which, among other things, the Company shall lease the Leased Assets to the Lessee for a term of 12 months with a total finance lease payment of RMB47,156,155, which shall include a finance lease principle of RMB45,000,000 and a finance lease interest income (inclusive of VAT) of RMB2,156,155.

THE PURCHASE AGREEMENT

The principal terms of the purchase Agreement are as follows:

Delivery of the Leased Assets and Payment of Transfer Consideration

The Leased Assets are high-performance servers, with a appraisal value of approximately RMB69,230,000.

The Lessee does not separately calculate the profits before and after tax of the Leased Assets. The transfer consideration for the acquisition of the Leased Assets under the Finance Lease Agreement will be funded by the Company's internal resources. If the Lessee has properly and fully performed all of its obligations under the Finance Lease Agreement, the Lessee is entitled to acquire the Leased Assets at the consideration of RMB100 in nominal value pursuant to the terms and conditions of the Finance Lease Agreement, upon the expiry of the Finance Lease Agreement.

The Lessee shall pay the lease payment to the Lessor at the end of each quarter in installments in accordance with the terms and conditions of the Finance Lease Agreement during the lease period.
