Announcement Trading Update Power Generation For July 2023

This announcement is made by CGN New Energy Holdings Co., Ltd. (the "Company") on a voluntary basis.

The board (the "Board") of directors (the "Directors") of the Company announces that, according to the preliminary statistics of the Company, the power generation of the Company and its subsidiaries (the "Group") on a consolidated basis amounted to 1,749.4GWh for the month of July 2023, representing an increase of 6.5% compared with the corresponding period of 2022. In particular, power generation of PRC wind projects increased by 38.0%, power generation of PRC solar projects increased by 4.1%, power generation of PRC cogen and gas-fired projects increased by 5.5%, power generation of PRC hydro projects decreased by 62.6% and power generation of Korea projects decreased by 14.4%. For the seven months ended 31 July 2023, the accumulated power generation of the Group of this year amounted to 11,890.0GWh, representing an increase of 6.5% compared with the corresponding period of 2022. In particular, power generation of PRC wind projects increased by 19.2%, power generation of PRC solar projects increased by 1.3%, power generation of PRC cogen and gas-fired projects increased by 4.0%, power generation of PRC hydro projects decreased by 66.1% and power generation of Korea projects decreased by 2.5%.
