ANNOUNCEMENT POWER GENERATION FOR JULY 2023

This announcement is made by China Datang Corporation Renewable Power Co., Limited* (the “**Company**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board of directors (the “**Board**”) of the Company announces that, according to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (collectively, the “**Group**”) for July 2023 on consolidated basis amounted to 2,171,959 MWh, representing an increase of 33.17% compared with that of the corresponding period of 2022, of which, the wind power generation amounted to 1,945,734 MWh, representing an increase of 32.65% compared with that of the corresponding period of 2022; and the photovoltaic power generation amounted to 226,226 MWh, representing an increase of 37.76% compared with that of the corresponding period of 2022. As of 31 July 2023, the total power generation of the Group for 2023 amounted to 19,295,534 MWh, representing an increase of 20.58% compared with that of the corresponding period of 2022, of which, the wind power generation amounted to 17,882,945 MWh, representing an increase of 18.40% compared with that of the corresponding period of 2022; and the photovoltaic power generation amounted to 1,412,589 MWh, representing an increase of 57.24% compared with that of the corresponding period of 2022.
