9. *Items (i) to (viii) are suggested forms of confirmation which may be amended to meet individual cases.*

10. *“Identical” means in this context:*

- *the securities are of the same nominal value with the same amount called up or paid up;*
- *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
- *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*

Remarks: The total number of issued shares as at 31 July 2023 was 25,046,457,462 (comprising 4,585,909,150 Class A ordinary shares and 20,460,548,312 Class B ordinary shares).
Xiaomi Corporation (the "Company") purchased a total of 49,500,000 class B ordinary shares during the period from 29 May 2023 to 11 July 2023 (the "Shares Repurchased") on the Stock Exchange. All the Shares Repurchased were subsequently cancelled on 21 August 2023 and the number of class B ordinary shares in issue was reduced by 49,500,000 shares as a result of the cancellation accordingly. Upon cancellation of the Shares Repurchased, the weighted voting rights ("WVR") beneficiaries of the Company, simultaneously reduced their WVR in the Company proportionately by way of converting their class A ordinary shares into class B ordinary shares on a one-to-one ratio pursuant to Rule 8A.21 of the Listing Rules, such that the proportion of shares carrying WVR of the Company shall not be increased, pursuant to the requirements under Rules 8A.13 and 8A.15 of the Listing Rules.
