The Board has no other information on the Winding-up Order other than those disclosed in the announcement dated 15 August 2023 made by the joint provisional liquidators of Goldin and published by Goldin (the "**Goldin Announcement**"). Despite Mr. Shek being the Chairman and an executive director of Goldin, the Winding-up Order is not related to the Group in any way. The Board considers that the Winding-up Order does not and will not have any impact on the business and operations of the Group and as disclosed in the Announcements, the Board is satisfied that Mr. Shek is suitable to continue to act as an independent non-executive Director.

Save as disclosed in this announcement, there is no other matter concerning the change in information of Mr. Shek that needs to be brought to the attention of the shareholders of the Company.
