### POLL RESULTS OF THE EXTRAORDINARY GENERAL MEETING HELD ON 24 AUGUST 2023

At the extraordinary general meeting (the “EGM”) of China Electronics Optics Valley Union Holding Company Limited (the “Company”) held on 24 August 2023, the proposed resolution as set out in the notice of the EGM dated 2 August 2023 was taken by poll.
