POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 25 AUGUST 2023

All the Proposed Resolutions as set out in the AGM Notice were duly passed by the Shareholders by way of poll at the 2023 AGM.

POLL RESULTS OF 2023 AGM

The board of directors of Tsui Wah Holdings Limited (the “**Company**”, the “**Directors**” and the “**Board**”, respectively) is pleased to announce that all the proposed ordinary resolutions (the “**Proposed Ordinary Resolutions**”) and the proposed special resolution (the “**Proposed Special Resolution**”) (collectively, the “**Proposed Resolutions**”) as set out in the notice of the annual general meeting of the Company (the “**AGM**”) dated 21 July 2023 (the “**AGM Notice**”) were duly passed by the holders of the Company’s ordinary shares of HK\$0.01 each (the “**Shares**” and the “**Shareholders**”, respectively) by way of poll at the AGM held on Friday, 25 August 2023 (the “**2023 AGM**”).

As at the date of the 2023 AGM, there were 1,411,226,450 issued Shares entitling the Shareholders to attend and vote for or against the Proposed Resolutions at the 2023 AGM. There were no Shares entitling the Shareholders to attend but abstain from voting in favour of the Proposed Resolutions at the 2023 AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on the Stock Exchange (the “**Listing Rules**”).

None of the Shareholders were required under the Listing Rules to abstain from voting on the Proposed Resolutions at the 2023 AGM. None of the Shareholders has stated in the Company’s circular dated 21 July 2023 (the “**Circular**”) his/her/its intention to vote against or to abstain from voting on any of the Proposed Resolutions at the 2023 AGM.

Computershare Hong Kong Investor Services Limited, the Hong Kong branch share registrar of the Company, was appointed and acted as the scrutineer for the vote-taking at the 2023 AGM.

Mr. LEE Yuen Hong (*chairman of the Board and executive Director*), Ms. LEE Yi Fang (*executive Director*), Mr. WONG Chi Kin (*non-executive Director*) and Mr. TANG Man Tsz (*independent non-executive Director*) attended the 2023 AGM in person while all the other Directors, including Mr. LEE Kun Lun Kenji (*Group Chief Executive Officer and executive Director*) participated in the 2023 AGM by way of video conference.
