 The register of members of the Company will be closed from Tuesday, September 12, 2023 to Friday, September 15, 2023 (both days inclusive), during which period no transfer of the shares will be effected. In order to qualify for attending the Meeting or any adjournment thereof, all transfers of shares accompanied by the relevant share certificates must be lodged with the Hong Kong share registrar of the Company, Tricor Investor Services Limited, at 17/F, Far East Finance Centre, 16 Harcourt Road, Hong Kong, no later than 4:30 p.m. on Monday, September 11, 2023. The record date for determining the entitlement of the Shareholders to attend and vote at the meeting will be Friday, September 15, 2023.
