Remarks:

Reference is made to the announcement of the Company dated 31 August 2023. As at 31 July 2023, the opening balance of the total number of issued Shares was 66,990,867 Shares which comprised 30,510,000 Domestic Shares, 19,490,000 Unlisted Foreign Shares and 16,990,867 H Shares. Following the Conversion and Listing, the H Shares were increased by 50,000,000 Shares, while the Domestic Shares were decreased by 30,510,000 shares and the Unlisted Foreign Shares were decreased by 19,490,000 shares. The total number of issued shares of the Company after the Conversion and Listing remains unchanged, comprising 66,990,867 H Shares.

We hereby confirm to the best knowledge, information and belief that, in relation to each issue of securities as set out in Section I, it has been duly authorised by the board of directors of the listed issuer and, insofar as applicable:

- (i) all money due to the listed issuer in respect of the issue of securities has been received by it;

- *“issued shares as a % of existing number of shares before relevant share issue” should be construed as “redeemed shares as a % of existing number of shares before relevant share redemption”; and*
- *“issue price per share” should be construed as “redemption price per share”.*

8. *The closing balance date is the date of the last relevant event being disclosed.*

9. *Items (i) to (viii) are suggested forms of confirmation which may be amended to meet individual cases.*

10. *“Identical” means in this context:*

- *the securities are of the same nominal value with the same amount called up or paid up;*
- *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
- *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*

11. *SEHK refers to Stock Exchange of Hong Kong.*
