If we do not receive the Reply Form from you in relation to or your response indicating your objection to the Website Arrangement by 4 October 2023 and until you inform the Company or the Company’s Hong Kong Share registrar by giving reasonable notice in writing (as described above), you will be deemed to have agreed to the Website Arrangement.
