UNAUDITED OPERATING STATISTICS FOR AUGUST 2023

The board (the “**Board**”) of directors (the “**Directors**”) of Shinsun Holdings (Group) Co., Ltd. (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce that in August 2023, (i) the total contracted sales attributable to the Group amounted to approximately RMB931 million; (ii) the contracted gross floor area attributable to the Group amounted to approximately 68,909 square meters; and (iii) the average contracted selling price attributable to the Group amounted to approximately RMB13,511 per square meter.

For the eight months ended 31 August 2023, (i) the total contracted sales attributable to the Group amounted to approximately RMB10,615 million; (ii) the contracted gross floor area attributable to the Group amounted to approximately 782,156 square meters; and (iii) the average contracted selling price attributable to the Group amounted to approximately RMB13,538 per square meter.

The operating statistics as disclosed above are unaudited and are based on preliminary internal information of the Group, which may differ from the figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collecting such information.
