Report on Production and Sales Volume of Dongfeng Motor Group for August at 2023

This is a voluntary announcement made by Dongfeng Motor Group Company Limited (the "Company").

The Company's sales volume in the first eight months of 2023 was 1,290,362 units, representing a decrease of 23.3% year-on-year. Dongfeng Motor Company, the parent company of the Company, recorded a total sale of 1455,563 vehicles for the first eight months, representing a decrease of 26.2% year-on-year. The sales volume of Dongfeng Automobile Company Limited (A-share code 600006, hereinafter referred to as "DFAC"), a subsidiary of the Company, was 97,464 units for the first eight months, representing a growth of 7.4% year-on-year.
