As disclosed in the circular of the Company dated 22 December 2006, on 29 March 2006, Chinese Water, an Independent Third Party, and the Jinxiang County Government entered into the BOT Agreement, pursuant to which Chinese Water was granted a licence to build and operate the Haiyuan Sewage Treatment Plant located in the Jinxiang County, the PRC, for an operational period of 29 years commencing from the completion of the construction in May 2007. Pursuant to a notice issued by Chinese Water to Haiyuan Water, on 8 May 2006, Chinese Water has agreed to transfer all the rights and obligations under the BOT Agreement to Haiyuan Water with immediate effect at nil consideration.

According to the Discharged Water Quality Standard Notice, all urban sewage treatment plants in Jining City, the PRC, shall be upgraded and modified by no later than 31 December 2023, to improve the quality of the discharged water from 國家一級A標準 (for transliteration purpose only, National Grade 1A Standard*) to 準四類出水標準 (for transliteration purpose only, Quasi Discharged Water Quality Standard Class IV*).

Construction Period

Thus, the Company considers that the Contract Price is on normal commercial terms and on arm's length basis.

It is expected that the Contract Price will be funded by the internal resources of the Group.

Wanrong Construction is a company established in the PRC with limited liability and is principally engaged in the provision of construction services in the PRC.

To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, as at the date of this announcement, Wanrong Construction is owned as to approximately 62.5% by Suzhou Guohao Chenxiang Software Technology Company Limited* (蘇州國浩辰翔軟件科技有限公司) ("Suzhou Guohao") and approximately 37.5% by Xuzhou Jiayuan Shunrong Management Consultancy Company Limited* (徐州佳元順融管理諮詢有限公司) ("Xuzhou Jiayuan").

To the best knowledge, information and belief of the Company having made all reasonable enquiries, Suzhou Guohao is owned as to approximately 80.0% by Mr. Du Houan and approximately 20.0% by Jiangsu Yixunbang Engineering Information Consultancy Company Limited* (江蘇易迅邦工程信息諮詢有限公司), which in turn is owned as to approximately 0.4% by Mr. Ginxin and approximately 99.6% by Bengbu City Dinggu Protection Engineering Company Limited* (蚌埠市鼎固防護工程有限公司), which in turn is owned as to 51% by Mr. Zhao Xiangpeng and 49% by Mr. Zhao Xiangkai.

Xuzhou Jiayuan is owned as to approximately 60.0% by Mr. Wang Dunchao and approximately 40.0% by Mr. Wang Dunfei.

To the best of the Directors' knowledge, information and belief, having made all reasonable enquiries, each of Wanrong Construction and its ultimate beneficial owners is an Independent Third Party.

INFORMATION ON HAIYUAN WATER

Haiyuan Water, being an indirect non-wholly owned subsidiary of the Company, is a company established in the PRC with limited liability and is principally engaged in the provision of sewage treatment services.

REASONS FOR AND BENEFITS OF ENTERING INTO THE HAIYUAN UPGRADING AND MODIFICATION CONTRACT

The Group is principally engaged in (i) provision of water supply, sewage treatment and construction services; (ii) exploitation and sale of renewable energy in the PRC; and (iii) property investment and development.

According to the Discharged Water Quality Standard Notice, all urban sewage treatment plants in Jining City, the PRC, shall be upgraded and modified by no later than 31 December 2023, to improve the quality of the discharged water from 國家一級A標準 (for transliteration purpose only, National Grade 1A Standard*) to 準四類出水標準 (for transliteration purpose only, Quasi Discharged Water Quality Standard Class IV*). In order to comply with the latest industry regulatory standard as stipulated in the Discharged Water Quality Standard Notice and fulfill the Group's obligations under BOT Agreement, Haiyuan Water has engaged Wanrong Construction as contractor to carry out the Haiyuan Upgrading and Modification Work.

The terms under the Haiyuan Upgrading and Modification Contract have been agreed after arm's length negotiation between the parties. The Directors consider that the terms of the Haiyuan Upgrading and Modification Contract, including the Contract Price, are on normal commercial terms, fair and reasonable and are in the interests of the Company and the Shareholders as a whole.

LISTING RULES IMPLICATION

As the Haisheng Upgrading and Modification Contract and the Haiyuan Upgrading and Modification Contract were all entered into by the Group with Wanrong Construction within a 12-month period, the transactions contemplated under the Haiyuan Upgrading and Modification Contract are aggregated with the transactions contemplated under the Haisheng Upgrading and Modification Contract for consideration for the purpose of this announcement.

As one or more of the applicable percentage ratio(s) (as defined under the Listing Rules) under the Haiyuan Upgrading and Modification Contract, when calculated on an aggregated basis with the transactions contemplated under the Haisheng Upgrading and Modification Contract, is/are more than 5% but less than 25%, the entering into of such transactions constitutes a discloseable transaction on the part of the Company and is thus subject to the reporting and announcement requirements but exempt from the Shareholders' approval requirement under Chapter 14 of the Listing Rules.
