## Election of Means and Language of Receipt of Corporate Communication

- (6) a proxy form.

You may choose:

- (2) to receive a printed English version only; or
- (3) to receive a printed Chinese version only; or
- (4) to receive both the printed English and Chinese versions of the Corporate Communication of the Company.
