If an email address is provided by you in the reply form, an electronic version of the notification of the publication of the Corporate Communications on website will be sent to you.

You have the right at any time by reasonable notice in writing to the Company or the Registrar by post or by e-mail at hengan-ecom@hk.tricorglobal.com to change the choice of language and means of receipt of the Corporate Communications.
