## Announcement Trading Update Power Generation For August 2023

This announcement is made by CGN New Energy Holdings Co., Ltd. (the "**Company**") on a voluntary basis.

The board (the "**Board**") of directors (the "**Directors**") of the Company announces that, according to the preliminary statistics of the Company, the power generation of the Company and its subsidiaries (the "**Group**") on a consolidated basis amounted to 1,347.0GWh for the month of August 2023, representing a decrease of 17.8% compared with the corresponding period of 2022. In particular, power generation of PRC wind projects decreased by 9.3%, power generation of PRC solar projects increased by 0.2%, power generation of PRC cogen and gas-fired projects decreased by 14.2%, power generation of PRC hydro projects decreased by 35.7% and power generation of Korea projects decreased by 31.7%. For the eight months ended 31 August 2023, the accumulated power generation of the Group of this year amounted to 13,237.0GWh, representing an increase of 3.4% compared with the corresponding period of 2022. - <sup>2:</sup> The year-on-year decrease in power generation in August 2023 was due to the significant year-onyear decrease in the load of power grid dispatch for the gas-fired project in Hubei Province and the cogen project in Jiangsu Province in August as a result of the lower temperatures in Wuhan and the Yangtze River Delta region in August this year as compared to last year.
- <sup>3:</sup> The cooperation of a 54,000 kW hydro project in Guangxi Zhuang Autonomous Region expired in September 2022 and the project was handed over to the local partner for operation and management. As a result, the power generation experienced a year-on-year decrease in August 2023.
- <sup>4:</sup> The year-on-year decrease in power generation in August 2023 was due to the decrease in the load of local power grid dispatch for Yulchon Power Plant as a result of the ongoing upgrade and revamp of the transmission line where Yulchon Power Project is located in Korea in August.
