Where there are joint holders of any share, any one of such persons may vote at any meeting, either personally or by proxy, in respect of such shares as if he was solely entitled thereto; but if more than one of such joint holders be present at any meeting personally or by proxy, that one of the said persons so present whose name stands first on the register of Shareholders in respect of such shares shall alone be entitled to vote in respect thereof.

To be valid, the proxy form together with any power of attorney or other authority (if any) under which it is signed or notarially certified copy of such power or authority must be deposited at the Company's branch share registrar in Hong Kong, Tricor Tengis Limited, at 17th Floor, Far East Finance Centre, 16 Harcourt Road, Hong Kong not less than 48 hours before the time appointed for holding the meeting or any adjournment thereof.		
8.	A proxy need not be a Shareholder of the Company but must attend the meeting in person to represent you.		
9.	Completion and return of this proxy form will not preclude you from attending and voting at the meeting if you so wish, and in such event, this proxy shall be leemed to be revoked.		
10.	The Register of Shareholders will be closed from Thursday, 5 October 2023 to Wednesday, 11 October 2023, both days inclusive, during which period no transfer or shares will be effected. In order to qualify for attending this special general meeting, all duly completed and signed transfer forms accompanied by the relevan share certificates must be lodged with the Company's branch share registrar in Hong Kong, Tricor Tengis Limited at 17th Floor, Far East Finance Centre, 16th Harcourt Road, Hong Kong not later than 4:30 p.m. (Hong Kong time) on Wednesday, 4 October 2023.
