ANNOUNCEMENT POWER GENERATION FOR AUGUST 2023

This announcement is made by China Datang Corporation Renewable Power Co., Limited* (the “**Company**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board of directors (the “**Board**”) of the Company announces that, according to the Company’s preliminary statistics, the power generation of the Company and its subsidiaries (collectively, the “**Group**”) for August 2023 on consolidated basis amounted to 1,629,059 MWh, representing a decrease of 17.26% as compared with that of the corresponding period of 2022, of which, the wind power generation amounted to 1,410,115 MWh, representing a decrease of 21.26% as compared with that of the corresponding period of 2022; and the photovoltaic power generation amounted to 218,944 MWh, representing an increase of 22.99% as compared with that of the corresponding period of 2022. As of 31 August 2023, the total power generation of the Group for 2023 amounted to 20,924,593 MWh, representing an increase of 16.44% as compared with that of the corresponding period of 2022, of which, the wind power generation amounted to 19,293,060 MWh, representing an increase of 14.20% as compared with that of the corresponding period of 2022; and the photovoltaic power generation amounted to 1,631,532 MWh, representing an increase of 51.58% as compared with that of the corresponding period of 2022.
