Management Discussion and Analysis

RESULTS OF OPERATION

The Group's revenue decreased significantly by 40.4% to RMB179.4 million during the Period (six months ended 30 June 2023), compared to the revenue of RMB300.9 million from the corresponding period of the previous year ("20221H"). Followed a year of global construction material shortage rising from blooming real estate market around the world, demand for wooden products has shown significant cooling down. During the Period, the Group registered a gross profit margin of 12.1% (20221H: 9.5%). The Group record a gross profit of RMB21.7 million during the Period (20221H: RMB28.5 million) as the Group has focused on higher margin products.

BUSINESS REVIEW

Segment review

During the Period, the performance of our business segments are as follows:

截至二零二三年六月三十日六個月（「期內」），本集團收益較去年同期（「二零二二年上半年」）下跌40.4%至人民幣179.4百萬元（二零二二年上半年：人民幣300.9百萬元）。經歷去年全球房地產市場強勁而引起的建材短缺後，木製品需求明顯冷卻。期內，本集團錄得毛利率12.1%（二零二二年上半年：9.5%）。由於本集團集中於較高毛利產品，本集團錄得人民幣21.7百萬元毛利（二零二二年上半年：人民幣28.5百萬元）。

The Group's core business segments comprise manufacturing and sales of wooden products and manufacturing and sales of renewable energy products. During the Period, revenue from the two business segments amounted to approximately RMB177.9 million and RMB1.5 million (20221H: approximately RMB298.0 million and RMB2.8 million), accounting for 99.1% and 0.9% of the total revenue (20221H: 99.1% and 0.9%) respectively.

Manufacturing and sales of wooden products is the principal segment of the Group. Followed a year of global construction material shortage rising from blooming real estate market around the world, demand for wooden products has shown significant cooling down. As a result, the Group's revenue from manufacturing and sales of wooden products to decrease 40.3% to RMB177.9 million (20221H: RMB298.0 million). Such reportable segment recorded a profit of RMB472,000 (20221H: a reportable segment loss of RMB396,000).

The Group's renewable energy business focuses on the recycling of leftover sawdust from the production of our wooden products into biomass pellet fuel. The Group's renewable energy business recorded a revenue of RMB1.5 million during the Period, with a profit of approximately RMB0.5 million (20221H: revenue of RMB2.8 million and profit of RMB0.5 million).

本集團的核心業務分部包括生產及銷售木製品，以及生產及銷售再生能源產品。期內，兩個業務分部收益分別約人民幣177.9百萬元及人民幣1.5百萬元（二零二二年上半年：約人民幣298.0百萬元及人民幣2.8百萬元），佔總收益99.1%及0.9%（二零二二年上半年：99.1%及0.9%）。

生產及銷售木製品乃本集團的主要業務分部。經歷去年全球房地產市場強勁而引起的建材短缺後，木製品需求明顯冷卻。本集團收益下跌40.3%至人民幣177.9百萬元（二零二二年上半年：人民幣298.0百萬元）。該可呈報分部錄得溢利人民幣472,000元（二零二二年上半年：可呈報分部虧損人民幣396,000元）。

本集團再生能源業務專注於回收木製品生產過程中產生的廢屑，然後將其轉化為生物質顆粒燃料。期內本集團的再生能源業務錄得收益為人民幣1.5百萬元，而其溢利為人民幣0.5百萬元（二零二二年上半年：收益為人民幣2.8百萬元及溢利為人民幣0.5百萬元）。

The Australasia markets continued to be the key driver of the Group's revenue. The Group has earned approximately RMB123.4 million (20221H: RMB220.7 million) from the continent. After a frantic surge since pandemic, the Australia home prices started to decrease nationwide. The gloom in the Australian housing market has tempered the prices of construction materials. During the Period, the Group continued its progressive approach towards Australia with a view to creating an established customer base for the development of the entire group business in the long run. Such approach included a concentration on high-quality product strategy has led to improvement in gross profit margin during the Period.

Domestically, revenue from the PRC market also recorded a decrease to approximately RMB29.7 million during the Period (20221H: RMB46.6 million), reflecting the weak domestic demand as a result of the slow down of the economy of China.

Since the exit from the United States in response to the increased tariff and the imposed antidumping and countervailing duty order in January 2020, revenue from the North America market has been significantly reduced. During the Period, revenue from the North American market was approximately RMB12.6 million (20221H: RMB11.9 million).

本集團最大的收益來源來繼續為澳大利西亞。來自該大陸的收益約為人民幣123.4百萬元（二零二二年上半年：人民幣220.7百萬元）。經歷疫情後的瘋狂增長後，澳洲全國房地產價格開始下降。房地產市場不景，影響建材價格。為建立穩定的客戶群以支持集團業務長遠穩定的發展，本集團繼續堅持積極推動在澳洲市場的發展。其中，集中高品質產品導致毛利率有所改善。

本地市場方面，來自中國的收益亦錄得下跌至約人民幣29.7百萬元（二零二二年上半年：人民幣46.6百萬元），主要反映中國經濟放緩導致需求疲弱。

自從本集團撤離美國市場，以應對該國加徵的關稅及二零二零年一月頒佈的反傾銷和反補貼稅令，來自北美市場的收益已大幅減少。於本期間，來自北美市場之收益為約人民幣12.6百萬元（二零二二年上半年：人民幣11.9百萬元）。

Revenue from timber houses and their related parts and structures remained the largest income stream of the Group during the Period. Revenue from such category decreased by 50.9% to RMB123.4 million (20221H: RMB251.4 million), representing 68.8% of total sales for the Period (20221H: 83.6%), mainly attributable to the decrease in sales in the Australasian markets.

期內，木屋及其相關部件及構件收益仍為本集團的最大收益來源。該分類的收益下跌50.9%至人民幣123.4百萬元（二零二二年上半年：人民幣251.4百萬元），相當於期內總銷售額的68.8%（二零二二年上半年：83.6%），主要由於在澳大利西亞市場銷售下跌所致。

Overall revenue from the leisure household products decreased by 17.5% to RMB26.4 million (20221H: RMB32.0 million), mainly attributable to the decrease in sales in the European markets.

During the Period, the Group recorded RMB28.1 million revenue from timber trading and RMB1.5 million from the renewable energy business respectively (2022H: RMB17.7 million and RMB2.8 million).

Other revenue

During the Period, other revenue increased 100.4% to RMB10.4 million (20211H: RMB5.2 million) mainly due to an increase in interest income from increased bank deposits.

Other net (loss)/gain

The Group recorded other net loss of RMB4.8 million for the Period (20221H: gain of RMB0.8 million). Such loss was attributable to from net loss in foreign exchange during the Period.

Selling and distribution expenses

Our selling and distribution expenses incurred during the Period decreased 12.6% to RMB8.7 million (20221H: RMB10.0 million) as the Group enhanced its efforts on reducing costs.

休閒傢俱產品的總收入下降17.5%至人民幣26.4百萬元(二零二二年上半年:人民幣32.0百萬元),主要由於在歐洲市場銷售下跌所致。

期內,本集團分別錄得人民幣28.1百萬來自木材貿易之收益及人民幣1.5百萬來自再生能源業務之收益(二零二二年上半年:人民幣17.7百萬元及人民幣2.8百萬元)。

其他收益

期內,其他收益上升100.4%至人民幣10.4百萬元(二零二一年上半年:人民幣5.2百萬元),主要由於銀行存款增加而帶動利息收入增長所致。

其他(虧損)/收益淨額

本集團於期內錄得其他虧損淨額人民幣4.8百萬元(二零二二年上半年:收益人民幣0.8百萬元),該虧損主要來自外幣匯兌虧損淨額。

銷售及分銷開支

由於本集團加強縮減成本,期內產生的銷售及分銷開支下跌12.6%至人民幣8.7百萬元(二零二二年上半年:人民幣10.0百萬元)。

Administrative expenses

Our administrative expenses incurred during the Period decreased to RMB12.8 million (20221H: RMB22.3 million), which was principally attributed to the tighter cost control during the Period.

Finance costs

Our finance costs increased to approximately RMB3.1 million (20221H: RMB0.7 million), which mainly represented the interest payment for bank loans during the Period.

Dividend

The Board does not recommend an interim dividend for the Period (20221H: Nil).

Profit for the Period

As a result of the foregoing factors, the Group has recorded a profit of approximately RMB2.7 million for the Period (20221H: RMB2.1 million).

Liquidity and capital resources

The Group principally meets its working capital and other liquidity requirements through operating cash flows and proceeds from bank borrowings. The Group anticipates that it can sufficiently meet funding needs for working capital and capital expenditure. As at 30 June 2023, the Group had current assets of RMB404.8 million (31 December 2022: RMB433.1 million), of which cash and cash equivalents were RMB36.6 million (31 December 2022: RMB113.8 million).

The Group's cash is generally deposited with banks and denominated mostly in RMB, USD and AUD. As at 30 June 2023, total banking facilities utilised amounted to RMB88.2 million (31 December 2022: RMB54.0 million) and these were mainly denominated in RMB and USD. All of the Group's banking facilities were subject to the fulfilment of certain covenants, as are commonly found in lending arrangements with financial institutions.

行政開支

期內產生的行政開支減至人民幣12.8百萬元(二零二二年上半年:人民幣22.3百萬元),主要由於期內更嚴格控制成本所致。

融資成本

我們的融資成本升至約人民幣3.1百萬元(二零二二年上半年:人民幣0.7百萬元),融資成本主要為銀行貸款利息。

股息

董事會並不建議派付期內的中期股息(二零二二年上半年:無)。

期內溢利

由於上述因素,本集團於期內錄得約人民幣2.7百萬元(二零二二年上半年:人民幣2.1百萬元虧損)。

流動資金及資本資源

本集團主要透過營運現金流量及銀行借款的所得款項滿足其營運資金及其他流動資金需求。本集團預計其可充分滿足營運資金及資本開支需求。於二零二三年六月三十日,本集團的流動資產為人民幣404.8百萬元(二零二二年十二月三十一日:人民幣433.1百萬元),其中銀行存款及現金(包括有抵押存款)為人民幣36.6百萬元(二零二二年十二月三十一日:人民幣113.8百萬元)。

本集團的現金一般存置於銀行並大部分以人民幣、美元及澳元計值。於二零二三年六月三十日,本集團的已動用銀行融資總額為人民幣88.2百萬元(二零二一年十二月三十一日:人民幣54.0百萬元)。該等銀行融資以人民幣及美元計值。本集團所有銀行融資須達成與金融機構所訂借貸安排中常見之干契諾。

PLEDGE OF ASSETS

As at 30 June 2023, the Group pledged its land use rights, buildings and deposits with banks mainly for the purpose of securing bank loans, derivative financial instruments and bill payables issued by banks to the Group.

CAPITAL EXPENDITURE

During the Period, the Group's total expenditure in respect of property, plant and equipment amounted to RMB42,000 (20221H: RMB3.9 million).

CAPITAL COMMITMENT AND CONTINGENT LIABILITIES

The Group had no significant capital commitments and contingent liabilities as at 30 June 2023.

SIGNIFICANT INVESTMENT, MATERIAL ACQUISITIONS AND DISPOSALS OF SUBSIDIARIES, FUTURE PLANS FOR MATERIAL INVESTMENTS OR ACQUISITION OF CAPITAL ASSETS

During the Period, there were no significant investments, material acquisitions or disposals of subsidiaries by the Company. The Group currently has no plan to make any substantial investments or acquisitions of capital assets, but will continue to seek out potential investment or acquisition opportunities according to the Group's development needs.

FOREIGN CURRENCY RISKS

The Group's sales are mainly denominated in USD, AUD and RMB while our cost of sales and operating expenses are mainly denominated in RMB. Therefore, the Group's profit margin would be affected if RMB appreciates against USD and AUD as the Group may not be able to reflect the appreciation in selling prices to overseas customers that were determined in USD and AUD. In response to this, the Group manages fluctuations in the exchange rate of RMB against USD and AUD by entering into foreign currency forward contracts mainly denominated in USD, AUD and RMB with banks when sales contracts were entered with overseas customers.

資產抵押

於二零二三年六月三十日，本集團其土地使用權、樓宇及銀行存款，主要用於取得銀行向本集團發出之銀行貸款、衍生金融工具及應付票據。

資本開支

期內，本集團有關物業、廠房及設備的總開支為人民幣42,000元（二零二二年上半年：人民幣3.9百萬元）。

資本承擔及或然負債

本集團並無任何重大資本承擔。於二零二三年六月三十日，本集團概無任何重大或然負債。

重大投資、重大收購及出售附屬公司、重大投資或收購資本資產的未來計劃

期內，本公司並無重大投資、重大收購或出售附屬公司。本集團現時並無計劃作出任何重大投資或收購資本資產，但會按本集團發展需要，繼續物色潛在投資或收購機會。

貨幣風險

本集團的銷售主要以美元、澳元及人民幣計值，而銷售成本及經營開支則主要以美元及人民幣計值。由於本集團可能無法在向海外客戶銷售時，將人民幣兌美元及澳元的升值反映於以美元及澳元釐定的售價中，故如人民幣升值，溢利將受影響。為此，本集團在與海外客戶訂立銷售合約的同時透過與銀行訂立主要以美元、澳元及人民幣計值的遠期外幣合約以管理人民幣兌美元及澳元的匯率波動。

The Group also manages foreign exchange risk by matching the cash inflow from our export sales denominated in USD with the cash outflow from our import of timber denominated in USD.

At 30 June 2023, the Group did not have any foreign currency forward contracts with their fair values recognised as derivative financial instruments (assets) (31 December 2021: RMB42,000) and derivative financial instruments (liabilities) of RMB10.2 million (31 December 2021: RMB18,000). The changes in fair value of the foreign currency forward contracts were recognised in the consolidated statement of profit or loss. All of the foreign currency forward contracts are to be settled within one year.

PROSPECTS

Although the world has come out of the haze of the epidemic, the global economy has not seen a significant recovery after the epidemic. The International Monetary Fund has warned that high inflation coupled with turmoil in the financial sector may result in a weak global economic outlook, and the global economy is entering a dangerous phase. In the latest global economic outlook released by the International Monetary Fund, it is predicted that Australia's GDP growth will slow down to 1.6% in 2023, and the growth rate in 2024 will only be 1.7%. Australia's inflation rate is currently at 6.8% and the International Monetary Fund predicts that it is unlikely to return to the Reserve Bank of Australia's target of 2 to 3% before 2025. If inflation remains high, the Reserve Bank of Australia will have to raise rates further and remain for longer period of time. This will increase the possibility of a recession. The Group will continue to adopt a cautious attitude and will try to expand its business scope in order to stabilize shareholder returns.

本集團亦透過以美元計值的出口銷售現金流入配合以美元計值的木材進口現金流出管理外匯風險。

於二零二三年六月三十日，本集團並無錄得外幣遠期合約的公平值按衍生金融工具（資產）（二零二二年十二月三十一日：人民幣42,000元）及衍生金融工具（負債）人民幣10.2百萬元（二零二二年十二月三十一日：人民幣18,000元）確認。外幣遠期合約的公平值變動乃於綜合損益表中確認。所有外幣遠期合約均在一年內結算。

前景

儘管全世界已經走出疫情的陰霾，環球經濟在疫情過後卻未見明顯復蘇。國際貨幣基金組織警告，高通脹加上金融業動盪可能會造成全球經濟前景疲軟，全球經濟正在進入一個危險的階段。在國際貨幣基金組織最新發表的全球經濟展望中，預測澳洲的國內生產總值增長在2023年將放緩至1.6%，而在2024年的增長亦只會在1.7%。澳洲的通脹率目前為6.8%，國際貨幣基金組織預測，澳洲的通脹率不太可能在2025年之前恢復到澳洲儲備銀行的目標，即2%至3%。但如果通脹率居高不下，澳洲儲備銀行將不得不進一步提高利率，並在更長時間內保持高利率。這將加大經濟衰退的可能性。本集團將繼續採取審慎態度，並會試圖擴大其業務版圖以穩定股東回報。

HUMAN RESOURCES

As at 30 June 2023, we employed a total of 204 (30 June 2022: 344) employees, mainly in the PRC and Hong Kong which included management staff, product designers, technicians, salespersons and workers. The Group has been consistently increasing production process automation, strengthening the training of staff with an emphasis on high-technique processing with a mission on the continuous development and enhancing of competitiveness. The Group offered highly competitive salary packages, as well as discretionary bonuses and contribution to social insurance to its employees.

The Group's emolument policies are formulated based on the performance of individual employee which will be reviewed periodically. The aggregate number of Award Shares which may be awarded to a selected person under the Share Award Scheme shall not exceed 2% of the total number of issued Shares as at the adoption date of the Share Award Scheme.

Subject to any early termination as may be determined by the board of directors, the Share Award Scheme shall be valid and effective for a term of 10 years commencing from the adoption date.

The Award Shares, once issued, will rank equal to all other issued Shares at that time and are not subject to any vesting condition. The selected persons will therefore have the right to receive dividends, dispose of and/or exercise the rights of the Award Shares as per his/ her own wishes once the Award Shares were issued.

On 14 December 2020, a total of 42,550,000 Award Shares were issued to 12 eligible persons (the “2020 Selected Persons”). The Award Shares were settled by way of issue and allotment of new Shares on 30 December 2020 pursuant to the general mandate. The 42,550,000 Award Shares represented approximately 5.74% of the total number of issued Shares and approximately 5.43% of the total number of Shares in issue as enlarged by the issue and allotment of the Award Shares. The 2020 Selected Persons are (i) senior and middle management of the Group and (ii) staffs who served the Group for a long period of time.

The Connected Selected Persons are the Directors of the Company.

The acceptance amount of the award shares is determined by the Board from time to time. The purchase price of the award shares (if any) shall be such price which shall be determined by the Board from time to time based on considerations such as the prevailing closing price of the Shares, the purpose of the award and the characteristics and profile of the selected participant. Such room for discretion provides the Board with flexibility to stipulate, if necessary, a purchase price for award shares, while balancing the purpose of the award and the interests of Shareholders. No amount was paid by selected participants on application or acceptance of the award shares granted to them under the Share Award Scheme.

COMPLIANCE WITH THE CORPORATE GOVERNANCE CODE

Throughout the Period and up to the date of this report, the Company has complied with the principles set out in the Corporate Governance Code, except code provision C.1.2 of the Corporate Governance Code as explained below.

According to code provision C.1.2, the management should provide all members of the Board with monthly updates giving a balanced and understandable assessment of the Company's performance, position and prospects in sufficient detail to enable the Board as a whole and each Director to discharge their duties under Rule 3.08 and Chapter 13 of the Listing Rules.

The Company has deviated from C.1.2 in that while the management has updated most of the Directors on a monthly basis about the business operation and performance of the Company, not all the Directors received such updates as the monthly updates were conducted on-site at the Group's factory in China. Members of the Board who did not attend such on-site meetings did not receive the updates. However, the management would provide detailed updates to all the Directors on a half-yearly and yearly basis. In the event that there are any significant updates to be provided, the management will update all the Directors as early as practicable for discussion and the passing of resolution. The Company also has in place a system for every Director to make enquiries with the senior management about the business operation of the Group and to give suggestions or feedback in the event such Director is not able to attend the monthly on-site update meetings.

1 BASIS OF PREPARATION

This interim financial report has been prepared in accordance with the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"), including compliance with International Accounting Standard ("IAS") 34, Interim financial reporting, issued by the International Accounting Standards Board ("IASB"). It was authorised for issue by the Board of Directors on 31 August 2023.

The interim financial report has been prepared in accordance with the same accounting policies adopted in the 2022 annual financial statements, except for the accounting policy changes that are expected to be reflected in the 2023 annual financial statements. Details of these changes in accounting policies are set out in note 2.

The preparation of an interim financial report in conformity with IAS 34 requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets and liabilities, income and expenses on a year to date basis. Actual results may differ from these estimates.

This interim financial report contains consolidated financial statements and selected explanatory notes. The notes include an explanation of events and transactions that are significant to an understanding of the changes in financial position and performance of the Group since the 2022 annual financial statements. The consolidated interim financial statements and notes thereon do not include all of the information required for full set of financial statements prepared in accordance with International Financial Reporting Standards ("IFRSs").

1 編製基準

2 CHANGES IN ACCOUNTING POLICIES

4 SEGMENT REPORTING
