FINANCE LEASE AGREEMENT

The Board hereby announces that on September 22, 2023, the Company (as the Lessor) entered into the Finance Lease Agreement I, the Finance Lease Agreement II and the Finance Lease Agreement III with the Lessee I, Lessee II and Lessee III respectively, pursuant to which, (i) the Lessor shall acquire the Leased Assets I, Leased Assets II and Leased Assets III owned by the Lessee I, Lessee II and Lessee III at a transfer consideration of RMB32,000,000, RMB6,600,000 and RMB4,400,000 respectively; and (ii) the Lessor shall lease the Leased Assets I, Leased Assets II and Leased Assets III back to the Lessee I, Lessee II and Lessee III for a term of 36 months with a total lease payment of RMB34,392,047, RMB7,093,360 and RMB4,728,906 which shall include a finance lease principal of RMB32,000,000, RMB6,600,000 and RMB4,400,000, and a finance lease interest income (inclusive of VAT) of RMB2,392,047, RMB493,360 and RMB328,906 respectively.

LISTING RULES IMPLICATIONS

As the Lessees are under the common control of the same ultimate beneficial owner, the Lessees are parties connected with one another (as set out under Rule 14.23 of the Listing Rules). As the transactions under the Financial Lease Agreements were entered into during the 12-month period, according to Rule 14.22 of the Listing Rules, the transactions thereunder shall be aggregated as a series of transactions. As the highest applicable percentage ratio under each of the Agreements is less than 5%, while the highest applicable percentage ratio upon aggregation of the Agreements is higher than 5% but less than 25%, the transactions contemplated under the Finance Lease Agreements constitutes a discloseable transaction of the Company and are subject to the notification and announcement requirements under Chapter 14 of the Listing Rules.

BACKGROUND

The Board hereby announces that on September 22, 2023, the Company (as the Lessor) entered into the Finance Lease Agreement I, the Finance Lease Agreement II and the Finance Lease Agreement III with the Lessee I, Lessee II and Lessee III respectively, pursuant to which, (i) the Lessor shall acquire the Leased Assets I, Leased Assets II and Leased Assets III owned by the Lessee I, Lessee II and Lessee III at a transfer consideration of RMB32,000,000, RMB6,600,000 and RMB4,400,000 respectively; and (ii) the Lessor shall lease the Leased Assets I, Leased Assets II and Leased Assets III back to the Lessee I, Lessee II and Lessee III for a term of 36 months with a total lease payment of RMB34,392,047, RMB7,093,360 and RMB4,728,906 which shall include a finance lease principal of RMB32,000,000, RMB6,600,000 and RMB4,400,000, and a finance lease interest income (inclusive of VAT) of RMB2,392,047, RMB493,360 and RMB328,906 respectively.

THE FINANCE LEASE AGREEMENTS

The principal terms of the Finance Lease Agreements are as follows:

Parties

Lessor: the Company

Lessee I: a limited liability company incorporated in the PRC, which is principally engaged in the production and operation of veterinary drugs.

Lessee II: a limited liability company incorporated in the PRC, which is principally engaged in the technical service industry.

Lessee III: a limited liability company incorporated in the PRC, which is principally engaged in the research and development of bio-based material technology.

To the best of the Directors' knowledge, information and belief after having made all reasonable enquiries, the Lessee and its ultimate beneficial owner are all independent third parties to the Company and its connected persons (as defined in the Listing Rules).

Leased Assets

The Leased Assets I are bioreactors, with a net book value of approximately RMB32,295,884.07.

The Leased Assets II are bioreactors, with a net book value of approximately RMB6,619,449.95.

The Leased Assets III are laser force analyzers, with a net book value of approximately RMB4,484,578.84.

The Lessees do not separately calculate the profits before and after tax of the Leased Assets. The transfer consideration for the acquisition of the Leased Assets under the Finance Lease Agreements will be funded by the Company's internal resources. If the Lessee have properly and fully performed all of their obligations under the Finance Lease Agreements, the Lessees entitled to acquire the Leased Assets at the consideration of RMB100 in nominal value pursuant to the terms and conditions of the Finance Lease Agreements, upon the expiry of the Finance Lease Agreements respectively.

Lease Period

The lease period of the Finance Lease Agreement I is 36 months, which commenced on September 22, 2023.

The lease period of the Finance Lease Agreement II is 36 months, which shall commence on September 22, 2023.

The lease period of the Finance Lease Agreement III is 36 months, which shall commence on September 22, 2023.

Lease Payment and Method of Payment

Under the Finance Lease Agreements, the respective total lease payment of RMB34,392,047, RMB7,093,360 and RMB4,728,906, included the respective finance lease principal of RMB32,000,000, RMB6,600,000 and RMB4,400,000, and the respective finance lease interest income (inclusive of VAT) of RMB2,392,047 (calculated based on the interest rate of 4.9% per annum), RMB493,360 (calculated based on the interest rate of 4.9% per annum) and RMB328,906 (calculated based on the interest rate of 4.9% per annum). The Lessee shall pay the lease payment to the Lessor at the end of each quarter in installments in accordance with the terms and conditions of the Finance Lease Agreements during the lease period.

The terms of the Finance Lease Agreements, including the transfer consideration for the Leased Assets, finance lease principal, finance lease interest income and other expenses, were determined upon arm's length negotiation between the Lessee and the Lessor with reference to net book value of the Leased Assets and prevailing market prices of the same category of finance lease products in the PRC.

Security Deposit

The Lessee agreed to pay the security deposit for the Finance Lease Agreements of RMB3,200,000(bearing nil interests), RMB660,000(bearing nil interests) and RMB440,000(bearing nil interests). When the last lease payments are due to be paid, the lease payment and other payables under the final payment will automatically be deducted from the deposit, and the Lessor will respectively refund the Lessee the remaining amount (if any).

Guarantee and Security

The guarantee and security arrangements for each of the Finance Lease Agreements are set out below:

- (1) The ultimate beneficial owner of the Lessee shall provide joint and several liabilities guarantee for the debts under the Finance Lease Agreements.
- (2) The controlling shareholder of the Lessee shall provide joint and several liabilities guarantee for the debts of Lessee under the Finance Lease Agreements.

REASONS FOR AND BENEFITS OF ENTERING INTO THE FINANCE LEASE AGREEMENTS

The Company's principal activities are to provide finance leasing and advisory services to customers. The entering of the Finance Lease Agreements is part of the Company's ordinary and usual course of business, which is expected to provide a stable revenue and cashflow to the Company.

The Directors consider that entering into the Finance Lease Agreements will generate revenue and profit to the Company over the lease period and is consistent with the Company's business development strategy. Since the Finance Lease Agreements was entered into under normal commercial terms, the Directors are of the view that the terms under the Finance Lease Agreements are fair and reasonable and are in the interests of the Company and its shareholders as a whole.
