The Placing Shares will be allotted and issued under the General Mandate.

The 100,000,000 Placing Shares represents (i) approximately 2.82% of the existing issued share capital of the Company as at the date of this announcement; and (ii) approximately 2.74% of the issued share capital of the Company as enlarged by the allotment and issue of the Placing Shares.

Assuming that all the Placing Shares are fully placed, the maximum gross proceeds from the Placing will be approximately HK\$95.0 million. It is expected that the net proceeds from the Placing (after deducting the placing commission payable to the Placing Agent and other expenses incurred in the Placing) will amount to approximately HK\$94.4 million. The Company intends to apply the net proceeds from the Placing for general working capital of the Group.

Principal terms of the Placing Agreement

Placing Shares:

The Company appointed the Placing Agent as its agent to procure not less than six Placees to subscribe up to 100,000,000 Placing Shares at a price of HK\$0.950 per Placing Share on a best effort basis. It is expected that none of the Placees will become a substantial shareholder (as defined in the Listing Rules) of the Company after Completion. The 100,000,000 Placing Shares represents (i) approximately 2.82% of the existing issued share capital of the Company as at the date of this announcement; and (ii) approximately 2.74% of the issued share capital of the Company as enlarged by the allotment and issue of the Placing Shares. The maximum aggregate nominal value of the Placing Shares under the Placing will be HK\$10,000,000.

Placing Price:

The price of HK\$0.950 per Placing Share was determined after arm's length negotiations between the Company and the Placing Agent with reference to the prevailing market price of the Shares on the Stock Exchange. The Placing Price represents:

- (a) a discount of approximately 12.84% to the closing price of HK\$1.090 per Share as quoted on the Stock Exchange on 27 September 2023, being the Last Trading Day; and
- (b) a discount of approximately 17.53% to the average closing price of HK\$1.152 per Share as quoted on the Stock Exchange for the last five consecutive trading days immediately prior to the Last Trading Day.

The Company will bear the costs and expenses of approximately HK\$0.6 million in connection with the Placing and the net proceeds from the Placing is estimated to be approximately HK\$94.4 million (assuming the Placing Shares are fully placed).
