# INSIDE INFORMATION OPERATION BRIEFINGS FOR THE THIRD QUARTER OF 2023

This announcement is made by CGN Power Co., Ltd.\* (the "Company", together with its subsidiaries, collectively, the "Group") pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of The Laws of Hong Kong).

## POWER GENERATION AND ON-GRID POWER GENERATION

The board (the "**Board**") of directors (the "**Directors**") of the Company announces that, based on the statistics of the Company, the total power generation of nuclear power generating units operated and managed by the Group from January to September 2023 amounted to approximately 169,707.23 GWh, representing a year-on-year increase of 11.39%. The total on-grid power generation amounted to approximately 158,989.14 GWh, representing a year-on-year increase of 11.31%.

Details of the power generation and on-grid power generation from January to September 2023 are as follows:

# STATUS OF OPERATION

# Units in operation

In the third quarter of 2023, the Group completed, as scheduled, an initial outage and five annual refuelling outages.

The Group completed, as scheduled, 13 refuelling outages as of September 30, 2023.

In the fourth quarter of 2023, in addition to continuing the refuelling outages for units which had commenced, the Group plans to conduct one new annual refuelling outage.

#### Units under construction

On July 31, 2023, the State Council of the People's Republic of China approved Ningde Unit 5 and Unit 6, which were in the preparation phase for the first concrete day (the "FCD") of nuclear island as of September 30, 2023.

On August 26, 2023, Lufeng Unit 6 commenced construction and entered the civil construction phase.

On September 28, 2023, Cangnan Unit 2 completed the dome lifting work and entered into the equipment installation phase.

As of September 30, 2023, the Group managed a total of nine nuclear power units being approved and under construction (including those under construction managed by the Company as entrusted by the controlling shareholder of the Company), among which one unit was in the commissioning phase, four units were in the equipment installation phase, two units were in the civil construction phase and two units in FCD preparation phase. Progress of construction for the units under construction is detailed in the table below:
