Report on Production and Sales Volume of Dongfeng Motor Group for September at 2023

This is a voluntary announcement made by Dongfeng Motor Group Company Limited (the "Company").

The Company's sales volume in the first nine months of 2023 was 1,491,259 units, representing a decrease of 20.7% year-on-year. Dongfeng Motor Company, the parent company of the Company, recorded a total sale of 1,683,135 vehicles for the first nine months, representing a decrease of 24.1% year-on-year. The sales volume of Dongfeng Automobile Company Limited (A-share code 600006, hereinafter referred to as "DFAC"), a subsidiary of the Company, was 113,634 units for the first nine months, representing a growth of 14.9% year-on-year.
