## ANNOUNCEMENT POWER GENERATION FOR SEPTEMBER 2023

This announcement is made by China Datang Corporation Renewable Power Co., Limited\* (the "Company") pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board of directors (the "Board") of the Company announces that, according to the Company's preliminary statistics, the power generation of the Company and its subsidiaries (collectively, the "Group") for September 2023 on consolidated basis amounted to 1,904,449 MWh, representing a decrease of 13.28% as compared with that of the corresponding period of 2022, of which, the wind power generation amounted to 1,694,826 MWh, representing a decrease of 17.18% as compared with that of the corresponding period of 2022; and the photovoltaic power generation amounted to 209,623 MWh, representing an increase of 40.02% as compared with that of the corresponding period of 2022. As of 30 September 2023, the total power generation of the Group for 2023 amounted to 22,829,041 MWh, representing an increase of 13.20% as compared with that of the corresponding period of 2022, of which, the wind power generation amounted to 20,987,886 MWh, representing an increase of 10.81% as compared with that of the corresponding period of 2022; and the photovoltaic power generation amounted to 1,841,155 MWh, representing an increase of 50.17% as compared with that of the corresponding period of 2022.
