**UPDATE ANNOUNCEMENT  
IN RELATION TO WINDING UP PETITION AGAINST THE COMPANY**

References are made to the announcements of Huisen Household International Group Limited (the “**Company**”) dated 11 July 2023, 2 August 2023, 5 September 2023, 27 September 2023 and 9 October 2023 (collectively, the “**Announcements**”) in relation to the Petition against the Company. Unless otherwise defined, capitalised terms used herein shall have the same meanings as defined in the Announcements.

**UPDATE ON THE PETITION**

On 11 October 2023, the Company received a summons (the “**Amendment Summons**”) dated 11 October 2023 filed by the Petitioner seeking for leave, among other things, to amend the Petition as per the draft amended petition (the “**Amended Petition**”) annexed thereto and to file and serve the Amended Petition within seven days from the date of the order to be made therein. The Amendment Summons was scheduled to be heard before the Court on 18 October 2023 (the “**Amendment Hearing**”), on the same date of the hearing of the Petition (the “**Petition Hearing**”).

On 17 October 2023, the Company received an updated draft Amended Petition in support of the Amendment Summons at the Amendment Hearing from the Petitioner.

Upon the Amendment Hearing and the Petition Hearing heard before Master J. Wong on 18 October 2023, the Court, among other things, (1) granted leave to the Petitioner to amend the Petition, (2) ordered the Petitioner to file and serve the Amended Petition within seven days from the date hereof and (3) adjourned the Petition Hearing to 29 November 2023 at 10:30 a.m. to be heard before a Master of the Court.

The Company will keep its shareholders and investors informed of any significant development of the Petition and will make further announcement(s) as and when appropriate.
