**ANNOUNCEMENT ON UNAUDITED OPERATING DATA
FOR THE THIRD QUARTER OF
THE THREE MONTHS ENDED 30 SEPTEMBER 2023 AND
THE NINE MONTHS ENDED 30 SEPTEMBER 2023**

This announcement is voluntarily made by Dynagreen Environmental Protection Group Co., Ltd.* (the “**Company**”, together with its subsidiaries, the “**Group**”).

The board of directors (the “**Board**”) of the Company is pleased to announce that the unaudited waste input volume, electricity generation volume, on-grid electricity volume and steam supply volume of the Group amounted to 3,694,500 tons, 1,246,541,400 kWh, 1,013,317,200 kWh and 105,700 tons respectively in the third quarter of the three months ended 30 September 2023. For the nine months ended 30 September 2023, the unaudited accumulated waste input volume of the Group amounted to 9,992,300 tons, representing a year-on-year increase of 18.42%; the accumulated electricity generation volume was 3,460,799,700 kWh, representing a year-on-year increase of 10.61%; the accumulated on-grid electricity volume was 2,848,521,000 kWh, representing a year-on-year increase of 11.32%; and the accumulated steam supply volume was 300,800 tons, representing a year-on-year increase of 43.65%.
