1. INTRODUCTION

The purpose of this Circular is, among other things, to give you notice of the EGM and to provide you with information in relation to the resolutions to be proposed at the EGM to enable you to make an informed decision on whether to vote for or against those resolutions at the EGM.

2. PROPOSED AMENDMENTS TO THE ARTICLES OF ASSOCIATION

Reference is made to the announcement of the Company dated October 24, 2023 in relation to the Board's recommendation to make the Proposed Amendments. The Proposed Amendments were introduced in light of the abolition of the Mandatory Provisions for Companies Listing Overseas* (《到境 外上市公司章程必備條款》) (the "Mandatory Provisions") and the Special Regulations on the Overseas Offering and Listing of Shares by Joint Stock Limited Companies* (《國務院關於股份有限公司境外募集股份及上市的特別規定》) on the effective date of the Trial Measures of Overseas Securities Offering and Listing by Domestic Companies* (《境內企業境外發行證券和上市管理試行辦法》)(the "Trial Measures") issued by the CSRC. With reference to the PRC Companies Law, the Trial Measures, the Guidelines on Articles of Association of Listed Companies* (《上市公司章程指引》) issued by the CSRC and other regulations, the Proposed Amendments include (1) comprehensively adaptive revisions to the Articles of Association that become inconsistent because of such changes of relevant laws and regulations; (2) amendments made in accordance with the Company's operational and management needs; and (3) other structural optimizations and expression adjustments. Among the Proposed Amendments, change of registered address and scope of business are subject to the registration and approval of the change with the company's registration authority.

None of the Proposed Amendments will introduce any change to the existing rights of class Shareholders of the Company or existing arrangement relating to Shareholders' class meeting. Notwithstanding the Proposed Amendments, the contents of the other chapters and articles of the Articles of Association shall remain unchanged.

The Proposed Amendments are set out in the Appendix to this Circular. According to the Articles of Association and the relevant laws and regulations, the Proposed Amendments will take effect subject to consideration and approval by the Shareholders at the EGM by way of special resolution.

The legal advisers to the Company as to the laws of Hong Kong and the laws of the PRC have respectively confirmed that the Proposed Amendments comply with requirements of the Listing Rules and applicable laws of the PRC. The Company confirms that there is nothing unusual about the Proposed Amendments for a company incorporated in the PRC and listed on the Stock Exchange.

3. PROVISION OF GUARANTEE

On September 27, 2023, Shengxin Co and the Creditor entered into the Loan Agreement to replace an existing loan of Shengxin Co with the same amount, pursuant to which the Creditor made available to Shengxin Co a loan at the principal amount of RMB518 million at the interest rate based on Loan Prime Rate (LPR) 5-year rate minus 90 bp subject to adjustment annually for a term ending on September 13, 2030.

The Company as a guarantor, will enter into the Guarantee Agreement in favour of the Creditor, pursuant to which the Company will provide joint and several liability guarantee for the due performance of the repayment obligations of Shengxin Co to the Creditor under the Loan Agreement in respect of 50% of the amount under the Loan Agreement.

REASONS FOR AND BENEFITS OF THE PROVISION OF GUARANTEE

The Directors are of the view that the Loan Agreement will alleviate the financial pressure of Shengxin Co for the expansion construction project of Shaoxing Section of Ningbo-Jinhua Expressway and is in line with the Group's overall business strategy and interest in the long run. Provision of the guarantee under the Guarantee Agreement is to provide a security to the Creditor for the performance of the Loan Agreement.

On September 29, 2023, Shaoxing Communications Investment, being the other joint venture partner of Shengxin Co, has executed a guarantee agreement in favour of the Creditor to provide guarantee of 50% of the amount under the Loan Agreement, the terms of which are identical to the Guarantee Agreement.

Having taken into consideration of the guarantee agreement executed by Shaoxing Communications Investment and that the risks exposed to the Company is proportionate to its equity interests in Shengxin Co, the Directors are of the view that the terms of the Guarantee Agreement are on normal commercial terms, are fair and reasonable and in the interests of the Company and its Shareholders as a whole.
