CHAIRMAN'S STATEMENT

主席報告

Dear Shareholders,

I am pleased to present UMP's annual report, chronicling our progress during a challenging yet transformative year for the industry.

The pandemic's impact has slowly abated as masks come off and travel resumes. However, healthcare staffing shortages in the industry remain pressing. The Hong Kong government's strong support for fundamental healthcare measures to address these needs is very encouraging. Post-pandemic, increased cross-boundary activities may allow us to expand our integrated care services to serve more patients. As regional networks become ever more interconnected, UMP remains committed to furnishing comprehensive, coordinated care for all.

HIGHLIGHTS

In fiscal year 2023, I am glad to report UMP's overall revenue rose year-over-year, led by our clinical services, aligning with broader economic recovery trends. Revenue of our Hong Kong and Macau clinics was impacted in the short-term by strategic investments in new imaging facilities. However, we believe these investments laid the groundwork for future growth. Despite lockdowns in the first half of the year, our Mainland China business saw significant profit growth, with the second half rebounding remarkably in revenue, profit, and patient visits. Our corporate solutions division also saw increased operating profit. Our balance sheet remained healthy in terms of liquidity to support ongoing expansion goals. I commend our team for exhibiting resilience throughout the health care crisis.

This year, we formed strategic partnerships with several prestigious Hong Kong medical groups and institutions, reinforcing UMP's leadership and shared vision to cultivate an enriched healthcare ecosystem to serve the public. These collaborations will furnish patients with seamless, coordinated and cross-regional care by combining our specialized expertise, extensive networks, and innovative technologies. These partnerships also leverage collective resources to elevate service standards and help promote community healthcare access. The Board and I believe that these partnerships help solidify UMP's position to achieve our goal of redefining care and population health for the communities we serve.

各位股東：

本人欣然提呈聯合醫務的年度報告，當中記錄了我們在過去充滿行業挑戰及變革的一年內的進展。

隨著口罩禁令解除及旅行復常，疫情影響已慢慢消退。然而，醫護業界人員短缺的問題依然緊迫。讓人非常鼓舞的是，香港政府大力支持基本的醫療保健措施，以滿足有關需求。疫情過後，跨境活動增加或有助我們擴大我們的綜合醫護服務，為更多患者提供服務。隨著地區網絡的相互聯繫變得更加緊密，聯合醫務繼續致力提供全面、協調及全人的醫療服務。

摘要

於2023財政年度，本人樂見聯合醫務的整體收入錄得按年增長，此增長由我們的臨床服務所帶動，並與更廣泛的經濟復甦勢頭一致。我們在香港及澳門的診所均錄得收入，惟因戰略性地投資於全新的影像設施而受到短期影響。然而，我們相信該等投資為未來增長奠定了基礎。我們的中國內地業務於上半年遭遇疫情封鎖，但依然呈現顯著利潤增長，而下半年在收入、利潤及患者就診人次方面均顯著反彈。我們的企業解決方案部門亦呈現經營利潤增長。我們保持健康的資產負債表流動性，以支持我們實現持續擴充的目標。我們的團隊在醫護危機中展現堅毅不拔的精神，本人對此深感讚揚。

今年，我們與香港多間著名醫療集團及機構建立戰略合作夥伴關係，加強聯合醫務的領導能力及共同願景，以培育更廣泛的醫療保健生態系統，為公眾服務。通過此等合作，結合我們的專業知識、廣泛網絡及創新技術，我們將可為患者提供無縫銜接的跨區域協調醫療服務。此外，此等合作亦推動各種資源的集中利用，藉此提高服務水平並有助促進社區醫療服務的普及。本人及董事會相信，此等夥伴關係有助鞏固聯合醫務的地位，以實現我們的目標—為我們服務的社區重新定義護理及大眾健康。

TRANSITION & GOVERNANCE

After decades of service, I stepped down as CEO, welcoming new leadership. Appointing Dr. Michael Sun and Ms. Jacquen Kwok as Co-CEOs strategically utilizes their medical and business acumen, excellently positioning UMP to expand our network in Hong Kong and Mainland China while maintaining our high clinical standards and quality of care. Dr. Michael Sun is now the Vice Chairman, promoting knowledge sharing through effective organizational management. I have full confidence in their ability to make informed decisions and achieve their quality care goals.

With the help of our new leadership, UMP also prioritizes robust ESG practices. Our Quality Assurance Committee, comprising seasoned medical professionals, ensures capable clinical governance across our facilities. We prioritize employee development through training and support diversity and inclusion. We address social concerns and assist underserved communities through charity and community health projects.

STRATEGIC PRIORITIES & OUTLOOK

The government's emphasis on public health encourages public-private collaboration to maximize community benefit through a multidisciplinary approach. 過渡與管治

CO-CEOs' REPORT

聯席行政總裁報告

Dear Valued Shareholders,

As we present our inaugural annual report since being appointed, we want to start by recognizing Dr. YK Sun's outstanding leadership as CEO since UMP's public listing in 2015. Over the past decade, Dr. Sun spearheaded UMP's transformation into an integrated medical network with a vision to provide coordinated care accessible by the wider public. Through both his medical expertise and foresight in developing partnerships, Dr. Sun established UMP's reputation as an innovative healthcare solutions provider. We are deeply grateful for the strong foundation he has built, which now propels us to advance UMP into its next growth phase.

PERFORMANCE HIGHLIGHTS

Despite macroeconomic uncertainties over the last year, our core business displayed tremendous resilience. During periods of movement restrictions, demand for services initially slowed as certain new centers openings were delayed due to lockdown measures. However, as restrictions were lifted, patient volumes began stabilizing and trending upwards as our expanded facilities launched to meet rising demand. This recovery phase remains underway. Overall, our integrated service strategy helped cushion volatility and created a solid foundation for future growth.

Another bright spot was our Mainland China operations, which delivered outstanding results amidst the turbulent environment. Revenue grew 19% compared to the previous year thanks to robust performance in major cities. This underscores the depth of demand for our services in the region.

Moreover, areas serving outbound travel also displayed encouraging bounce-backs. Our dental and dermatology clinics in Hong Kong and visa medical examination business in China rebounded significantly following the easing of public health controls. This demonstrates how our core offerings adapted swiftly as restrictions eased.

各位尊敬的股東：

在我們提交上任以來首份年度報告之際，我們首先要向孫耀江醫生致意，感謝他自聯合醫務2015年上市以來擔任行政總裁的傑出領導。過去十年，孫醫生帶領聯合醫務轉型為一個綜合醫療網絡，冀望為更廣泛的大眾提供全面、協調的護理。孫醫生憑藉其醫學專業及其重視建立夥伴關係的思維，為聯合醫務建立了作為創新醫療解決方案提供者的聲譽。我們衷心感謝彼建立的堅實根基，幫助我們將聯合醫務推向下一個成長階段。

工作要點

儘管去年宏觀經濟形勢不明朗，但我們的核心業務表現展現強大韌性。在封控措施導致出行受限期間，若干新落成的中心被迫延遲開業，初期服務需求略有放緩。然而，隨著限制措施解除，患者數量開始回穩並呈上升趨勢，而我們的設施在擴建後亦投入使用，滿足上升需求。上述復甦仍在行進中。總體而言，我們的綜合服務策略起了緩解波動的作用，並為未來增長奠定了堅實基礎。

另一亮點為我們的中國內地業務，在環境動盪下仍取得亮麗業績。得益於主要城市的強勁表現，收入按年增長19%。此凸顯了內地對我們服務的需求深度。

此外，為出境人士服務的業務板塊表現回升，令人鼓舞。而我們在香港的牙科及皮膚科診所以及在中國的出國簽證體檢業務在公共衛生管制鬆綁後亦大幅反彈。由此可見，我們的核心服務在限制措施放寬後迅速調整。

UPCOMING PRIORITIES

Having recently completed a strategic expansion phase, we now focus on integration efforts to optimize synergies. Multiple new clinics and centers were established over the last three years to expand our coverage footprint. As these service points become fully operational, we are streamlining inter-business processes through a digital transformation program. This will enhance the customer experience across all touchpoints with the aid of online scheduling, electronic health records, and new payment solutions.

Another objective is to strengthen interconnectivity among our divisions to allow seamless and coordinated referrals and follow-up, and optimized use of collective capacity and partnerships. This creates a true patient-centric experience while improving resource efficiency.

As one of the few integrated providers offering third-party administration (TPA) and medical services together, we are uniquely positioned to deliver cost-effective healthcare programs tailored to payers' needs. The Voluntary Health Insurance Scheme initiated by the Hong Kong government aims to increase individual healthcare protection, which is expected to further drive private market demand. Leveraging our expertise and networks, we see significant potential to capture this growing commercial market for workplace health benefits and individual medical cost management programs.

Our balance sheet reflects capital investments made to establish strategic assets that position UMP for continued growth. Significant investments were directed towards facilities, technology, and talent recruitment last year. While weighing on short-term profits, these investments have established high-quality infrastructure crucial for service expansion, innovation, and market penetration in coming fiscal periods. With a robust capital structure, we are well-positioned to capitalize on new opportunities.

來年的優先事項

我們最近完成了一階段的策略性擴張，現階段正集中精力進行整合，以增進協同效應。過去三年，我們一直擴闊業務足跡，開立了多間新的診所和服務中心。隨著該等服務設施全面投入營運，我們實行數碼轉型來簡化業務之間的流程，透過網上預約、電子健康記錄和新的結帳方式，幫助提升每個服務點的用戶體驗。

另一目標是創造以患者為本的服務體驗，故此我們會加強各業務和部門之間的相互聯繫和溝通，充分善用資源和綜合能力，讓診症服務之間的轉介和跟進無縫銜接。

作為市場少有同時提供第三方管理(TPA)和醫療服務的綜合機構，我們擁有獨特優勢，可以根據付款人的需要提供具成本效益的醫療保健計劃。香港政府推動的自願醫保計劃旨在提升個人醫療保障，預計將進一步推高私人市場需求。可見職場醫療福利及個人醫療開支管理計劃的商業市場將持續增長，而以我們的專業知識及網絡，甚具潛力爭取市場份額。

我們的資產負債表顯示了有助於聯合醫務未來發展而進行的策略資本投資。我們去年投放了相當的資金於增添設施、提升技術和招聘人才方面。雖然此等開支對短期利潤造成壓力，但它們開發了高品質的基礎設施，這對於未來財政年度的服務擴展、創新和市場滲透甚為重要。憑藉穩健的資本結構，我們完全有能力把握新機遇。

OUR LEADERSHIP APPROACH

As the new leadership team, we are committed to UMP's vision, leveraging our business philosophy, and building upon decades of dedication to preventive and value-driven care. In the coming year, we will concentrate on four priorities: expanding network reach by deepening key city and service presence; elevating operational excellence through talent empowerment and quality initiatives; powering innovation through targeted R&D and partnerships; and replicating successes across the Greater China and Asia region through strategic partnership building.

We have also established strategic partnerships with reputable medical groups and institutions to enhance our service capabilities and extend our reach. These collaborations allow us to tap into specialized expertise, leverage each other's strengths, and create seamless referral channels and synergies within our ecosystem.

One of our key objectives is for UMP to be recognized among corporate and insurance clients as the one-stop comprehensive solution for their healthcare needs. By executing integrated care models, preventive solutions, and public-private programs, we aim to become the new standard in the private healthcare market in terms of accessibility and service excellence.

Through a collaborative leadership style focused on accountability, adaptability and empowerment, we aspire to maximize competitive differentiation in a rapidly changing industry.

We thank our other Board members and shareholders for their ongoing support and confidence as we work to realize our ambitious goals. We also extend our heartfelt gratitude to the entire UMP staff for their unwavering dedication, hard work, and invaluable contributions to the company's success. 我們的領導方式

OUR BUSINESS

UMP's business scope consists of the following business lines:

1. Hong Kong & Macau Corporate Healthcare Solution Services

UMP provides corporate healthcare solutions through the design and administration of tailored healthcare benefits plans for its Contract Customers. The extension of third party administration service to our insurance company clients is an important offering among UMP's corporate healthcare solutions. UMP aims to provide convenient, reliable, coordinated, comprehensive and affordable healthcare services through the well-established and multi-specialties UMP Network. As at 30 June 2023, the UMP Network comprises over 1,000 points of services located across Hong Kong and Macau.

The Group's Contract Customers comprise (i) insurance companies, which enter into contracts with the Group for healthcare services for their policyholders or employees of their policyholders and (ii) corporations, which enter into contracts with the Group for healthcare services for their employees and/or their dependants. When designing healthcare benefits plans, the Group collaborates closely with the Contract Customers and designs and refines corporate healthcare benefits plans, with each plan tailored to each customer's needs based on factors such as industry or occupational health-related concerns, scope of healthcare benefits desired, employee demographic as well as their budget.

我們的業務

聯合醫務的業務範疇包括以下業務線：

1. 香港及澳門企業醫療保健解決方案服務

聯合醫務通過設計及管理針對其合約客戶度身定製的醫療保健福利計劃，提供企業醫療保健解決方案。本集團將第三方管理服務拓展至我們保險公司客戶，是聯合醫務的企業醫療保健解決方案的重要一環。聯合醫務旨在通過完善及多個不同專科的UMP網絡，提供便捷、可靠、協調、全面及實惠的醫療保健服務。於2023年6月30日，UMP網絡包括超過1,000個位於香港及澳門的服務點。

本集團的合約客戶包括(i)保險公司，為彼等保單持有人或保單持有人的僱員就醫療保健服務與本集團訂立合約；及(ii)企業，為彼等僱員及／或彼等的家屬就醫療保健服務與本集團訂立合約。在設計醫療保健福利計劃時，本集團與合約客戶密切合作，設計及優化企業醫療保健福利計劃，根據行業或有關的職業健康問題、所需醫療福利的範圍、僱員特徵及其預算開支等因素，針對每一客戶的需求提供度身定製的計劃。

2. Hong Kong & Macau Clinical Healthcare Services

UMP provides medical and dental services, medical imaging and laboratory services and other auxiliary medical services to Self-paid Patients. For medical services, UMP provides (i) general practice services, which serves as the first point of contact for the patients and (ii) specialist services covering more than 20 different specialties. For dental services, UMP provides both primary dental care and secondary dental care such as dental implants.

Medical imaging and laboratory services are an integral part of medical and healthcare. UMP, through its ProCare medical group, provides one-stop and comprehensive imaging and laboratory services. Equipped with many advanced imaging equipment and testing facilities including PET-CT, MRI, CT Scan, ultrasound, mammography and X-ray, we provide extensive and reliable medical diagnosis and laboratory services. UMP can provide a wide range of imaging and laboratory services at our own laboratory, including haematology, immunology, microbiology, molecular biology, cytology, and histology, as well as urinalysis, stool analysis, allergy test and drug test. As at 30 June 2023, the Group invests and/or operates a total of 12 advanced imaging and laboratory centres, including its own registered laboratory, in Hong Kong.

For other auxiliary medical services, UMP provides services such as physiotherapy and vision care.

3. Mainland China Clinical Healthcare Services

Our Mainland China Clinical Healthcare Services currently consists of (i) health check-up business and (ii) selected outpatient services such as family medicine within the clinics we own and operate.

2. 香港及澳門臨床醫療保健服務

聯合醫務向自費患者提供醫療及牙科服務、醫學影像及化驗服務以及其他輔助醫療服務。醫療服務方面，聯合醫務提供(i)全科醫療服務，為患者的首個接觸點；及(ii)專科服務，覆蓋超過20個不同專科。牙科服務方面，聯合醫務提供基本牙科護理及第二層牙科護理(例如植牙)。

醫學影像及化驗服務是旗下業務的不可或缺組成部分。聯合醫務通過其普康醫療集團，提供一站式及全面的影像及化驗服務。我們備有多種先進的影像設備及測試設施，包括正電子電腦斷層掃描、磁力共振成像、電腦斷層掃描、超聲波、乳房造影及X光，提供廣泛而可靠的醫療診斷及化驗服務。聯合醫務可以在自置的化驗室提供廣泛的影像及化驗服務，包括血液學、免疫學、微生物學、分子生物學、細胞學及組織學，以及尿液分析、糞便分析、過敏測試及藥物測試。於2023年6月30日，本集團在香港共投資及／或經營12間先進的影像及化驗中心，包括其註冊化驗所。

其他輔助醫療服務方面，聯合醫務提供物理治療以及眼科護理等服務。

3. 中國內地臨床醫療保健服務

我們的中國內地臨床醫療保健服務目前包括(i)體檢業務；及(ii)在我們擁有及經營的診所內提供選定門診服務(如家庭醫學服務)。

BUSINESS REVIEW

During FY2023, following the increase in vaccination coverage, the changes in people's lifestyles and the gradual lifting of pandemic control measures in Hong Kong, Macau and Mainland China, many businesses and social activities have gradually recovered. During the year under review, our Group strived to focus on our principal businesses to maintain stability in our performance. Meanwhile, we continued to refine our business and development strategies to boost our competitive strength and improve our operational efficiency.

Hong Kong & Macau Corporate Healthcare Solution Services

Revenue for this business line marginally increased by 3.9% from HK\$237.0 million for FY2022 to HK\$246.2 million for FY2023 (before inter-segment elimination) and our operating profit for this business line increased by 27.5% from HK\$35.3 million for FY2022 to HK\$45.0 million for FY2023. The increase was mainly attributable to improving customer base and overall profit margins from our corporate healthcare solution products.

Hong Kong and Macau Corporate Healthcare Solution Services is one of our core business lines. Through our professional knowledge and extensive medical service network, we have designed, provided and administered comprehensive and cost-effective healthcare solutions for different local and international companies, insurance companies and insurance brokerage companies.

Our extensive and long-term relationship with our customers and service providers has established a strong and stable customer base. During FY2023, this business line continued its momentum and reported a positive contribution to the Group, maintaining a steady growth in revenue and profits.

To reinforce the Group's development in Hong Kong and Macau Corporate Healthcare Solution Services, we have been making effort on the following during the year under review:

於2023財政年度，隨著疫苗接種率的提高、大眾生活模式的改變，以及香港、澳門及中國內地逐步取消疫情防控措施，許多商業及社會活動已逐漸恢復。於回顧年度，本集團致力專注發展主營業務，以穩定我們的業績表現。與此同時，我們繼續優化業務及發展策略，以提升我們的競爭力及營運效率。

香港及澳門企業醫療保健解決方案服務

來自此業務線的收入(分部間抵銷前)由2022財政年度的237.0百萬港元略增3.9%至2023財政年度的246.2百萬港元，而我們來自此業務線的經營利潤由2022財政年度的35.3百萬港元增加27.5%至2023財政年度的45.0百萬港元。此增加主要是由於客戶群及我們的企業醫療保健解決方案產品的整體利潤率有所提升。

香港及澳門企業醫療保健解決方案服務乃我們的核心業務線之一。憑藉專業知識及龐大醫療服務網絡，我們一直為各類本地及跨國公司、保險公司及保險經紀公司設計、提供及管理全面且具成本效益的醫療保健解決方案。

有賴我們與客戶及服務提供者建立廣泛而長遠的業務關係，我們的客戶群龐大而穩健。於2023財政年度，此業務線繼續保持其業務增長勢頭，並為本集團帶來積極貢獻，在收入及利潤方面均保持穩定增長。

為鞏固本集團在香港及澳門企業醫療保健解決方案服務領域的發展，我們在回顧年度內一直致力於以下工作：

(i) Provision of premium healthcare services in UMP+ centres in Central

In July 2022, our new multi-floor medical facilities “UMP+ & Pedder Health” at One Chinachem Central (“OCC”) in Central were launched to provide comprehensive medical and imaging services. Such development strengthens our provision of comprehensive, competitive and value-added healthcare solution services to our corporate customers. Moreover, it broadens our service package and will improve our overall revenue and gross profit margins of the Group.

(ii) Provision of Third Party Administration (“TPA”) service to FTLife and expand cashless treatment coverage for scheme members

In October 2022, the Group has entered into an agreement with FTLife Insurance Company Limited (“FTLife”) in respect of the provision and administration of the medical services by the Group to the insured, policyholders and their respective family members (the “FTLife TPA Agreement”).

The FTLife TPA Agreement provides FTLife individual medical insurance scheme members with a series of cashless treatments with pre-approval by network doctors. The approved arrangements will be payment- and claims-form-free so that patients can receive timely and high-quality medical services, with comprehensive protection and less financial burden and psychological stress during treatment.

This new service agreement with FTLife is UMP’s first customised healthcare solution for individual scheme customers of an insurance company, further intensifying the collaboration model of “Medical+Insurance” and speeding up our development of healthcare solution business-to-business-to-consumer (B2B2C) market.

(i) 中環的UMP+醫務中心提供尊貴醫療保健服務

於2022年7月，我們位於中環華懋中心I期（「華懋I期」）的全新多層醫療設施「UMP+ & Pedder Health」正式啟用，提供綜合醫療及影像服務。此項新啟用設施有助增強我們的服務能力，為企業客戶提供全面而具競爭力的增值醫療保健解決方案服務，並令我們的服務組合更為多元，有助提高本集團的整體收入及毛利率。

(ii) 為富通保險提供第三方管理服務並擴大計劃成員的免現金治療服務範圍

於2022年10月，本集團與富通保險有限公司（「富通保險」）訂立協議，內容有關由本集團向有關受保人、保單持有人及其相關家庭成員提供及管理醫療服務（「富通保險第三方管理協議」）。

富通保險第三方管理協議為富通保險個人醫療保險計劃成員提供由聯網醫生預先批准的一系列免現金治療服務。經批准的安排將可免找數和免填表索償，使患者能夠及時得享優質醫療服務，受到全面保障，並減少治療期間所面臨的財務負擔及心理壓力。

是次與富通保險訂立新服務協議乃聯合醫務首度為保險公司個人計劃客戶定製醫療保健解決方案，進一步深化「醫療+保險」的合作模式，並推動我們將醫療保健解決方案業務拓展至企業對企業對消費者(B2B2C)市場。

(iii) Exploring and establishing strategic alliances

During the year under review, the Group has proactively liaised with certain reputable medical providers and established different forms of valuable strategic and commercial alliances.

These collaborations and strategic cooperations will bring in more business opportunities, which are expected to result in increased revenue momentum for our business. Such potential and established strategic alliances would also improve our service spectrum and packages, enhancing our service comprehensiveness and value. These strategic alliances will be a positive driving force and provide competitive advantage for our corporate healthcare solution business.

Hong Kong & Macau Clinical Healthcare Services

Revenue for this business line increased by 12.5% from HK\$500.4 million for FY2022 to HK\$562.8 million for FY2023 (before inter-segment elimination), of which HK\$157.0 million was derived from our medical imaging and laboratory services for FY2023 (before inter-segment elimination) (FY2022: HK\$147.3 million). Our extensive clinical chains have been developed over the years, which support our corporate healthcare solution service unit and, on the other hand, serve walk-in patients. During FY2023, social life has gradually returned to normal following the gradual lifting of pandemic control measures in Hong Kong and Macau. The demand for our clinical healthcare services increased, resulting in an overall increase in revenue from the provision of clinical healthcare services in Hong Kong and Macau for FY2023.

Our operating profit for this business line decreased by 53.3% from HK\$68.6 million for FY2022 to HK\$32.0 million for FY2023. This is mainly attributable to the (i) significant initial operating expenses, including depreciation of right-of-use assets, depreciation of property, plant and equipment and property rental and related expenses for the new medical and imaging centres; (ii) increase in staff costs arising from expansion in the clinical medical team which was in line with our development plan of medical and imaging facilities; and (iii) partially offset by the increase in operating profit from body health check services.

(iii) 探索並建立戰略聯盟

於回顧年度，本集團積極與若干知名醫療服務提供者保持聯繫，把握建立各形式戰略及商業聯盟的寶貴機會。

此等協作及戰略合作關係可創造更多商機，預期將推動我們的業務營利增長。該等潛在及現有戰略聯盟亦有助改善我們的服務範圍及組合，從而為客戶提供更全面的高價值服務，更會為我們的企業醫療保健解決方案業務注入積極動力及競爭優勢。

香港及澳門臨床醫療保健服務

來自此業務線的收入（分部間抵銷前）由2022財政年度的500.4百萬港元增加12.5%至2023財政年度的562.8百萬港元，其中157.0百萬港元的2023財政年度收入（分部間抵銷前）來自我們的醫學影像及化驗服務（2022財政年度：147.3百萬港元）。我們廣泛的連鎖診所已建立多年，在支援企業醫療保健解決方案服務單位的同時，亦為門診使用者服務。於2023財政年度，隨著香港及澳門逐步取消疫情防控措施，社會生活已逐漸恢復正常。我們的臨床醫療保健服務需求有所增加，致使2023財政年度香港及澳門臨床醫療保健服務收入錄得整體增長。

我們來自此業務線的經營利潤由2022財政年度的68.6百萬港元減少53.3%至2023財政年度的32.0百萬港元，主要是由於(i)錄得顯著的初始經營開支，包括就新啟用的醫療及影像中心所錄得的使用權資產折舊、物業、廠房及設備折舊、物業租金及相關開支等；(ii)為配合我們的醫療及影像設施發展計劃而擴大了臨床醫療團隊，導致員工成本增加；及(iii)獲體檢服務的經營利潤增長所部分抵銷。

During FY2023, the Group continued to seize opportunities arising from increasing demand for our health check-ups and medical imaging services resulting from the increase in healthcare awareness and the aging population, together with emigration and overseas studying. The Group made the following progress during the year under review:

(i) Commencement of business of new medical and imaging centres in Central, Tsim Sha Tsui and Admiralty

- (a) The new multi-floor medical facilities “UMP+ & Pedder Health” at OCC in Central started to operate since July 2022. The centres are operated in conjunction with Pedder Healthcare Group, a private healthcare group in Hong Kong formed by a team of professional physicians and surgeons. Together we offer a range of medical services, including oncology, day surgery, diagnostic imaging, general and specialist consultations, vaccination, physiotherapy and various preventive health check-ups.
- (b) A new integrated imaging centre at 26 Nathan Road in Tsim Sha Tsui (“**26 Nathan Road**”) started to operate in February 2023 to provide medical imaging services including but not limited to CT Scan, MRI, bone density scan, Mammogram and X-ray services (“**ProCare Imaging Centre - TST**”).

26 Nathan Road is a multi-functional building with many medical specialties and surgical practices as tenants. ProCare Imaging Centre – TST is situated at a strategically convenient location to serve and provide quality imaging and laboratory services to the medical specialties and surgical practices in the same building and district.

於2023財政年度，本集團繼續抓緊大眾健康意識提高及人口老化，加上更多客戶移民及海外求學等因素，帶動對我們的體檢及醫學影像服務需求增長的機遇。本集團於回顧年度取得了以下進展：

(i) 於中環、尖沙咀及金鐘的全新醫療及影像中心正式開業

- (a) 位於中環華懋I期的全新多層醫療設施「UMP+ & Pedder Health」已於2022年7月開始營業。此中心由我們與仁德醫健集團（其為一間由多名外科及內科專科醫生創辦的香港私營醫療保健集團）合作營運，共同提供一系列醫療服務，包括腫瘤科、日間手術、醫學影像、全科及專科診症、疫苗接種、物理治療，以及各類型預防性體檢。
- (b) 位於尖沙咀彌敦道26號（「**彌敦道26號**」）的全新綜合影像中心已於2023年2月開始營業，其提供醫學影像服務包括（但不限於）電腦斷層掃描、磁力共振成像、骨密度掃描、乳房造影及X光服務（「**普康醫學影像中心－尖沙嘴**」）。

彌敦道26號為一幢綜合大樓，已有多家專科及外科診所入駐。普康醫學影像中心－尖沙嘴位置便利，具戰略優勢，可為大樓內及同區專科及外科診所提供優質醫學影像及化驗服務。

- (c) A new PET-CT imaging centre at the Bank of America Tower in Admiralty, with a brand-new digital PET-CT scanner installed, started to operate in June 2023.

PET-CT imaging is a type of nuclear medicine imaging that uses radiotracers to diagnose various types of clinical conditions accurately. This non-invasive examination is used for cancer and heart disease diagnosis and is especially important in cancer treatment. PET-CT scanning helps to facilitate early cancer diagnosis, staging and treatment response assessment. However, due to the unique requirements for installing PET-CT imaging facilities, PET-CT scanning services are not widely available in the Hong Kong market.

For the abovementioned new centres, certain significant initial rental charge and depreciation charge during the renovation, installation and licenses application period and initial operating stage amounted to approximately HK\$31.1 million were recognised for the year ended 30 June 2023. These new centres have been gradually ramping up and have started to provide positive revenue contribution. With increased operational efficiency, we anticipate an improvement in the Group's financial performance.

The Group is optimistic about the growing demand for private imaging and laboratory services. We expect the new imaging centres will strengthen our imaging and laboratory capability and act as one of the key driving forces to the revenue growth and business development of the Group.

- (c) 位於金鐘美國銀行中心的全新正電子電腦斷層掃描影像中心已於2023年6月開始營業，其已安裝了全新的數碼正電子電腦斷層掃描設備。

正電子電腦斷層掃描影像為其中一項核子醫學影像技術，其採用放射性核素以準確診斷各類臨床狀況。此項非入侵性檢查技術可用於癌症及心臟疾病診斷，並在癌症治療中尤為重要，在進行早期癌症診斷、癌症分期及評估治療反應方面均有顯著作用。然而，由於安裝正電子電腦斷層掃描影像設施有特定規定，故相關服務於香港市場的供應依然有限。

就上述新啟用的中心而言，於截至2023年6月30日止年度，在裝修、安裝及申請牌照期間以及初始營運階段錄得的若干重大初始租金及折舊支出約31.1百萬元。該等新啟用中心的營運正逐步上軌，並已開始帶來正面收入回報，預計隨著營運效率提高，我們預期本集團的財務表現亦會得以改善。

本集團對私人醫學影像及化驗服務的需求增長感到樂觀。我們預期新啟用的影像中心將加強我們的醫學影像及化驗服務能力，並將成為本集團收入增長及業務發展的主要動力之一。

(ii) Business Cooperation with Humansa

In October 2022, SkinCentral, our Group's dermatology centre, entered into a service agreement with Humansa, a New World Group healthcare brand, under which SkinCentral provides professional dermatology and aesthetics services at Humansa•Victoria Dockside Flagship in Tsim Sha Tsui.

Entering into this service agreement further strengthens our strategic cooperation with other premium health and wellness brand such as Humansa and the New World Group. Humansa is focusing on building a ground-breaking health and wellness ecosystem across the Greater Bay Area, which will benefit our future business development in the same area.

(iii) Purchase of medical imaging equipment

In response to the increasing demand for health check-ups and medical imaging services due to the aging population and increased health awareness generally, the Group has been focusing on precision and preventive medicine as our core services and actively expanding our advanced medical imaging and laboratory services.

To cope with our increasing medical imaging service points, purchasing medical equipment is an important part of the capital investment in the medical imaging business development.

In August 2022, the Group has entered into a series of purchase contracts for new medical imaging equipment. The purchase covered the ordering and purchase of advanced and powerful imaging machineries including but not limited to the CT machine, MRI machine, PET-CT machine and their relevant auxiliary supporting systems. The capital expenditure is in line with the Group's overall strategic development in the medical imaging business and is expected to provide a positive return to the Group. For further details, please refer to the Company's announcements dated 31 August 2022 and 6 September 2022.

(ii) 與仁山優社展開業務合作

於2022年10月，本集團的皮膚科專科中心SkinCentral與新世界集團旗下的醫療保健品牌仁山優社訂立服務協議，由SkinCentral在位於尖沙咀的仁山優社•維港文化匯旗艦中心提供專業皮膚專科治療及醫學美容服務。

是次訂立服務協議後，我們進一步加強與仁山優社等其他優越醫療健康品牌以及新世界集團的戰略合作。仁山優社正致力於大灣區建立完備的醫療保健生態圈，有關合作有助推動我們未來在該區的業務發展。

(iii) 購買醫學影像設備

鑒於人口老化以及大眾整體健康意識提高，體檢及醫學影像服務需求不斷增加，本集團因此一直以精準及預防醫療服務為核心，並積極拓展先進醫學影像及化驗服務。

為配合本集團醫學影像服務點的不斷增加，購買醫療設備是投入資本發展醫學影像業務的重要一環。

於2022年8月，本集團就購買全新醫學影像設備訂立一系列採購合約。有關採購涉及訂購和購買先進及強大的醫學影像設備，包括(但不限於)電腦斷層掃描設備、磁力共振成像設備、正電子電腦斷層掃描設備及相關輔助配套系統。此項資本開支符合本集團醫學影像業務方面的整體戰略發展，預期將為本集團帶來積極回報。進一步詳情請參閱本公司日期為2022年8月31日及2022年9月6日的公告。

(iv) New integrated imaging centre in Causeway Bay

In July 2023, the Group and a private hospital group leased the 26th floor of Lee Garden Two in Causeway Bay to operate a new one-stop multi-service medical centre. Together we offer a range of medical services, where the Group is mainly responsible for providing medical imaging services including but not limited to CT Scan, MRI, bone density scan, mammogram and X-ray services.

Due to increasing public health awareness and high demand for healthcare services by an aging population in Hong Kong, the demand for comprehensive medical services, high-end medical imaging and health check services and other ancillary medical services remain strong. The Group believes that the collaboration with the private hospital group will create synergistic effects in the operation of clinical network and drive our operating profit.

The site is under renovation and is expected to open in the first quarter of 2024.

Although some of the aforementioned developments required high initial capital investments due to the nature of the business, the Board believes that establishing these foundations will provide the Group with a solid platform for sustainable growth. Moreover, the Group's customer base will be strengthened and synergistic contributions will be created, promoting to the overall growth in the healthcare business and yielding long-term returns.

Mainland China Clinical Healthcare Services

Revenue for this business line increased by 18.8% from HK\$37.6 million for FY2022 to HK\$44.7 million for FY2023 (before inter-segment elimination) and our operating profit for this business line increased by 994.7% from HK\$1.5 million for FY2022 to HK\$16.8 million for FY2023. Such growth was primarily due to the increase in (i) number of health check-ups; and (ii) operation efficiency and effective cost control.

Medical service teams in Mainland China principally provide healthcare check-up services and selected outpatient family medical services mainly in Beijing and Shanghai. Driven by a massive demand for quality healthcare services in Mainland China, the performance of the Mainland China clinical healthcare business maintained momentum and reported an encouraging growing result for FY2023.

(iv) 於銅鑼灣的全新綜合影像中心

於2023年7月，本集團與一間私家醫院集團合租銅鑼灣利園二期26樓以經營全新的一站式綜合醫療中心，共同提供一系列醫療服務。本集團主要負責提供醫學影像服務，包括但不限於電腦斷層掃描、磁力共振成像、骨密度掃描、乳房造影及X光服務。

由於大眾健康意識不斷提高，加上香港人口老化對醫療服務的需求日增，因此，綜合醫療服務、高端醫學影像及體檢服務及其他配套醫療服務的需求依然強勁。本集團相信，與私家醫院集團合作將會在臨床網絡經營方面帶來協同效應，並提高我們的經營利潤。

該址現正進行裝修，預計於2024年第一季度啟用。

儘管上述部分業務發展因業務性質關係而需要高額的初始資本投資，惟董事會相信，奠定此等基礎將為本集團提供堅實平台，藉以實現可持續增長。此外，本集團的客戶基礎將獲得加強，並且將創造協同貢獻，從而推動醫療保健業務的整體增長及帶來長期回報。

中國內地臨床醫療保健服務

來自此業務線的收入(分部間抵銷前)由2022財政年度的37.6百萬港元增加18.8%至2023財政年度的44.7百萬港元，而我們來自此業務線的經營利潤由2022財政年度的1.5百萬港元增加994.7%至2023財政年度的16.8百萬港元。此增長主要是由於(i)體檢次數增加；及(ii)營運效率提高及有效控制成本。

中國內地的醫療服務團隊主要在北京和上海提供醫療保健體檢服務及選定門診家庭醫療服務。目前中國內地對優質醫療保健服務有龐大需求，推動中國內地臨床醫療保健業務表現保持發展動力，並於2023財政年度取得令人鼓舞的增長佳績。

First Innovation Centre for Healthcare Technology

UMP believes in the use of advanced technology in the healthcare industry. The Group supports the development of advanced medical application technology and the exchange of scientific research knowledge and experience among all relevant industry players. In light of this, we launched UMP Healthcare Innov Centre (“**Innov Centre**”) on 1 November 2022 at the UMP’s headquarters at Wing On House. Innov Centre is the first permanent medical technology centre in Hong Kong to showcase the latest medical technology and products.

We believe that the Innov Centre will become an attractive hotspot to display the latest advanced technology. The support of various advanced medical equipment industry players and medical technology developers will facilitate related research and development projects to be commercialised. We hope that the advanced medical devices and solutions displayed in the Innov Centre will be further applied in actual medical settings, which will benefit the industry and the public at large.

首個醫療保健技術創科中心

聯合醫務深信在醫療保健行業採用先進科技的重要性，並支持發展先進醫療應用技術，鼓勵所有相關行業持份者交流科研知識及經驗。有見及此，聯合醫務於永安集團大廈的總部成立聯合醫務創科中心（「**創科中心**」），並於2022年11月1日正式啟用。此乃香港首個常設醫療技術中心，為最新醫療技術及產品提供展示平台。

我們相信，創科中心將成為最新先進技術的展覽熱點。在各先進醫療設備行業持份者及醫療技術開發商的支持下，其有助推動相關研發項目進行商業化。我們希望，創科中心所展示的先進醫療設備及解決方案能夠進一步應用於實際醫療場所，從而令行業及廣大公眾受惠。

FINANCIAL REVIEW

FY2023 compared to FY2022

Revenue from continuing operations

During FY2023, we primarily generated revenue from (i) the provision of corporate healthcare solutions to Contract Customers in Hong Kong and Macau, (ii) the provision of clinical healthcare services to Self-paid Patients in Hong Kong and Macau and (iii) the provision of clinical healthcare services in Mainland China.

Total consolidated revenue from continuing operations increased by 9.2% from HK\$665.9 million in FY2022 to 727.2 million in FY2023, primarily due to the growth in our imaging and specialist lines of business and health assessments performed, which enjoy relatively higher margin.

Professional Services Expenses

Professional services expenses primarily comprise fees paid to Doctors, Dentists and Auxiliary Services Providers for Medical Services, Dental Services, medical imaging and laboratory services and Auxiliary Services rendered within the UMP Network, as well as fees paid to third party laboratories and medical imaging centres for services rendered to the Group.

Professional services expenses increased by 7.3% from HK\$238.0 million for FY2022 to HK\$255.4 million for FY2023, in line with the nature of the services provided and turnover growth during the year.

財務回顧

2023財政年度與2022財政年度比較

來自持續經營業務的收入

於2023財政年度，我們的收入主要來自(i)於香港及澳門向合約客戶提供企業醫療保健解決方案；(ii)於香港及澳門向自費患者提供臨床醫療保健服務及(iii)於中國內地提供臨床醫療保健服務。

來自持續經營業務的總綜合收入由2022財政年度的665.9百萬港元增加9.2%至2023財政年度的727.2百萬港元，乃主要由於我們的醫學影像及專科業務線以及健康評估錄得增長而有關業務的利潤率較高。

專業服務費用

專業服務費用主要包括就醫生、牙醫及輔助服務提供者於UMP網絡內提供的醫療服務、牙科服務、醫學影像及化驗服務以及輔助服務而向其支付的費用，以及就第三方化驗及醫學影像中心向本集團提供的服務而向其支付的費用。

專業服務費用由2022財政年度的238.0百萬港元增加7.3%至2023財政年度的255.4百萬港元，與本年度內所提供服務的性質及營業額增長相符。

Employee Benefit Expense

Employee benefit expense primarily comprise salaries and related costs, equity-settled share-based payment expense, as well as pension scheme contributions for nurses and administrative personnel, and also include those of the Directors and key management personnel.

Employee benefit expense increased by 9.2% from HK\$164.7 million for FY2022 to HK\$179.8 million for FY2023. The increase in employee benefit expense reflects the Group's talent strategy as we continue to increase the talent pool in preparation for the next phase of our development. While the employee benefit expense is not a direct variable cost, its increase is in line with business growth.

Depreciation and Amortisation

Depreciation and amortisation, which comprises of depreciation of the right-of-use assets and depreciation and amortisation of other non-current assets.

Depreciation and Amortisation increased by 32.1% from HK\$78.6 million for FY2022 to HK\$103.9 million for FY2023, which is in line with business growth.

Other Expenses

Other expenses primarily comprise provision of impairment loss and general overhead expenses such as utilities, operating and other administrative expenses such as professional fees, repair and maintenance expenses incurred with respect to the Group's offices and medical equipment, printing expenses and bank charges.

Other expenses, increased by 12.5% from approximately HK\$65.8 million for FY2022 to HK\$74.0 million for FY2023, primarily due to the write-off of brand name of HK\$9.8 million during the year.

僱員福利開支

僱員福利開支主要包括護士及行政人員以及董事及主要管理人員的薪金及相關成本、以權益結算的股份支付開支以及退休金計劃供款。

僱員福利開支由2022財政年度的164.7百萬港元增加9.2%至2023財政年度的179.8百萬港元。僱員福利開支增加反映本集團的人才策略，因為我們繼續壯大人才庫，為下一階段的發展作好準備。僱員福利開支並非直接的可變成本，其增加與業務增長一致。

折舊及攤銷

折舊及攤銷包括使用權資產折舊以及其他非流動資產之折舊及攤銷。

折舊及攤銷由2022財政年度的78.6百萬港元增加32.1%至2023財政年度的103.9百萬港元，符合業務增長步伐。

其他開支

其他開支主要包括減值虧損撥備及日常開銷，例如水電、經營及其他行政開支（例如專業費用、與本集團辦公室及醫療設備相關的維修及保養開支、印刷費及銀行收費）。

其他開支由2022財政年度約65.8百萬港元增加12.5%至2023財政年度的74.0百萬港元，主要由於年內撇銷價值9.8百萬港元的品牌名稱。

KEY FINANCIAL POSITION ITEMS

Right-of-use assets

Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. The recognised right-of-use assets are depreciated on a straight-line basis over the shorter of the estimated useful life and the lease term.

As at 30 June 2023, the Group's right-of-use assets amounted to HK\$107.9 million (30 June 2022: HK\$136.0 million).

Goodwill

Goodwill primarily represents the excess of the aggregate of the consideration over the fair value of the identifiable assets acquired and liabilities assumed. After initial recognition, goodwill is measured at cost less any accumulated impairment losses.

As at 30 June 2023 the Group's goodwill amounted to HK\$164.8 million (30 June 2022: HK\$164.8 million).

Investments at fair value through other comprehensive income, financial assets at fair value through profit or loss and financial assets at amortised cost

Investments at fair value through other comprehensive income, financial assets at fair value through profit or loss and financial assets at amortised cost primarily represent unlisted equity investments at fair value, listed equity and debt investments at fair value and investment funds. Certain equity investments are designated at fair value through other comprehensive income as the Group considers these investments to be strategic in nature.

As at 30 June 2023, the Group's investments at fair value through other comprehensive income, financial assets at fair value through profit or loss and financial assets at amortised cost amounted to HK\$36.8 million, HK\$29.4 million and HK\$Nil (30 June 2022: HK\$31.5 million, HK\$28.5 million and HK\$18.9 million), respectively. The increase of investments at fair value through other comprehensive income is primarily due to changes in fair value. The decrease of financial assets at amortised cost is due to its redemption.

The Group has historically funded its operations primarily by cash generated from operating activities. Upon the listing of the shares of the Company on the Stock Exchange, the Group intended to satisfy its liquidity requirements using a combination of cash generated from operating activities, net proceeds from the Global Offering and the net considerations received from the series of transactions. As of 30 June 2023, the Group had cash and bank deposits of HK\$289.1 million.

CAPITAL EXPENDITURE

The capital expenditure during the year was primarily related to deposits paid for and expenditures on additions of property, plant and equipment for the Group's medical, dental, medical imaging and laboratory and Auxiliary Services centres. For FY2023, the Group incurred capital expenditure in an aggregate amount of approximately HK\$109.3 million (FY2022: HK\$84.5 million).

INDEBTEDNESS

Contingent Liabilities

As at 30 June 2023, the Group did not have any material contingent liabilities.

Capital Commitment

As at 30 June 2023, the Group has material capital commitments of approximately HK\$50.6 million in relation to the acquisition of property, plant and equipment.

TREASURY MANAGEMENT

The Group employs a conservative approach to cash management and risk control. To achieve better risk control and efficient fund management, the Group's treasury activities are centralised.

During FY2023, the Group's receipts were mainly denominated in Hong Kong dollars and Renminbi. Payments were mainly made in Hong Kong dollars and Renminbi. Cash was generally placed in short-term deposits denominated in Hong Kong dollars.

The objective of the Group's treasury policies is to minimise risks and exposures due to the fluctuations in foreign currency exchange rates and interest rates. The Group does not have any significant interest rate risk at present as the Group did not have any bank borrowings or outstanding bank loans and did not enter into any bank loan facilities.

RISK MANAGEMENT

Foreign Currency Risk

During the reporting period, the Group undertook certain transactions in foreign currencies, which exposed the Group to foreign currency risk, primarily relating to the Renminbi against Hong Kong dollars.

The Group did not use any derivative contracts to hedge against its exposure to currency risk. The management manages the currency risk by closely monitoring the movement of the foreign currency rates and will consider hedging against significant foreign exchange exposure when the need arises.

Credit Risk

The credit risk of the Group's financial assets arises from default of the counterparty, with a maximum exposure equal to the carrying amounts of these instruments.

The Group trades only with recognised and creditworthy third parties. It is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. In addition, receivable balances are monitored on an ongoing basis and concentrations of credit risk are managed by customer/counterparty.

PLEDGE OF ASSETS

As at 30 June 2023, the Group has pledged certain deposits with an aggregate carrying amount of HK\$1.4 million (30 June 2022: HK\$2.4 million) in connection with a surety bond issued by a bank in favour of respective independent third parties for potential disruption of Medical and Dental Services.

EMPLOYEE AND REMUNERATION POLICY

As at 30 June 2023, the Group had a total of 508 full-time employees (30 June 2022: 449 full-time employees). For FY2023, the staff cost (including Directors' remuneration in the form of salaries and other benefits) was approximately HK\$179.8 million (FY2022: HK\$164.7 million).

The Group ensures that the pay levels of its employees are competitive and employees are rewarded on a performance-related basis, together with reference to the profitability of the Group, prevailing remuneration benchmarks in the industry, and market conditions within the general framework of the Group's remuneration system.

信貸風險

資產抵押

As at 30 June 2023, there was no option remained outstanding under the Pre-IPO Share Option Scheme. Under the Pre-IPO Share Option Scheme, 23,822,000 options were lapsed and no share options were exercised during FY2023. As at 30 June 2023, there were 25,740,000 options under the Post-IPO Share Option Scheme remained outstanding. Under the Post-IPO Share Option Scheme, 570,000 options were lapsed or forfeited and no share options were granted or exercised during FY2023.

In addition, the Company has also adopted the Share Award Scheme on 30 June 2016 to provide an incentive and reward to selected participants for their contribution or potential contribution to the Group. During FY2023, 2,000,000 awarded shares were granted and vested under the Share Award Scheme, with no awarded shares were lapsed.

The remuneration of the Directors are reviewed by the Remuneration Committee and approved by the Board, according to the relevant Director's experience, responsibility, workload and the time devoted to the Group, the Company's operating results and comparable market statistics.

FINAL DIVIDEND

The directors proposed the payment of a final dividend of HK3.00 cents per Share for FY2023 (FY2022: HK3.00 cents with scrip option), subject to the approval of the Shareholders at the 2023 AGM. Such proposed dividend is expected to be distributed on Friday, 5 January 2024 to the Shareholders whose names appear on the register of members of the Company on Friday, 8 December 2023.

The Company has maintained on its website and on the website of the Stock Exchange an updated list of its Directors identifying their roles and functions, and whether they are independent non-executive Directors. Independent non-executive Directors are identified as such in all corporate communications that disclose the names of Directors.

Board Independence Evaluation

The Company has established a Board Independence Evaluation Mechanism which sets out the processes and procedures to ensure a strong independent element on the Board, which allows the Board effectively exercises independent judgment to better safeguard Shareholders’ interests.

The objectives of the evaluation are to improve Board effectiveness, maximise strengths, and identify the areas that need improvement or further development. The evaluation process also clarifies what actions of the Company need to be taken to maintain and improve the Board performance.

The Board has conducted a review and considered that the Board Independence Evaluation Mechanism has been properly implemented for FY2023 and is effective.

Board Diversity Policy

The Board adopted a board diversity policy setting out the approach to achieve diversity on the Board. The Company considered diversity of Board members can be achieved through consideration of a number of aspects, including but not limited to the gender, age, cultural, educational background and professional experience of the Board members. The appointment of Directors will be based on the Group’s own business model and specific needs, having due regard to the benefits of diversity of the Board.

The Company believes that the current Board composition is well-balanced and of a diverse mix appropriate for the business of the Company. The Board currently has one female Director and in compliance with Board gender diversity requirement under Rule 13.92 of the Listing Rules. We will continue to strive to enhance female representation and achieve an appropriate balance of gender diversity. The Board has reviewed the Board Diversity Policy for FY2023 and is of the view that the Board Diversity Policy has been properly implemented and is effective.

As at 30 June 2023, the gender ratio in the workforce (including senior management) of the Group was approximately 26.6% male and approximately 73.4% female. The Group treats every employee equally and equal opportunities for different genders. In particular, the recruitment process of the Group shall not involve any discrimination on the grounds of race, disability, gender, sexual orientation, family responsibilities, marital status, age or other discriminatory factors. It is relatively more challenging for the Group to achieve equal gender ratio across all business units of the Group due to the characteristics and work types of different business units. The Group will continue to enhance diversity in different levels of workforce.

Chairman and Chief Executive Officer

According to code provision C.2.1 of the part 2 of the Corporate Governance Code, the roles of the chairman and chief executive should be separate and should not be performed by the same individual. Dr. Sun Yiu Kwong, the Chairman of the Board, was also the Chief Executive Officer. The Board believed that vesting the roles of both chairman and chief executive in an experienced and qualified person such as Dr. Sun Yiu Kwong provided the Company with strong and consistent leadership while allowing effective and efficient planning and implementation of business decisions and strategies. The Board considered that this structure would not impair the balance of power and authority between the Board and the management of the Group.

Dr. Sun Yiu Kwong retired from his role as the Chief Executive Officer of the Company with effect from 1 January 2023. With the full support and agreement of the Board, Dr. Sun Yiu Kwong remained as the Chairman and an executive Director of the Company after his retirement as the Chief Executive Officer. Upon Dr. Sun Yiu Kwong's retirement, the Company has complied with the code provision C.2.1 of separating the roles of the Chairman and the Chief Executive Officer under the Corporate Governance Code as set out in Appendix 14 to the Listing Rules.

The Board will review the corporate governance structure and practices from time to time and shall make necessary arrangement when the Board considers appropriate.

Independent Non-executive Directors

During FY2023, the Board at all times met the requirements of the Listing Rules relating to the appointment of at least three independent non-executive Directors representing one third of the Board with one of whom possessing appropriate professional qualifications or accounting or related financial management expertise. The Company has received written annual confirmation from each of the independent non-executive Directors in respect of his independence in accordance with the independence guidelines set out in Rule 3.13 of the Listing Rules. The Company is of the view that all independent non-executive Directors are independent.

Roles of the Board and Management

The Board oversees the management, business, strategic directions and performance of the Group. It is collectively responsible for the management and operation of the Company. The Board is the ultimate decision making body of the Company except for matters requiring the approval of the Shareholders in accordance with the Articles, the Listing Rules or other applicable laws and regulations.

The Board delegates day-to-day operations of the Group to the management of the Company. The Board and the management have clearly defined authorities and responsibilities under various internal control and check and balance mechanisms.

Notice incorporating the agenda for each regular Board meeting is given to all Directors at least 14 days in advance. For other Board meetings and Board committee meetings, reasonable notice will be given. All Directors or Board committee members are given the opportunity to include matters for discussion in the agenda. Meeting agenda and accompanying meeting papers are sent to all relevant Directors at least 3 days in advance of every regular Board meeting or committee meeting.

The Company Secretary assists the Chairman of the Board and the chairmen of Board committees in preparing meeting agendas and ensures that the Corporate Governance Code as well as all applicable laws and regulations are duly complied with. Minutes of Board meetings and Board committee meetings are recorded in sufficient details of the matters considered and decisions reached at the relevant meetings. Draft and final versions of the minutes in respect of Board meetings and Board committee meetings are sent to all Directors or Board committee members respectively for comment and records within a reasonable time after the relevant meetings. All minutes are properly kept by the Company Secretary and are available for the Directors' and Board committee members' inspection.

All Directors are entitled to have access to timely information in relation to the Company's business and make further enquiries or retain independent professional advisors where necessary. The management provides all relevant explanation and information to the Board so as to give the Board the information it needs to discharge its responsibilities. During FY2023, the management has provided all members of the Board with adequate information giving a balanced and understandable assessment of the Company's performance, position and prospects.

Directors' Appointment, Re-election and Removal

Each of the executive Directors has entered into a service contract with the Company for a term of three years subject to the provision of retirement and rotation of Directors under the Articles and the provision under the service contract.

Each of the independent non-executive Directors (other than Mr. Chau, Chit Jeremy) has entered into a letter of appointment with the Company for a term of three years commencing on the date of his appointment. Thereafter, the appointment is renewable automatically for successive terms of one year. Mr. Chau, Chit Jeremy has entered into a letter of appointment with the Company for a fixed term of three years. All independent non-executive Directors are subject to the provision of retirement and rotation of Directors under the Articles and the provision under their letters of appointment.

The Articles provide that each Director is subject to retirement from office by rotation and re-election once every three years and that one-third (or the number nearest to but not less than one-third) of the Directors shall retire from office every year at the annual general meeting. Any Director appointed by the Board to fill a casual vacancy shall hold office until the first general meeting after his appointment and be subject to re-election at such meeting while any Director appointed by the Board as additional Director shall be subject to re-election at the next following annual general meeting.

Directors' training and Professional Development

Every Director keeps abreast of responsibilities as a Director and of the conduct, business activities and development of the Company. Every newly appointed Director receives a comprehensive, formal and tailored induction package covering the statutory and regulatory obligations of Directors, organizational structure, policies, procedures and codes of the Company, terms of reference of board committees and charter of responsibilities of internal audit. The Directors are encouraged to attend seminars and conferences to enrich their knowledge in discharging their duties as a director. The Company Secretary from time to time updates and provides written training materials to the Directors, and organizes seminars on the latest development of the Listing Rules, applicable laws, rules and regulations relating to Directors' duties and responsibilities.

DIRECTORS' RESPONSIBILITIES FOR FINANCIAL STATEMENTS

The Board is responsible for the preparation of the financial statements which should give a true and fair view of the state of affairs of the Group and of the financial performance and cash flows for such reporting period. In preparing the financial statements, the Board has adopted generally accepted accounting standards in Hong Kong and suitable accounting policies and applied them consistently, made judgments and estimates that are prudent, fair and reasonable, and prepared the financial statements on a going concern basis. The Board is responsible for ensuring that the Group keeps proper accounting records which disclose with reasonable accuracy at any time the financial position of the Group.

The Board is not aware of any material uncertainties relating to events or conditions which may cast significant doubt over the Group's ability to continue as a going concern. Accordingly, the Board has continued to adopt the going concern basis in preparing the financial statements.

The auditor is responsible for auditing and reporting its opinion on the financial statements of the Group and the independent auditor's report for FY2023 is set out in the section headed "Independent Auditor's Report" of this annual report.

INTERNAL CONTROL AND RISK MANAGEMENT

The Board acknowledged its responsibility for the risk management and internal control systems and overseeing their effectiveness. Such systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

The Company has developed and adopted various risk management procedures and guidelines with defined authority for implementation by key business processes and office functions, including clinic chain operations, business development, financial reporting, human resources, information technology and handling and dissemination of inside information.

All departments conducted internal control assessment regularly to identify risks that potentially impact the business of the Group and various aspects including key operational and financial processes, regulatory compliance and information security.

The management, in coordination with department heads, assessed the likelihood of risk occurrence, provide treatment plans, and monitor the risk management progress, and reported to the Audit Committee and the Board on all findings and the effectiveness of the systems.

The internal audit team is responsible for providing the internal audit function and performing independent review of the adequacy and effectiveness of the risk management and internal control systems.

The key elements of the Group's risk management and internal control structure are as follows:

- well-defined organizational structure with appropriate segregation of duties, limit of authority, reporting lines and responsibilities to minimize risk of errors and abuse;
- establish written policies and procedures for major functions and operations;
- important business functions or activities are managed by experienced, qualified and suitably trained staff;
- continuous monitoring of the key operating data and performance indicators, timely and up-to-date business and financial reporting, immediate corrective actions are taken where necessary; and
- internal audit function to perform independent appraisal of major operations on an ongoing basis.

A risk-based approach is adopted to ensure that a methodical coverage of the Group's operations and resources are focused on high risk areas. The internal audit team takes the lead to evaluate the risk management and internal control systems of the Group by reviewing the major operations of the Group on a rotational basis every year. The review covers all material controls including financial, operational, compliance controls and risk management.

Review results and recommendations in the form of written reports are submitted to the Audit Committee for discussion and review. Follow up actions will be taken up by the internal audit team to ensure that findings previously identified have been properly resolved. The Board had discussed and reviewed the effectiveness of the Group's risk management and internal control systems for the FY2023, and considered them effective and adequate.

The Company also established a procedure to facilitate employees of the Company to raise, in confidence, concerns about possible improprieties in financial reporting, internal control or other matters of the Company.

During FY2023, the Board, in conjunction with the Audit Committee, conducted a review of the effectiveness of the internal control system of the Company and its subsidiaries, including the adequacy of resources, staff qualifications and experience, training programmes and budget of the Company's accounting, internal audit and financial reporting function, as well as those relating to the Group's ESG performance and reporting. The Board considered that the Group's risk management and internal control systems for FY2023 was effective and adequate and no significant areas of concern has been identified.

Convening an extraordinary General Meeting

Article 58 of the Articles of the Company provides that any one or more members of the Company holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the Company Secretary, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within 2 months after the deposit of such requisition. If within 21 days of such deposit the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

Shareholders may follow the procedures set out above to convene an extraordinary general meeting for any business specified in such written requisition.

The Group offers a wide range of healthcare services suited for diverse individual needs, while also partnering with corporate and insurance companies to administer customised corporate healthcare benefit plans for their members. UMP, through its affiliated companies, operated multiple joint-ventured medical centres with local health service partners in major Chinese cities and facilitated the provision of family doctor training. The UMP network spans over 1,000 self-owned and affiliated medical service points across Hong Kong and Macau.

Since its inception in 1990, the Group has been providing trusted and affordable services to patients. Maintaining a high standard of professional practice and acting with integrity are core tenets of UMP. The Group has integrated Environmental, Social and Governance (“ESG”) management principles into operations and services. The effective management of ESG issues is essential to ensure the sustainable growth of our business. We embrace ESG responsibility and continuously improve the quality and effectiveness of our response to align with our mission, focusing on what is most important to our company, and where we can achieve the greatest impact.

We are committed to upholding a culture of integrity and ensuring that our employees comply with our Code of Ethics and internal policies. Our business operations comply with our Procurement Policy and relevant laws and regulations, such as registering and licensing clinics, handling radioactive substances and apparatuses, treating clinical waste, marketing and promoting healthcare products and services, possessing and distributing drugs, and safeguarding customer and patient privacy. We believe that strict and effective regulation within our company is crucial for sustainable growth and to instil confidence in our stakeholders.

Materiality assessment

Materiality assessment is a continuous process to review our sustainability approach and reporting. Through a review of the impact and importance of ESG issues to the Group and its stakeholders, our assessment process has showed changes in the material ESG topics this year. With reference to the material topics that were identified last year, we have incorporated two new topics into the list of material topics, namely “Development and Training” and “Access to Health Care”, to align with industry norms and respond to the evolving priorities of our stakeholders. By adding these new areas of focus, we maintain a comprehensive and relevant sustainability framework that promotes positive change for our company, stakeholders, and the environment.

OUR SERVICES

UMP is dedicated to safeguarding community health, providing quality service, and improving patient satisfaction. Our Quality Assurance and Safety Committee, comprising medical practitioners and senior management, is responsible for monitoring the performance of our clinics and providing suggestions on clinical governance, clinical risk, and continuous development of clinical and professional services. The Committee also formulates policies and procedures regarding the healthcare and medical services offered by the Group.

The Group strictly complied with all relevant laws and regulations on health and safety, advertising, labelling and privacy matters relating to products and services provided.

我們的服務

聯合醫務致力保障社區健康、提供優質服務、及提高患者滿意度。我們的質量保證及安全委員會由本集團的醫生及高級管理層組成，負責監察我們診所的表現，並就臨床管治、臨床風險、以及臨床及專業服務的持續發展提供意見。該委員會亦制定有關本集團醫療保健及醫療服務的政策及程序。

本集團已嚴格遵守所有有關所提供產品及服務的健康與安全、廣告、標籤及私隱事宜的相關法律及法規。

Clinic hygiene and infection control

To ensure a healthy and comfortable clinical environment, we prioritise maintaining environmental hygiene in our medical centres. Other than good ventilation and lighting systems, we equip clinics with a special suction apparatus to reduce aerosols in the air and procure personal protective equipment (“PPE”) to maintain sufficient stock across our clinic chains. Patient triage and placement procedures are in place to prevent the transmission of disease within clinics. We carefully sterilise reusable medical equipment and ensure that sufficient sanitary and hand-washing facilities are available to all patients and staff. Hand hygiene tips and cough etiquette posters are also displayed at our clinics to act as a reminder for all. We provide clinic infection control training to clinic staff to prevent epidemic diseases and further reduce the risk of communicable diseases. Surgical masks and other necessary protective equipment are also provided to frontline staff to safeguard their health. Proper disposal of waste generated by clinics is also an important clinical infection control. Please refer to the “Our Environment” section for further details.

Patient relationship management

To ensure high-quality medical services, it is important for us to understand our patients’ needs and concerns. The Group has various established communication platforms to engage with patients and provide them with enhanced convenient and quality services. Our mobile app UMP Service Point is the primary platform for communication, allowing users to access the latest information about doctor availability, types of healthcare services offered, and the location and operation hours of our medical centres.

Following our Complaints and Incident Reporting guidelines, all first-hand complaints about the clinics are to be directed to the respective clinic-in-charge. Feedback or suggestions can be submitted via the UMP hotline or website. Any complaints that relate to medical practice are handled by Clinic Chain Management Department and will be investigated thoroughly and impartially. During FY2023, the Group did not receive any complaints related to our services and products.

診所衛生及感染控制

為確保健康及舒適的診症環境，我們首要任務是要維持我們醫務中心的環境衛生。除了良好的通風及照明系統外，我們的診所配備特殊抽吸器，以減少空氣中的氣溶膠，而我們亦為各醫務中心採購充足庫存的個人防護裝備。為防止疾病於診所內傳播，我們實施患者分流及安置程序。我們對可重複使用的醫療設備進行嚴格消毒，並確保為所有患者及職員提供足夠的衛生及洗手設施，同時我們在診所內張貼了潔手告示及咳嗽禮儀海報，提醒大家留神注意。我們為診所職員提供診所感染控制培訓，以防範流行性疾病傳播及進一步減低傳染病的風險。我們亦為前線職員提供外科口罩及其他必要的防護裝備，以保障他們的健康。正確處理診所產生的廢棄物亦是臨床感染控制的重要一環。進一步詳情請參閱「我們的環境」一節。

患者關係管理

為確保高質素的醫療服務，了解患者的需要及關注是至關重要的。本集團已建立不同的溝通平台，以便與患者溝通以及為他們提供更方便及優質的服務。我們的「UMP服務點」流動應用程式是我們的主要溝通平台，讓用戶能夠獲取有關醫生應診時間、所提供醫療保健服務類型、以及醫療中心的位置及營業時間等的最新資訊。

根據我們的投訴及意外報告指引，所有與診所有關的一手直接投訴均直接提交予相關診所負責人處理。意見或建議可透過聯合醫務熱線或網站提出。任何與醫療有關的投訴均由醫務中心管理部處理，其會對此進行徹底及公正的調查。於2023財政年度，本集團並無收到任何與我們的服務及產品有關的投訴。

Safeguarding patient's rights and their privacy

The Group treats patients of all backgrounds equally and prohibits any discrimination in terms of age, race, sex, marital status, pregnancy, disability, or any other traits protected by anti-discrimination legislation.

To protect patients' rights, UMP is committed to maintaining a transparent and open relationship with patients throughout the entire healthcare process. The patients' medical status is kept confidential, and we respect patients' decisions to accept or refuse medication or treatment.

The Group complies with the Personal Data (Privacy) Ordinance ("PDPO") regarding the collection, retention, handling, disclosure, and use of personal data including medical history. To avoid unauthorised disclosure of confidential information, we maintain a data storage system to regularly monitor and evaluate the risk of improper use of information. Our Employee Handbook stipulates that staff may only access confidential information on a need-to-know basis and must follow our procedures when handling printed and electronic documents related to personal data. To strengthen the protection of confidential patient information, we provided trainings on personal data privacy this year to guide staff in upholding their responsibilities on privacy matters.

Quality of medical services and products

UMP is highly conscious of the responsibility to deliver quality services and products to achieve and maintain patients' health and well-being. We have implemented a service quality management approach in our day-to-day business operations. This approach strictly monitors operations from patient registration to clinical consultation procedures and efficiency management. This approach is also clearly outlined in our internal guidelines for staff, and we regularly review the relevant procedures to ensure they remain up to date.

維護患者權利及私隱

本集團平等對待不同背景的患者，嚴禁任何基於年齡、種族、性別、婚姻狀況、懷孕、殘疾或任何其他受反歧視條例保障的特徵而作出的歧視行為。

為保護患者權利，聯合醫務致力於在整個醫療過程中與患者保持透明及坦誠的關係。患者的醫療狀況會保密處理，而我們尊重患者接受或拒絕任何藥物或治療的決定。

本集團遵守個人資料(私隱)條例有關收集、保留、處理、披露及使用個人資料(包括病歷)等方面的規定。為避免保密資料被未經授權披露，我們已設有資料儲存系統，以定期監察及評估資料被不當使用的風險。我們的員工手冊訂明，只有「必須知情」的職員才可存取保密資料，並且於處理與個人資料有關的印刷及電子文件時必須遵循我們的程序。為加強保護患者的保密資料，我們於本年度提供有關個人資料私隱的培訓，以指導員工在私隱事宜上恪守責任。

醫療服務及產品質量

聯合醫務非常重視向患者提供優質服務及產品，以促進並維護他們的健康及福祉。我們在日常業務營運中實施了服務質量管理方針，嚴格監控從患者登記到臨床診症程序的運作及效率管理。此方針亦於我們的內部員工指引中清晰訂明，我們會定期檢討相關程序，確保與時並進。

We believed that digitalisation and innovation are crucial to ensuring and improving the quality of our services. In view of this, the Group has collaborated with a local university to develop an artificial intelligence (“AI”)-powered nurse named “WaiWai”. This mobile application uses medical big data to analyse and predict users’ health conditions, providing personalised care services tailored to different age groups and treatment strategies. In addition to WaiWai, UMP has established the UMP Healthcare Innov Centre, which serves as a platform for exchanging ideas among medical technology developers, medical professionals, and health-conscious individuals. This platform supports the development of MedTech and HealthTech in Hong Kong, promotes the use of advanced medical devices and treatment options, and supports the development of related technologies. By investing in digitalisation and innovation, we strive to bring new possibilities to medical services in Hong Kong and provide the best possible care to our patients.

Professional practitioners

The Group takes pride in providing safe and high-quality healthcare services through qualified practitioners. At UMP, all medical practitioners possess valid certifications and qualifications to provide relevant medical treatments and handle drug and pharmacy matters. Doctors, dentists, and certain auxiliary service providers are required to comply with applicable codes of professional conduct or discipline.

To ensure that all practitioners are competent in providing quality healthcare services, we have a process in place that involves more than one senior executive from UMP to identify qualified and suitable practitioners. The recruitment process begins with a review of the candidate’s background by a Director from the Human Resources Department, followed by a video or face-to-face meeting. Suitable candidates are then interviewed by the General Manager. The Co-Chief Executive Officers are also involved in the hiring decision-making process. Professional qualifications and certificates are collected and kept on record.

我們相信數碼化及創新對確保和提高我們的服務質量至關重要。有見及此，本集團與一間本地大學合作，攜手開發人工智能（「AI」）護理應用程式—AI小護理「為為」。此流動應用程式利用醫療大數據分析及預測用家的身體狀況，針對不同年齡層及治療策略，提供度身訂造的個人化護理服務。除了「為為」外，聯合醫務亦已成立「聯合醫務創科中心」，作為醫療技術開發人員、專業醫療團隊及關注健康的個人之間交流意見的平台。該平台支援香港醫療應用科技及智慧健康科技的發展，推廣先進醫療設備及治療方案的使用，並支持相關科技的發展。通過投資於數碼化及創新，我們致力為香港的醫療服務帶來新的可能，並盡可能為患者提供最好的護理。

專業的醫療從業人員

本集團透過合資格醫療從業人員提供醫療保健服務，並以其安全及優質服務為榮。在聯合醫務，所有醫療從業人員均必須具備有效的執業證書及資格，可提供相關醫療服務以及處理藥物及配藥事宜。醫生、牙醫及若干輔助服務提供者均須遵守適用的專業操守或紀律守則。

為確保所有醫療從業人員均有能力提供優質的醫療保健服務，我們已制定一套程序，其訂明由多於一名聯合醫務的高級管理人員參與物色合資格及合適的醫療從業人員。招聘過程首先從人力資源部總監審查應徵者背景開始，其次是進行視像或面對面會談。然後，合適人選將由總經理親自面試。聯席行政總裁亦會參與招聘的決策過程。過程中所收取的專業資格及證書副本將予保存，以作記錄。

At UMP, we make a concerted effort to ensure that our medical services meet industry standards. To achieve this, we provide our practitioners with the necessary resources to enhance their skills and knowledge. Our dedicated team conducts regular clinical visits to engage with our affiliated practitioners and ensure consistency in the quality of care provided. We periodically review our policies on practitioner selection, remuneration, and training with the senior management team to ensure that we deliver clinical care in accordance with industry standards and promote sustainable business operations.

Supply chain management

UMP procures medicines and medical equipment from qualified pharmaceutical companies and suppliers of medical consumables in compliance with applicable laws and regulations. Our Procurement Policy provides a framework for all procurement activities within the Group, and specific procedures are developed for different business units as needed.

The procurement and supplier management processes aim to support the long-term business development of UMP by continuously improving supplier performance and the relationship between suppliers and UMP. Performance ratings for suppliers are determined by assessing multiple criteria, including product quality, delivery time, brand reputation, and environmental and social factors. Suppliers with higher performance ratings, are engaged when procuring a particular good or service. The Group encourages feedback from suppliers to monitor procurement progress and identify areas for improvement. The preferred supplier list is reviewed annually to ensure supplier performance meets UMP's procurement standards.

In addition, UMP adopts a centralised procurement system to facilitate the ordering and distribution of medical supplies to individual UMP Medical Centres. Each centre is responsible for storing its own inventory of drugs and medical consumables. This system effectively controls the quality and costs of procurement, while also eliminating the risk of corruption and bribery.

在聯合醫務，我們齊心協力確保我們的醫療服務符合行業標準。為此，我們為旗下醫療從業人員提供必要資源，以提高他們的技能及知識。我們的專責團隊定期到訪診所與我們的聯屬醫療從業人員交流，確保所提供的護理服務質量保持穩定。我們定期與高級管理團隊一同檢討我們甄選、薪酬及培訓醫療從業人員方面的政策，以確保我們所提供的臨床護理符合行業標準，並促進可持續的業務營運。

供應鏈管理

聯合醫務按照適用法律及法規，向合資格製藥公司及醫療消耗品供應商採購藥物及醫療設備。我們的採購政策為本集團內所有採購活動提供框架，另外亦為不同業務單位按需提供具體程序。

採購程序及供應商管理程序旨在通過持續改善供應商表現以及供應商與聯合醫務之間的關係，支持聯合醫務的長遠業務發展。供應商的表現評分是通過評估多項標準釐定，評估標準包括產品質量、交付時間、品牌聲譽、以及環境及社會因素。表現評分較高的供應商會於採購某項貨品或服務時獲選用。本集團鼓勵供應商提供反饋，以監控採購進度並找出需要改進的地方。首選供應商名單每年均會進行檢討，以確保供應商表現符合聯合醫務的採購標準。

此外，聯合醫務採用中央採購系統，其有利訂購及分發醫療用品至個別的聯合醫務中心。各醫務中心負責其自身的藥物及醫療消耗品庫存。此制度可有效控制採購的質量及成本，同時亦可消除貪污及賄賂的風險。

BUSINESS ETHICS

The Group continues to maintain high ethical standards and works closely with employees to promote strong ethical values.

UMP has a zero-tolerance approach towards all forms of corruption and observes and upholds high standards of business integrity, honesty, fairness, impartiality, and transparency. Our Anti-corruption Policy sets out the minimum standard of conduct which applies to all directors, officers, and employees of the Group. Compliance with this policy is obligatory, and any violation thereof may result in disciplinary action, including potential employment termination and the imposition of civil or criminal sanctions. As part of our efforts to strengthen anti-corruption practices and promote employee awareness, we have invited Independent Commission Against Corruption to deliver annual anti-corruption training sessions to directors and all employees this year.

Our Employee Handbook contains guidelines setting out the Group's policies regarding gifts from suppliers and clients. To avoid conflicts of interest, employees are recommended to either return the gift with a written explanation, donate it to a charity through the Group, or keep the gift while donating an amount equal to the market value of the gift to charity. In certain circumstances, we request employees to report necessary instances to their supervisors and the Human Resources and Administration Department.

The Group encourages employees to report any suspected instances of unethical business behaviour. Our Whistleblowing Policy, which is a part of our internal risk management system, sets forth the procedures for reporting inappropriate behaviour or violations of UMP's Code of Ethics. The Group has established an email address to receive whistleblowing reports, providing a secure channel for employees to report any irregularities and improprieties to the Internal Audit Department. The utmost confidentiality is maintained, with the Group ensuring that the identity of whistleblowers will not be divulged without their explicit consent or the issuance of a court order. Employees can anonymously report any misbehaviour, dereliction of duty, or irregularities involving the Group, without fear of reprisal.

商業道德

本集團繼續保持高道德標準，並與僱員緊密合作，促進崇高的道德價值觀。

聯合醫務對一切形式的貪污採取零容忍態度，奉行並恪守高標準的商業廉潔、誠信、公平、公正及透明。我們必須遵守反貪污政策列明適用於本集團所有董事、管理人員及僱員的最低行為標準，任何違反政策的行為均可能導致紀律處分，包括可能終止僱傭關係以及民事或刑事制裁。為加強反貪污實踐及提高僱員意識，我們於本年度邀請廉政公署派員為董事及全體僱員主持年度反貪污培訓課程。

我們的員工手冊載有對本集團有關供應商及客戶贈禮的政策指引。為避免利益衝突，僱員應當退回禮物並以書面向贈禮方作出解釋，或透過本集團將禮物捐贈予慈善機構，或接受禮物但同時向慈善機構捐贈等同於禮物市價的金額。在若干情況下，我們會要求僱員向其主管及人力資源及行政部報告必要的細節。

本集團鼓勵僱員舉報任何可疑的不道德商業行為。我們的舉報政策屬於我們內部風險管理系統的一部分，當中訂有舉報不當行為或違反聯合醫務道德守則的程序。本集團已設立接收舉報的電郵地址，為僱員提供安全的渠道以向內部審計部舉報任何不合規及不正當行為。本集團會確保在未經舉報人明確同意或法院並無發出命令的情況下，不會洩露舉報人的身份，保證有關資料絕對保密。僱員可匿名舉報任何涉及本集團的不當行為、怠忽職守或違規行為，而毋須害怕遭到報復。

UMP also thinks highly of the intellectual property rights of the company and respect third party intellectual property rights. Over the years, the Group had registered a myriad of trademarks for its services offered in Hong Kong and Mainland China, covering diverse domains such as family doctor services, payment application, internal training courses and branches of different professional centre. The Group maintains a Trademark Register which keep records of the registration number, mark image, class number, owner's name and expiry date. The Group will take legal action and consult with legal experts if there are any violations of the intellectual property rights that the company owns. We will continue to strengthen intellectual property application and protection.

During FY2023, there have been no legal cases regarding corruption, bribery, extortion, fraud or non-compliance with intellectual property laws brought against the Group or our employees.

OUR EMPLOYEE Employee benefits and welfare

We recognise the valuable contribution made by our employees to the success of the business. To ensure compliance with relevant laws and regulations, such as the Employment Ordinance, the Sex Discrimination Ordinance, the Disability Discrimination Ordinance of the Laws of Hong Kong, the Labour Law of the PRC, and the Labour Contract Law of the PRC, the Group has implemented various human resources management policies and procedures. Our Employee Handbook outlines detailed rules and guidelines for employee conduct, as well as the rights and responsibilities of staff in the workplace.

We strive to create an inclusive and positive work culture that promotes the well-being of our staff. Employees from all departments and levels are encouraged to express their views on improving work efficiency and internal communication to achieve better quality and productivity.

聯合醫務亦高度重視本公司的知識產權，並尊重第三方知識產權。多年來，本集團就其於香港及中國內地提供的服務已註冊多項商標，其涵蓋廣泛領域，包括家庭醫生服務、支付應用、內部培訓課程及不同的專業醫務中心分店等。本集團備存一份商標登記冊，當中記錄登記號碼、標記圖像、類別號碼、擁有人姓名及有效期。倘發現任何侵犯本公司知識產權的行為，本集團將採取法律行動並諮詢法律專家。我們將繼續加強知識產權的應用及保護。

於2023財政年度，並無針對本集團或旗下僱員提起的貪污、賄賂、勒索、欺詐或不遵守知識產權法律的法律案件。

我們的僱員 僱員待遇及福利

我們肯定僱員為企業成功所作的寶貴貢獻。為確保遵守香港《僱傭條例》、《性別歧視條例》、《殘疾歧視條例》以及中國《中華人民共和國勞動法》、《中華人民共和國勞動合同法》等相關法律及法規，本集團已實行各種人力資源管理政策及程序。我們的員工手冊闡述了有關僱員操守的詳細規則及指引，以及員工在工作場所的權利及責任。

我們矢志營造包容及積極的工作文化，以促進員工的福祉。我們歡迎各部門、各層級的僱員就如何提升工作效率及內部溝通發表意見，以提高質量及生產力。

To incentivise and motivate employees to support UMP's goals, the Group offers competitive remuneration and merit bonuses, including share options and share awards schemes. Staff benefits include comprehensive medical insurance, employment compensation insurance, directors' and officers' liability insurance and mandatory provident fund for employees. Employees are also entitled to annual leave, maternity leave, paternity leave, marriage leave and examination leave. To encourage work-life balance and ensure well-being among employees, the Group has clear policies outlining overtime working arrangements. We are devoted to creating career development opportunities and fostering unified spirit amongst employees across the Group.

Labour Standards

UMP is dedicated to conducting all of its business affairs in accordance with the highest standards and regulations of ethical business conduct. As per the Employment Ordinance (Cap. 57 of the Laws of Hong Kong) and the International Labour Organisation Conventions, the Group strictly adheres to the principles of respecting basic human rights and eradicating any and all forms of child or forced labour practices. We oblige our suppliers to uphold and apply the same stringent standards in their operations.

To prevent incidents of such infringements, the Group implements multiple measures, including thorough identity verification checks on potential candidates, unambiguous employment contracts, and avoiding hiring candidates with fake qualifications and under legal working age. If any instances of child or forced labour are discovered, the Group immediately terminates the contract. The management regularly reviews the effectiveness of its labour standards management approach.

During FY2023, the Group was not found with nor involved in any non-compliance in employment and labour or employment of any child labour or forced labour.

為激勵僱員支持聯合醫務的目標，本集團提供具競爭力的薪酬及績效花紅，包括購股權及股份獎勵計劃。員工福利包括綜合醫療保險、僱員補償保險、董事及行政人員責任保險及為僱員而設的強制性公積金。僱員亦享有年假、產假、侍產假、婚姻假及考試假。為鼓勵工作與生活平衡並確保僱員身心健康，本集團已明確制定關於加班工作安排的 policy。我們竭力為僱員創造事業發展機會，並培養集團上下團結一心的精神。

勞工準則

聯合醫務致力在其所有業務經營的過程中遵循道德商業行為的最高標準及法規。在遵照《僱傭條例》(香港法例第57章)及《國際勞工組織公約》下，本集團嚴格堅持尊重基本人權以及消除任何及一切形式的童工或強制勞工的原則。我們要求我們的供應商在其營運中秉承並應用同樣嚴格的標準。

為防止有關侵犯權利的事件發生，本集團採取多項措施，包括對潛在求職者進行徹底的身份驗證檢查、訂立清晰的僱傭合約、以及避免聘用虛假資歷及低於法定工作年齡的求職者。倘發現任何童工或強制勞工的情況，本集團會立即終止合約。管理層會定期檢討其勞工準則管理方針的成效。

於2023財政年度，本集團並無發現或涉及任何不遵守僱傭及勞工規定或任何僱用童工或強制勞工的行為。

Development and training

With the principle of maximising the utility of our employee's capability, UMP is committed to supporting the career development of the Group's employees. We provide professional support to ensure employees can manage and perform their duties effectively. To ensure the well-being of our employees and patients, the clinic's management team has established a set of guidelines for clinic staff to follow to prevent and mitigate the spread of infectious diseases.

All new employees are required to attend an orientation where they will receive a thorough introduction to the Group and its operations. UMP also provides educational sponsorship and examination leave for clinic staff to pursue additional external training related to their duties, including injection techniques, blood sample collection, medication dispensing and other job-related skills and knowledge. All employees can receive up to HKD3,000 per year for external work-related training, with 80% of the course fee being subsidised. The sponsorship program aims to enhance the personal and professional development of our medical and clinical support staff. With above measures implemented, UMP is on track to reduce the risk of infection transmission within the clinic, provide a safe and comfortable environment for patients and staff and enhance the clinic's reputation for safety and quality care.

Other than clinic-related matter, employees are required to be familiarised with protocols for maintaining a clean, orderly, and safe work area that is hazard-free, performing work in a safe manner so as not to jeopardise oneself or others in the work area, using protective equipment and safe materials and being able to identify and become familiar with the Emergency Plan, Evacuation Procedures, Procedures for Life Safety Threats, and other general safety issues in the event of an emergency to ensure safety and minimise loss.

Furthermore, UMP encourages employees to expand their work contacts within the Group and to take advantage of career development opportunities. Employees will have the chance to pursue development in other parts of the Group, and the policy also allows us to maximise the company's utility by transferring capable employees to the most suitable service areas.

發展及培訓

以發揮僱員的最大能力為原則，聯合醫務致力支援本集團僱員的事業發展。我們提供專業支援，以確保僱員能夠有效管理及履行職責。為確保僱員及患者身心健康，診所的管理團隊已制定一套指引供診所職員依循，以預防並減輕傳染病的傳播。

所有新入職僱員均須參加迎新培訓，並將透過培訓獲得對本集團及其營運的詳細認識。聯合醫務亦為診所職員提供教育贊助及考試假，讓他們能夠參與與其職務有關的額外外部培訓，培訓內容包括注射技巧、血樣採集、配藥及其他工作相關技能及知識。所有僱員每年最多可獲3,000港元的工作相關外部培訓贊助，當中有80%的課程費用獲得資助。此贊助計劃旨在加強我們的醫療及臨床輔助職員的個人及專業發展。通過推行上述措施，聯合醫務正著力降低診所內的感染傳播風險，為患者及員工提供安全及舒適的環境，並提升診所在安全及優質護理方面的聲譽。

除診所相關事宜外，僱員亦必須熟悉以下程序：保持工作範圍整潔、有序、安全及無害；在安全的情況下工作，以免危及自身或工作範圍內的其他人；使用防護裝備及安全物料；並能夠分辨並熟習緊急應變計劃、疏散程序、應對生命安全威脅的程序、以及其他在緊急情況下的一般安全問題，以確保安全並盡量減少損失。

另外，聯合醫務鼓勵僱員在本集團內擴大工作聯繫網絡，並把握職業發展機會。僱員將有機會到本集團其他部門發展，而我們亦能藉此政策將有能力的僱員調往最合適的服務領域，從而實現公司效用最大化。

Health and safety at workplace

The health and safety of employees are of the utmost priority at UMP. Health and safety policies and practices are integrated into our business operations and activities to minimise safety risks.

Infection control is a priority in every clinic. The clinic has been equipped with personal protection and preventive equipment, including hand-washing facilities, adequate masks, and sharps disposal containers. All clinic staff have been educated on health and safety procedures and are encouraged to proactively raise awareness of infection control and report potential risks to the person in charge for the clinic.

We require all employees to be aware of unsafe medical procedures. Special medical equipment such as irradiation apparatus can only be operated by certified staff. Clinic staff are regularly trained in proper use of medical equipment to keep up with the changes. All employees are also required to follow the general office safety and workplace rules.

During FY2023, the Group strictly complied with all relevant laws and regulations on occupational health and safety, including but not limited to the Occupational Safety and Health Ordinance and the laws of the PRC on prevention and control of occupational diseases.

OUR COMMUNITY

Our mission is to offer trusted and affordable services to individuals from all walks of life. We aim to go beyond providing our patients with healthcare services but also promote public health within the communities we serve. We hold ourselves to the highest standards of quality and strive to make a positive impact on the overall well-being of those we cater to.

Access to healthcare is a fundamental component of a healthy society that promotes health equity. It ensures that everyone has equal opportunities to receive proper medical care, regardless of their socioeconomic status, race, or gender. By improving accessibility to healthcare, we can also achieve significant cost savings for both individuals and society as a whole.

工作場所的健康與安全

僱員的健康與安全是聯合醫務的重中之重。我們將健康及安全政策及實踐融入我們的業務營運及活動中，以盡量減低安全風險。

感染控制是每間診所的重點工作。診所已配備個人防護及預防裝備，包括洗手設施、足夠的口罩及利器處置容器。所有診所職員均已學習了健康及安全步驟，我們同時亦鼓勵他們主動提高有關控制感染的意識，並向診所負責人報告潛在風險。

我們要求所有僱員注意醫療程序安全。輻射儀器等特殊醫療設備僅可由經認證的員工操作。診所職員定期接受正確使用醫療設備的培訓，以跟上科技變化。全體僱員亦須遵守一般辦公室安全及工作場所規則。

於2023財政年度，本集團嚴格遵守所有有關職業健康與安全的法律及法規，包括但不限於《職業安全及健康條例》及中國的職業病防治法律。

我們的社區

我們的使命是為各個社會階層的个人提供值得信賴及可負擔的服務。我們的目標不僅是為患者提供醫療保健服務，還要促進我們所服務社區的公共衛生。我們堅持最高的質量標準，並努力為我們所服務對象的整體福祉帶來正面影響。

在一個健康社會裡，人人享有醫療保健是促進健康公平的基本要素。健康公平是確保任何人均有平等機會獲得適當的醫療護理，無論其社會經濟地位、種族或性別如何。通過改善醫療保健的可及性，我們亦能夠為個人及整個社會節省大量成本。

To improve accessibility to healthcare, UMP has established a virtual care platform that enables patients to have video consultations with a doctor and receive necessary prescriptions without leaving their homes, which helps to effectively respond and solve many common illness and chronic conditions. In FY2023, we provided free telemedicine services for COVID-19 patients. The program involves the participation of 16 doctors and 50 supporting staff and has benefited 1,627 individuals from the convenience of remote healthcare consultations. Moreover, to improve health literacy among the general public, we have initiated a health literacy campaign, which includes publishing health leaflets and educational videos to raise public awareness of common illnesses and promote mental health. Recognising the importance of educating younger generations, we have collaborated with local schools to organise health talks and work tasting programs, fostering a culture of proactive health awareness and building a healthier future generation.

UMP recognises that individuals who are marginalised or disadvantaged may face additional difficulties in accessing to healthcare. The Group aims to address the barriers of financial concerns and promoting accessibility to healthcare for elderlies by promoting the Government Health Scheme. We are also part of the Colorectal Cancer (“CRC”) Screening Programme, which is subsidised by the government and has now been fully implemented and extended to asymptomatic Hong Kong residents aged between 50 and 75. By participating in the programme, we are helping to promote early detection and treatment of colorectal cancer, which can ultimately save lives and reduce medical expenses in our society.

We also actively participate in charitable events organised by non-governmental organisations (“NGOs”). During FY2023, the Group donated a total of HK\$79,000 to various charitable or NGOs. In the future, UMP will continue encouraging employees to care for the community and contribute to society by organising and participating in volunteer activities, and actively building a sustainable society while pursuing business development.

為改善醫療保健的可及性，聯合醫務已建立虛擬護理平台，讓患者足不出戶便可與醫生進行視像問診並獲配必要處方，有助有效應對及解決許多常見疾病及慢性病。於2023財政年度，我們為新型冠狀病毒肺炎患者提供免費視像診症服務。此計劃有16名醫生及50名輔助人員參與，並已惠及1,627名個人，使他們得以享受遙距醫療諮詢的便利。此外，為提高公眾的健康素養，我們已展開一項健康素養活動，內容包括發佈健康宣傳單張及教育影片，以提升公眾對常見疾病的認識及促進心理健康。我們認識到教育年輕一代的重要性，因此與本地學校合作舉辦健康講座及職場體驗計劃，培養積極主動的健康意識文化，打造更健康的下一代。

聯合醫務深知，一些邊緣或弱勢群體在享有醫療保健方面可能會面對更大困難。通過推廣政府醫療計劃，本集團冀解決財務障礙的問題並將醫療保健推廣至更多長者。我們亦參與了由政府資助的「大腸癌篩查計劃」，有關計劃現已恆常化，並已擴展至50至75歲沒有症狀的香港居民。通過參與該計劃，我們正為促進及早發現及治療大腸癌出一分力，最終能夠拯救生命並減少社會的醫療開支。

我們亦積極參與由非政府組織（「非政府組織」）舉辦的慈善活動。於2023財政年度，本集團向多個慈善團體或非政府組織合共捐贈7.9萬港元。未來，聯合醫務將繼續鼓勵僱員通過組織及參與志願活動以關愛社區和回饋社會，在追求業務發展的同時，積極構建可持續發展的社會。

OUR ENVIRONMENT

The Group recognises that we have a responsibility to minimise our impact on the environment and to promote sustainable practices both within our organisation and throughout our industry, as outlined in our CSR policy. While our top priority is providing high quality and reliable medical services, we strictly comply with applicable environmental laws and standards. Our environmental efforts include actively reducing our impact on the environment through energy conservation, waste reduction and recycling, as well as raising employees' awareness of environmental issues and promoting employees' contribution to improving our environmental performance.

Waste management

UMP recognises the importance of safe and effective waste management, as well as to follow established local protocols and guidelines to minimise the risk of accidents or exposure to hazardous materials. In terms of disposing of clinical waste, the Group strictly abide by environmental policies and regulations including the Code of Practice on Clinical Waste Management in Hong Kong and the Clinical Waste Management Ordinance in the PRC. UMP is experienced in handling clinical waste in a safe, legal, and professional manner to avoid potential risks to the environment and human health caused by improper disposal.

Prior to collection, clinical waste is segregated and placed in appropriately labelled garbage bins and bags, while chemical waste is categorised and disposed of in labelled containers that specifically designed to be leakproof and puncture resistant. The Code for the Disposal of Medical Waste specifies the categories of medical waste, including syringes, contaminated pads, cotton balls, human tissue samples from examinations, dental amalgam, and expired medicines, and provides staff with specific procedures to properly manage and dispose of medical waste. Records of Medical Waste should be sealed, labelled, and stored in designated locations in our medical centres for collection by licensed waste collector for further processing. We keep detailed medical waste records with tracking information, such as delivery date and address, quantity, and name of licensed collector. All clinic staff are required to receive training to ensure proper implementation of these procedures. We regularly monitor the disposal of both clinical and chemical waste to ensure that they are handled correctly and safely.

我們的環境

本集團意識到，誠如我們的企業社會責任政策所闡述，我們有責任盡量減少對環境的影響，並在內部及整個行業推廣可持續發展的實踐。雖然我們的首要工作是提供優質可靠的醫療服務，但同時我們亦嚴格遵守適用的環境法律及標準。我們的環保工作包括通過節能、減廢及循環再用，積極降低我們對環境的影響，以及提高僱員對環境問題的意識，推動僱員為改善我們的環境表現作出貢獻。

廢棄物管理

聯合醫務深明實施安全有效的廢棄物管理以及遵循本地程序及指引，對盡量減少事故發生或有害物質暴露的風險相當重要。在處置醫療廢棄物方面，本集團嚴格遵守各項環境政策及法規，包括香港《醫療廢物管理工作守則》及中國《醫療廢物管理條例》。聯合醫務在以安全、合法及專業的方式處理醫療廢棄物方面擁有豐富經驗，避免因處置不當而對環境及人類健康造成潛在風險。

在收集之前，醫療廢棄物會被分類並放置於貼有適當標籤的垃圾箱及袋子中，化學廢棄物則會在分類後放置於經過專門設計、並具有防漏及防刺穿功能的標籤容器中。《處理醫療廢棄物守則》訂明各項醫療廢棄物的類別，包括注射器、受污染的墊片、棉球、檢驗產生的人體組織樣本、牙用銀汞合金及過期藥物，並為員工提供正確管理及處置醫療廢棄物的具體程序。醫療廢棄物紀錄應予密封、貼上標籤、並存放於我們醫務中心的指定地點，以便持牌廢棄物收集商收集作進一步處理。我們備存詳細的醫療廢棄物紀錄，並標記追蹤資料，如交付日期及地址、數量、及持牌收集商的名稱等。所有診所職員均須接受培訓，以確保有關程序獲妥善執行。我們定期監察醫療廢棄物及化學廢棄物的處置，以確保其得到正確及安全處理。

Non-hazardous waste of the Group is composed of general waste and office paper waste. To reduce the amount of non-hazardous waste, the Group has adopted the following measures:

- Educate our staff to reduce unnecessary material consumption and disposal;
- Employ electronic system for administrative purposes to minimise paper usage; and
- Disseminate internal communications through emails and electronic messages instead of printed materials.

Resource management

Ensuring medication safety and quality requires appropriate packaging that includes individual packaging and clear labelling with relevant information for identification purposes. At UMP, we employ various types of packaging to meet these requirements. Medicinal bottles, pill pouches, ointment jars, ointment bottles, dropper bottles, and plastic bags are used for packaging medicines, pills, and topical ointments. Likewise, report folders and bags are utilised for our imaging services, while specimen containers serve our laboratory services. Recognising the importance of environmental preservation and reducing plastic waste, we are actively exploring the implementation of a USB burning system as a substitute for wet film, which has the potential to result a substantial reduction in X-ray bag consumption.

本集團的無害廢棄物包括一般廢棄物及廢棄辦公用紙。為減少無害廢棄物的產生量，本集團已採取以下措施：

- 教育我們的僱員減少不必要的材料消耗及處置；
- 採用電子行政管理系統，以盡量減少紙張使用；及
- 透過電子郵件及電子訊息發佈內部通訊，而非印刷本。

資源管理

藥物需要適當的包裝，才能確保安全及質量；其應獨立包裝並附有清晰可見的標籤，標籤上應印有相關識別信息。在聯合醫務，我們使用各式各樣的包裝來滿足此等要求。藥物、丸劑及外用藥膏所用的包裝包括藥物瓶、藥丸袋、藥膏罐、藥膏瓶、滴管瓶及塑膠袋。同樣，我們的影像服務使用報告文件夾及文件袋，我們的化驗服務則使用標本容器。我們明白保護環境及減少塑膠廢棄物的重要性，並正積極探討採用USB燒錄系統來取代X光顯影片，這有可能大幅減少X光袋的消耗。

A significant portion of UMP's energy consumption is attributed to the general lighting and the use of medical equipment, such as high-temperature disinfection and X-ray imaging apparatus. To reduce our energy consumption, we are continuously exploring energy-saving measures in our daily operations, such as installing LED lighting systems in some medical centres and prioritising energy efficiency medical equipment to improve energy efficiency. In order to optimise the management of energy consumption, we have launched a Smart Energy Monitoring Solution at our ProCare Integrated Medical Imaging and Laboratory Centre (Tsim Sha Tsui) this year which enables real-time monitoring of energy usage and provides intricate analysis of energy consumption patterns. By leveraging this technology, we can identify areas of superfluous energy usage and implement targeted strategies to enhance energy efficiency.

Furthermore, the Group is actively promoting centralised information management and digitising operations by utilising IT systems to reduce paper consumption. Clinical management and administrative work, including the Group's E-Claims system, have been digitised to further minimise our paper consumption.

While climate change is not considered material for UMP's operation, it is recognised as a significant global environmental issue that poses health and safety risks to individuals and communities. For instance, air pollution increases the risk of respiratory infections, heart disease and lung cancer, and higher temperatures and humidity can lead to the proliferation of disease-carrying mosquitoes, which can cause illnesses such as malaria and dengue fever. In addition to the health impacts, climate change can also lead to an increase in the frequency and severity of extreme weather events. Appropriate measures have been implemented to train staff members and ensure that the operations can respond quickly during extreme weather events. The Employee Handbook outlines clear guidelines and rules in response to Typhoon Signal No. 8 or above or Black Rainstorm Warning, and medical centres facing greater risks from extreme weather events are identified and managed through risk management strategies.

As a responsible healthcare service provider, the Group is taking steps to reduce our greenhouse gas emissions and adopting measures to prepare our operations to respond to climate-related risks. In doing so, we aim to reduce the environmental impacts of our operations and protect the health and well-being of our patients and the wider community.

聯合醫務的很大部分能源消耗歸因於一般照明及醫療設備的使用，例如高溫消毒及X光影像儀。為減少能源消耗，我們在日常營運中不斷探索節能措施，例如在部分醫務中心安裝LED照明系統以及優先選用具能源效益的醫療設備，以提高能源效率。為了優化能源消耗的管理，我們於本年度在普康綜合醫學影像及化驗中心(尖沙咀)實施智能能源監控解決方案，實時監控能源的使用情況，並提供精細的能源消耗模式分析。利用此項技術，我們能夠確定能源使用過剩的區域，並實施針對性策略以提高能源效率。

另外，本集團正積極推行中央資料管理，利用IT系統進行數碼化營運，以減少紙張消耗。臨床管理及行政工作(包括本集團的「康橋」電子理賠系統)現已實現數碼化，以進一步減少紙張消耗。

雖然氣候變化對聯合醫務的業務而言並不屬於重要事項，但其被視為一項對個人以至社區構成健康及安全風險的重大全球環境問題。舉例而言，空氣污染會增加呼吸道感染、心臟病及肺癌的風險；而氣溫及濕度升高會導致攜帶疾病的蚊子滋生，從而造成瘧疾及登革熱等疾病感染。除對健康造成影響外，氣候變化亦可能導致極端天氣事件的頻率及嚴重程度增加。我們已採取適當措施，以訓練員工應對極端天氣事件，確保各業務部門能夠於極端天氣事件發生時作出迅速應對。員工手冊概述了有關八號或以上颱風信號或黑色暴雨警告信號的明確指引及規則，而我們已透過風險管理策略對受極端天氣事件威脅的風險較大的醫務中心進行識別及管理。

作為負責任的醫療保健服務提供者，本集團正採取措施減少溫室氣體排放，並採取措施使我們的營運做好應對氣候相關風險的準備。在此過程中，我們的目標是減少我們的營運對環境的影響，並保護患者以至廣泛社區的健康及福祉。

The Directors are pleased to present their report together with the audited consolidated financial statements for FY2023.

PRINCIPAL ACTIVITIES

The principal activity of the Company is investment holding. Details of the principal activities of its principal subsidiaries are set out in note 1 to the consolidated financial statements.

BUSINESS REVIEW AND OUTLOOK

A review of the business of the Group during the year and a discussion on the Group's future business development are set out in "Chairman's Statement" on pages 8 to 10 of this annual report, in "Co-CEOs' Report" on pages 11 to 13 of this annual report and in "Management Discussion and Analysis" on pages 14 to 33 of this annual report, which forms part of this report of Directors. The financial risk management objectives and policies of the Group are set out in note 46 to the consolidated financial statements. Besides, the potential risks and uncertainties faced by the Group, key relationship between the Group and its employees, customers and suppliers, the environmental policies of the Group and compliance with the relevant laws and regulations which have significant impact are set out below.

KEY RISKS AND UNCERTAINTIES

The Groups' results and operations are subject to various factors with the key risks summarised below:

Strategy Risk

The current macroeconomic uncertainty and sluggish economy may cause episodic disruptions to the medical industry. Our Company must effectively and efficiently allocate resources in order to minimize the risk brought on by the uncertain economic environment. We must also continue to find new strategic angles to improve our operations and business. The sluggish economy may continue to impact global business in the near future. The Group must be prepared to continue being agile in our operations and ready to switch gears to curb any unexpected operational headwinds that might cause significant interruptions to our business. As consumer discretionary spending decreases, we need to be thoughtful about pricing and promotional strategies. At the same time, we should look for opportunities to diversify our revenue streams and create new partnerships to weather the economic downturn.

業務回顧及展望

本集團於本年度內的業務回顧及有關本集團未來業務發展的討論載於本年報第8至10頁的「主席報告」、本年報第11至13頁的「聯席行政總裁報告」及本年報第14至33頁的「管理層討論及分析」(其構成本董事會報告一部分)。本集團的財務風險管理目標及政策載於綜合財務報表附註46。此外，本集團所面臨的潛在風險及不明朗因素、本集團與僱員、客戶及供應商的主要關係、本集團的環境政策及遵守帶來重大影響的相關法律法規的情況載列於下文。

主要風險及不明朗因素

本集團的業績及營運受多種因素影響，主要風險概述如下：

策略風險

當前宏觀經濟的不確定性以及經濟低迷均可能對醫療行業造成偶發干擾。本公司必須切實且有效地分配資源，將經濟環境的不確定性所帶來的風險降至最低。我們亦必須繼續尋找新的戰略角度，以改善我們的營運及業務。經濟低迷於未來可能會持續影響全球業務一段短時間。本集團必須做好準備，繼續保持靈活經營，並隨時做好轉向準備，以應對任何無法預料，且可能會對我們業務造成重大影響的經營阻力。隨著消費者的可自由支配支出減少，我們在定價及推銷策略上需要深思熟慮。同時，我們應該尋找機會擴闊我們的收入來源，並建立新的合作夥伴關係，以抵禦經濟衰退。

Reputation Risk

The Group's success in Hong Kong depends significantly on the recognition of its brand and reputation as a leading corporate healthcare solutions provider. However, Doctors, Dentists and Auxiliary Services Providers working in the Group may from time to time be subject to complaints, allegations or legal actions regarding the adequacy of patient care, treatment outcome and medical services provided, which may harm the business, results of operations, financial condition, brand and reputation of the Group.

Compliance Risk

The Group's business operations, Doctors, Dentists and Auxiliary Services Providers in the Group's network working in Hong Kong, Macau and Mainland China are subject to extensive laws, regulations and licensing requirements, any failure to comply with such laws, regulations or licensing requirement could harm the Group's business, results of operations, financial condition, brand and reputation.

KEY RELATIONSHIPS BETWEEN THE GROUP AND ITS EMPLOYEES, CUSTOMERS AND SUPPLIERS

The Group fully understands that employees, customers and suppliers are the key to our sustainable and stable development. We are committed to establishing a close relationship with our employees, enhancing cooperation with our suppliers and providing high-quality services to our customers so as to ensure the Group's sustainable development.

ENVIRONMENTAL POLICIES

As a responsible corporation, the Group recognises the importance of good environmental stewardship. In this connection, the Group strictly adopted and implemented policies and procedures to ensure environmental protection. To the best knowledge of the Directors, the Group has complied with all the relevant laws and regulations that have a significant impact on the Group in relation to its business including health and safety, workplace conditions, employment and the environment. During FY2023, no environmental claims, lawsuits, penalties or administrative sanctions were reported to our management.

合規風險

本集團的業務經營、本集團網絡內在香港、澳門及中國內地工作的醫生、牙醫及輔助服務提供者須遵守大量法律、法規及發牌規定。若未能遵守該等法律、法規及發牌規定，可能損害本集團的業務、經營業績、財務狀況、品牌及聲譽。

本集團與僱員、客戶及供應商的主要關係

本集團充分意識到僱員、客戶和供應商是我們持續穩定發展的關鍵。我們致力與員工建立密切關係，加強與供應商合作，為客戶提供高品質的服務，從而確保本集團可持續發展。

環境政策

作為負責任企業，本集團認同良好的環境管理工作的重要性。就此，本集團嚴格採取及實施政策及程序以確保環境受到保護。就董事所深知，本集團已遵守對本集團業務方面（包括健康及安全、工作環境狀況、僱傭及環境）有重大影響的所有相關法律及法規。於2023財政年度，我們的管理層概無收到有關環保申索、訴訟、懲罰或行政處罰的匯報。

Our establishments and operations accordingly shall comply with relevant laws and regulations in the Cayman Islands, Hong Kong, Macau and Mainland China. During FY2023, our businesses were in compliance with all the relevant laws and regulations in Cayman Islands, Hong Kong, Macau and Mainland China in all material aspects.

RESULTS AND DIVIDENDS

The profit of the Group for FY2023 and the Group's financial position as at 30 June 2023 are set out in the consolidated financial statements on pages 156 to 159 of this annual report.

The Board proposed the payment of a final dividend of HK3.00 cents per Share for FY2023 (FY2022: HK3.00 cents with scrip option), subject to the approval of the Shareholders at the 2023 AGM. Such proposed dividend is expected to be distributed on Friday, 5 January 2024 to the Shareholders whose names appear on the register of members of the Company on Friday, 8 December 2023.

Together with the interim dividend of HK1.7 cent per Share paid in April 2023, the total distribution of dividend by the Company for FY2023 will be HK4.7 cents per Share (FY2022: HK4.50 cents per Share).

DIVIDENDS POLICY

The Board has approved and adopted a dividend policy (the "Dividend Policy"). The Company is endeavor to maintain sufficient operating capital to develop and operate the Group's business, and to provide stable and sustainable returns to the Shareholders.

RE-ELECTION OF DIRECTORS

Pursuant to the Articles of Association, any Director appointed by the Board to fill a casual vacancy shall hold office until the first general meeting of the Company after his appointment and be subject to re-election at such meeting and any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following annual general meeting of the Company and shall then be eligible for re-election. At each annual general meeting, one-third of the Directors for the time being (or, if their number is not a multiple of three (3), the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at an annual general meeting at least once every three years. The details of Directors (as required by the Listing Rules) who will retire and being eligible, offer themselves for re-election at the AGM, will be provided in the accompanying circular. The re-election of each Director will be subject to vote of shareholders of the Company by separate resolutions.

Dr. Li Kwok Tung, Donald, Mr. Lee Luen Wai, John, Mr. Yeung Wing Sun, Mike and Mr. Chau, Chit Jeremy shall retire at the Annual General Meeting. Among them, Dr. Li Kwok Tung, Donald, Mr. Lee Luen Wai, John, being eligible, offer themselves for re-election at the AGM while Mr. Yeung Wing Sun, Mike and Mr. Chau, Chit Jeremy will not seek for re-election at the AGM as Mr. Yeung Wing Sun, Mike wishes to devote more time for his personal commitments and Mr. Chau, Chit Jeremy would want to focus on his other work arrangement and both will retire as an Independent Non-executive Director after the conclusion of the AGM.

Pursuant to code provision B.2.3 of the Corporate Governance Code, if an independent non-executive director has served more than nine years, such director's further appointment should be subject to a separate resolution to be approved by shareholders. Both Dr. Li Kwok Tung, Donald and Mr. Lee Luen Wai, John have served as an Independent Non-executive Director since November 2015. Current term of appointment of each of Dr. Li Kwok Tung, Donald and Mr. Lee Luen Wai, John will expire on 5 November 2023 which is automatically renewable for successive terms of one year. If Dr. Li Kwok Tung, Donald and Mr. Lee Luen Wai, John are re-elected at the AGM and their letters of appointment are renewed upon expiry of their current term and for any successive term, they will have served on the Board as Independent Non-executive Directors for more than nine years by 6 November 2024.

Dr. Li Kwok Tung, Donald and Mr. Lee Luen Wai, John both have in-depth understanding of the Company's operations and business, and have expressed objective views and given independent guidance to the Company over the years, demonstrate a firm commitment to their role.

The Board considers that the long service of Dr. Li Kwok Tung, Donald and Mr. Lee Luen Wai, John would not affect their exercise of independent judgment and is satisfied that they have the required character, integrity and experience to continue fulfilling the role of an Independent Non-executive Director. The Board believes that they will continue to contribute effectively to the Board. Accordingly, the Board has proposed that each of the above retiring Directors, namely Dr. Li Kwok Tung, Donald and Mr. Lee Luen Wai, John stands for re-election as Director and separate resolutions for their continuous appointment will be proposed at the AGM.

Each Director has disclosed to the Company the names and the titles and nature of office held in the public companies or organisations prior to the acceptance of the appointment and promised to inform the Company timely of any relevant change. The Company will also require Directors to submit written confirmation twice a year, and update their biographical details, if any.

(c) Total number of securities available for issue

The total number of Shares which may be issued upon exercise of all options to be granted under the Post-IPO Share Option Scheme and any other share option schemes (including but not limited to the Pre-IPO Share Option Scheme) of the Company must not in aggregate exceed 10% of the total number of Shares in issue as at the Listing Date.

(d) Maximum entitlement of each participant

An offer of options not accepted within this period shall lapse.

An amount of HK\$1.00 is payable upon acceptance of the grant of an option and such payment shall not be refundable and shall not be deemed to be a part payment of the exercise price.

On 13 November 2015, the Company and Dr. Lee Pak Cheung, Patrick entered into a consultancy agreement, and on 6 September 2018, the Company and Dr. Lee Pak Cheung, Patrick further entered into a first consultancy renewal agreement (the "First Consultancy Renewal Agreement with Dr. Lee Pak Cheung, Patrick"), pursuant to which the Group appointed Dr. Lee Pak Cheung, Patrick, as a consultant to provide Medical Services, in particular Dental Services, to the Group. During FY2021, the Group agreed to continue engaging Dr. Lee Pak Cheung, Patrick as a consultant after the expiry of the First Consultancy Renewal Agreement with Dr. Lee Pak Cheung, Patrick. On 23 September 2021, the Company entered into a second consultancy renewal agreement with Dr. Lee Pak Cheung, Patrick (the "Consultancy Agreement with Dr. Lee Pak Cheung, Patrick") for a term up to 30 June 2024. The major terms of the agreement are set out as follows:

- Dr. Lee Pak Cheung, Patrick shall provide Dental Services to the Group;
- the annual fees charged by Dr. Lee Pak Cheung, Patrick to the Group shall be negotiated on an arm's length basis, and shall be on normal commercial terms which, from the Group's perspective, are expected to be no less favourable than those which the relevant members of the Group could obtain from independent consultants of similar expertise, experience and reputation for similar role, scope of services and responsibilities; and

The transactions contemplated under the Consultancy Agreement with Dr. Lee Pak Cheung, Patrick constitute continuing connected transactions of the Company under Chapter 14A of the Listing Rules.

The annual cap for the consultancy fees paid by the Company to Dr. Lee Pak Cheung, Patrick for FY2023 was HK\$7,800,000 and the actual amount paid or payable to Dr. Lee Pak Cheung, Patrick was HK\$3,912,000.

B. Medical Services Framework Agreement

On 13 November 2015, the Company and CTFE entered into a medical services framework agreement, and on 6 September 2018, the Company and CTFE further entered into a first medical services framework renewal agreement (the "First Medical Services Framework Renewal Agreement"), pursuant to which the Group shall provide Medical, Dental and Auxiliary Services to the employees of CTFE and/or its associates. During FY2021, the Group agreed to continue providing medical, dental and auxiliary services to the employees of CTFE and its associates after the expiry of the First Medical Services Framework Renewal Agreement. On 23 September 2021, the Company entered into a second medical services framework renewal agreement with CTFE (the "Medical Services Framework Agreement") for a term up to 30 June 2024. The major terms of the agreement are set out as follows:

- the Group shall provide Medical, Dental and Auxiliary Services to the employees of CTFE and its associates;

 - the Medical Services Framework Agreement shall commence from 1 July 2021 to 30 June 2024 (both days inclusive) and may be renewed by mutual consent of the parties.

The annual cap for the aggregate fees to be received by the Company from CTFE for FY2023 was HK\$31,000,000 and the actual amount received or receivable by the Company was HK\$19,984,000.

C. Consultancy Renewal Agreement with Dr. Sun Man Kin, Michael

The Company entered into a consultancy agreement with Dr. Sun Man Kin, Michael (“Dr. Michael Sun”) on 13 November 2015, and further entered into a first consultancy renewal agreement (the “First Consultancy Renewal Agreement”) with Dr. Michael Sun on 6 September 2018 to regulate the consultancy relationship between the Group and Dr. Michael Sun for the provision of radiologist services by Dr. Michael Sun to the Group. The Company intends to continue engaging Dr. Michael Sun as a consultant after the expiry of the First Consultancy Renewal Agreement with Dr. Michael Sun. On 23 September 2021, the Company entered into the second consultancy renewal agreement with Dr. Michael Sun (the “Second Consultancy Renewal Agreement”) for a term up to 30 June 2024. Details of the Second Consultancy Renewal Agreement with Dr. Michael Sun are set out below:

- Dr. Michael Sun shall provide radiologist services to the Group;
- the consultancy fees payable under the Second Consultancy Renewal Agreement with Dr. Michael Sun, shall be determined by the parties through arm’s length negotiation and on normal commercial terms and based on the scope of services rendered by Dr. Michael Sun and with reference to the fees charged by independent consultants of similar expertise, experience and reputation with similar role, scope of services and responsibilities under similar circumstances to ensure that the terms are no less favourable to the Group than terms available by independent consultants; and
- the Second Consultancy Renewal Agreement with Dr. Michael Sun shall commence from 1 July 2021 until 30 June 2024 and may be renewed by mutual consent of the parties.

Dr. Michael Sun is an executive Director and is therefore a connected person of the Company pursuant to Rule 14A.07(1) of the Listing Rules. Therefore, the transactions contemplated under the Second Consultancy Renewal Agreement with Dr. Michael Sun constitute continuing connected transactions of the Company under Chapter 14A of the Listing Rules.

C. 與孫文堅醫生的顧問重續協議

- 根據與孫文堅醫生的第二次顧問重續協議應付的顧問費用應經各方公平磋商後按一般商業條款及基於孫文堅醫生所提供的服務範圍以及參考在類似情況下具備類似專業知識、經驗及聲譽的獨立顧問就類似角色、服務範圍及職責所收取的費用釐定，以確保就本集團而言，有關條款不遜於可從獨立顧問獲得的條款；及
- 與孫文堅醫生的第二次顧問重續協議自2021年7月1日起 至2024年6月30日止，可經雙方同意後續期。

孫文堅醫生為執行董事，因此，根據上市規則第14A.07(1)條，其為本公司的關連人士。因此，與孫文堅醫生的第二次顧問重續協議項下擬進行的交易根據上市規則第14A章構成本公司的持續關連交易。

The annual cap for the consultancy fees paid by the Company to Dr. Michael Sun for FY2023 was HK\$7,500,000 and the actual amount paid or payable to Dr. Michael Sun was HK\$4,362,000.

D. Medical Services Agreement

On 1 October 2022, UMP Professional Management Limited (“UMP Professional”), an indirect wholly-owned subsidiary of the Company, entered into a Medical Services Agreement with FTLife Insurance Company Limited (“FT Life”) in respect of provision and administration of the Medical Services by UMP Professional (or procure its applicable affiliates) to the insured and/or policyholders of FTLife (“FTLife Members”) and/or respective family members of policyholders of FTLife including spouse and children (“Family Members”).

UMP Professional agreed (or procure its applicable affiliates) to provide and administer medical services to FTLife Members and/or Family Members, including (a) various administrative services including, among others, 24/7 hotline services, third-party administrative services and other ancillary digital support for FTLife Members and/or Family Members (“Administrative Services”); and (b) medical services including, among others, day procedures, diagnostic imaging services, in-patient surgical procedures, medical advice and other relevant services (“Clinical Services”) (collectively, the “Medical Services”).

FTLife is an indirect wholly-owned subsidiary of NWS Holdings Limited which in turn is a subsidiary of New World Development Company Limited (“NWD”) and CTFE (a substantial shareholder of the Company) is a controlling shareholder of NWD. Hence, FTLife is a connected person of the Company and the transactions contemplated under the Medical Services Agreement constitute continuing connected transactions of the Company under Chapter 14A of the Listing Rules.

The term of the Medical Services Agreement shall be for three (3) years commencing from the 1 October 2022, unless terminated in accordance with the terms of the Medical Services Agreement.

聯合醫務專業同意（或促使其適用之聯屬公司）向富通保險成員及／或家庭成員提供及管理醫療服務，包括(a)對象為富通保險成員及／或家庭成員的不同行政管理服務，包括（除其他服務外）24/7全天候熱線服務、第三方行政管理服務及其他配套數碼支援（「行政管理服務」）；及(b)醫療服務，包括（除其他服務外）日間手術、診斷影像服務、住院手術、醫療建議及其他相關服務（「臨床服務」）（統稱「醫療服務」）。

富通保險為新創建集團有限公司之間接全資附屬公司，而新創建集團有限公司為新世界發展有限公司（「新世界發展」）之附屬公司及周大福企業（本公司之主要股東）為新世界發展之控股股東。因此，富通保險為本公司之關連人士，而根據上市規則第十四A章，醫療服務協議項下擬進行之交易構成本公司之持續關連交易。

除非根據醫療服務協議之條款終止，否則醫療服務協議之期限為自2022年10月1日起三(3)年。

The actual demand for the Medical Services under the Medical Services Agreement has exceeded the original expectations which has resulted in a corresponding increase in the total amount of service fees payable by FTLife to UMP Professional under such agreement. As such, the aggregate amount of service fees payable by FTLife to UMP Professional under the Medical Services Agreement are expected to be higher than the level envisaged at the time when the parties entered into the Medical Services Agreement. On 11 May 2023, an extraordinary general meeting approved the annual caps (revised) and the transactions contemplated thereunder.

The caps for nine months ended 30 June 2023 received by UMP Professional from FTLife was HK\$30,000,000 and the actual amount received or receivable by UMP Professional was HK\$22,321,000.

The Company's independent non-executive Directors have reviewed the above non-exempt continuing connected transactions for the year ended 30 June 2023 and confirmed that:

- (a) the transactions have been entered into by the Group in the ordinary and usual course of its business;
- (b) the transactions have been entered into either (i) on normal commercial terms or (ii) (where there are not sufficient comparable transactions to judge whether they are on normal commercial terms) on terms no less favourable to the Group than terms available to or from (as appropriate) independent third parties; and
- (c) the transactions have been entered into in accordance with the relevant agreement governing them on terms that are fair and reasonable and in the interests of the Shareholders as a whole.

The Company's auditors have reported to the Directors that (i) nothing has come to their attention that causes them to believe that the disclosed continuing connected transactions have not been approved by the Board; (ii) for transactions including the provision of goods or services by the Group, nothing has come to their attention that causes them to believe that the transactions were not, in all material respects, in accordance with the pricing policies of the Group; (iii) nothing has come to their attention that causes them to believe that the disclosed continuing connected transactions were not entered into, in all material respects, in accordance with the relevant agreements governing such transactions; and (iv) with respect to the aggregate amount of each of the above continuing connected transactions, nothing has come to their attention that causes them to believe that the disclosed continuing connected transactions have exceeded the annual cap as set by the Company.

MANAGEMENT CONTRACTS

The Company has not entered into any contract with any individual, firm or body corporate to manage or administer the whole or any substantial part of any business of the Group during FY2023.

EQUITY-LINKED AGREEMENTS

Save for the Share Option Schemes and Share Award Scheme as disclosed on pages 125 to 135 of this annual report, no equity-linked agreements were entered into by the Company, or existed during FY2023.

1. CORPORATE AND GROUP INFORMATION

2.1 BASIS OF PREPARATION

These consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”) (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“HKASs”) and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for equity investments and certain other assets which have been measured at fair value. These consolidated financial statements are presented in Hong Kong dollars and all values are rounded to the nearest thousand except when otherwise indicated.

Basis of consolidation

The consolidated financial statements include the consolidated financial statements of the Group for the year ended 30 June 2023. A subsidiary is an entity directly or indirectly, controlled by the Company. The consolidated financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or retained profits, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

Amendments to HKAS 37, Provisions, contingent liabilities and contingent assets: Onerous contracts – cost of fulfilling a contract

The amendments clarify that for the purpose of assessing whether a contract is onerous, the cost of fulfilling the contract includes both the incremental costs of fulfilling that contract and an allocation of other costs that relate directly to fulfilling contracts.

Previously, the Company included only incremental costs when determining whether a contract was onerous. In accordance with the transitional provisions, the Group has applied the new accounting policy to contracts for which it has not yet fulfilled all its obligations at 1 July 2022, and has concluded that none of them is onerous.

New HKICPA guidance on the accounting implications of the abolition of the MPF-LSP offsetting mechanism

In July 2023, the HKICPA published Accounting implications of the abolition of the mandatory provident fund (“MPF”)–long service payment (“LSP”) offsetting mechanism in Hong Kong that provides guidance on the accounting considerations relating to the offsetting mechanism and the abolition of the mechanism.

The Group is currently assessing the impact of the HKICPA guidance and expect to adopt this guidance in its annual financial statements for the year ending 30 June, 2024.

HKFRS 17, *Insurance Contracts*

HKFRS 17 replaces HKFRS 4 *Insurance Contracts* and is effective for annual periods beginning on or after 1 January 2023, with early adoption permitted.

HKFRS 17 establishes principles for the recognition, measurement, presentation and disclosure of insurance and reinsurance contracts. Under certain fixed-fee service contracts (see note 2.4), the Group accepts significant insurance risk by agreeing to compensate the customer if a specified uncertain future event adversely affects the customer. Some of these contracts could be insurance contracts within the scope of HKFRS 17. Where the Group mitigates the risk by using other contracts to transfer part of the risk to insurance companies, those other contracts would be reinsurance contracts within the scope of HKFRS 17.

The premium allocation approach is an optional measurement model in HKFRS 17 that is available for insurance and reinsurance contracts that meet the eligibility criteria. As the coverage period of each of the Group's insurance and reinsurance contracts would be one year or less, they are expected to meet the eligibility criteria and be measured using the premium allocation approach.

HKFRS 17 may change how balances of insurance and reinsurance contracts and the related income and expenses are presented and disclosed in the Group's consolidated financial statements. However, the Group expects that the premium allocation approach would result in similar measurements of contract balances as under the Group's current accounting policies. Therefore, the adoption of HKFRS 17 is expected to have no material impact on the Group's total equity at 1 July 2023 and 1 July 2022.

香港財務報告準則第17號取代香港財務報告準則第4號*保險合約*，並於2023年1月1日或之後開始之年度期間生效，並可提早採納。

香港財務報告準則第17號確立保險及再保險合約之確認、計量、呈列及披露原則。根據若干固定收費服務合約(見附註2.4)，倘某項特定不確定未來事件對客戶造成不利影響，本集團同意向該客戶作出賠償，並由此承擔重大保險風險。其中部分合約可能屬於香港財務報告準則第17號範圍內之保險合約。倘本集團利用其他合約將部分風險轉移至保險公司以降低風險，則該等其他合約將屬於香港財務報告準則第17號範圍內之再保險合約。

保費分配法為香港財務報告準則第17號所述之一種可選計量模式，其適用於符合條件標準之保險及再保險合約。由於本集團每份保險及再保險合約之承保期將為一年或更短，該等合約預計將符合條件標準，並將採用保費分配法進行計量。

香港財務報告準則第17號可能會改變本集團綜合財務報表中保險及再保險合約結餘及相關收支之呈列及披露方式。然而，本集團預計按保費分配法將會得出與本集團現行會計政策下之合約結餘相若之計量。因此，採納香港財務報告準則第17號預期不會對本集團於2023年7月1日及2022年7月1日之權益總額造成重大影響。

Investments in associates and joint ventures

An associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it is in a position to exercise significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's investments in associates and joint ventures are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses. Adjustments are made to bring into line any dissimilar accounting policies that may exist. The Group's share of the post-acquisition results and other comprehensive income of associates and joint ventures is included in the consolidated statement of profit or loss and consolidated other comprehensive income, respectively. In addition, when there has been a change recognised directly in the equity of the associate or joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its associates or joint ventures are eliminated to the extent of the Group's investments in the associates or joint ventures, except where unrealised losses provide evidence of an impairment of the assets transferred. Goodwill arising from the acquisition of associates or joint ventures is included as part of the Group's investments in associates or joint ventures.

聯營公司指本集團於其擁有一般不少於20%股本投票權的長期權益，並可對其實施重大影響的實體。重大影響指對投資對象的財務及經營政策有參與決策的權力，但並非對該等政策形成控制或共同控制。

合資公司乃一種合營安排，據此，對安排擁有共同控制權的各方享有該合資公司淨資產的權利。共同控制指通過訂約協定共享安排的控制權，僅在相關活動決策須經共享控制權的各方一致同意的情況下存在。

本集團於聯營公司及合資公司的投資乃在綜合財務狀況表列賬為本集團應佔資產淨值（根據權益會計法計算，扣除所有減值虧損）。倘出現任何不相符的會計政策，即會作出調整加以修正。本集團應佔聯營公司及合資公司的收購後業績及其他全面收入乃分別於綜合損益表及綜合其他全面收入列賬。此外，倘直接於聯營公司或合資公司的權益確認變動，本集團應於綜合權益變動表確認其任何應佔的變動（如適用）。本集團與其聯營公司或合資公司之間交易產生的未變現盈虧以本集團於聯營公司或合資公司的投資為限對銷，惟尚未變現虧損提供已轉讓資產減值的證據，則作別論。收購聯營公司或合資公司所產生的商譽計入本集團於聯營公司或合資公司的部分投資。

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate or joint venture upon loss of significant influence or joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

倘對聯營公司的投資成為對合資公司的投資，或對合資公司的投資成為對聯營公司的投資，留存權益不會重新計量，而是繼續按權益法將投資列賬。在所有其他情況下，若本集團失去對聯營公司的重大影響力或合資公司的共同控制權，則會按公允價值計量及確認任何留存投資。失去對聯營公司的重大影響力或對合資公司的共同控制權時，聯營公司或合資公司的賬面值與留存投資公允價值及出售所得款項之間的差額於損益確認。

業務合併與商譽

業務合併以收購法入賬。轉讓之代價乃以收購日期的公允價值計算，該公允價值為本集團轉讓的資產於收購日期的公允價值、本集團所承擔被收購方前擁有人的負債，及本集團發行以換取被收購方控制權的股權之總和。就各項業務合併而言，本集團選擇是否以公允價值或被收購方可識別資產淨值的應佔比例，計算於被收購方的非控股權益（屬現時擁有人權益並賦予擁有人權利於清盤時按比例分佔其資產淨值）。非控股權益的所有其他組成部分按公允價值計量。收購相關成本於產生時列為費用。

當本集團收購一項業務時，會按照合約條款、收購日期的經濟環境和相關狀況評估所承接金融資產和負債，以作出適當分類及指定，其中包括對被收購方於主合約所持嵌入式衍生工具進行分離。

如果業務合併分階段完成，過往所持股權權益按收購日期的公允價值重新計量，而由此產生的任何損益在損益中確認。

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable net assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 30 June. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units ("CGUs"), or groups of CGUs, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the CGU (group of CGUs) to which the goodwill relates. Where the recoverable amount of the CGU (group of CGUs) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

商譽起初按成本計量，即已轉讓總代價、已確認非控股權益及本集團先前持有被收購方股權的公允價值總額，超出所收購可識別資產淨值及所承擔負債的差額。如代價及其他項目的總和低於所收購資產淨值的公允價值，於重新評估後其差額將於損益內確認為議價收購收益。

初始確認後，商譽按照成本減任何累計減值虧損計量。商譽須每年進行減值測試，倘事件發生或情況變動顯示賬面值可能已減值時，則應更頻繁地進行減值測試。本集團於每年的6月30日對商譽進行年度減值測試。就減值測試而言，不論本集團其他資產或負債有否分配至本集團各現金產生單位（「現金產生單位」）或現金產生單位組別，因業務合併所得商譽乃自收購日期起分配至該等現金產生單位或現金產生單位組別，而該等現金產生單位或現金產生單位組別預期將受惠於合併帶來的協同效益。

減值是通過評估商譽相關的現金產生單位（或現金產生單位組別）的可收回金額而釐定。若現金產生單位（或現金產生單位組別）的可收回金額低於其賬面值，將確認減值虧損。就商譽確認的減值虧損不會在其後期間撥回。

Where goodwill has been allocated to a CGU (or group of CGUs) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation disposed of and the portion of the CGU retained.

Fair value measurement

The Group measures its equity investments and certain debt investments at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

若獲分配商譽的現金產生單位(或現金產生單位組別)的部分業務被出售,則於釐定出售盈虧時,與所出售業務有關之商譽計入該業務賬面值。在此等情況下出售之商譽,按所出售業務與其現金產生單位所保留部分對應的比例計量。

公允價值計量

本集團於各報告期末按公允價值計量股本投資及若干債務投資。公允價值為市場參與者於計量日期在有序交易中出售資產可能收取或轉讓負債可能支付的價格。公允價值計量假設出售資產或轉讓負債的交易於該資產或負債的主要市場進行,或在無主要市場的情況下,則於對該資產或負債最有利的市場進行。主要市場或最有利市場是本集團可進入的市場。資產或負債的公允價值計量採用市場參與者進行資產或負債定價時所使用的假設,即市場參與者以自身最佳經濟利益行事。

非金融資產的公允價值計量須考量市場參與者產生經濟效益的能力,即最大限度使用該資產達致最佳用途或將該資產售予可最大限度使用該資產達致最佳用途的另一市場參與者時所產生的經濟效益。

本集團使用適合不同情況的估值方法,而其有足夠資料計量公允價值,從而盡量利用相關可觀察輸入數據,並盡量減少使用不可觀察輸入數據。

All assets and liabilities for which fair value is measured or disclosed in the consolidated financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 — based on quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2 — based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
- Level 3 — based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the consolidated financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, deferred tax assets and financial assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or CGU's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the CGU to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the consolidated statement of profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the consolidated statement of profit or loss in the period in which it arises.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the consolidated statement of profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in the consolidated statement of profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

Intangible assets with indefinite useful lives are tested for impairment annually either individually or at the CGU level. Such intangible assets are not amortised. The useful life of an intangible asset with an indefinite life is reviewed annually to determine whether the indefinite life assessment continues to be supportable. If not, the change in the useful life assessment from indefinite to finite is accounted for on a prospective basis.

Brand names

Brand names with indefinite useful lives are stated at cost less any impairment losses, and are not amortised.

Customer relationships

Customer relationships are stated at cost less any impairment losses and are amortised on the straight-line basis over their estimated useful economic lives of 5 years.

Software

The development cost is stated at cost less any impairment losses and is amortised on the straight-line basis over its estimated useful economic life of 1 year.

Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

The Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets. At inception or on reassessment of a contract that contains a lease component and non-lease components, the Group adopts the practical expedient not to separate non-lease components and to account for the lease component and the associated non-lease components (e.g., property management services for leases of properties) as a single lease component.

無形資產 (商譽除外)

單獨收購的無形資產於初始確認時按成本計量。通過業務合併收購的無形資產的成本為收購日期的公允價值。無形資產的可使用年期評定為有限期或無限期。有限期的無形資產隨後按可使用經濟年期攤銷，並於有跡象顯示無形資產可能出現減值時評估減值。具有有限可使用年期的無形資產的攤銷期及攤銷方法至少於各財政年度末檢討一次。

無限可使用年期的無形資產個別地或按現金產生單位層面每年進行減值測試。該等無形資產不予攤銷。無限年期的無形資產之可使用年期會每年檢討，以釐定無限年期評估是否繼續獲得支持。否則，可使用年期評估由無限變更為有限及以未來適用法基準入賬。

品牌名稱

具有無限使用年期的品牌名稱按成本減任何減值虧損列賬，且並不予以攤銷。

客戶關係

客戶關係按照成本減任何減值虧損列賬，並根據其估計可使用經濟年期5年以直線法攤銷。

軟件

開發成本按照成本減任何減值虧損列賬，並根據其估計可使用年期1年以直線法攤銷。

租賃

本集團在合約開始時評估合約是否為租賃或包含租賃。倘合約為換取代價而授予在一段期間內可識別資產的使用控制權，則該合約為租賃或包含租賃。

本集團作為承租人

本集團就所有租賃應用單一確認及計量方法，惟短期租賃及低價值資產租賃除外。本集團確認租賃負債以作出租賃付款，而使用權資產指使用相關資產的權利。在包含租賃部分和非租賃部分的合約開始時或對有關合約重新評估時，本集團採納可行權宜方法，不將非租賃部分分開，而將租賃部分和相關的非租賃部分（如物業租賃的物業管理服務）作為單一租賃部分入賬。

(a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

(b) Lease liabilities

The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

The Group's lease liabilities are presented separately in the consolidated statement of financial position.

(c) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to its short-term leases (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets to leases of office equipment that are considered to be of low value.

Lease payments on short-term leases and leases of low-value assets are recognised as an expense on a straight-line basis over the lease term.

The Group as a lessor

When the Group acts as a lessor, it determines at lease inception whether each lease is a finance lease or an operating lease. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to the ownership of an underlying assets to the lessee. If this is not the case, the lease is classified as an operating lease.

When the Group is an intermediate lessor, the sub-leases are classified as a finance lease or as an operating lease with reference to the right-of-use asset arising from the head lease. If the head lease is a short-term lease to which the Group applies the exemption, then the Group classifies the sub-lease as an operating lease.

Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income, and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15, *Revenue from contracts with customers*, in accordance with the policies set out for "Revenue recognition" below.

Except for investment in equity securities, in order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

Financial assets at amortised cost (debt instruments)

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in the consolidated statement of profit or loss when the asset is derecognised, modified or impaired.

Financial assets at fair value through other comprehensive income (debt instruments)

For debt investments at fair value through other comprehensive income, interest income, foreign exchange revaluation and impairment losses or reversals are recognised in the consolidated statement of profit or loss and computed in the same manner as for financial assets measured at amortised cost. The remaining fair value changes are recognised in other comprehensive income. Upon derecognition, the cumulative fair value change recognised in other comprehensive income is recycled to the consolidated statement of profit or loss.

Financial assets designated at fair value through other comprehensive income (equity investments)

Upon initial recognition, the Group can elect to classify irrevocably its equity investments as equity investments designated at fair value through other comprehensive income when they meet the definition of equity under HKAS 32, *Financial Instruments: Presentation*, and are not held for trading. The classification is determined on an instrument-by-instrument basis.

Gains and losses on these financial assets are never recycled to the consolidated statement of profit or loss. Equity investments designated at fair value through other comprehensive income are not subject to impairment assessment.

Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss are carried in the consolidated statement of financial position at fair value with net changes in fair value recognised in the consolidated statement of profit or loss.

This category includes derivative instruments and equity investments which the Group had not irrevocably elected to classify at fair value through other comprehensive income. Dividends on equity investments classified as financial assets at fair value through profit or loss are also recognised as other income in the consolidated statement of profit or loss when the right of payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a “pass-through” arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

Impairment of financial assets

The Group recognises an allowance for expected credit losses (“ECLs”) for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

一般方法

預期信貸虧損分兩個階段確認。就初始確認以來信貸風險並無顯著上升的信貸敞口而言，會就未來12個月內可能發生的違約事件所產生的信貸虧損計提預期信貸虧損撥備（12個月預期信貸虧損）。就初始確認以來信貸風險顯著上升的信貸敞口而言，須就預期於敞口的餘下年期產生的信貸虧損計提減值撥備，而不論違約的時間（全期預期信貸虧損）。

For debt investments at fair value through other comprehensive income, the Group applies the low credit risk simplification. At each reporting date, the Group evaluates whether the debt investments are considered to have low credit risk using all reasonable and supportable information that is available without undue cost or effort. In making that evaluation, the Group reassesses the external credit ratings of the debt investments. In addition, the Group considers that there has been a significant increase in credit risk when contractual payments are more than 30 days past due.

The Group considers a financial asset in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Debt investments at fair value through other comprehensive income and financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables which apply the simplified approach as detailed below.

Simplified approach

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

For trade receivables that contain a significant financing component and lease receivables, the Group chooses as its accounting policy to adopt the simplified approach in calculating ECLs with policies as described above.

Financial liabilities

Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as loans and borrowings.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

Subsequent measurement of financial liabilities at amortised cost (loans and borrowings)

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the consolidated statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is recognised in the consolidated statement of profit or loss.

Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the consolidated statement of profit or loss.

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the consolidated statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

Derivative financial instruments

Derivative financial instruments are initially recognised at fair value on the date on which a derivative contract is entered into and are subsequently remeasured at fair value. Derivatives are carried as assets when the fair value is positive and as liabilities when the fair value is negative. Any gains or losses arising from changes in fair value of derivatives are taken directly to the consolidated statement of profit or loss.

Shares held under the share award scheme

Where shares are acquired by the share award scheme from the market or by electing for scrip in lieu of cash dividends, the total consideration of shares acquired from the market (including any directly attributable incremental costs) or under the scrip dividend scheme is presented as shares held for the share award scheme and deducted from total equity.

Upon vesting, the related costs of the vested awarded shares purchased from the market and shares acquired under the scrip dividend scheme (dividend shares) are credited to shares held for the share award scheme, with a corresponding decrease in the share-based payment reserve for awarded shares and a decrease in retained profits for dividend shares.

Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the weighted average basis. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to disposal.

Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is recognised in the consolidated statement of profit or loss.

A provision for reinstatement costs is recognised when a contractual obligation under the terms of an operating lease has arisen to reinstate a leased property at the end of the lease. Reinstatement costs are provided at the value of the expected costs to settle the obligation at the end of the reporting period using estimated cash flows and an equivalent asset is recognised and depreciated over the term of the operating lease. The estimated future costs of reinstatement are reviewed, and adjusted if appropriate, at least at each financial year end. Changes in the estimated future costs are added to or deducted from the cost of the corresponding asset.

Onerous contracts

An onerous contract exists when the Company has a contract under which the unavoidable costs of meeting the obligations under the contract exceed the economic benefits expected to be received from the contract. Provisions for onerous contracts are measured at the present value of the lower of the expected cost of terminating the contract and the net cost of fulfilling the contract. The cost of fulfilling the contract includes both the incremental costs of fulfilling that contract and an allocation of other costs that relate directly to fulfilling that contract.

Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries/jurisdictions in which the Group operates.

Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. Revenue recognition

Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

- (b) Revenue from the below services are recognised as services are rendered:
 - medical and dental services;
 - healthcare management services; and
 - administrative support services
- (c) dividend income, when the shareholders' right to receive payment has been established;

Fixed-fee service contracts

The Group has certain medical, dental and other service contracts, in which the Group agrees to provide specific services over the terms of the contracts for a fixed fee in which the level of services depends on uncertain future events (the “Fixed-fee Service Contracts”). The Fixed-fee Service Contracts are in general of one to two years and the Group receives the related service fees upfront. The Contract Customers cannot recover the service fee upon the expiration of the respective fixed-fee service contract periods irrespective of whether the plan members utilised any services under the Fixed-fee Service Contracts.

At the end of each reporting period, tests are performed to ensure the adequacy of the contract liabilities under the Fixed-fee Service Contracts. In performing these tests, the current best estimates of future contractual cash flows under the Fixed-fee Service Contracts are used. Any deficiency is immediately charged to the consolidated statement of profit or loss by establishing a provision for losses.

Fees received or receivable under the Fixed-fee Service Contracts are recognised on a time proportion basis (i.e., straight-line basis) over the terms of the Fixed-fee Service Contracts. At the time of revenue recognition, plan members may not utilise any services under the Fixed-fee Service Contracts and hence, no direct cost will be incurred by the Group in association with the professional services rendered by the doctors, dentists and auxiliary service providers. Accordingly, expenses incurred in connection with the Fixed-fee Service Contracts are charged to the consolidated statement of profit or loss as incurred.

本集團持有若干醫療、牙科及其他服務合約，本集團於此等合約中約定於合約期內以固定費用提供特定服務，而服務程度取決於未來的不確定事項（「固定費用服務合約」）。固定費用服務合約一般為期一至兩年，且本集團預收相關服務費。於相關固定費用服務合約屆滿後，不管計劃會員有否使用固定費用服務合約項下的任何服務，合約客戶均不能收回該服務費。

於各報告期末，本集團會進行測試以確保固定費用服務合約之合約負債足夠。進行此等測試時，對於固定費用服務合約下的未來合約現金流量，應使用當前的最佳估計。任何不足額隨即透過設立虧損撥備於綜合損益表內扣除。

於固定費用服務合約下的已收或應收費用，應按照時間比例基準（即按直線基準）在固定費用服務合約的履約期內確認。於確認收入時，計劃會員可能並未使用固定費用服務合約下的任何服務，因此，本集團並不會發生與醫生、牙醫及輔助服務提供者提供專業服務相關的直接成本。因此，與固定費用服務合約相關的費用於發生時從綜合損益表中扣除。

Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

Share-based payments

The Company operates share option schemes, a share award scheme and warrants scheme for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Employees (including directors), consultants and a business partner of the Group receive remuneration in the form of share-based payments, whereby employees, consultants and a business partner render services as consideration for equity instruments ("equity-settled transactions").

In situations where the share-based payment transactions are with employees of the Group, the cost of equity-settled transactions is measured by reference to the fair value of the equity instruments at the date at which they are granted, taking into account the terms and conditions upon which these equity instruments are granted. In situations where the share-based payment transactions are with non-employees of the Group, the cost of equity-settled transactions is measured by reference to the fair value of goods or services received, unless that fair value cannot be estimated reliably. If the Group cannot estimate reliably the fair value of the goods or services received, the Group measures the goods or services received, indirectly, by reference to the fair value of the equity instruments granted.

The fair value of the share options granted is determined by an external valuer using a binomial model, further details of which are given in note 36 to the consolidated financial statements.

以股份為基礎的付款

本公司設有購股權計劃、股份獎勵計劃及認股權證計劃,向為本集團業務成就作出貢獻的合資格參與者提供獎勵及報酬。本集團僱員(包括董事)、顧問及業務夥伴按以股份為基礎的付款方式收取薪酬,僱員、顧問及業務夥伴以提供服務作為權益工具的代價(「以權益結算之交易」)。

若以股份為基礎的付款交易以本集團的僱員為對象,則以權益結算之交易的成本參照權益工具於授出當日的公允價值計量,並考慮此等權益工具的授出條款及條件。若以股份為基礎的付款交易並非以本集團僱員為對象,則以權益結算之交易的成本參照所接收的貨品或服務的公允價值計量,除非無法可靠估計其公允價值。若本集團無法可靠估計所接收貨品或服務的公允價值,則本集團將參照授出的權益工具的公允價值間接計量所接受貨品或服務。

The fair value of the warrants granted is determined by an external valuer using a Black-Scholes option pricing model, further details of which are given in note 36 to the consolidated financial statements.

The cost of equity-settled transactions is recognised either in employee benefit expense or other expenses, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to the consolidated statement of profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

The Group shall revise the estimates of the amount for the goods or services received if subsequent information indicates that the number of equity instruments expected to vest differs from previous estimates. For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of the modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

The dilutive effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

Other employee benefits

Pension schemes

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to the consolidated statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

Pension schemes (Continued)

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute certain percentages of their payroll costs to the central pension scheme. The contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension scheme.

The employees of the Group's subsidiaries which operate in Macau are required to participate in a social security fund operated by the government of the Macao Special Administrative Region. These subsidiaries are required to contribute certain fixed amounts of their payroll costs to the social security fund. The contributions are charged to the consolidated statement of profit or loss as they become payable in accordance with the rules of the social security fund.

Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the consolidated financial statements.

Interim dividends are simultaneously proposed and declared, because the Company's memorandum and articles of association grant the directors the authority to declare interim dividends. Consequently, interim dividends are recognised immediately as a liability when they are proposed and declared.

Non-current assets held for sale

A non-current asset (or disposal group) is classified as held for sale if it is highly probable that its carrying amount will be recovered through a sale transaction rather than through continuing use and the asset (or disposal group) is available for sale in its present condition. A disposal group is a group of assets to be disposed of together as a group in a single transaction, and liabilities directly associated with those assets that will be transferred in the transaction.

When the Group is committed to a sale plan involving loss of control of a subsidiary, all the assets and liabilities of that subsidiary are classified as held for sale when the above criteria for classification as held for sale are met, regardless of whether the Group will retain a non-controlling interest in the subsidiary after the sale.

Immediately before classification as held for sale, the measurement of the non-current assets (and all individual assets and liabilities in a disposal group) is brought up-to-date in accordance with the accounting policies before the classification. Then, on initial classification as held for sale and until disposal, the non-current assets (except for certain assets as explained below), or disposal groups, are recognised at the lower of their carrying amount and fair value less costs to sell. The principal exceptions to this measurement policy so far as the consolidated financial statements of the Group and the Company are concerned are deferred tax assets and financial assets. These assets, even if held for sale, would continue to be measured in accordance with the policies set out elsewhere in this note.

Impairment losses on initial classification as held for sale, and on subsequent remeasurement while held for sale, are recognised in profit or loss. As long as a non-current asset is classified as held for sale, or is included in a disposal group that is classified as held for sale, the non-current asset is not depreciated or amortised.

Discontinued operation

A discontinued operation is a component of the Group's business, the operations and cash flows of which can be clearly distinguished from the rest of the Group and which represents a separate major line of business or geographical area of operations, or is part of a single co-ordinated plan to dispose of a separate major line of business or geographical area of operations, or is a subsidiary acquired exclusively with a view to resale.

Classification as a discontinued operation occurs upon disposal or when the operation meets the criteria to be classified as held for sale, if earlier. It also occurs if the operation is abandoned.

Where an operation is classified as discontinued, a single amount is presented on the face of the statement of profit or loss, which comprises:

- the post-tax profit or loss of the discontinued operation; and
- the post-tax gain or loss recognised on the measurement to fair value less costs to sell, or on the disposal, of the assets or disposal group(s) constituting the discontinued operation.

Foreign currencies

These consolidated financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the consolidated statement of profit or loss. Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions.

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

The functional currencies of certain subsidiaries outside Hong Kong, associates and a joint venture are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into Hong Kong dollars at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into Hong Kong dollars at the weighted average exchange rates for the year. The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in the consolidated statement of profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amounts of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

外幣

綜合財務報表以港元呈列，港元亦為本公司的功能貨幣。本集團各下屬實體可自行決定其功能貨幣，而各實體財務報表內項目採用該功能貨幣計量。本集團各實體的外幣交易在初始確認時，採用其各自的功能貨幣於交易日的即期匯率入賬。以外幣計值之貨幣資產和負債採用各報告期末匯率將外幣金額折算為功能貨幣金額。由此產生的結算或貨幣項目折算差額，均於綜合損益表確認。以外幣按歷史成本計量之非貨幣項目，採用初始交易日期之匯率折算。

在釐定有關預付代價的非貨幣資產或非貨幣負債終止確認時初始確認相關資產、開支或收入使用的匯率時，初始交易日期即本集團初始確認預付代價產生的非貨幣資產或非貨幣負債的日期。倘支付或收取多筆預付款，則本集團對支付或收取的每一筆預付代價釐定交易日期。

若干香港以外附屬公司、聯營公司及一間合資公司的功能貨幣為港元以外貨幣。於報告期末，該等實體的資產及負債採用報告期末的匯率折算為港元，而其損益表採用該年度的加權平均匯率折算為港元。就此產生的匯兌差額，確認為其他全面收入並在匯兌波動儲備中累計。出售海外業務時，將與該海外業務相關的其他全面收入部份於綜合損益表中確認。

因收購海外業務產生的商譽及任何因收購而產生的資產及負債賬面值之公允價值調整，均被視為該海外業務的資產及負債並採用收盤匯率進行折算。

For the purpose of the consolidated statement of cash flows, the cash flows of subsidiaries outside Hong Kong are translated into Hong Kong dollars at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of overseas subsidiaries which arise throughout the year are translated into Hong Kong dollars at the weighted average exchange rates for the year.

3. SIGNIFICANT ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the Group's consolidated financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below.

Impairment of goodwill

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the value in use of the cash-generating units to which the goodwill is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating units and also to choose a suitable discount rate in order to calculate the present value of those cash flows. The carrying amount of goodwill at 30 June 2023 was HK\$164,768,000 (2022: HK\$164,768,000). Further details of impairment testing are set out in note 18 to the consolidated financial statements.

Impairment of indefinite-lived intangible assets

The Group determines whether indefinite-lived intangible assets are impaired at least on an annual basis. This requires an estimation of the value in use of the indefinite-lived intangible assets. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the indefinite-lived intangible assets and also to choose a suitable discount rate in order to calculate the present value of those cash flows. The carrying amount of the indefinite-lived intangible assets at 30 June 2023 was HK\$47,134,000 (2022: HK\$56,958,000). Further details of impairment testing are set out in note 18 to the consolidated financial statements.

於報告期末有關未來之主要假設及其他估計不確定性之主要來源，會使下一個財政年度內的資產及負債賬面值有重大調整的風險，詳見下文論述。

商譽減值

本集團至少每年釐定商譽有否減值。為此需對商譽所分配現金產生單位的使用價值作出估計。估計使用價值需要本集團估算現金產生單位之預期未來現金流量，並選擇合適的折現率計算該等現金流量的現值。於2023年6月30日的商譽賬面值為164,768,000港元（2022年：164,768,000港元）。減值測試的進一步詳情載於綜合財務報表附註18。

無限年期的無形資產的減值

本集團至少每年釐定無限年期的無形資產是否發生減值。為此需估計無限年期的無形資產的使用價值。估計使用價值需本集團對無限年期的無形資產產生的的預期未來現金流量進行估計，並選擇合適的折現率以計算該等現金流量的現值。無限年期的無形資產於2023年6月30日的賬面值為47,134,000港元（2022年：56,958,000港元）。減值測試的進一步詳情載於綜合財務報表附註18。

4. OPERATING SEGMENT INFORMATION

For management purposes, the Group is organised into business units based on their products and services and has three reportable operating segments as follows:

- (a) Hong Kong & Macau Corporate Healthcare Solution Services segment engages in the provision of corporate healthcare solutions to Contract Customers in Hong Kong and Macau;
- (b) Hong Kong & Macau Clinical Healthcare Services segment engages in the provision of medical and dental services, medical imaging and laboratory services, health check-up, and other auxiliary services in Hong Kong and Macau; and
- (c) Mainland China Clinical Healthcare Services segment engages in the provision of health check-up service and selected outpatient services in Mainland China.

Management monitors the results of the Group's operating segments separately for the purpose of facilitating decision-making process of resources allocation and performance assessment. Segment performance is evaluated based on reportable segment profit/ loss, which is a measure of adjusted profit/loss before tax. The adjusted profit/loss before tax is measured consistently with the Group's profit before tax excluding interest income, other income and gains, and share of profits and losses of joint ventures and associates as well as head office and corporate expenses.

Segment assets exclude goodwill, investments in joint ventures and associates, financial assets at fair value through profit or loss, financial assets at amortised cost, investments at fair value through other comprehensive income, other assets and other unallocated head office and corporate assets as these assets are managed on a group basis.

Segment liabilities exclude derivative financial instrument, and other unallocated head office and corporate liabilities as these liabilities are managed on a group basis.

Inter-segment sales and transfers are transacted with reference to the selling prices used for sales made to third parties at the then prevailing market prices.

The requirement is effective from 1 January 2008 and applies to earnings after 31 December 2007. Withholding tax rate may be applied if there is a tax treaty between Mainland China and the jurisdiction of the foreign investors. For the Group, the applicable rate is 10%. The Group is therefore liable for withholding taxes on dividends distributed by those subsidiaries established in Mainland China in respect of earnings generated from 1 January 2008.

At 30 June 2023, no deferred tax has been recognised for withholding taxes that would be payable on the unremitted earnings that are subject to withholding taxes of the Group's subsidiaries established in Mainland China. In the opinion of the directors, it is not probable that these subsidiaries will distribute such earnings in the foreseeable future. The aggregate amount of temporary differences associated with investments in subsidiaries in Mainland China for which deferred tax liabilities have not been recognised totalled approximately HK\$19,633,000 at 30 June 2023 (2022: HK\$9,336,000).

The Company operates a pre-initial public offering share option scheme (the “Pre-IPO Share Option Scheme”) and a share option scheme (the “Share Option Scheme”) (collectively, the “Schemes”) for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group’s operations. The principal terms of the Pre-IPO Share Option Scheme are similar to the terms of the Share Option Scheme except that (i) no further options could be granted under the Pre-IPO Share Option Scheme; and (ii) the exercise price and the exercise period of the share options are different as further detailed below.

Eligible participants of the Schemes include the Company’s directors, including independent non-executive directors, other employees of the Group, consultants of the Group, suppliers of goods or services to the Group, customers of the Group, the Company’s shareholders, and any non-controlling shareholder in the Company’s subsidiaries. The Pre-IPO Share Option Scheme was approved and adopted on 18 August 2015. The Share Option Scheme became effective on 27 November 2015 and, unless otherwise cancelled or amended, will remain in force for 10 years from that date.

The maximum number of unexercised share options currently permitted to be granted under the Schemes is an amount equivalent, upon their exercise, to 10% of the shares of the Company in issue at any time. The maximum number of shares issuable under share options to each eligible participant in the Schemes within any 12-month period is limited to 1% of the shares of the Company in issue at any time. Any further grant of share options in excess of this limit is subject to shareholders’ approval in a general meeting.

Share options granted to a director, chief executive or substantial shareholder of the Company, or to any of their associates, are subject to approval in advance by the independent non-executive directors. In addition, any share options granted to a substantial shareholder or an independent non-executive director of the Company, or to any of their associates, in excess of 0.1% of the shares of the Company in issue at any time or with an aggregate value (based on the closing price of the Company’s shares at the date of grant) in excess of HK\$5 million, within any 12-month period, are subject to shareholders’ approval in advance in a general meeting.

37. SHARE AWARD SCHEME

On 30 June 2016, the Company adopted a share award scheme (the “Share Award Scheme”) for the purpose of recognising the contributions by certain eligible participants and providing them with incentives in order to retain them for the continual operation and development of the Group and to attract suitable personnel for the growth and further development of the Group.

Eligible participants of the Share Award Scheme include the Company’s directors, senior management and other employees of the Group, and employed experts of the Group. The Share Award Scheme will remain in force for 10 years from 30 June 2016, unless otherwise cancelled or amended.

The maximum number of shares currently permitted to be granted under the Share Award Scheme is limited to 2% of the issued share capital of the Company at any time. The maximum number of shares which may be awarded to each eligible participant in the Share Award Scheme is limited to 1% of the issued share capital of the Company in each year.

The eligible participant for participation in the Share Award Scheme (the “Selected Participant”) is selected and the number of shares to be awarded under the Share Award Scheme is determined by the board of directors. The shares to be awarded under the Share Award Scheme will be purchased by a trustee (the “Trustee”) from the open market out of cash contributed by the Group and be held on trust for the Selected Participant until such shares are vested with the Selected Participant in accordance with the provisions of the Share Award Scheme.

The Trustee shall not exercise the voting rights in respect of any shares held on trust for the Group or the Selected Participant.

During the year, the Group purchased 3,156,000 (2022: 200,000) of its own shares through the Trustee from the open market. The total amount paid to acquire the shares was approximately HK\$2,537,000 (2022: HK\$157,000) and has been deducted from equity. As at 30 June 2023, such shares were classified as treasury shares of the Company as they were not yet vested.

受託人不得行使以信託形式為本集團或獲選參與者持有的任何股份的表決權。

On 31 December 2021, 55% shareholding of The GBA Healthcare Group Limited (“GBA Healthcare Group”), previously known as UMP Healthcare China Limited, an indirect non-wholly owned subsidiary of the Company, was disposed of at a consideration of HK\$22 million. Subsequent to the transaction, the Group’s shareholding in GBA Healthcare Group decreased from 80% to 25% and the Group ceased control over GBA Healthcare Group. As a result, GBA Healthcare Group and its subsidiaries have become the associates of the Group. As the disposed business is considered as a major line of business, the corresponding operation had been classified as a discontinued operation as a result of the completion of disposal.

46. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group's principal financial instruments comprise cash and cash equivalents and short term deposits. The main purpose of these financial instruments is to finance the Group's operations. The Group has various other financial assets and liabilities such as trade receivables and trade payables, which arise directly from its operations.

The main risks arising from the Group's financial instruments are credit risk and liquidity risk. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below.

Credit risk

The Group trades only with recognised and creditworthy third parties. It is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. In addition, receivable balances are monitored on an ongoing basis and the Group's exposure to bad debts is not significant.

With respect to listed equity and debt investments, the Group purchases and holds them only through various creditworthy financial institutions.

Maximum exposure and year-end staging

The tables below show the credit quality and the maximum exposure to credit risk based on the Group's credit policy, which is mainly based on past due information unless other information is available without undue cost or effort, and year-end staging classification as at 30 June. For listed debt investments, the Group also monitors them by using external credit ratings and ensures that investments are only made in debts meeting a certain credit rating to minimise credit risk. The amounts presented are gross carrying amounts for financial assets.

Capital management
