 Where there are joint registered holders of any Shares, any one of such persons may vote at the Meeting or any adjournment thereof, either personally or by proxy, that one of such Share as if he were solely entitled thereto; but if more than one of such joint holders are present at the Meeting personally or by proxy, that one of the said persons so present whose name stands first on the register of members of the Company in respect of such Share shall alone be entitled to vote in respect thereof.
