The opening balance of the total number of issued shares of the Company as at 30 September 2023 was 128,048,700 H Shares, 720,378,000 Domestic Shares and 330,042,000 Unlisted Foreign Shares, amounting to a total of 1,178,468,700 issued shares of the Company. Following the Conversion and Listing, the H Shares increased by 1,050,420,000 shares, while the Domestic Shares and the Unlisted Foreign Shares decreased by 720,378,000 shares and 330,042,000 shares, respectively. The total number of issued shares of the Company after the Conversion and Listing remains unchanged, comprising 1,178,468,700 H Shares.
