### **Report on Production and Sales Volume of Dongfeng Motor Group for October at 2023**

This is a voluntary announcement made by Dongfeng Motor Group Company Limited (the "Company").

The Company's sales volume in the first ten months of 2023 was 1,696,883 units, representing a decrease of 19.2% year-on-year. Dongfeng Motor Company, the parent company of the Company, recorded a total sale of 1,923,309 vehicles for the first ten months, representing a decrease of 22.3% year-on-year. The sales volume of Dongfeng Automobile Company Limited (A-share code 600006, hereinafter referred to as "DFAC"), a subsidiary of the Company, was 127,648 units for the first ten months, representing a growth of 15.7% year-on-year.
