If the shareholder is a company, it should execute this proxy form under its common seal or by the signature(s) of its legal representative(s) or its directors or (a) person(s) authorised to sign on its behalf. In case of joint holders, only the person whose name stands first on the register of members may attend and vote at the EGM, either in person or by proxy.
- To be valid, this proxy form, together with the power of attorney or other authority, if any, under which it is signed, or a notarially certified copy of such power of attorney or authority, must be completed and delivered to, for the holders of H shares, the office of the H share registrar of the Company, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong, and for the holders of domestic shares, the Office of the Board of Directors (Supervisors) of the Company at 35/F, Tower A, No. 2788 Aoti West Road, Lixia District, Jinan, Shandong Province, the PRC, not less than 24 hours before the time scheduled for the holding of the EGM (i.e. by 10:00 a.m. on Monday, 27 November 2023) or any adjournment thereof.
- Please refer to the circular of the Company dated 13 November 2023 for details of the above resolutions to be proposed at the EGM for consideration and approval.
- Completion and return of this proxy form do not affect your right to attend and vote at the EGM in person.
