UNAUDITED OPERATING STATISTICS AND LAND PLOTS ACQUIRED IN OCTOBER 2023

The board of directors (the “**Board**”) of Longfor Group Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) hereby announces that, as at the end of October 2023, the Group achieved aggregated contracted sales of RMB151.67 billion with contracted sales in terms of GFA amounted to 9,103,000 sqm. In October 2023, the Group recorded total contracted sales of RMB14.05 billion with contracted sales in terms of GFA amounting to 847,000 sqm. In October 2023, the Group recorded contracted sales attributable to the shareholders of the Company of RMB9.34 billion, with contracted sales in terms of GFA attributable to the shareholders of the Company amounting to 566,000 sqm.
