**JANUARY TO OCTOBER IN 2023**

The board of directors and all directors of Metallurgical Corporation of China Ltd.\* (the “Company”) warrant that there are no misrepresentations or misleading statements contained in, or material omissions from this announcement, and accept legal responsibilities for the truthfulness, accuracy and completeness of the contents of this announcement.

The value of newly signed contracts of the Company from January to October in 2023 amounted to RMB1,081.82 billion, representing an increase of 3.1% from the same period of last year. Among them, the value of newly signed overseas contracts amounted to RMB34.74 billion, representing an increase of 15.4% from the same period of last year.
