OVERSEAS REGULATORY ANNOUNCEMENT ANNOUNCEMENT ON OPERATING DATA FOR OCTOBER 2023

This overseas regulatory announcement is made pursuant to Rule 13.09 and Rule 13.10B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

China Eastern Airlines Corporation Limited (the “**Company**”) and all members of the board of directors confirm that the information contained in this announcement is true, accurate and complete, and no misrepresentations, misleading statements or material omissions are contained herein.

I. OPERATIONS

In October 2023, the Company’s passenger transportation capacity (measured by available seat kilometres) increased by 243.58% year-on-year; passenger traffic volume (measured by revenue passenger kilometres) increased by 302.30% year-on-year; passenger load factor increased by 11.26 percentage points year-on-year to 77.08%. In October 2023, freight traffic volume (measured by revenue freight tonne-kilometres) increased by 13.13% year-on-year.

In October 2023, the launch of new routes, resumption of routes and increased flight frequency of routes for domestic, international and regional markets of the Company are as follows:

Domestic market: New routes such as Guangzhou — Chongqing, Hangzhou — Guiyang, Qingdao — Haikou, Fuzhou — Yinchuan; and increased flight frequency for routes such as Shanghai Pudong — Xiamen, Shanghai Hongqiao — Tianjin, Guangzhou — Xi’an, Guangzhou — Wuxi.

International market: New routes such as Shanghai Pudong — Vientiane, Hangzhou — Singapore; resumed routes such as Shanghai Pudong — San Francisco, Shanghai Pudong — Brisbane, Shanghai Pudong — Nagasak; and increased flight frequency for routes such as Shanghai Pudong — Bangkok, Shanghai Pudong — Singapore, Guangzhou — Bangkok.

Regional markets: Resumed routes such as Xi'an — Macau, Xi'an — Hong Kong, Wuhan — Kaohsiung, Hohhot — Kunming — Hong Kong.

II. FLEET STRUCTURE

In October 2023, the Company introduced an A350 aircraft without retiring any aircraft. As of the end of October 2023, the Company operated a total of 782 aircraft, including 291 self-owned aircraft, 263 aircraft under finance lease and 228 aircraft under operating lease.
