ANNOUNCEMENT POWER GENERATION FOR OCTOBER 2023

This announcement is made by China Datang Corporation Renewable Power Co., Limited* (the "Company") pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board of directors (the "Board") of the Company announces that, according to the Company's preliminary statistics, the power generation of the Company and its subsidiaries (collectively, the "Group") for October 2023 on consolidated basis amounted to 2,237,530 MWh, representing a decrease of 12.03% as compared with that of the corresponding period of 2022, of which, the wind power generation amounted to 2,032,486 MWh, representing a decrease of 15.18% as compared with that of the corresponding period of 2022; and the photovoltaic power generation amounted to 205,044 MWh, representing an increase of 39.26% as compared with that of the corresponding period of 2022. As of 31 October 2023, the total power generation of the Group for 2023 amounted to 25,066,571 MWh, representing an increase of 10.38% as compared with that of the corresponding period of 2022, of which, the wind power generation amounted to 23,020,372 MWh, representing an increase of 7.89% as compared with that of the corresponding period of 2022; and the photovoltaic power generation amounted to 2,046,199 MWh, representing an increase of 49.00% as compared with that of the corresponding period of 2022.
